DIEPPE CEREMONIES

MON LEO CADIEUX IS AS YOU KNOW RETURNING TO OTT MON EVENING AND WILL BE AVAILABLE TUE BUT AT HIS REQUEST I AM SENDING YOU THIS PRELIMINARY REPORT ON THE CEREMONIES HELD AT DIEPPE AUG 18 AND 19 TO MARK THE 25TH ANNIVERSARY OF THE RAID.

2. BRIEFLY DIEPPE WAS A HAPPY CONTRAST TO THE 50 ANNIVERSARY OF VIMY

LAST APR 9. EXCEPT FOR SOME RAIN DURING THE MARCH PAST EVERYTHING WENT WELL FROM EVERYONES POINT OF VIEW. VIRTUALLY THE ENTIRE POPULATION OF DIEPPE, SOME 35,000 PEOPLE, WITNESSED ONE OR ANOTHER PART OF THE PROGRAMME, AND AT LEAST THAT NUMBER WERE ATTRACTED BY THE SPECTACULAR SOUND OF LIGHT REENACTMENT OF THE RAID WITH LAVISH FIREWORKS ON THE BEACH SAT EVENING. SHORTLY BEFORE THIS, THE FRENCH NATL TV NEWS HAD FEATURED DIEPPE INCLUDING LONG EXTRACTS FROM A GERMAN FILM OF THE ACTUAL OPERATIONS AND BBC BROADCASTS OF AUG 19/42.

3. CDN UNITS PARTICIPATING IN THE CEREMONIES OUTDID THEMSELVES AND THE SURVIVORS PRESENT WERE PARTICULARLY WARMLY ACCLAIMED. ALTHOUGH THE BRIT WERE ALSO WELL REPRESENTED AND LORD MOUNTBATTEN TENDED TO STEAL THE SHOW DURING THE FOUR HOURS HE SPENT IN DIEPPE, IT WAS ESSENTIALLY CDAS DAY BOTH FOR THE DIEPPE PEOPLE AND IN

THE FRENCH NEWS TREATMENT OF THE EVENT. FRENCH OFFICIALS AT EVERY LEVEL OF GOVT (MUNICIPAL, PREFECTORAL AND CENTRAL) WENT OUT OF THEIR WAY TO DO ALL THAT THEY POSSIBLY COULD FOR US. THAT THIS IMPLIED A

WORD FROM THE TOP WAS CONFIRMED BY THE OFFICIAL REP OF THE FRENCH GOVT, MR DUVILLARD VETERANS MINISTER, WHO TOLD MR CADIEUX THAT GEN DEGAULLE HAD PERSONALLY GONE OVER THE WHOLE PROGRAMME IN DETAIL.

4. IN ADDITION, MR DUVILLARD EXPLAINED TO ME THAT THE FRENCH GOVT WERE USING THIS AND OTHER SIMILAR OCCASIONS TO TRANSMIT TO THE NEXT GENERATION SOMETHING OF WHAT THE WAR HAD MEANT AND WHY IT HAD BEEN FOUGHT. THE GOVT HAD BEEN SHOCKED TO LEARN FROM A RECENT PUBLIC OPINION SURVEY THAT ONLY HALF THE YOUNG PEOPLE OF FRANCE HAD ANY CLEAR IDEA WHO HITLER WAS, STILL LESS WHAT HE STOOD FOR. THEY WERE MAKING AN EFFORT TO CORRECT THIS IGNORANCE, FOR EXAMPLE BY SUBSIDIZING WAR FILMS. SO THEY HAD THEIR OWN REASONS FOR PLAYING UP THE DIEPPE ANNIVERSARY.

5. ALTHOUGH IT WAS OF COURSE NEVER STATED AS A REASON, I CANNOT RPT NOT HELP FEELING THAT ANOTHER ELEMENT WAS THE WISH TO ERASE THE DAMAGE DONE BY VIMY AND TO EMPHASIZE THAT, IN SPITE OF THE RECENT NON VISIT TO OTT, OFFICIAL FRANCE DOES NOT RPT NOT WANT RELATIONS WITH CDA TO DETERIORATE. WITH ONE NOTABLE EXCEPTION, A MUCH MORE POSITIVE STATEMENT OF THE POSITION COULD BE MADE

AS YOU KNOW JOINT CDN-BRIT RECONNAISSANCE OF DIEPPE AREA WHICH HAD BEEN TENTATIVELY PROPOSED FOR JUL5-6 WAS POSTPONED FOR LACK OF PRIOR AUTHORIZATION FROM QUAL. WE UNDERSTAND LIMITED AUTHORIZATION WAS IN FACT GRANTED ON EVENING OF JUL6 BUT BECAUSE OF SHORT TIME AVAILABLE BEFORE HIS SCHEDULED RETURN TO CDA GROUP CAPTAIN EMOND WAS OBLIGED TO MAKE PRELIMINARY RECONNAISSANCE ON HIS OWN.

2. IN MEANTIME BOTH CDA AND BRIT HAVE RECEIVED FULL AUTHORIZATION TO PARTICIPATE IN ANNIVERSARY CELEBRATIONS(EMBPARI TEL 2094 JUL 7) AND BRITS ASSUME JOINT RECONNAISSANCE DESIGNED TO CLARIFY

PRACTICAL ASPECTS OF PROPOSED ARRANGEMENTS CAN NOW PROCEED. WE

UNDERSTAND GROUP CAPTAIN EMOND WILL SHORTLY BE RETURNING TO FRANCE

AND BRITS HAVE SUGGESTED IN INTEREST OF EARLY SOLUTION THAT JOINT RECONNAISSANCE OF DIEPPE CEREMONY TAKE PLACE ON WED JUL19.

2. FO INFORMS US THEY SENT INSTRUCTION TO BRIT EMB PARIS LATE LAST
NIGHT JUN28 SUGGESTING AMBASSADOR GET IN TOUCH WITH CDN AMBASSADOR
TO DISCUSS MOST APPROPRIATE MANNER IN WHICH BRITS SHOULD APPROACH
FRENCH AUTHORITIES ABOUT BRIT PARTICIPATION IN DIEPPE CEREMONY.
SUBJ TO THIS CONSULTATION BRIT AMBASSADOR IS INSTRUCTED TO RAISE
QUESTION OF BRIT PARTICIPATION WITH QUAI AT EARLIEST OPPORTUNITY.
LORD MOUNTBATTEN HAS SPECIFICALLY ASKED THAT GEN DEGAULLE BE INFORM-
ED OF HIS APPOINTMENT AS BRIT FORCES REP. THIS WILL BE BROUGHT TO
QUAIS ATTN AT SAME TIME BY BRIT AMBASSADOR RATHER THAN BY MOUNTBATT-
EN WRITING DIRECT.

3. IT WAS OUR UNDERSTANDING AND WE BELIEVE IT IS ALSO BRIT UNDER-
STANDING THAT CDA AND UK SHOULD MAKE SEPARATE BUT COORDINATED ARR-
ANGEMENTS FOR DIEPPE CEREMONY. TIME IS GETTING VERY SHORT AND BRITS
CAN HARDLY HOPE FOR OFFICIAL AUTHORITY TO MAKE EARLY RECONNAISSANCE
IN DIEPPE IF THEY HAVE NOT RPT NOT PREVIOUSLY SOUGHT FORMAL AUTHO-
RITY FOR PARTICIPATION IN CEREMONY. ADDITIONALLY THERE HAS BEEN SPE-
CULATION THAT ONE OF REASONS FOR FRENCH DELAY IN REPLYING TO CDN

G/C RE EMOND ACCOMPANIED BY COL ALAN CHAMBERS DVA ATTACHE AND BY CDA HOUSE REP ATTENDED MTG THIS MORNING JUN27 AT BRIT MINISTRY OF DEFENCE OF SUB CTTEE ENGAGED IN COORDINATING ARRANGEMENTS FOR DIEPPE CEREMONY UNDER CHAIRMANSHIP OF AP MONTEATH OF MOD.MTG WAS ATTENDED BY BARRATT PRIVATE SECRETARY TO LORD LOUIS MOUNTBATTEN AS WELL AS HIS AIDE DE CAMP ROYAL MARINE CAPT COLEBY.

2.ALTHOUGH MTG WAS SUPPOSEDLY CONVENED TO DISCUSS WITH MOUNTBATTENS STAFF CERTAIN QUESTIONS RELATING TO THE CEREMONY AS FAR AS LORD LOUIS WAS CONCERNED MTG BROADENED WHEN TWO OVERSIGHTS IN BRIT PLANNING ARRANGEMENTS WERE REVEALED.BRITS HAVE NOT RPT NOT YET FORMALLY APPROACHED FRENCH GOVT ABOUT THEIR PART IN PROPOSED CEREMONY;AND LORD MOUNTBATTEN CONTEMPLATED ARRIVING DIEPPE AROUND NOON AUG19 AND DEPARTING ABOUT 1630 SAME DAY.

3.ANTHONY CHAMIER FO REP INFORMED CTTEE THAT AS FAR AS HE KNEW BRIT NAVAL ATTACHE IN PARIS HAD BEEN KEPT INFORMED OF DRAFT PROGRAMME AND SOME DETAILS OF OTHER PROPOSED ARRANGEMENTS BUT THAT BRIT EMB HAD NOT RPT NOT BEEN REQUESTED TO APPROACH FRENCH GOVT ABOUT BRIT PARTICIPATION IN SPECIAL CEREMONY CONTEMPLATED FOR 25TH ANNIVERSARY.WE CONFIRMED CDN EMB PARIS HAD ALREADY TAKEN THIS STEP AS

FAR AS CDN PARTICIPATION IS CONCERNED AND THAT OFFICIAL REPLY HAD NOT RPT NOT YET BEEN RECEIVED. FO REP UNDERTOOK TO RAISE THIS MATTER WITH BRIT EMB PARIS AT EARLIEST OPPORTUNITY. MOUNTBATTEN HAS OFFERED TO WRITE DIRECT TO PRESIDENT DEGAULLE IF THIS WOULD BE CONSIDERED HELPFUL.

4. LORD MOUNTBATTENS SECRETARY STATED THAT WHEN ACCEPTING INVITATION TO REPRESENT BRIT ARMED FORCES AT DIEPPE CEREMONY MOUNTBATTEN IN LET DATED APR11 HAD CLEARLY STATED HIS PREFERENCE FOR TRAVELLING FROM IRELAND TO DIEPPE AND RETURNING SAME DAY. THERE WERE GOOD REASONS FOR THIS. LORD MOUNTBATTEN NORMALLY LED VERY ACTIVE LIFE AND WOULD IN FACT BE LEAVING FOR CDA JUL5 TO OPEN CALGARY STAMPEDE AND TO ATTEND SEVERAL ROYAL CDN LEGION MTGS. HE HAD EARLY PLANNED TO TAKE OVERDUE HOLIDAY DURING AUG AT HIS PLACE IN IRELAND AND WOULD PREFER THAT HIS PRESENCE AT DIEPPE CEREMONY NOT RPT NOT INVOLVE COMPLICATIONS OF OVERNIGHT STOP IN ENGLAND OR FRANCE ENROUTE. BARRATT WENT ON TO SAY ROYAL NAVY WOULD BE PROVIDING MOUNTBATTEN WITH HERON TYPE AIRCRAFT WHICH INVOLVED FLYING TIME OF ABOUT THREE AND ONE QUARTER HOURS FROM IRELAND TO FRANCE AND A HELICOPTER CONNECTION FROM CLOSEST SUITABLE AIRFIELD WOULD TAKE ADDITIONAL TIME. BARRATT ESTIMATED TOTAL TRAVELING TIME FROM IRELAND TO DIEPPE WOULD BE ABOUT FOUR HOURS TEN MINUTES WHICH MADE IT UNLIKELY THAT MOUNTBATTEN COULD PARTICIPATE MUCH BEFORE NOON ON AUG19.

5. CONSIDERABLE DISCUSSION THEN ENSUED BETWEEN MONTEATH AND BARRATT ON WHY MOUNTBATTENS LET OF APR11 HAD NOT RPT NOT BEEN SUFFICIENTLY

TAKEN INTO ACCOUNT. CDN REPS MADE CLEAR THEY WERE UNAWARE OF LET AND OF ARRANGEMENTS PROPOSED THEREIN.

6. MONTEATH ATTEMPTED TO DUCK RESPONSIBILITY ON THIS POINT BUT BARRATT PRESSED TO HAVE PROPOSED PROGRAMME AMENDED TO MAKE IT POSSIBLE FOR MOUNTBATTEN TO ATTEND PRINCIPAL FUNCTIONS AROUND NOON AND THEREAFTER. DRAFT PROGRAMME WAS THEN REVIEWED. IT WAS AGREED THAT PROGRAMME HAD BEEN PREPARED BY FRENCH LOCAL AUTHORITIES ON BASIS OF EXPERIENCE GAINED FROM PREVIOUS ANNUAL AND 20TH ANNIVERSARY CEREMONIES AND ANY CHANGES WOULD NECESSARILY INVOLVE CONSULTING FRENCH AUTHORITIES. ADDITIONALLY A RESCHEDULING OF COMMEMORATIVE SERVICE AT CIMETIERE DES VERTUS FROM 0915 HRS TO 1230 HRS AS HAD BEEN SUGGESTED BY SECRETARY WOULD DISRUPT ARRANGEMENTS INCLUDING MOVEMENT OF PARTICIPANTS FROM THIS CENTRAL CEREMONY TO LANDING SITES ON BEACHES IN DIEPPE AND NEIGHBOURING TOWNS. POSSIBILITY OF RESCHEDULING RELIGIOUS CEREMONY FROM 1015 TO 1200 HRS WAS ALSO EXAMINED AT SUGGESTION OF SECRETARY BUT THIS WAS TENTATIVELY ABANDONED BECAUSED IT IS PRIMARILY FRENCH FUNCTION.

7. BARRATT EVENTUALLY AGREED TO ASCERTAIN WHETHER MOUNTBATTEN DESPITE HIS PREVIOUS STIPULATIONS COULD ARRIVE ON FRI AUG 18 STAYING OVERNIGHT AT LETOUQUET AND PARTICIPATE IN CEREMONY FROM 0915 ON SAT UNTIL CONCLUSION OF MILITARY PARADE AT 1630. ALTERNATIVE SEEMED TO BE THAT MOUNTBATTEN ARRIVE AS CURRENTLY ENVISAGED AT 1230, PROCEED TO SUB PREFECTURE WHERE HE COULD JOIN MOTORCADE AT FRENCH WAR MEMORIAL AT 1245, DEPOSIT WREATH AND PROCEED TO CASINO FOR OFFICIAL LUNCHEON AT WHICH HE COULD MAKE SPEECH, LATER ATTENDING MILITARY

PARADE BEFORE RETURNING TO IRELAND. THIS DISCUSSION TOOK OVER HOUR AND HALF.

8. WE HAVE SINCE HEARD FROM FO THAT MOUNTBATTEN REACTED UNFAVOURABLY TO BARRATT'S PHONED ACCOUNT OF MTG. HE IS DISINCLINED TO ALTER HIS TRAVEL PLANS SO AS TO ARRIVE EVENING BEFORE CEREMONY. YOU MAY WISH TO CONSIDER WHETHER YOU MIGHT AGREE TO ANY PROGRAMME ALTERATIONS BEING MADE TO MEET MOUNTBATTEN'S TRAVEL ARRANGEMENTS, SAY BY MOVING RELIGIOUS CEREMONY FORWARD TO 1200. IN OUR VIEW HOWEVER NEGOTIATIONS ON THIS QUESTION, IF CDN APPROVAL IS GIVEN, SHOULD BE CONDUCTED BETWEEN BRIT AND FRENCH AUTHORITIES SINCE MOUNTBATTEN IS BRIT FORCES REP AND PRINCIPAL CDN CEREMONY AT 0915 WILL NOT RPT NOT BE AFFECTED.

MEMORANDUM FOR THE PRIME MINISTER

Re: Battle of Dieppe - 25th Anniversary
Commemorative Ceremony

Because of the difficulties which arose in relation to the holding of commemorative ceremonies at Vimy, France, on April 9 of this year, it was felt desirable that representatives of the Prime Minister's Office, the Department of External Affairs, the Department of National Defence and the Department of Veterans Affairs should review arrangements that had been made to date with regard to the ceremony to be held at Dieppe, France, on August 19, 1967, to commemorate the 25th anniversary of the landing. With this in mind, the following attended a meeting in the Department of Veterans Affairs on May 9:

Mr. Elgin Armstrong, Deputy Minister, from the Department of National Defence;

Mr. Marcel Cadieux, Under-Secretary, and Mr. John Halstead, Head of the European Division, from the Department of External Affairs;

Mr. J.S. Hodgson, from the Prime Minister's Office; and

Mr. Paul Pelletier, Deputy Minister, and Mr. F.T. Mace, Assistant Deputy Minister, from the Department of Veterans Affairs.

Since the end of World War II, the local French authorities have organized annually a commemorative ceremony to mark the anniversary of the Dieppe raid. This has been, essentially, a French ceremony at which Canada has usually been represented on a relatively modest scale.

Because this year marks the 25th anniversary of the raid, and because it was known that a number of Canadian regimental associations were planning organized pilgrimages, the Department of Veterans Affairs' London representative, Colonel Alan Chambers, wrote Mr. J. Juilhard, Sous-Prefet of Dieppe, on December 22, 1966, inquiring as to French plans for this year and suggesting an early meeting. Mr. Juilhard readily agreed and a meeting was held in Dieppe on January 4, which was attended by the Sous-Prefet, the Mayor of Dieppe, the President of the Syndicat de l'Hotellerie de Dieppe and by Mr. Chambers. At this meeting a program was drawn up and, subsequently, was submitted to the British Ministry of Defence Ceremonials Committee by Mr. Chambers who, throughout, has acted as liaison between the local French authorities at Dieppe and the British military authorities.

In February and March of this year, the draft program (copy attached as Appendix A) was approved by the three parties concerned at the level referred to above. At the same time, it was understood that the Sous-Prefet of Dieppe would transmit the program to the French Ministry of the Interior for consideration and approval and that this program would not become official until it had been made so by the French Government. To date it is not known whether in fact the proposed program has been submitted to the Ministry of the Interior nor indeed what reaction can be expected from the French Government.

Since 1967 marks the 25th anniversary of the Dieppe raid, the ceremonies to be held at Dieppe on August 19 will be somewhat more elaborate, at least from the point of view of Canadian and British participation, than has been the case in the past. In our view, the ceremony this year will none the less remain, as it always has been, an essentially French ceremony in which we and the British participate.

At the moment, the Department of Veterans Affairs proposes that the official Canadian delegation be headed by the Minister of Veterans Affairs or some other member of the government and that a Canadian Guard of Honour of one hundred men and a band be provided by the Canadian Forces in Europe. It is understood that the British plan to have a destroyer sail to Dieppe for the occasion and also intend to provide a Military Guard of fifty men to represent the British

Commandos and another Guard of fifty men to represent the Navy.

Naturally none of these plans can be considered firm and no final decisions can be taken until the formal approval of the French Government has been obtained. It is therefore recommended that the Canadian Ambassador to France now be instructed to approach the French authorities in order to inform them that a draft programme for a special ceremony at Dieppe on August 19 has been prepared locally, to ask whether the proposed Canadian participation meets with their approval and to request their views on the nature of the ceremony (e.g., do they agree to treat it as an essentially French ceremony with Canadian and British participation, or do they wish to adopt some other formula?). In the light of their answers to these questions we can then decide what the level of Canadian representation should be and how the proposed British participation should be handled. A telegram to our Embassy in Paris along these lines is attached for approval.

This memorandum is concurrently being submitted to the Secretary of State for External Affairs, the Minister of National Defence, the Minister of Veterans Affairs and the Associate Minister of National Defence, as well as to you, for consideration and approval.

FRIDAY 18th AUGUST

NIGHT WATCH

A Night Watch will be held in the Canadian War Cemetery of Les Vertus, on the heights behind the City of Dieppe, commencing at night-fall. This is as organised every year by the French Veterans, Resistance Members, Deportees and former Prisoners, and is to commemorate those buried in the Cemetery.

It is suggested that Canadian and British Survivors of the Raid may wish to make a personal visit to the Cemetery containing the graves of their comrades from say 20.00 hours onwards and then participate in the Night Watch individually if they so desire.

SATURDAY 19th AUGUST

09.15 hours

COMMEMORATIVE CEREMONY

The Official Commemorative Ceremony will be held in the Canadian War Cemetery at Les Vertus in the presence of the Official Representatives of Canada, Great Britain and France, for the Canadian and British Survivors of the Battle, relatives of those who died and their friends. During the Ceremony, Addresses will be given by the Canadian and British Official Representatives.

10.15 hours

PUBLIC RELIGIOUS SERVICE

A public Religious Service organised by the Authorities of the City of Dieppe will be held in the open air on the Esplanade. It will be attended by the Official Representatives of the three Governments.

10.45 hours

VISIT TO ESPLANADE REGIMENTAL MEMORIALS

At the conclusion of the Religious Service, the Representatives of the three countries, together with the Survivors and Veterans of the Regiments concerned, walk together to each of the Regimental Memorials on the Esplanade and then to the Memorial erected by the City of Dieppe at the end of the Esplanade. At each of these Memorials, wreaths will be laid.

10.45 hours

At the conclusion of the Religious Service, the Veterans of those Regiments and Units having no Memorial on the Esplanade at Dieppe, will instead go to their main points of interest at Varangeville, Pourville, Puy or Berneval, as the case may be, to take part in such local Ceremonies as they may themselves have arranged.

VISIT TO THE BEACHES

At the conclusion of their visit to the Regimental Memorials on the Esplanade, the Representatives will move in a procession of French military vehicles from the Esplanade at Dieppe to the other localities where Regimental Associations have arranged Ceremonies - as above. This will be given by the Canadian Government to the Official Representatives and to the Veterans. It will take place in the Rotonde which is on the Esplanade opposite the Casino.

The City of Dieppe will give a Popular Ball at the Salle Municipale for the Veterans and the military contingents who have taken part in the day's events.

MEMORANDUM FOR THE PRIME MINISTER

Re: Dieppe

Today I went to a preliminary meeting with representatives of External Affairs, Veterans Affairs and National Defence, on plans for the observance of the 25th Anniversary of the Dieppe Raid on August 19th.

For years the local authorities at Dieppe have been conducting commemorative ceremonies with small-scale Canadian participation. These local authorities have apparently been in touch with Veterans Affairs suggesting a much more elaborate ceremony this year and sending a draft programme for that Department's consideration.

Naturally in any plans made for Dieppe, our officials concerned will wish to keep in mind the sequence of events affecting the recent Vimy ceremony. There is probably little doubt that in any Dieppe ceremony the French would be the hosts, and Canadians and British would be participating guests. No formal steps have yet been taken from the Canadian side.

As a result of today's meeting, a memorandum is being prepared for the consideration of yourself and Messrs. Martin, Teillet and Hellyer. It will state the position rather more fully than the above, and will submit for your consideration a draft message to our Ambassador in Paris. Leger has already mentioned informally to Couve de Murville that we have been approached by the local French authorities. The suggested message would ask for some official indication of the position of the Quai d'Orsay and would indicate that if invited to participate, Canada would be prepared to respond on a considerable scale.

We believe that the British will probably be taking parallel action to the Quai d'Orsay. You will recall that they have in mind being represented by Lord Mountbatten. In the Dieppe Raid the British participation included two marine groups, plus RN and RAF support.


