



Upon the termination of the UNESCO conference in Paris in December, 1960, the delegates' documents were turned over to the Embassy for transmission to the Department by seabag. Through an oversight, the documents were held in storage at the Embassy and were not shipped until January 27, 1961 after a request from the Department for a check on their disposition.

2. When the packages of documents were received in the Mail Section on February 13, several of them were found to have been damaged in transit and it was necessary to rewrap and address them in the Mail Section for onward transmission by parcel post to the various addressees in Canada.

3. Two packages, addressed to Mr. Vincent Price, Apt. 802, 110 St. Clair Ave., Toronto 7, Ont., which were among those rewrapped in the Mail Section, were forwarded to the Ottawa Customs House in error. In accordance with existing arrangements, Customs released the packages to Canadian National Express for onward transmission to Toronto, express collect. Upon receipt Mr. Price paid \$2.00 to C.N. Express.

4. In view of the combination of errors which resulted in inconvenience and expense to Mr. Price, I believe you may wish to arrange to reimburse him for \$2.00 express charge. Details of the shipment are contained in the attached copy of the C.N. Express billing.

MEMORANDUM FOR THE MINISTER

The United Nations Conference on  
Diplomatic Intercourse and Immunities:  
Congolese Credentials

The delegation to the United Nations Conference on Diplomatic Intercourse and Immunities has indicated that the credentials of the Congolese delegation of President Kasavubu might be challenged, and has asked for our guidance.

While Canada abstained in the voting on President Kasavubu's credentials at the United Nations General Assembly last fall, we made it clear that we did so on the grounds that Canadian membership on the Secretary-General's Advisory Committee on the Congo precluded our taking a stand on the question. At the same time, we pointed out that as the credentials had been accepted by the majority of the members, the Assembly had to recognize the legality of President Kasavubu's position.

While we abstained again later at the UNESCO Conference we were one of a very small number of countries to do so. As Canada has accepted the decision of the General Assembly to recognize President Kasavubu's delegation we should, I think, uphold this decision in international conferences or organizations associated with the United Nations if the question is raised.

If you agree, the attached instructions might be sent to the delegation in Vienna.

Dear Mary,

I was indeed worried about the apparent loss of the Conference documents. I had enquired from the registry who had never received them nor had been told by our Delegation that they should expect to have a large shipment for Ottawa. On rechecking, they were found in the shipping section where some packages had to be divided up because of their size. This section, I learnt, is understaffed and the messenger in charge took some holidays during the Xmas season. Moreover, he had been told to wait for further instructions. All this explains the delay.

I had endeavoured on three occasions to press for the photographs you had ordered; notwithstanding, nothing could be done before January 16th. I immediately forwarded one to Pierre Charpentier and the rest to you by courier. At least I am satisfied that they will have arrived on time for the article you have in mind since they will have reached you before January 30th.

The great halls of UNESCO became very silent when the Conference came to an end. However, gradually UNESCO is again what it was before - active but not agitated. Officers have returned from their holidays and things are running smoothly with the vast programme ahead.

Officers in charge of UNESCO's programme in the Congo were very pleased when they received from Canada a number of candidates which is in fact small but rather large when compared with the number of applications from other countries. I hope that no political developments in the Congo will oblige our teachers to change their minds. I am seeing to-morrow Mr. P.C. Terenzio to discuss this question with him.

I have just returned from a speaking tour in the Franche-Comté and, although meetings were extremely successful, they have taken much of my time; and kept me away from the office for a week.

I hope that everything is well with you and that you are gradually clearing your desk ... if desks can ever be cleared. It was nice working with you all during the Conference and now we shall follow the developments in a calmer atmosphere.

I should like to thank you for your letter of December 22 concerning Canadian representation at the General Conferences of Unesco. I have noted your request that in the selection of delegations to future conferences the Government give consideration to naming a representative from the architectural profession in Canada.

You will, of course, realize that because the cultural and artistic programme of Unesco covers such a wide range of activity, it is not possible at each conference to have representation from all the interested groups, so that an attempt must be made from session to session to take into account a variety of Canadian interests and experiences. As you no doubt recall, an architect was included in the delegation to an earlier conference and it may well be that the profession could again be represented at some future conference.

I should like to assure you that the Government is happy to learn of the interest of the Royal Architectural Institute of Canada in Unesco matters, and it welcomes suggestions from organizations such as yours, which have special competence in one or other of Unesco's fields of activity.

I might also draw your attention to the rôle of the Canadian National Commission for Unesco with which, I understand, the RAIC is associated. Under its terms of reference the Commission has authority to advise the
