

The children, Mary Loue and Linda May, were taken into care in the Yukon Territory a number of years ago, when they were resident here.

All Indians in the Territory are deemed to be our responsibility, regardless of residence.

Johnny Louie has now been taken into care by the authorities in B.C. where the boy and his father have been off Reserve and not in receipt of assistance for at least three years.

There are two jurisdictions involved and I do not see how what happens in one jurisdiction can affect a decision in the other which should be based on the residence history of the child and parent concerned, within that jurisdiction.

We note that you state this child and his father have been resident off a reserve for a number of years, self-supporting. Our file indicates that two other children of this family, Mary Lou and Linda May, were taken into care by the Yukon Superintendent of Child Welfare on September 22, 1959, and Authority Nos. 2080/62-63/320 and /321 for their maintenance have not been cancelled. We assume, therefore, that you are still paying maintenance accounts on their behalf, and if so, this family cannot establish residence off a reserve since we accepted responsibility for other children and they are still in care of the Superintendent of Child Welfare.

Please advise further or forward an Initial Child Placement Application for Johnny, as soon as possible.



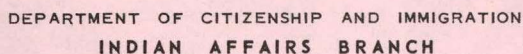

In view of the recent death of Mary Quock, a reply to your request for a progress report on the two above-named children has been delayed.

There had been some question at the Court hearing of allowing the children to return to the father [redacted], should he be in a position to care for them. Now, with the death of the mother, Mary, plans will have to be made regarding the future of these children. The mother had shown no interest in them since placement.

Both children have progressed very well. Linda May showed signs of great insecurity at first, but has now outgrown her fears and tensions, and has developed into a well-adjusted child. She appeared quite dull and withdrawn for the first months, but is now a well-mannered, poised, interested child who plays well with her peers and adjusts in relationships with adults. She is able to show and receive affection and has improved in appearance; is quite attractive with a delicate face, big brown eyes, dark-brown hair, rather large ears and of a slim build. She is slightly Indian in appearance with olive skin.



Mary Lou is a beautiful, diminutive child, with white skin, small, dark-brown, bright eyes, and dark-brown hair and round face. She has never shown any signs of tension and is well-adjusted. She is advanced in speech and described as exceptionally bright. She is a very lovable child and identifies well with her foster family. Definitely not Indian in appearance.

Neither child has had any illnesses, and both have been fully immunized.

These children are considered very adoptable and should be placed for adoption. A decision will have to be made regarding this in the near future.
