

Father Moss School, Sioux Narrows

Draft copy of the tripartite agreement for the termination of the Joint School Agreement concerning Father Moss School prepared by the Ministry of Education and revised by our Headquarters has been submitted to both the Kenora Separate and Public School Boards as per attached memos December 21, 1976.

Mr. Ken Hay, Director of Education, for the Public Board, has proposed some changes to the draft as per attached letter of December 29, 1976.

In my opinion these changes are acceptable and I agree that they are consistent with the earlier discussions. Specifically, there was never any question that the amount repayable to the Federal Government would be \$103,357.71, less depreciation of four percent per year commencing September 1, 1974. Please advise me whether the depreciation should be calculated at four percent yearly on the decreased balance in which case the amount would be approximately \$87,790, or a straight 16% for four years which will result in a depreciated amount of about \$86,820.

Both Boards have made a submission to the Thunder Bay Regional Office of the Ministry of Education concerning provincial grants to make this transfer of Father Moss School possible. The Ministry's reply is expected within two weeks from today.

Dear Mr. Weigeldt:

This is in reply to your communication of December 21st regarding the proposed agreement between the Department of Indian Affairs and the two School Boards regarding the Father Moss School building. Your letter will be referred to the attention of the Board at its next meeting.

In the interim, however, I would like to draw your attention to a number of items included in the agreement which seem to be either inconsistent with our earlier discussions, or which may require change in light of the possibility that The Kenora Board of Education will purchase the Father Moss building rather than lease it:

Paragraph 1. Change the sentence starting "Moreover, the Minister agrees that the Separate School Board may lease the said school..."

-to-

"Moreover, the Minister agrees that the Separate School Board may lease, sell or otherwise dispose of the said school..."

Paragraph 2. Delete - and change to -

"The Separate School Board and the Board of Education agree that in consideration of the payment of monies provided for in Paragraph 3 hereunder, the Separate School Board will enter into an agreement to lease or sell the Father Moss School to the Board of Education upon such terms and considerations as shall be set out in the agreement between the said Boards."

Paragraph 3. Change "the sum of \$100,000 payable in 10 equal and consecutive annual instalments of \$10,000.

"the sum of \$86,820.48 payable in 10 annual and consecutive instalments of \$8,682."

I make reference to the discussions concerning the take-over of Father Moss School by the Kenora Board of Education as of September 1, 1978, and the plans for the construction of a new federal school on the Whitefish Bay Indian Reserve.

In order to obtain approval for capital funds for the construction of this new school it will be necessary to reach agreement on the termination of the existing Joint School Agreements between the Kenora District R.C. Separate School Board and the Department of Indian Affairs. Since the Kenora Board of Education wishes to utilize the school buildings of Father Moss School, the Ministry of Education, Toronto, prepared a draft copy of a tripartite agreement to that effect. This draft copy has been reviewed and revised by the Legal Counsel of the Department and is enclosed for the consideration by your Board.

May I emphasize that agreement to terminate the existing Joint School Agreements and agreement to repay the unamortized portion of the Department's investment in the sewage treatment plant at Father Moss School have to be reached before Treasury Board will give approval for capital funds for the construction of the new school on the Whitefish Bay Reserve. In order to have this new school operational by September 1, 1978, it will be necessary to obtain Treasury Board approval before April 1, 1977. Therefore, it is most urgent that both Boards reach agreement in the near future and sign the proposed tripartite agreement. Please advise me as soon as possible of any changes you wish to make in the enclosed draft copy, in order to give the other parties time to review them.

This will refer to our telephone conversation of this date and to the draft copy of the Ministry of Education agreement prepared in their Toronto office and forwarded to their field offices for consideration. As I indicated, this draft copy was sent to Ottawa for their review and the attached revised draft document has been returned from Ottawa after consultation with our Legal Counsel.

The attached document eliminates the necessity for two additional agreements, i.e. (1) an agreement between the Minister and the Separate School Board and (2) an agreement between the Minister and the Board of Education. It also provides for the latter to make payment in full at any time.

Again, as we discussed, this document will provide an opportunity for you to raise the urgency to have the payment to the department finalized at an early date. ~~We suggest that this draft be presented to the parties involved with the view to reaching consensus on an agreement. Any significant change to the proposed agreement will necessarily be referred to our counsel in Ottawa.~~

Memorandum of Agreement made this Day of 1976

Between: Her Majesty The Queen in Right of Canada, represented by the Minister of Indian Affairs and Northern Development, hereinafter called 'the Minister'

Of The First Part

And

The Kenora Board of Education, in the Province of Ontario, hereinafter called 'the Board'

Of The Second Part

Whereas the Board wishes to leave Father Moss school at Sixty Narrows, Ontario from the Kenora District R.C. Separate School Board as of September 1, 1978;

And

Whereas the Minister invested the sum of \$103,357.71 for the construction of a Sewage Treatment Plant at the Father Moss school site, this sum representing 184/200ths of the total cost of the Sewage Treatment Plant of \$-112,345.33

And

Whereas the rate of depreciation for the said Sewage Treatment Plant is calculated at four per cent per year commencing September 1, 1974;

Now This Agreement Witnesses that the Minister and the Board agree to enter into a Rental Purchase Agreement for the said Sewage Treatment Plant as of September 1, 1978 on the following terms and conditions:

1. The Minister leases the Sewage Treatment Plant at the Father Cross School Site to the Board commencing September 1, 1978 for a period of ten years;
2. The Board as the Lessee agrees to pay rent in the amount of \$163,357.71 less depreciation of four per cent per year commencing September 1, 1974;

The rental payments to be made in ten yearly instalments each First Day of September, the first payment to be due Sept. 1, 1978 and the final payment to be made on September 1, 1987 as per attached pay schedule;

- 3. The Board as the Lessee assumes full responsibility for the cost of operation, maintenance, and repairs of this Sewage Treatment Plant for the duration of the lease-term;
- 4. Upon expiry of this lease-term and upon payment of the agreed upon rent the Board shall own that portion of the Sewage Treatment Plant for which the Minister paid the initial cost.

In Witness Whereof the Minister of Indian Affairs and Northern Development has hereunto set his seal on behalf of Her Majesty in Right of Canada and the Board of Education has executed this Agreement by the hands and seals of its proper officers duly authorized in that behalf this Day of 1976
