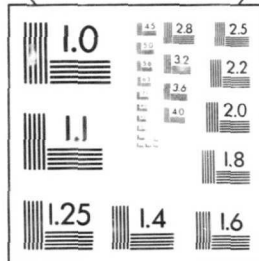

"By allowing 22 million tons of U.S. coal to be annually dumped into Canada at a time when Canadian miners are laid off or forced to go on part time work is a crime against Canada" said Mr. Swankay. "It means that Ottawa is putting the profits of U.S. coal trusts ahead of the welfare of Canadian miners. The government can and must adopt a policy of Canadian coal for the Canadian market."

Outlining the growing market crisis in agriculture which he charged was caused by U.S. control over Canada's trade policies, Mr. Swankay called for new policies of trade with the whole world, the acceptance of British pounds sterling in exchange for Canadian farm produce, for floor prices under all farm products and for cash advances on farm stored grain.

He pointed out that great iron ore deposits have been discovered in the Peace River area and yet nothing was being done to develop a local steel industry. "An Alberta steel industry could provide 20,000 new jobs" said Mr. Swankey, "as well as provide a stable and large market for our coal." He asked that "Alberta's wealth should be developed for her people, not for the profits of U.S. trusts." Mr. Swankey further declared that "our governments, both provincial and federal, must follow a policy of 'put Canada first' if the threat of depression and war is to be successfully met."

1. Further to the above, a Labor Progressive Party nominating convention for the Crow's Nest Pass area was held at Coleman on Dec. 4, 1954. This took the form of a banquet and dance held at the Ukrainian Hall, the main address was made by Ben SWANKEY of Edmonton. About 75 persons attended, including the following: Dan LEMECHAK, Nick UKRAVITZ, Steve MALANCHUK and wife, Mike STELMACHOWICHA, Steve ANDROS, Cecil MAKULAK, Peter ZOOK, Nick POLSKI, Aloha VERISHKO and Mrs. Henry MCCARTNEY, all of Coleman; Steve HARMATNEYA of Natal, B.C., Aloha PIROZAK and wife of Blairmore, E. M. WAKALUK and wife of Bellevue, Peter LELUK and William FERBEY of Hillcrest and Fred KONDRATIUK of Bellevue. There were a few people from outside the Pass, and

2. Steve ANDROS gave a short address explaining the purpose of the gathering, and nominated Ben SWANKEY as L.P.P. candidate for the next provincial election in the Pincher Creek-Crow's Nest constituency. William FILOWICH then nominated Steve ANDROS, this caused some consternation and after considerable discussion ANDROS declined the nomination, leaving SWANKEY to be the choice by acclamation.

3. SWANKEY gave a short address, he spoke of the war aims of the U.S.A., and recalled the horrors of the last war. He mentioned the release of Kurt MEIER from prison, and mentioned this was further indication of subservience of the Canadian government to the wishes of the U.S.A., who wanted to re-arm West Germany to bolster an attack on the U.S.S.R. SWANKEY gave the usual attention to the coal situation and the lack of a government coal policy. He stated there would be frequent meetings in the Crow's Nest area to acquaint the public with the aims of the L.P.P.

4. The sum of \$3.00 per couple was collected, supper and beer were supplied. A liquor permit had been secured by Tony PATERA on Nov. 29th. Further detail concerning SWANKEY's activities in the Pass could not be learned.

5. The following account of the meeting was prepared by the L.P.P. and handed to the Lethbridge Herald correspondent by Steve MALANCHUK, and appeared in the Dec. 7th issue of the Lethbridge Herald:

'CANADIAN COAL FOR CANADIAN MARKETS' CALLED FOR BY SWANKEY

Approximately 150 persons attended the banquet and nomination meeting of the Labor Progressive Party held in Coleman on December 4th. Present were members and supporters from many points in the constituency, including the mining towns and rural areas. Guest speaker was Ben Swankey of Edmonton, provincial leader, who was nominated as the party's candidate to contest the provincial riding of Pincher Creek-Crow's Nest Pass in the next election. A dance followed the meeting.

During his address, Mr. Swankey dealt with the emergency in the coal industry and the danger of another war arising out of German re-armament.

"To allow 22 million tons of United States coal to be annually dumped into Canada at a time when Canadian miners are idle or forced to go on part time work, is a crime against Canada," said Mr. Swankey. "It means that Ottawa is putting the profits of the United States coal trust ahead of the welfare of Canadian miners. 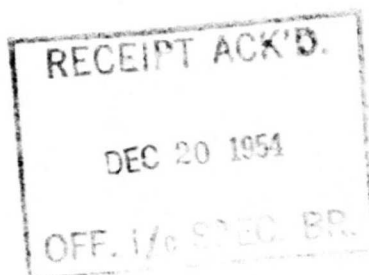

Canada Day: no gathering arranged. Agreed to order 400 Canada Day leaflets for Michel, 300 Coleman, 300 Blairmore, 200 Bellevue. Agreed to order 25 Tribs for Bellevue and 15 for Coleman.

Coal policy- Agreed to issue leaflet to youth. Sam to prepare draft for bure. Decided to issue press release from the meeting directed to Alta and BC governments. Agreed also to press in locals for action on UMWA delegation to Ottawa and for trade union conferences on unemployment.

Steel industry campaign- our press release had been carried in whole by Pass Herald which has circulation of over 2000 in miners homes; also carried as insert in Lamp; union secretaries had not yet taken up LPP letter on subject at their union local meetings.

Calgary: Met with City Committee

- Canada Day - joint gathering being organized by national groups and party. Decided to order 3000 leaflets and 140 copies of Trib.
- Party Building - number of very good contacts who are to be approached, before end of month.
- Trib circulation: clubs are going ahead with drive, but too

We are glad to report that one of the decisions of that meeting - that we finish the Tribune Sustaining Fund Drive on time - has already been carried out successfully. 1. [redacted] a banquet, sponsored by the Coleman Labor Progressive Party, was held in the Ukrainian hall in Coleman on May 15, 1954. The stated purpose of the banquet was to honor Mrs. Harry KOBOWKA on the occasion of some anniversary or birthday, however Mrs. KOBOWKA was not even present and it was evident the banquet was held for the purpose of hearing A.A. Macleod of Toronto. Present were Dan LEMECHAK, Stanley MALANCHUK and wife, Joe POLSKI, Molly KINAKIN, Sam KINAKIN, Nick POLSKI and wife, Wm. FILEWICH, Tony PATERA, Steve ANDROS, Nick UKRAVITZ, Frank KOZLER, of Natal, Steve HARMATNY and wife of Natal, George IWASIUKE of Hillcrest and some unidentified Doukhobors.

2. Steve ANDROS was chairman and introduced A. A. Macleod, stating he had recently come west from Toronto, and had a message for the people. Macleod spoke briefly, stating he was travelling all over Canada, organizing and giving assistance in explaining the policies of the L.P.P. He stated that to members and supporters of the party progress appeared slow, but educating the people takes time and that in ten years or so the country will be ready to receive socialism. He then gave an account of the benefits of socialism, with particular stress on the situation of the unemployed miners.

3. A charge of \$2.00 per person was made for the banquet, a permit had been obtained and beer was served. Due to the small number attending the affair was not a financial success. William TARASOFF of Lethbridge is believed to have attended, as he drove to Coleman to bring Macleod and Steve SZOKE of Toronto to Lethbridge.

4. Further enquiries are being made in an effort to identify the Doukhobors present, and determine to what extent they are associated with the L.P.P.

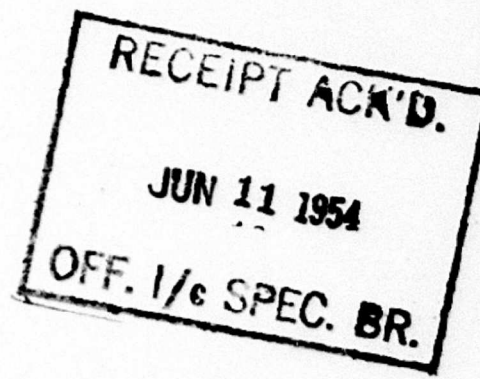

1. Further to the above, there is no indication of an active Labor Progressive Party group in Coleman at the present time.

2. during the recent federal election campaign there appeared to be no organized activity in Coleman towards furthering the campaign of Tony PATERA, LPP candidate from Frank. known communists such as Nick POLSKI and Dan LEMIECHA stated they had not been approached for funds, and that PATERA's deposit of two hundred dollars had been put up by Pauline ELSHINSKY and Stanley MALANCHUK out of their own funds. PATERA was considered by the communists to be a poor choice for a candidate, and this might account to some extent for the apparent lack of activity during the election campaign. It will be noted that Steve ANDROS and Stanley MALANCHUK were active in Blairmore on PATERA's behalf.

3. There has been no recent word of any activity on the part of Harry McCARTNEY and his wife, who have been considered mainstays in the Party at Coleman. Most of the LPP adherents in Coleman are active in the Association of United Ukrainian Canadians and other communist front organizations in the district.

With reference to memorandum from the Insp., Officer i/c Special Branch "E" Division dated Victoria, B.C., February 11, 1953 with Documentary Exhibits Nos. 8335 and 8341 attached, together with forwarding minutes of the Officer Commanding Nelson S/Division, Nelson, B.C., 13-2-53, relative to the above, following is a report in an effort to identify the Party members referred to in the above Exhibits.

2. Doc. Exhibit No. 8335 (1-13) is a letter written by Adolph POTHORN [REDACTED] to Alf. DEWHURST of the L.P.P. Prov. Headquarters of Vancouver, B.C. This letter was written from P.O. Box 366, Natal, B.C. which was rented by James Emil POLASKI [REDACTED] while he was at Natal. POTHORN was located in the Crows Nest Pass District for several months during the latter part of 1951 as a Party Organizer in conjunction with the B.C. and Alberta Committees of the L.P.P. This letter deals with Party activity in the Crows Nest Pass area. In Ex. No. 8335 (2) he mentions having to stop over in C & T. This would refer to Cranbrook and Trail. He arranged for a Club Org. meeting in Bell (Bellevue, Alta.) Friday 13th plus a full Area meeting on Sunday in BL or B.C.? which refers to Blairmore or Blairmore-Coleman, Alta. He had a final class in F. (Fernie) on 12th.

3. The S. mentioned in Exhibit No. 8335 (3) refers to Sam ENGLISH, Michel, B.C. [REDACTED] He mentions S. numerous times in Exhibit 8335 (3 & 4) as being responsible for weakness in the local Clubs and also that ENGLISH is loaded with T.U. (Trade Union) work, Lamp Edite Board (English writes articles for the shop paper "LAMP" published by the L.P.P. in Edmonton, Alta.), Hospital etc. POTHORN mentions the general trend is for s(ENGLISH) to be Chairman and T.U. (Trade Union) Director for area.

4. In para. 2 of Exhibit No. 8335 (4), it is mentioned that S. suggested to POTHORN "what about J. as area Org. This refers to James Emil POLASKI, who succeeded POTHORN as Party Organizer at Natal-Michel. The initials St. Contained in para. 2 of Ex. No. 8335 (6) refer to Stefan (Steve) HARMATNY, Natal, B.C. [REDACTED]. There are also references to St. in Ex. No. 8335 (7) pertaining to HARMATNY's work in the Mass Organizations, referring to the W.B.A. and FEDERATION OF RUSSIAN CANADIANS etc. In Exhibit No. 8335 (9) is a reference to "Jim's" shack. This refers to James E. POLASKI who rented a shack from Fred RYBACHUK, Natal. POLASKI is referred to in the same page as J. as being suggested by S. (Sam ENGLISH). Jim (POLASKI) is referred to in Ex. 8335 (10) as having a best grasp, Coast Experience?, etc. Other references in the letter deal with the Party situation in F. (Fernie) and Nan (Nanaimo)

Arthur ROBERTS of Drumheller, Alta. addressed a meeting in the Union Hall, Natal, B.C. on Sunday, Dec. 9th, 1951, 2 days before the letter of POTHORN's was written. ROBERTS was a member of the CANADIAN TRADE UNION DELEGATION to the Soviet Union representing the United Mine Workers. He refers to the attendance at the Natal meeting and also at BL (Blairmore, Alta.)

6. Doc. Exhibit No. 8341 is another letter written by POTHORN to Alf DEWHURST on Sept. 10th, 1951 dealing with Party activities in the Natal-Michel, B.C. area, Fernie and the Alberta towns of the Crows Nest Pass. In Ex. No. 8341 (1) he refers to B.(Blairmore), C(Coleman). In para. 2 he mentions that Ben is to be in the Crows Nest Pass from Friday afternoon till Monday on recruiting drive trip and that POTHORN will be with him. Ben refers to Ben SWANKEY, Prov. leader of the LPP in Alberta. In para. 3 he refers to the situation in M.N. (Michel Natal) and mentions only one of us i.e. Steve with foreign accent. This refers to Stefan (Steve) HARMATNY, Natal, B.C. In Ex. No. 8341 (2) reference is made to Sam and Jim, these being Sam ENGLISH and Jim POLASKI. In para. 3 POTHORN states that "Old George" of course won't go near the classes. This refers to George GASEOFF, Natal, B.C. In para. 4 is another reference to Steve (Steve HARMATNY).

7.- In Ex. No. 8341 (3) he asks DEWHURST to tell Steve that they will have a youth club set up. In the opinion of the writer he is referring to Steve ENDICOTT, formerly of Vancouver, B.C., who has visited Natal-Michel as an N.F.L.Y. organizer. POTHORN ends his letter with a message to Rosaleen (Rosaleen ROSS) of the Prov. officer of the L.P.P.

We need to compare our progress in party building with the plans laid at our Provincial Committee meeting last June. At that time we set ourselves an objective of 111 new members by the end of the year, as follows:

To-date we have achieved 22% of our Provincial objective.

Experience thus far indicates, that wherever recruiting has been looked upon as very important work, where it has been tackled with enthusiasm and consistency, the results have been good.

What has been our main problem and weakness? Not all clubs and leading committees have yet had a serious discussion on party building, but even where a good discussion took place, where a list of prospective members was drawn up and where clubs members were assigned to visit them, a collective check-up was not carried out with the result that not all

prospective recruits were visited and new names were not added to the list. This lack of check-up applies not only to the clubs; it applies even more to the city and regional committees and particularly the provincial secretariat which is in charge of the drive. Lethbridge, which drew up a list of 22 names and saw to it that these people were visited and asked to join, got results- but only because there was a good check-up.

But it would be wrong to regard lack of check-up as only an organizational weakness. It comes from a failure to regard Party Building as a Political Task, a job of primary importance, that can't be put on the shelf because we also have other important tasks.

Side by side with better check-ups in the Clubs and a better appreciation in practice of the importance of Party Building, the "new approach" that Stanley Ryerson calls for also includes an improvement in our independent public work. The present campaign for Tribune subs, and the Public Forums being organized by a number of Clubs, are two examples of good public work that needs to be strengthened.

Each Party Committee and Club should now review its recruiting work, discuss experiences and shortcomings, and draw up definite plans that will ensure the success of the drive in each area and club.

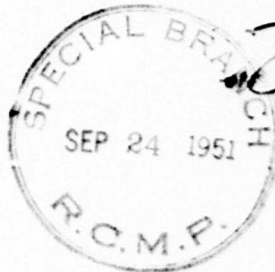
