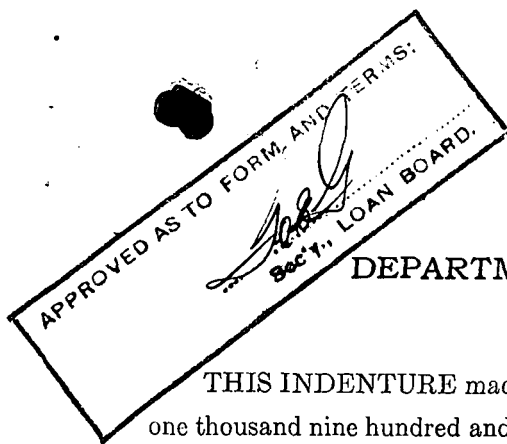

Attached herewith please find copy of letter received from Mr. M. McLeod, In Charge of the Sarcee Indian Agency with reference to the Band Loan approved and made to David Jacobs.

In this case Jacobs offered practically all of his possessions as security for a \$250.00 loan. Included in this security were 8 x 2 year old steers and 4 yearling steers.

It is, therefore, suggested and recommended that as Jacobs has sufficient security to cover the amount of the loan, that the 8 x 2 year old steers and the 4 yearling steers which are saleable as they come of age, be deleted from the mortgage form. It may be added that 3 of these steers were sold this past fall.

May this request be considered, please, and the necessary deletion be authorized.

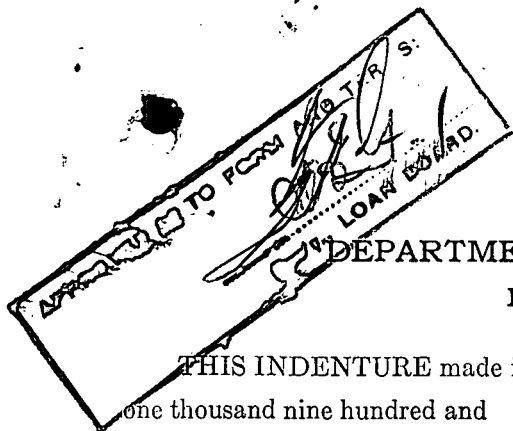

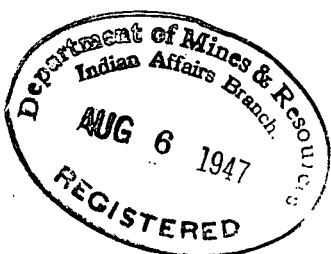

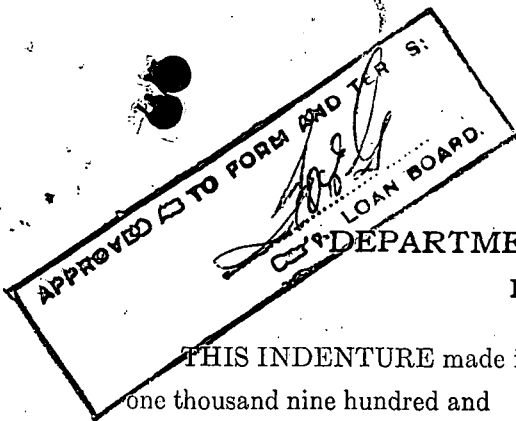

Re: Applications for Band Loans  
Sarcee Indian Reserve

It is desired to submit herewith two sets of applications for loans under the revolving band loan, authorized by the Indian Affairs Branch, date April 14th. last, File No. 161-20-1 (T2).

The writer has had no experience in drawing-up this type of form, but believes that the ground has been fairly well covered. Each application has attached to it, a report as well as a resolution of the Band Council naming individually the applicants for this loan.

It will be noted that all are for the amount of \$250.00 and that the repayment plan as discussed with the Indians concerned and the Council has been set at \$50.00 per applicant, plus 5% interest over a period of 5 years in each case. They have pledged their own individual share of annuity and interest to cover the loan in case of arrears.

It will also be noted in the case of land as security that this has been left blank in as much as there are no location tickets and no established ownership. The recognized form of land holdings as practised in the West is the method by which the Indians are allotted land by mutual arrangement on this reserve.

In the case of chattels, the majority of the buildings as shown on the application forms are band buildings, erected from band funds and therefore cannot be used as security in this instance.


