



DRAFT TUITION AGREEMENT

SECONDARY SCHOOLS ENROLLING CHRISTIAN ISLAND STUDENTS

THIS AGREEMENT made this \_\_\_\_\_ day of \_\_\_\_\_ 19 .

BETWEEN: THE SIMCOE COUNTY BOARD OF EDUCATION  
in the Province of Ontario  
hereinafter called "the Board"

OF THE FIRST PART

AND: HER MAJESTY THE QUEEN, in right of  
Canada hereinafter called  
"Her Majesty"

OF THE SECOND PART

AND WHEREAS pursuant to Section 114(1) of the Indian Act, R.S.C. 1952, Ch. 149, the Minister of Indian Affairs and Northern Development may enter into an agreement with the Board.

AND WHEREAS pursuant to Section 162 of the Education Act 1974, Statutes of Ontario 1974, the Board may enter into an agreement with Her Majesty the Queen respecting the education of Indian children.

NOW, THEREFORE, THIS AGREEMENT WITNESSETH that the parties hereto covenant and agree with each other as follows:-

1. (a) Unless the context otherwise requires, in this agreement "Indian Child" means child of an Indian as defined in the Indian Act (Canada), and includes, subject to Band Council permission to reside on the Reserve:
  - i) non-Indian children of women of former Indian status who return to reserves because of the desertion or death of their husbands, or for other good reasons, either living with their mothers on a reserve or with friends or relatives on a reserve;
  - ii) non-Indian children of Indian mothers, either living with their mothers on a reserve or with friends or relatives on a reserve;
  - iii) non-Indian children whose mother became Indian by marriage and who live on a reserve;
  - iv) non-Indian children legally adopted by Indian families and living on a reserve with the adoptive parents.
- (b) "Band Council" means the Beausoleil Band Council.
- (c) "Tuition Fee" means a per pupil fee paid annually to the Board for each Indian pupil enrolled in secondary schools operated by the Board.
- (d) "Minister" means the Minister of Indian Affairs and Northern Development.
- (e) "Said School" means a Secondary School operated by the Simcoe County Board of Education.
- (f) "Department" means Department of Indian Affairs and Northern Development.
2. HER MAJESTY shall pay to the Board an annual tuition fee for each Indian child and the basic fee shall be calculated as follows:-

.....2

2. (a) For those Indian children attending the secondary schools, the fee shall be determined according to the regulations made under Section 10, subsection 3(e) of the Education Act 1974, Statutes of Ontario 1974, ch. 109, but excluding the pupil accommodation charge thereby provided, for attendance at schools covered by a capital agreement.
- (b) Where negotiations between the parties hereto have resulted in the provision of extra education services for Indian children and where the Board has incurred additional costs to provide such services, Her Majesty shall pay to the Board an amount equal to the additional cost of such services in accordance with the terms and conditions of an addendum to this agreement which shall be entered into prior to the provision of such services.
3. (a) Her Majesty shall pay tuition fees as described in Clause 2 in accordance with provisions of the regulations made under Section 10, subsection 3(e) of the Education Act 1974, Statutes of Ontario 1974, ch. 109, and the financial statement referred to shall be accompanied by a certified list of Indian pupils enrolled in the said school OR any other school in which an Indian child is enrolled by reason of his being placed in a boarding home by the Department of Indian Affairs and Northern Development or the Band Council or any school in which an Indian child is enrolled because the course desired and requested by the pupil and his parents is not offered in the said school.
- (b) The board shall advise the Band Council:
  - i) at the end of each school month of any changes in Indian enrolment;
  - ii) at the end of each school year the graduation results for the Indian pupils.
- (c) The Board agrees to accept for enrolment in its schools, subject to the terms of this Agreement, all Indian pupils promoted or transferred upon the recommendation of the elementary school principal. In addition, the Board agrees to accept other students who wish to re-enrol after a period of absence. All secondary school pupils of Christian Island commuting from Christian Island Indian Reserve shall be enrolled in Midland Secondary School subject to Section 3(a).
4. In an instance where in order to provide for the enrolment of Indian children in any school administered by the Board, it is necessary to construct new facilities, expand existing facilities or carry out major renovations, the title to the building(s) being vested in the Board, Her Majesty will enter into a separate agreement for the sharing on a pro rata basis of the capital expenditures arising therefrom provided that the Council of the Christian Island Indian Band pass a Band Council Resolution indicating the Band's concurrence and the official representative of the Band sign the statement of concurrence attached to the agreement.
5. (a) The Board shall provide education facilities and programs of education suited to the cultural needs of Indian pupils enrolled in its school including the provisions in this tuition agreement.
- (b) The Board and the Band Council agree to encourage maximum feasible interaction between the said school and the Indian community. The Board will make every effort to involve the Indian community in school affairs and will welcome the active participation of Indian parents in the education of their children.
- (c) The Board and its employees will give Indian parents a fair hearing in all matters concerning the education of their children.

6. (a) The Board shall continue its practice of appointing an Indian representative to the Board of Education as a trustee with full voting power.
- (b) The Band Council and the Board agree on the following procedures regarding this Indian representation on the Board:
- i) For each term of office of the Simcoe County Board of Education two representatives shall be elected or appointed (one from the Chippewas of Rama Band and one from the Beausoleil Band).
  - ii) During any one term of office of the Simcoe County Board of Education one of the two representatives shall serve as a member of the Board. For the first term under this Agreement, this representative will be selected by chance.
  - iii) For the first term under this Agreement, the second representative shall act as a liaison officer between the Simcoe County Board and its officials. The liaison officer shall attend all open Board meetings, shall receive all mailings directed to Board members and shall be paid by Her Majesty at a rate equivalent to that paid by the Board to its members. (Section 202 of the Education Act 1974, Statutes of Ontario 1974, to be applicable to the attendance of the liaison officer at Board meetings.)
  - iv) During the second term of office of the Simcoe County Board of Education under this Agreement, the second representative or his replacement shall serve as a member of the Board and the first representative of his replacement (mentioned in (ii) above) will become the liaison officer.
  - v) In accordance with the above arrangement, each of the two representatives, as elected or appointed, shall be accepted by the Board for alternate terms as trustee and liaison officer.
  - vi) Any renegotiation of this Tuition Agreement shall be made only with due regard to the principle that each of the two Band Councils should have equal time of representation on the Simcoe County Board of Education.
- (c) The Board shall send a copy of the minutes of all its Board meetings within ten (10) days of approval by the Board to Beausoleil Band Council, Christian Island, Ontario.
7. (a) The Board agrees to make every effort to recruit Indian teachers in filling future vacancies on the staff of the said school, provided that the qualifications and ability are judged to be equal to other applicants.
- (b) The Board agrees to make every effort to recruit members of the Beausoleil Indian Band in filling future vacancies on the administrative, maintenance and custodial staff of the Simcoe County Board of Education, subject to existing union agreements. Every effort will be made to utilize the Department's Training-on-the Job Plan for this purpose.
- (c) The Board will encourage its teachers who are involved with the Indian children to enrol in Indian studies programs (appropriate University and Ministry of Education courses).
8. The residents of the Indian community shall be accorded equal rights for after-school use of school buildings in which Indian children are enrolled to those accorded residents of the relevant non-Indian communities according to Board policy.

.....

- 9. (a) i) This agreement does not confer on Her Majesty or the Band Council any right of direct supervision over the curriculum, the administration, the teaching personnel, the method or materials of instruction or management generally of the relevant Simcoe County Schools provided that the members of the Band Council and its Education Committee and Her Majesty and any person authorized by Her Majesty shall have the right to visit the schools from time to time according to the appropriate education act.
- ii) Nothing in this agreement precludes the right of Indian parents to exercise an interest in the educational matters of the schools attended by their children.
- (b) The Board shall ensure that there will be no segregation by reason of race or colour in schools enrolling Indian children.
- (c) Education officials representing Her Majesty and the Band Council may with the knowledge and approval of the Board, assist in planning, developing or improving an educational program culturally suited to the needs of Indian children.
- 10. All notices or communications required to be given or sent under the terms of this Agreement shall be deemed to sufficiently given or sent if mailed or sent by telegram to the recipient party.

THIS AGREEMENT SHALL come into force on \_\_\_\_\_, and shall remain in force from year to year unless:

- (a) renegotiation is requested by any of the parties hereto in which case such request must be made by February 1st of the then current school year and the renegotiation must be completed by May 1st of the then current school year.
- (b) termination is requested by either party hereto. Either party may terminate this Agreement at the end of any school year by giving written notice of termination to other party at least twelve months before the day of termination.
- (c) cancellation or termination of this Agreement will automatically cancel or terminate any related capital Agreement referred to in Section 4 of this Agreement.

Thank you for your September 30th, 1977 letter in response to our September 15th letter regarding guaranteed basic tuition payments for Indian pupils. May we now refer to certain comments raised in your letter.

You indicate your appreciation of a board's reluctance to arrange for services under an agreement when an inaccurate estimate of enrolment is given. We find this statement difficult to relate to, as far as, normal situations are concerned. Indian students are normally enrolled in the various grades in a school board's system. These students and their movement through the grades places the board's staff in an informed position on enrolments for succeeding years. I am sure you are also aware that high schools through direct registration with feeder elementary schools have first hand knowledge of feeder elementary schools operated by our department.

You have also indicated that guaranteed amounts are paid to Boards for special programs. These programs are for special student native language or native studies programs provided totally at the expense of the department because very few boards contribute or obtain financial assistance from the Ministry for special courses provided only for Indian students. These services are not, however, involved in the basic tuition costs. As mentioned in our earlier letter, none of our tuition agreements for the basic per pupil tuition costs, on services available to all students in the system, carry guaranteed enrolments. Our billings and agreements with every other school board are calculated on the enrolment on the specified dates in your regulations to cover Calculation of Fees and Calculation of Average Daily Enrolments.

Dear Walter:

Thank you for your September 15th letter concerning the agreements with school boards with respect to tuition for Indian pupils.

The principle underlying the financing of school boards and the grants formula is that the level of local taxation be related to the level of per pupil expenditure by the board. Boards are expected to accurately determine average daily enrolment and arrange staffing and services accordingly. If a board over-estimates its enrolment, the result is a higher per pupil cost, loss of general legislative grants and consequently, an addition to the mill rate. The matter is of specific concern to boards at a time when they are experiencing declining enrolment. Notwithstanding the difficulty of correctly estimating enrolment, I have no hesitation in defending the position that the boards should be responsible for correctly determining their levels of services, and failing to do so, are responsible for the resulting effect on local taxes.

The situation is somewhat different for arrangements that are made with respect to pupils for whom the local ratepayers have no direct responsibility. I can appreciate a board's reluctance to arrange for services under an agreement when an inaccurate estimate of enrolment related to the agreement would increase local mill rates.

I have been advised that agreements have been made with the Department of Indian and Northern Affairs which, in effect, stand behind the number of pupils involved through use of the provisions of the Calculation of Fees Regulations that apply to high cost programs. In essence, where special education programs are involved, the agreements have ensured that services put in place under the agreement are paid for, notwithstanding enrolment variations.

If interpretation is such that agreements cannot be made which prevent errors of projections of enrolment under agreements from having a detrimental effect on local taxes, I would be sympathetic to an amendment to our Regulations to clarify the matter.

I feel the present situation with respect to declining enrolment at both the elementary and secondary levels provides even more of an opportunity for co-operation and agreement which should not be hampered by misplaced responsibility with respect to enrolment projection.

Over the past several months, our district office in Fort Frances, along with several Bands in the area, have been attempting to reach agreement on a general tuition agreement with the Fort Frances-Rainy River Board of Education.

Our department has entered into many tuition agreements with provincial school boards across Ontario. All these agreements state the boards' authority as Section 162 (1), (2), (3) of the Education Act 1974, and stipulate that fees shall be calculated in accordance with the regulations. The regulations to cover Calculation of Fees and Calculation of Average Daily Enrolment are, in our opinion, contained under Ontario Regulations 864/76 and 863/76, respectively. In all our agreements for basic tuition, it is established that tuition billings will be based upon enrolments at the three specified times of the year, multiplied by the applicable per pupil rate.

The discussions with the Fort Frances-Rainy River Board of Education have been long and difficult because of the board's insistence upon a guaranteed enrolment. The first draft proposal was rejected by this office and the Bands because of the following clause:

"2(a)(iii). For tuition purposes, the minimum number of pupils enrolled in the schools operated by the Board shall be that number of pupils enrolled on September 30th of a school year."

Discussions with the Board have continued since we rejected the first draft. As a result of these discussions, the Director of Education, Mr. A.J. Gillies, has written a letter to our District Superintendent of Education proposing the full guarantee be reduced to an 85% guarantee. We have no recourse but to again reject such a clause.

THERE MAY BE SPECIAL CASES WHERE UNUSUALLY LONG DISTANCES TRAVELLED BY THE INDIAN REPRESENTATIVE OR A SECOND REPRESENTATIVE OR OBSERVER COULD BE CONSIDERED A JUSTIFIABLE CHARGE TO THE DEPARTMENT IF THE BOARD HAS NOT ACCEPTED THE SHARING OF THIS CHARGE. PLEASE ENSURE THIS INFORMATION IS MADE AVAILABLE TO BRANTFORD EDUCATION OFFICE AND SERVICE OFFICES.







## Evaluation of Indian Studies Program at McArthur High School

(August 1973 - June 1975)

This project evaluates the effectiveness of Indian Studies Program at McArthur High School. In 1973 the Ontario Regional Office provided funds to McArthur High School to develop an Indian Studies Program including crafts and recreation. Additional funds were also made available to institute an orientation program for Indian Students commencing studies in Ottawa Public/High Schools.

### Introduction:

The idea of an Indian Studies Program for Native Students commencing education for the first time in Ottawa high schools originated with some concerned individuals. This concern was especially voiced by the staff of McArthur High School who had an intense desire to fulfill a "deep seeded void" in high schools in Ottawa and in particular at McArthur High School. It was felt that Indian Students in Ottawa not only had to face the emotional and psychological traumas of separation from their homes and communities, but also the problems associated with making an adjustment to a style of life involving different attitudes and values.

In addition, the staff learned that the school system in Ottawa failed to provide direction and guidance in teaching students from a different culture. They took it upon themselves to make a concerted search for "answers and solutions" and contacted various individuals, groups organizations and government departments. In their search they became aware of the following:

1. That no one person or department speaks for all Indians about their way of life, and that there are as many differences as there are Indian Tribes, and any generalization would be unfair.
2. That everyone is unique, and it is wrong to attempt to integrate all cultures and make them all alike. Where Indians are concerned, the "melting pot" concept should not apply.

3. That because Indians come from different geographic areas where the environment and ecology have unique impact on their style of life, Indian self-perception differs from one area to another.
4. That Indian history does not begin with the arrival of Europeans, but goes far beyond it in terms of its own history, tradition and roots.
5. That the Indian Interpretation of the universe and philosophy of life differs from that of the whites, although a certain degree of duality has been accommodated, particularly through the influence of Christianity.
6. That Educators must have an awareness of the major socio-cultural differences and apply that understanding to the educational process.
7. That a culture influences what an individual learns and how he behaves, and also influences how rapport, communication and educational approaches are established.
8. That staff as a whole form strong bonds with Indian students and therefore must be consistent in what they say and do as teachers.
9. That culture influences value orientation.

Because of this awareness, the staff at McArthur High School approached the Indian Counselling Unit for approval and funding to develop an Indian Studies Program and other related activities.

#### Indian Studies Program:

The Indian Studies Program designed by the McArthur High School was divided into the following three main categories.

1. Orientation
  - a) First Orientation Camp - 1973
  - b) Second Orientation Camp - 1974
2. Indian Studies Instruction
3. Recreation

1. Orientation Program

The main purpose of the orientation program was to introduce Indian students from Northern Reserves of Ontario and Quebec to urban living so that students can be comfortable in the City of Ottawa.

(a) First Orientation Camp 1973

The first orientation program was a joint venture of the OFY and the Indian Counselling Unit. The first 8 weeks were to be spent on research and camp planning, one week for staff orientation at the campsite and the last two weeks for actual orientation to the city in which 40 Indian Boys (students) from Northern Indian Reserves would be involved. The main objectives of the orientation camp were to ease cultural shock and provide the basis for a good school program so that a decrease in the drop-out rate among Indian Students might be achieved.

(A) Selection

This program was intended for those students from Northern Ontario and Quebec who were required to enroll at the McArthur High School for the school year 1973-74.

(B) Orientation activities

- i) Lectures, seminars and discussions
- ii) Films
- iii) Field trips
- iv) Sports, campfires and related activities

(C) Administration

Mr. Ed Fiddler, an Indian High School Student was appointed Camp Director. The other appointments included Mr. Paul Brown, McArthur High School teacher as Camp Adviser and his wife as Assistant Camp Adviser. Some Indian High School students were placed in positions of Counsellors.

b) Second Orientation Camp 1974

The second orientation camp was a week long program held in 1974 from August 26 to August 30. The objectives and the program content for this camp were similar to that of the first camp conducted in 1973. The selection criteria however, differed in that all Indian students intending to enroll in high schools in Ottawa schools were included. Although students for other high schools were involved, the program remained a joint venture of McArthur High and the Indian Counselling Unit. Ten Indian Students took part in this program.

Observations and Evaluation

1. The camp was better organized than the previous one.
2. The participating students were not required to enrol in McArthur High School. It should be mentioned that McArthur High school provides both educational and vocational facilities to slow learners.
3. The camp facilities were designed to accommodate at least 20 students but only 10 students took advantage of this program.

In summary, both orientation programs offered potentially good opportunities for Indian students to orient themselves to city living. But the program was hampered by poor enrolment and insufficient preparations on the part of the campers.

Indian Studies Program

Main Objective: To decrease the drop-out rate by making Indian students feel more at home in the High School environment in Ottawa.

Sub Objectives:

- 1) To bring about a greater understanding of the young native students' awareness of his history and culture.
- 2) To prepare students make the adjustment from a rural to an urban way of life within the framework of their own value system.

- 7 -

The James Bay forum was to provide the meeting place where students could engage themselves on matters that are vital to them.

3. Indian Origin

This part was to trace the history of the origin of Indians and to introduce native students to the history of Indian - White relationship from 16th century until recent developments. The emphasis was to be on political and economic relations.

4. Indian Cultural Evolution

This included a study of specific tribal groups and their evolution in terms of their culture and social institutions.

5. Indian Contributions to White Society

This part of the curriculum was to bring about an awareness and appreciation of Indian cultural gifts to white Canadian society in the matter of food, arts and crafts, transportation, recreation, military tactics, medicine, communication, language, shelter and personalities.

In addition to the above-mentioned there was instruction given in conversational and written Cree by a University student, Clarence Tomatuk. His language instructions made up part of the cultural education program, instructions on how to survive in White Society was also a part of the Indian studies program.

The whole curriculum of the Indian studies Program was designated as a Social studies course, and taught one hour per day. To facilitate learnings, students were divided in pairs or groups of three during home room period and shop periods. The social studies period was the only period during the day where they all met as a group. This served as a meeting place to discuss immediate problems and to achieve immediate goals. The shop options opened to the native students varied from one term to the next. Each teacher made a special effort to individualize their programs to meet the special needs of the native students as well as endeavouring to students face and compete in an urban society.

9. McArthur High School was selected for offering Indian Studies Program without any evidence of high native enrolment at that school.

3. Recreation Program

Objective

To provide opportunities for Indian students to get together in order to re-inforce their identity, besides developing physical, social and cultural aspect of their lives.

The Program

Every Thursday night Indian students attending high schools in Ottawa met at McArthur High School for taking part in sports and other recreational activities.

Observations and Evaluations

1. Initially some students made use of the program, but gradually the interest declined.
2. The program helped to create better understanding among students.
3. The Counselling Unit failed to acquaint students attending other high schools in Ottawa with the program, therefore the facilities at McArthur High remained underused.
4. McArthur High School was not centrally located, therefore it was not convenient for most students to participate on a regular basis.

Recommendations

Orientation Program

There is a definite need for an orientation program for Indian students coming to Ottawa for the first time to pursue their high school studies. However, certain fundamental changes are required, both in terms of format, content, and administration. The following suggestions are therefore offered.

...10

1. The Indian Counselling Unit should contact all the school boards in Ottawa as well as private educational institutions, in order to obtain their interest in introducing Indian Studies Program in their school curricula.
2. High School students should be contacted for ideas, suggestions, and recommendations in term of developing the curriculum.
3. The Ottawa Board of Education has included a native studies course as one of the units in its first year History program. This particular program holds promise for a good beginning, but the fact remains that a number of concerns should be examined by the Indian Counselling Unit, such as:
  - a) It is very important that an Indian teacher be involved in teaching courses having to do with Indian culture and values. In the event that such a course is taught by a non-Indian, the Ottawa Board of Education should be impressed upon to seek a qualified Indian teacher. As a matter of principle, non-Indians should never, never, attempt to teach an Indian child what it means to be an Indian.
  - b) The Indian student should not be made a target for microscopic examination by the teacher and the class.
  - c) There should be several professional development days set aside for discussion, suggestions and talks on this topic.
4. There should be a training program set for the teachers who are teaching this course.
5. The Indian Counselling Unit should be fully involved in setting up the program and evaluating it on a continuing basis.

#### Recreation Program

Currently the Indian Counselling Unit in co-operation with the Indian Friendship Centre is involved in providing various recreational and sports activities to High School students. On termination of the current school year, the effectiveness of the program be evaluated in order to develop a new program for the next school year. In any evaluation and development







It has become a custom in all branches of this program to have requisitions prepared with the request that the cheque be returned to the responsibility centre. This is contrary to good internal control and will result in adverse comments at the time of an audit.

While it is known that cheques are received sooner when they are returned to the department we must insist that they be forwarded direct to the payee except in unusual circumstances; e.g. when the Deputy Minister or Assistant Deputy Minister require special instructions to be included with the cheque.

Many branches forward a covering letter with the cheque. It is recommended that this procedure be changed and a letter be forwarded informing the payee that a cheque is forthcoming.

Requisitions without a mailing address will be returned to the responsibility centre except when there are unusual circumstances. Please inform your staff.
