Introduction

INTRODUCTION

Presented herewith are the budget estimates for the Belgian Division for 1964.

ACTIVITY FORECAST

Data of the estimated activity of the Division in 1964 are given in the diagrams at Annexes C and D, together with the corresponding details for previous years. The variations compared with 1963 can be summarised as follows :

- Stocks	: No change
- Inputs	: + 12 %
- Movements	: + 7 %
- Deliveries to airfields	: + 6 %
- Deliveries to trucks, rail cars and national depot	: + 12 %

However, as the result of the contract for the civil use of the Antwerp-Pernis section authorised by the Committees in 1963, movements may be further increased by approximately 5,5 %.

ORGANISATION AND ESTABLISHMENT

Despite the greater activity in 1964, the organisation and establishment of the division remain unchanged.

As in previous years, all legal matters as well as the pay-roll and execution of payments are dealt with by the Ministry of Defence, Brussels. No personnel for these tasks are therefore included in the establishment of the division, the respective costs being covered by the appropriation requested for "Administrative Services" (cf Item 09-7) which is unchanged.

The expenses recommended in these budget proposals exclude all those covering the training of personnel for wartime.

OPERATIONAL EXPENSES

The operational expenses for 1964 amount to :

B.Fr. 38.094.000 against B.Fr. 36.917.000

approved for 1963, representing an increase of approximately 3,2 %. This increase is due chiefly to higher expenditure in the following chapters :

(i) Chapter 01 - Personnel

Increase due to the revalorisation of military salaries.

Increase due to the rise in activity and concerns

1. consumption of fuel

2. consumption of electricity, all installations being now connected to the civilian electricity supply.

This shows that the increase in power requirements is only partly absorbed by the utilisation of electric power.

CAPITAL EXPENSES

The total capital expenses recommended for 1964 amount to :

B.Fr. 1.337.000 of which

(i) B.Fr. 1.066.000 are justified by operational necessity. They include the usual standardised provisions covering minor modifications and the procurement of minor items of equipment that may be required during the year and to which the procedure laid down in AC/120-D/108 applies. Mention must also be made of the fitting up of a permanent laboratory at the divisional head office to replace the truck-mounted mobile laboratory which should be returned to the Belgian Army in 1964.

(ii) B.Fr. 218.000 are justified by an increase in operational efficiency. B.Fr. 200.000 of this appropriation are required for the procurement of a diesel engine injection pump test bench.

(iii) B.Fr. 53.000 are required for the replacement of minor laboratory and detection equipment.

The following items have been shown "pro memoria" (p.m.) in these proposals :

- 07-1-2 Pipeline repairs (replacement of pipes at the Chièvres depot)
- 09-9 Various other general expenses
- 12-1 Modifications to depots (installation of 3 loading arm meters).

RECEIPTS

No amount is shown in Part IV of the budget proposals. Receipts arising from sales of scrap and slop oils being negligible, they have been shown "p.m.".

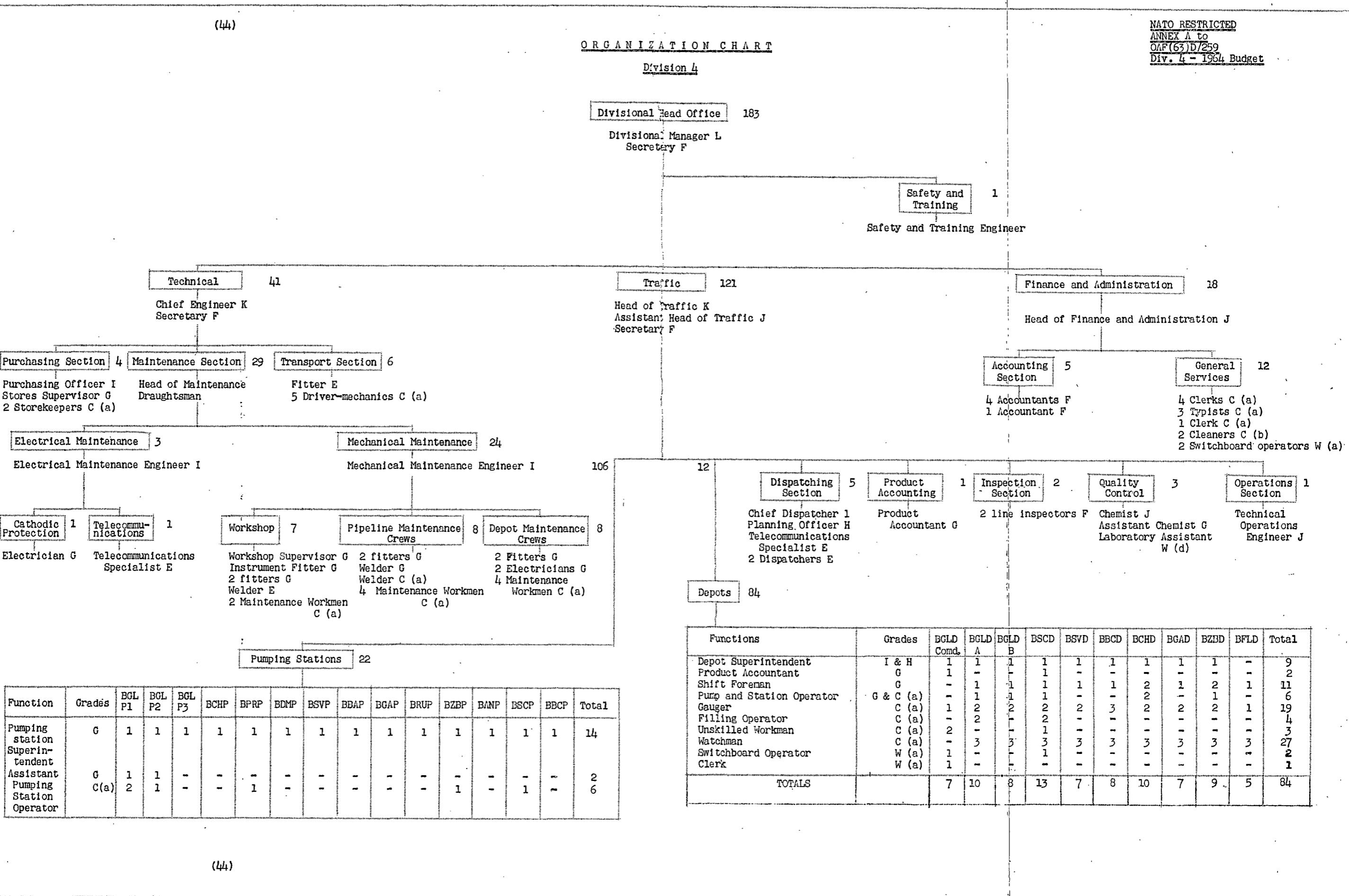

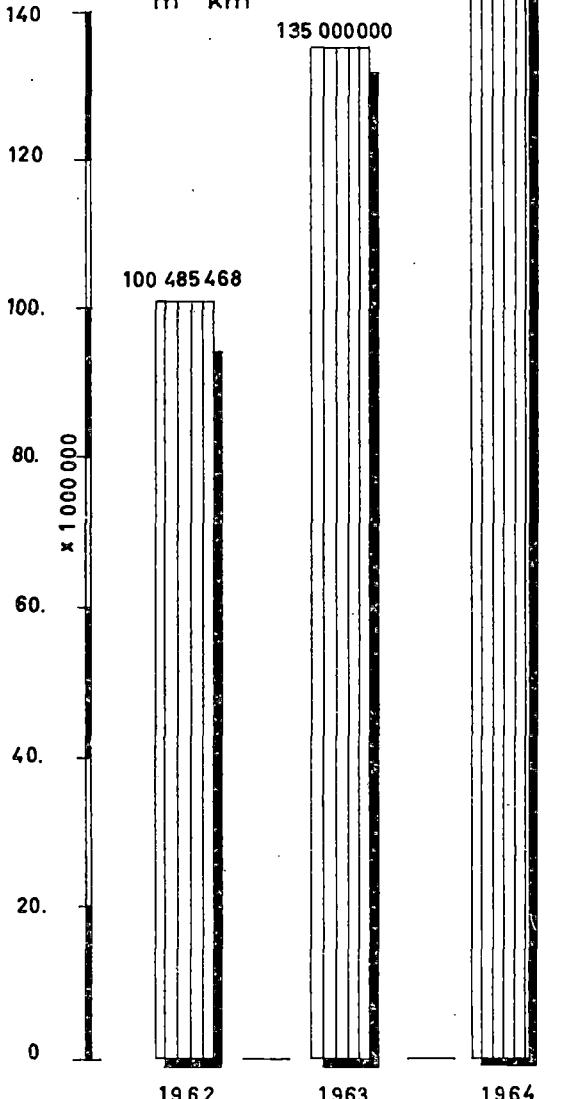
