MEMORANDUM FOR MR. DAVIS

Demise of the Crown

See the attached exchange of correspondence with Esmond Butler. I do not know whether the previous document would be with you or whether it is on a general file. In any event, would you please seek it out and make appropriate arrangements for its destruction.

Looking through this document has raised in my mind again the question of the form in which we are casing our procedural material.

This particular item is, of course, a very complex one procedurally. A lot of agencies and people become involved with a lot of different steps. The format we are proposing is quite different from the British one. On a thing like this, will it be equally clear? Does this document suggest any modification at all in the line of approach we are taking?

I do not raise the above questions because of any specific doubts but simply because now is the time that we must be sure that we get the form right. Once it is set, it is going to be awfully hard to modify or change.
