When the application of Tom Hong Wong has been properly completed, if you will forward it to this office along with the other documents required, we will be prepared to give it further consideration.

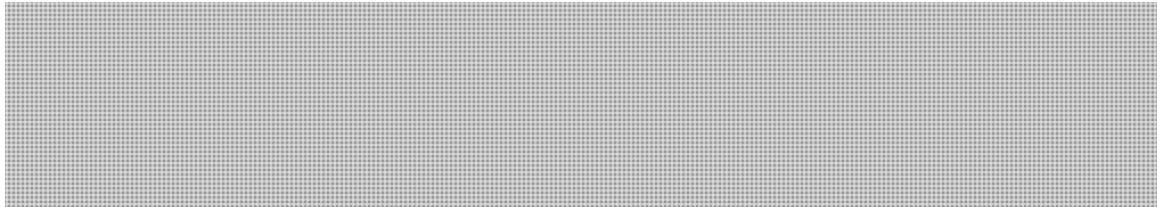

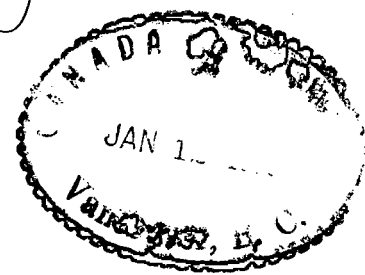
