During October, 1957, an examination of the water supply serving the Deseronto Indian Day School was carried out by this office to ascertain the bacteriological quality of the supply, and to recommend procedures by which the heavy concentrations of hydrogen sulphide in the water could be removed.

The source of supply is a sealed drilled well, 154 ft. deep, from which water is pumped to two 200 gallon pressure tanks. Approximately 100 students and teachers are served by this supply.

Following the survey, it was recommended that this supply be super-chlorinated and filtered by means of activated carbon filters to

- (1) Oxidise and remove the heavy concentrations of  $H_2S$
- (2) Disinfect the supply which was found to be contaminated.

Subsequently, equipment manufactured by Culligan was installed consisting of an electrically operated hypochlorinator and two activated carbon filters. The rate of feed of the hypochlorinator is adjustable and injects chlorine solution at the discharge side of the pump before the pressure tanks. The filters are placed on the line in parallel after the pressure tanks. Each filter has a flow rate of 3.5 gpm and a backwash rate of 1.75 gpm. They are backwashed once a week.

On November 17 and 18, 1957, visits were made to this school by Messrs. W. S. Tait and T. J. Busk to carry out certain analytical

procedures by which the efficiency of the equipment treating the supply could be evaluated. It was noted at the time that the odour of hydrogen sulphide could not be detected anywhere in the school.

The hypochlorinator was set for a dosage rate of 41 gallons per 24 hours. Since this unit is synchronized with the pump, it operates only when the pump is also in operation. The actual dosage is approximately 20 gallons of chlorine solution per week. One Imperial gallon of Javex (7% available chlorine) to 19 gallons of water is the strength of the solution used.

Determinations carried out during this survey are as follows

- (1) Ca and Mg Hardness as  $\text{CaCO}_3$  - p.p.m.
- (2) Total Sulphides as S - p.p.m.
- (3) pH
- (4) Residual Chlorine - p.p.m.
- (5) Total Coliform count - M.P.N.

Eight samples each of the raw and filtered supplies were examined during November 17 - 18th as noted. In the case of chlorine residuals, chlorinated samples from the pressure tanks and filtered samples from the drinking water fountains were compared. The results are noted in Tables #1 and #2 hereunder -

Conclusions

The results indicate that the equipment used is doing a satisfactory job in maintaining water of good quality. Both coliforms and sulphides are absent from the finished supply. Hardness is high and remains unchanged by the treatment as would be expected. PH is also relatively unaffected and reflects the alkaline condition of the supply.

Chlorine residuals are in the 1 - 1.5 ppm range except for those samples taken in the early morning which show lower results. Low water demand during the night would encourage volatilization of chlorine during this period.

The residuals indicate a satisfactory degree of chlorination. Higher residuals are not recommended as filter life would be shortened and cost of treatment increased. Although the concentration of sulphide in the raw supply appeared fairly uniform, it is understood that heavier concentrations of H<sub>2</sub>S are experienced in the Spring. Stronger chlorine solutions are then used with the same dosage rate.

The well seems to be subject to a sporadic type of contamination. Good samples were obtained from the raw supply on November 17, while all samples taken on November 18 indicated water of "dangerous" quality.


Repairs to Deseronto Clinic Building



Your recent verbal advice to Dr. Wiebe of the trouble which has developed about having the new accommodation in the Post Office accepted by the Department of Public Works, and the possibility that some considerable delay may ensue before we are able to move in, has some significance insofar as the decision to hold in abeyance the needed repairs to the present Clinic Building. In this connection we enclose for your information, and for the information of Dr. Boyce, a copy of a memorandum we have today addressed to our Director suggesting that the matter of when these repairs are to be carried out, should be reviewed in the light of the above information.

Dr. Boyce should not worry about his tenancy of the present building, as no decision has yet been made as to its future use, and none will be, until the Clinic operations are being conducted from the new accommodation at the Post Office, following which the future of the Clinic Building will undoubtedly have to be referred to the Director for his consideration and decision.

We shall appreciate your keeping us posted as to any developments arising out of the new quarters, and when we may expect to occupy these.

With reference to our memorandum to you dated August 18th and your above noted reply, Mr. Cassie the Indian Superintendent at Tyendingaga recently telephoned and advised us that the new accommodation being provided for our Clinic in the Post Office at Deseronto would not apparently be ready for occupancy by Dr. Boyce and our Nurse for an uncertain time, as DFW have refused to approve the work done for various deficiencies as to quality. It seems likely that legal proceedings will ensue and that this will delay the removal of our operations from the present building.

In view of this development, it is suggested that the question of whether to continue to hold the matter of repairs to the present building in abeyance should be reviewed. If as could be the case, we have to use the present building through another Winter, then it would seem logical to carry out these repairs as indicated in the Invitation to Tender which is attached for your ready reference, regardless of whether a decision is eventually reached to sell the building once our operations are removed to the new quarters, whenever these are available.



Attached is a self explanatory memorandum dated August 8th. from Mr. Cassie, enclosing two tenders from local contractors for indicated repairs and painting to the above building.

In this connection we would comment as follows:-

1. Some repairs to the building are necessary although as Mr. B. White during his inspection of the property last winter indicated verbally to us, these could well be left until this summer and a final decision arrived at in the light of what future use the Department might have for the building in question.
2. The new office and clinic space in the Post Office is nearly ready for occupancy following which we can see no use for the present building except as sleeping accommodation for Dr. Boyce, which of course would hardly warrant our retaining the building for that purpose alone.
3. Dr. Boyce is currently on sick leave and there is some doubt as to just when and if he will return to duty.
4. In any event on his return the new clinic and office space should be ready for occupancy which brings up the question of what is to be done with the present building. We can see no need for it in our operations at Deseronto and our recommendation would be that it be sold.

May the attached tenders be considered in the light of the above remarks and a decision made as to whether the repairs should be carried out or arrangements made to dispose of the building "as is".

- (a) GARAGE:
  - (1) re hang front doors
  - (2) replace flooring planks as required.
  - (3) scrape and repaint whole building.
- (b) SIDE VERANDA (1) shore up posts and set same in cement
- (c) Front Walk: about 20 feet to replace along with three steps.
- (d) FRONT VERANDAH:  
Replace sills on cement piers, jack verandah back into position.

Re: Wells, on Tyendinaga Indian Reserve

Attached hereto please find a report constructed by Dr. Boyce and Nurse McAlpine, concerning the wells on Tyendinaga Indian Reserve. The information contained therein indicates that wells here are generally in a very poor state, both as to purity, and as to construction.

Dealing with the pollution necessitates structural modifications to have any permanent effect. I therefore suggest that a programme be authorized whereby each of the polluted wells be cleaned up and provided with a suitable cover at least.

The programme would consist of:

Firstly: having the wells pumped out and disinfected until they test pure, or until it is evident that they can not be cleaned up, and

Secondly: constructing suitable covers of cement for the wells and replacing the present covers with this improved design, and -

Thirdly: in some cases, inserting a water tight casing of cement tile, or steel pipe into the present holes.

A portable gas pump is available for rent in this district, so the wells could be quickly emptied of water. It would be possible to construct a number of "standard" well covers in one location, and transport them to the various wells. This could be accomplished over the winter months, or early spring when labour is plentiful. Cement tile, and steel pipe is available through trade channels.

The cost of such an undertaking is most difficult to estimate. Also I am not sure how the Department of Indian Affairs or the Department of National Health and Welfare should share the expense. Your comments in this regard are awaited, as well as any advice you would care to offer on the feasibility of trying to improve the quality of the water supply on Tyendinaga Indian Reserve.

At request of Mr Cassie Indian Agent, Homemakers' Club and few individuals of Tyendinaga Reserve we undertook the tedious task of making a survey and testing of the wells of the Reserve. To date we have completed about 80% of the wells.

Of eighty-eight wells tested only thriteen were "A". All the others with the exception of one were Grade 3, one was Grade 2.

This shows these wells to be polluted with bacteria of intestinal origin. Most of the wells have very poor if any coverings, of nature to keep out any surface drainage.

We found sticks, boards and other material floating in many. In one was a dead cat.

Those that had cement tops ~~were~~ found were not of the proper structure to keep out any washings or drainage. One alarming feature was the flimsy and weakened structures of these tops, we really were afraid to step on them ourselves. It is a surprise to me that some person or animal has not fallen into many of these wells.

From this report we would advise that action be taken at once if possible to clean thses wells out and new tops of proper construction be done.

If nothing is done this survey so far has been useless, and at some time may be caus of outbreak of typhoid fever or some serious throat etc. conditions.




Enclosed please find tenders re repairs for the above noted building, received from the R.Sexsmith Construction Co. and L.E. Gordanier.

Dr. H.A.Boyce arrived at this Agency on October 21st, 1952, and commenced his duties as Medical Attendant. As accommodation is not available to him in the Department of National Health and Welfare house, he has made temporary arrangements to room in town. This is not altogether satisfactory, but is the best we can arrange for the present.

I have instructed the nurse to make available to him the National Health and Welfare Vehicle. This will possibly solve the transportation problem for the doctor, who does not wish to drive his own vehicle on the reserve under the present mileage rate of 9¢ per mile.

I did take Dr. Boyce around the reserve and visited several of the schools and some of the Indians. He seemed to be well received, by them and we anticipate that he will settle in satisfactorily, barring outsiders influencing the attitude of the Indians.



I have this day put two Indians to work on the grounds, cleaning up the leaves, digging the flower beds, cutting the grass, etc. I have engaged two tree trimmers to cut down part of the tree which overhangs the house and garage, and will be engaging a woman to clean the office. Your concurrence in these actions is requested in order than an authority may be quoted on the Vouchers for payment.

Mr Willoughby Jr, present occupant, is not the least bit agreeable to having workmen enter the house during his tenancy. Would you please advise if you still want me to have the workment enter to effect repairs, or if you would rather we waited until the house is vacant. I am not prepared to recommend all that the house should have done to it, but I do know that the office, the kitchen, bathroom and back hall should all be redecorated. The furnace should be cleaned and the bathroom drain cleaned and possibly some back venting done on the upstairs plumbing. I believe that Dr. Boyce concurs with all these repairs, and he will probably have a few more he wants done.

It also occurs to me that if he is to use the Department's vehicle, it may be necessary to add a foot or two to the garage, which would be relatively easy, in view of its form and construction.
