2. It is understood that before despatching the wife of a Canadian soldier to Canada a check is made with the C.P.M. and the Officer i/c Records to ensure that the woman is the recognised wife of the soldier concerned. There is a list of bigamous marriages kept by this branch, but there is no case in this list of which the C.P.M. is not also aware. A few cases may not be brought to the attention of the C.P.M., but in such cases no Dependents Allowance is in payment to the bigamous wife. Accordingly a check of the list kept by this branch would not be an added safeguard. Because of the adequacy of your present arrangements, therefore, it is suggested that the information asked for by N.D.H.Q. is in fact superfluous and would not justify the considerable work involved in preparing and maintaining a list in the manner suggested by N.D.H.Q.
3. May this matter be referred back to N.D.H.Q. please and advice received in due course whether, in view of the above, any further action is required.

MEMORANDUM

To: D.A.G.

Discipline - Bigamy.

1. Reference folios 121 and 126.

2. I have examined carefully the two folios above mentioned with a view to determine what action we should now take and how it should be taken. With reference to the N.D.H.Q. letter, there are some preliminary comments:-

- (a) Para 2: N.D.H.Q. has expressed the view that it is not our duty to bring to the attention of the civil authorities cases of bigamy, but you have indicated that you feel that there is a duty where it is reasonably clear that an offence against the civil law has been committed. I agree with your view and have planned our future procedure accordingly.
- (b) Para 6: The type of case in which a fraud is perpetrated on the D.A.B. is, I think, not likely to be prevalent in the U.K. to the same extent that it may be prevalent in Canada. However, there may be cases where D.A. is in payment to a "bigamous" wife who is in the U.K. While it is difficult to prove bigamy, I consider that it is even more difficult to prove the wilful perpetration of a fraud on the D.A.B. I have allowed for this type of prosecution in the procedure outlined below.
- (c) Officers: The N.D.H.Q. letter refers to "all ranks" (para 1), "personnel" (para 3), "officer or other rank" (para 3). However, I still maintain my original view that there is little excuse for the offence of bigamy by an officer and all cases coming to our attention should be prosecuted by G.C.M. after reference to the civil authorities.

3. With regard to the taking of action upon a charge of bigamy and for purposes of consolidating in this memorandum as much of the whole picture as possible, I draw to your attention the requirements of proof. They are:-

- (a) The First Marriage: This requires production of the original attestation paper, expert evidence of the law of the Province where the first marriage took place, certificate of the first marriage and expert evidence of the validity of the first marriage and that the marriage certificate is proof of the contents stated therein.
- (b) Identity: This is proved by production of suitable original pay documents bearing the signature of the accused. They also usually contain an admission that the accused was married. There is also produced an acquittance roll or some other document signed by the accused in the presence of the witness producing it.

- 2 -

- (c) The Second Marriage: This is proved by the production of the certificate of the second marriage. It proves itself but should be produced by one of the witnesses to the second marriage who could identify the accused.
- (d) First wife alive at time of second marriage: This is a difficult point and the weak link in any prosecution.

4. There is no presumption of the continuance of life in a criminal trial for bigamy. There is a presumption that the accused is innocent until proven guilty and this negates any possible presumption of the continuance of life. This fact, therefore, must be proved as a fact and the only safe method to prove it is to take commission evidence in Canada. In some cases proof has been offered that the accused has not altered his assignment originally made to his wife. From this fact the inference arises that his wife is still alive as of the date of proof. A Court is entitled to accept this inference and, therefore, to accept as a fact that the first wife was alive at a date subsequent to the second marriage. However, this form of proof is definitely weak and a finding of fact upon such proof would very likely be upset by a court of appeal in civil practice. No matter how certain in substance we may be that bigamy was committed, it might well be exceedingly dangerous to rely on a lay court, finding as a fact upon such weak proof, that the first wife was alive at a date subsequent to the second marriage. It follows, therefore, that prosecution of a case of bigamy in a reasonably secure manner would involve the taking of evidence on commission. This is a long drawn out, tedious and uneconomical procedure.

5. The difficulties of proof above-mentioned are faced, not only by Courts Martial, but by the civil authorities and their almost invariable reaction has been to drop the matter.

6. I am advised that the practice of the British Army within the U.K. is to leave the matter entirely to the civil authorities. They do not prosecute by Court Martial. However, they do not have the same problems and the conditions are by no means similar to those applicable to our cases.

7. Paras 3, 4 and 5 of the N.D.H.Q. letter contain the policy. In short they say that where circumstances of an aggravated nature occur coupled with the reckless disregard of his responsibilities as a member of the services, of the soldier, the matter will be brought to the attention of the civil authorities. The selection of such cases is left to the M.G.A. It is further provided that those cases not prosecuted by the civil authorities "will be dealt with by Court Martial". The practical result of this from our point of view and judging from our past experience, is that cases considered to come within the class above-mentioned will require ultimately to be prosecuted by Court Martial. The very great majority of cases will be refused by the civil authorities. The provision, therefore, of a programme must contemplate that the responsibility for prosecution of such cases will rest on the military authorities.

8. Our main problem resolves itself into the getting of the necessary information upon which we can classify the cases which come to our attention - upon which we can determine whether the circumstances are of an aggravated nature and there is "a reckless disregard for his responsibilities as a member of the services". It will be noted also that para 3 of the N.D.H.Q. letter provides for prosecution "generally when it is deemed advisable by the military authorities". In acquiring the

information the following factors are relevant:-

- (a) In practically every case the first indication of the possibility of bigamy having been committed comes to us from Pay. They get it by reason of an enquiry from the bigamous wife concerning her non-receipt of D.A. and A.P. The situation is always, so far as we are concerned, that a bigamous marriage is "indicated".
- (b) There remain three sources of information:-
 - (i) The soldier. Obviously he cannot be asked to incriminate himself. We can, however, draw the allegation to his attention and ask him for an explanation, but the explanation cannot be used in evidence. I think that we are justified in asking for any explanation of the allegation that the soldier may wish to offer.
 - (ii) The bigamous wife: The same conditions apply to any request to her, for information.
 - (iii) Other sources: Occasionally a relative of the bigamous wife may draw the matter to our attention. In these cases it is usually a request to know whether or not the soldier is in fact, married to the bigamous wife or whether or not he has a wife in Canada. These outside sources seldom produce any useful information.

9. Under the Army Act there is a limitation upon the taking of proceedings by Court Martial. A.A. 161 provides that "a person shall not be tried or punished for any offence triable by Court Martial committed more than three years before the date at which his trial begins". The jurisdiction of a civil court is preserved and there are other exceptions which are not important at the moment. At folio 98 the interpretation of the underlined words is given by D.J.A.G. as meaning the actual date on which the trial itself starts. All time, therefore, occupied in preparation of the case, runs against the prosecution. Should we determine that appropriate cases be prosecuted (and I suggest, by court martial) and the machinery is put in motion at once, I would consider that a period of six months would be required to complete the preparation. I recommend, therefore, that we should fix 30 Sep 41 as the date prior to which any alleged offence of bigamy should be ignored.

10. With regard to all the cases presently under consideration I would recommend the following procedure:-

- (a) Elimination of all cases in which the bigamous marriage took place prior to 30 Sep 41. A rough calculation would indicate that there are, at the moment, 55 cases left to be considered for prosecution.
- (b) Determine the present location of each individual soldier in each case not eliminated under (a). We should then eliminate all those cases where disciplinary action would be inexpedient by reason of the soldier's present location; for example, any theatre of operations, or Canada.
- (c) With respect to any cases remaining after (a) and (b), we should check carefully the information we now have and eliminate all those cases where disciplinary action is clearly inexpedient, for example :-

- (i) [REDACTED] - decree absolute obtained in Minnesota of first marriage.
 - (ii) [REDACTED] - had heard nothing of his wife for over 7 years.
 - (iii) [REDACTED] - has been tried in a civil court on a charge of bigamy and sentenced to 12 months imprisonment.
- (d) Where it is not known, we should then find out the name and last known address of the woman concerned in each of the remaining cases. This can be obtained by drawing the pay file for each soldier. At the same time the pay file will disclose whether or not D.A. and/or A.P. is in payment as a result of the bigamous marriage.
- (e) With respect to all cases remaining after (a) (b) and (c) we should write to the Commanding Officer of each individual soldier whether or not we know the name of the woman concerned, requesting from the soldier a careful explanation of the alleged bigamy. I think it must be pointed out to the soldier that his actual explanation cannot be used in evidence but that proof of the facts which he discloses may be established by other evidence.
- (f) On the return of each explanation, the case should then be examined and there should be eliminated all cases in which:-
- (i) The soldier's explanation would, if told in court, give rise to a reasonable doubt of his guilt.
 - (ii) The prosecution would probably fail for other reasons. For example action taken by the civil courts.
- (g) In all cases then remaining we should write to the woman concerned requesting her story. She should be told:-
- (i) Information has been received from which there is reason to believe that the soldier concerned, by marrying her, has committed bigamy.
 - (ii) It is desired to obtain all relevant information to determine whether or not the soldier should be prosecuted for this offence.
 - (iii) That any letter which she writes to us cannot be used in evidence, but that she may be called as a witness to give evidence herself.
 - (iv) We should attempt in our letter to avoid frightening her too much.
- (h) Upon the return to us of the woman's explanation, there should be eliminated:-
- (i) All cases in which reasonable doubt of guilt of the soldier would arise from answers which she would probably make on cross examination.

- 5 -

- (ii) All cases in which disciplinary action would be inexpedient after considering the effect of the combined explanations of the soldier and the woman.
- (i) Each case remaining after the eliminations referred to in sub-paras (a) to (h) inclusive, should then be examined to determine in which ones "a bigamous union has been entered into under circumstances of an aggravated nature in which there is an indication that the other rank concerned has acted with a reckless disregard of his responsibilities as a member of the service"
- (j) All cases coming within the requirements of sub-para (i) should then be referred to the appropriate civil authorities with a suitable offer of co-operation and the request that we be advised whether or not they propose to prosecute.
- (k) During the process (a) to (j) inclusive, cases will, no doubt be disclosed in which reference to the civil authorities would be advisable upon general grounds. After a decision taken under sub para (i) they should be referred to the civil authorities at once and in the same manner as set out in sub-para (j).
- (l) Cases may also be disclosed where a fraud on the D.A.B. is indicated. These should be examined carefully with a view to disciplinary action by court martial.

11. When we have received appropriate answers from the civil authorities (which I anticipate in most cases will be a refusal to prosecute), a decision must then be taken as to the action directed by para 5 of N.D.H.Q. letter. They say "will be dealt with by court martial". You will note the requirements for a decision to prosecute which are set out in para 10(i) above - "reckless disregard of his responsibilities as a member of the service". I suggest that this be interpreted to mean only the cases in which military discipline generally would be seriously affected or prejudiced if action were not taken. This I think, should be the measure for determining the advisability of prosecution by Court Martial. If this measure is adopted, then a decision under para 10(i) to refer a case to the civil authorities would automatically constitute a decision to prosecute by Court Martial - failing civil action.

12. Each case which requires trial by Court Martial should then be referred to J.A.G. Section for preparation and prosecution.

13. This procedure will be suitable, not only for the cases of which we are presently aware, but for each individual case as and when it comes to our attention.


14. One final point requires attention. Who will make the appropriate decisions during the carrying out of this procedure? In para 4 of the N.D.H.Q. letter it is stated that the M.G.A. will decide what cases "fall within para 3". I consider that this means the final decision in each individual case. 1. The prosecution of offences of bigamy committed by all ranks of the Canadian Army in the United Kingdom and in Canada is primarily a matter for the Civil Courts of the United Kingdom and Canada. In all cases where the Civil Authorities consider civil prosecution desirable, the Canadian Army will give every assistance possible.

2. It is not considered that it is the duty of the Canadian Military Authorities either in the United Kingdom or in Canada to bring to the attention of the Civil Authorities all cases where it may appear that a bigamous union has been entered into by personnel of the Canadian Army.

3. Cases will be brought to the attention of the Civil Authorities where a bigamous union has been entered into by personnel of the Canadian Army under circumstances of an aggravated nature in which there is an indication that the officer or other rank concerned, has acted with a reckless disregard for his responsibilities as a member of the Service, or generally when it is deemed advisable by the Military Authorities.

4. The Adjutant-General in Canada and the Major-General in charge of Administration, London, England, will decide what cases fall within para 3.

5. Cases falling within para 3 which are not prosecuted by the Civil Authorities will be dealt with by Court-Martial.

6. Cases where it appears that a bigamous union has been entered into with a view to perpetrating a fraud on the Dependents' Allowance Board should, in addition to being treated as bigamy under the terms in the foregoing paras, be considered by the Military Authorities in the light of such fraud and such disciplinary action taken under Section 18(5) A.A. as the case may warrant.

1. At folio 104 is my memorandum to the Senior Officer in which I recommend, with reasons, that no further action be taken with regard to the prosecution of O.R. personnel guilty of the offence of bigamy, but that proceedings should be taken where officers are involved.

2. The Senior Officer has now directed that the whole matter be placed before N.D.H.Q. Will you therefore please prepare a draft for an airmail letter to N.D.H.Q. on this subject. This letter should contain a general statement of the situation and recital of the reasons why in most cases action could not be taken until after authority was secured to take commission evidence in Canada (see folio 31); a recital of the fact that DJAG has advised that prosecutions are practicable in 44 cases; a summary of the reasons for and against proceeding in these cases along the lines of my memo at folio 104; a statement by the Senior Officer that he has reached the conclusion, in view of the foregoing, that it is inadvisable to commence proceedings in these cases, and a request for N.D.H.Q.'s views on the subject.

3. The letter should also set out that a considerable number of these cases have been brought to the attention of the Civil authorities who have decided not to prosecute; that if our view is concurred in we will bring all such cases both past and future to the attention of the appropriate Civil authorities, advising them that we will give them all available information and every possible assistance in the event that they decide to prosecute. - ii) On 23 Apr 43 I discussed the general situation including numbers, with Brigadier Beament, at which time no action could be taken because we were still awaiting authority re commission evidence.
- iii) On 30 Apr 43 I received copy of P.C. providing for commission evidence and on that date directed Dis (Lt.Col. Walker) to "at once review" all pending cases to determine where proceedings should be instituted (folio 31). There is no clear indication as to what instructions Dis issued in pursuance of this, but on 10 Aug 43 (folio 86) DJAG passed to AG5a a memorandum together with an analysis of each case and recommendations as to whether or not the soldier should be prosecuted. There is no indication as to what action, if any, AG5a (Capt. H.A. Martin) took in regard to this, and he is not now available.
- iv) My recollection is that about the middle of Nov, Dis (Lt.Col. McDonald) discussed with me the problems involved in regard to the prosecution of these cases, and on my instructions AJAG was requested on 19 Nov 43 (folio 96) to prepare a memorandum setting out the procedure required to be taken etc. in regard to these cases. Memorandum by DJAG d. 25 Nov 43. appears at folio 98; comments of AG5 (29 Nov 43) at folio 101, and memo to me from Dis (4 Dec 43) at folio 102. My memò to you of 6 Dec 43 is at folio 104.

2. Summarized, the situation appears to be as follows:-

- a) Until provision was made to take commission evidence in Canada, it was a practical impossibility to undertake proceedings except in a very few of these cases.
- b) As soon as authority to take commission evidence was secured, instructions were issued by me to Dis to review the situation for the purpose of determining which cases could be prosecuted.
- c) So far as can be determined from the file, it appears either that Dis. (Lt.Col. Walker) failed to carry out my instructions, or, alternatively, that AG5a (Capt. Martin) with whom Dis dealt directly on these matters, failed to carry out instructions to him. In any event, there is an unexplained and unwarranted delay from May until Aug. Again, there is a further unexplained and unwarranted delay between 10 Aug 43 and Nov when Dis (Lt. Col. McDonald) brought the matter to my attention again.
- d) While these delays were inexcusable, the explanation probably is that because AG5a was handling such a very large volume of files, and also because from day to day he was handling minor routine matters on this particular file, he, in the first place, overlooked or neglected to take the necessary action on this matter. I have to point out that as Lt.Col. Walker and Capt. Martin are both not available to explain what they did in regard to this matter, it is not fair to allocate to either of them the blame for this situation.

1. Further to folio 107, at folio 110 and 112 are lists of members of the Cdn Army who have been tried upon charges of bigamy. You will recall that this was requested by the Senior Officer at folio 105.

2. In the order in which the Senior Officer asked for them, the following are the particulars:-

- (a) Cases prosecuted in the civil courts (folio 110) -
9 cases including 1 of making a false statement under the Marriage Act. All are cases of other ranks, and the convictions cover apparently the whole of England. Sentences run from 1 case of having been bound over, to 12 months imprisonment. One case involved a fine of £50 or 3 months hard labour.
- (b) Cases prosecuted in field units:
 - (i) By the civil authorities (apparently 4)
 - (ii) By FGCM - Nil.
- (c) Cases prosecuted in units under command CMHQ
 - (i) By the civil authorities - 5
 - (ii) By FGCM - 3

3. In addition to the foregoing, 3 officers had been tried by GCM upon a charge of bigamy, and all were sentenced to be dismissed from His Majesty's Service.

1. Reference your 20/Bigamous/1 of 11 Dec 43, attached hereto, relative to them/n matter.
2. Pursuant to your request, the following information has been obtained in this regard:-

- (a) This Branch has no record of convictions of Cdn personnel by civilian courts. It is understood, however, that such a record is kept by the DPM and he could, no doubt, give you the information which you require in this connection. The only civil prosecution for bigamy of which we have any knowledge is one against [redacted] who was convicted thereof at the Old Bailey of 21 Oct 43 and sentenced to 12 months' imprisonment. I may also say that ex-Lieut [redacted] whose case is hereinafter noted, was also prosecuted for bigamy at the Old Bailey and convicted thereof. He was sentenced to 3 years' penal servitude. He had been involved in two bigamous marriages.
- (b) There have been no prosecutions by way of FGCM in field units, that is to say, units under command of First Cdn Army.
- (c) The following persons have been charged with bigamy and tried by FGCM in units under command of CMHQ:







1. Re folio 105.
2. I have asked D.J.A.G. to obtain the particulars requested by the Senior Officer in his para 1. They maintain statistics.
3. I am afraid that I may be responsible for the impression gained by the Senior Officer as mentioned in his para 2. He mentioned the matter to me on 9 Dec when I was seeing him about some other things and I am afraid that I did not make myself clear.
4. I did not intend that he should get the impression that a decision had been taken NOT to prosecute. What I was trying to express was that a decision had not been taken to prosecute, pending determination of all of the factors including the amount of work involved.
5. The history of the whole matter is as follows:-
 - (a) Folio 1, 14 Apr 42, memorandum of discussion between then AG5 and then AAG(Pers) in which the policy determined is stated to be the taking of disciplinary action in all cases after investigation.
 - (b) Folio 6, 15 Sep 42, memorandum from then AG5a to then AAG(Pers) with recommendations concerning the taking of disciplinary action, and comments by then AAG(Pers). The recommendations of Pers were:-
 - (i) Charges only in the most flagrant cases.
 - (ii) Sentences limited to maximum of 6 months.
 - (iii) Special consideration in officer cases.
 - (iv) Completion of necessary statistics.
 - (c) Folio 12, 18 Nov 42, memorandum from ADAG(B) to then AAG(Pers) requesting that matter of PC on the subject of commission evidence be expedited.
 - (d) Folio 17, 3 Dec 42, copy of letter from Senior Officer to NDHQ concerning commission evidence with particular reference to bigamy. This letter apparently was not sent.
 - (e) Folio 29, 16 Apr 43, memorandum from then AG5a to AG5 concerning the matter generally with recommendations
 - (i) Cable action to expedite matter of commission evidence.
 - (ii) Consideration be given to making legal personnel available to prosecute, and that all cases pending be referred to JAG Branch to obtain necessary evidence from Canada.



1. At the present time there are approximately 90 undisposed of cases of bigamy in which Canadian Army Overseas personnel are involved.

2. As you know for a very long time it was quite impossible for us to institute proceedings in the vast majority of cases because of the impossibility of securing evidence from Canada in regard to the first marriage, identity of parties, etc. A few months ago, provision was made by P.C. Order for evidence to be taken on commission so that it is now possible to secure the necessary evidence in normal cases.

3. At folio 86 is a letter from DJAG and attached to it is a summary of cases to that date with recommendations, etc., as to whether or not proceedings could or should be commenced. At folio 98 is a memorandum from DJAG setting out the various steps required to be taken in prosecuting bigamy cases together with recommendation by DJAG (folio 97, para 7) that the matter should be dropped. At folio 102 is recommendation of AAG(Dis) to the same effect, with the exception that he recommends that in officer cases proceedings should be taken.

4. I have considered this matter and now list herewith the reasons for and against taking proceedings in these cases. These are as follows:-

a) Reasons for proceeding.

- i) It is a civil offence punishable by the law of U.K.
- ii) These offences do tend to bring Cdn. Army into disrepute.
- iii) The best deterrent is punishment.


b) Reasons against proceeding.

- i) It is primarily the duty of the civil authorities to handle these cases. If they will not undertake to prosecute, with whatever assistance we can give, they can have no substantial grounds for complaint if we fail to proceed.
- ii) While these cases do bring the Cdn. Army into

- disrepute, they do so to a much lesser degree than many other kinds of offences.
- iii) In order to handle the 90 cases a tremendous amount of work would be involved, and could only be done at the expense of other and to us more important duties.
- iv) A considerable number of cases are statute barred (3 years RF 36A(iii) and many others will be before action can be taken. In view of necessity for commission evidence in practically every case, proceeding will in most cases take many months to complete. Due to the difficulty of locating witnesses, securing evidence, etc. it is probable that many prosecutions will fail. The effect of a considerable number of offenders "getting away with it" in this way would be harmful.
- v) It is probable that in many cases, the wives in Canada and/or the victims here would be very reluctant to give evidence, thus increasing our difficulties.
- vi) The problem is a diminishing one, largely due to the fact that registrars will not issue a marriage licence without a certificate of permission to marry from the C.O., so that the necessity for exemplary punishments is minimized. The figures, so far as I have them are:
- 1940 - 8; 1941 - 40; 1942 - 34; 1943 - 6.
- vii) Generally speaking, commission of the offence of bigamy is no indication that the man is not a good soldier. There is merit in the argument that at this time the national interest requires that every fit man should be required to fight. Prosecution of any considerable number would tie up considerable manpower who might be otherwise better employed and conviction would deprive us of many good fighting soldiers; it would also further load our already overtaxed detention facilities.

3.

5. In view of the above, I have, with some reluctance, been forced to the conclusion that no further action should be taken in regard to these offences insofar as O.Rs. are concerned. Proceedings should be taken where officers are involved; I therefore recommend accordingly.

Prosecution of Bigamous Marriages.

1. At folio 98 Lt-Col Kelly has analysed the bigamy situation. There are for all practical purposes 90 cases awaiting prosecution should we decide so to do. Comments by A.G.5 are at folio 101.

2. Lt-Col Kelly feels that these prosecutions should not be proceeded with, and the reasons are, in my opinion, quite sound. I feel that the time and expense involved even though a number of soldiers would, in all probability, plead guilty, is most disproportionately large to the benefit which can be derived. As I see it, the whole result would be to produce some 80 or 90 inmates for Col Shankland's institution with the resultant loss of good manpower.

3. I feel myself that discipline is not going to suffer by non-prosecution of these cases. I think that it is only a peculiar type of individual who indulges in this sort of stupidity and that fear of penal consequences is not a particularly serious factor. He will undoubtedly have plenty to worry about without that.

X

4. The fact that the offence is not a military one does not in itself impress me particularly. The paramount consideration is to maintain discipline in the Army as a whole, and whether an offence is civil or military, its effect on discipline generally is the chief consideration.

5. I would therefore recommend that as a matter of policy we should assist the civil authorities if they wish to prosecute, but that we ourselves should not do so in any cases.

6. I do recommend one exception, and I think it is justified. If an officer commits the offence of bigamy we should prosecute. I feel that it is a perfectly reasonable distinction to make.

Prosecution of Bigamous Marriages

1. Reference memorandum from D.J.A.G. at fo 98.
2. I agree with the opinions and recommendation of D.J.A.G.
3. The offence of bigamy is purely a civil offence. I think its commission by members of the Cdn Army does not bring disrepute on the Army or on Canada as a whole, but is recognised as a purely personal matter in each case. The civil authorities are perfectly capable of dealing with the offence if they choose to do so. The difficulties of proof are often serious, and for this reason in most cases the civil authorities have not prosecuted and probably will not do so. The difficulty of proof of the requisite ingredients of the offence are almost if not quite as difficult under military procedure, and furthermore in view of the substantial number of cases if proceedings were to be commenced a special staff would be required for the purpose.
4. For all of the above reasons, and particularly because the offence is not in any sense a military offence, I recommend that no action be taken by the military authorities for the prosecution of offences of bigamy unless the very special circumstances of any particular case seem to require special consideration and action.
5. May I receive your instructions, please.





Prosecution of Bigamous Marriages

1. With further reference to the memo of 19 Nov 43 at fo 96, it is considered that the proper procedure to be adopted is that an ordinary Summary of Evidence should be commenced in each case. All possible evidence available in this country should be recorded and the Summary then adjourned in order that any necessary evidence from witnesses in Canada be obtained on commission and the Summary thereby completed. The taking of the Summary of Evidence shall be the responsibility of the unit concerned, although this Branch shall assist the units in every possible way.

2. The items to be proved to substantiate the charge are as follows:-

- (a) The First Marriage - This should be proved by the production of the attestation paper. The particulars of the attestation paper contain an admission of a prior marriage. This constitutes prima facie evidence that a former marriage has been celebrated according to law. In addition to this, an expert in the law of the Province where the first marriage took place will give evidence as to the laws relating to marriage in that particular Province. He will then produce a certificate of the first marriage and will swear that it is in the form prescribed by the law of the Province concerned. This expert will then go on to testify that in his opinion the marriage was a valid marriage and that the marriage certificate which he has produced makes proof of the contents therein stated.
- (b) Identity - A Pay officer will produce MFM 16 (application for DA), properly certified under Overseas RO 3131. This document also contains an admission that the accused was married. He will also produce MFM 17 (assignment of pay) and MFM 5 (particulars of family).

The unit Paymaster will then produce an Acquittance Roll or pay book or some document signed by the accused the signature on which he can positively identify as being that of the accused. He will compare this with the signatures on the other documents and will certify that in his opinion the signatures are identical.

- (c) The Second Marriage - This will be proved by the production of the certificate of marriage. This document proves itself and can be obtained from the Registry Office. This document should be produced by one of the witnesses to the second marriage who shall identify the accused as being one of the parties to the second marriage.
- (d) First Wife alive at time of Second Marriage - This is the weak link in the case and without obtaining evidence on commission the only proof available is evidence by the unit Paymaster to the fact that no application has been made for the cancellation of Dependents' Allowance. It is considered that this is not sufficient proof on this point and that evidence on commission is essential to ensure that the charge shall not fail. With regard to the evidence on commission, if it is possible the first wife should be called - here it must be remembered that she is not a compellable witness though she is competent. She should give evidence of the first marriage and may strengthen the identity angle by

describing her husband and, if possible, producing a picture or photograph of him.

If the first wife will not testify then one of the witnesses to the first marriage may be called. This witness should swear to the fact of the first marriage and state all the circumstances relating thereto. This witness might also describe the man taking part in the ceremony.

On the actual point of the wife being alive at the date of the second marriage, a witness can declare that at the date of the second marriage the first wife was alive. The mother of the first wife would be an excellent witness in this respect but any person who can swear that on the given date the first wife was alive will be satisfactory. This witness can also swear that the man taking part in the ceremony is a soldier and may possibly describe him accurately.

3. 75 files have already been reviewed by this Branch, each dealing with alleged bigamous marriages and from the book referred to in para 2 of the memo at fo 96 there appear to be some 11 more cases which have not been submitted to this Branch -

. In all, therefore, there is a total of 86 cases. Not all of these can be proceeded with as in several instances any action under the Army Act has become outlawed (AA 161 and RP 36A (iii)). In other cases, for various reasons, it was suggested by this Branch that no action be taken. The cases which are barred by lapse of time, together with those where it is felt no proceedings should be taken number 19, so, if the advice of this Branch is accepted, as set out at fos 57-86 inclusive, the minimum number of prosecutions will be 67. Under AA 161 and RP 36A (iii) action under the Army Act is barred if the time which elapsed between the commission of the offences and the beginning of the trial is more than three years. This Branch interprets "the beginning of the trial" as meaning the actual date on which the trial itself starts. Thus, it must be borne in mind that more of these cases will be outlawed before the accused soldiers can be brought to trial - as the gathering of the evidence, especially that taken on commission, the taking of a Summary etc. will involve time in each case.

4. As stated above, action under the Army Act in many of these cases will be barred before ~~their~~^{the} cases can be brought to trial as the taking of the commission evidence will necessarily take considerable time. It should be remembered then that if these cases are proceeded with it will have the unfortunate effect of the more recent bigamists being punished while those earlier offenders, who set the example, will go free.


5. With charges of this nature, if trial by court-martial is ordered, it is considered that a JA should be appointed to act at each trial as bigamy charges are sometimes more difficult to prove than ordinary military offences. It is impossible to make any sound estimate of the stenographic help that will be necessary, but as the trials may be difficult for the usual lay court it is felt that court reporters should be employed. It can be appreciated that the recording and the transcription of so many trials will entail a great deal of labour.

6. Difficulty will doubtless be encountered with regard to the scattered locations of the units of the Cdn Army concerned - this same difficulty will be encountered in procuring the attendance of the necessary witnesses. Many of the bigamous marriages occurred some time ago and it may be difficult in some cases to procure the attendance of essential witnesses. Again, if certain witnesses are not procurable, it will mean that some offenders are punished and some are not for only this reason. There will be no consistency as to which cases are tried and which are not.

7. The offence of bigamy is purely a civil offence yet the civil authorities have so far prosecuted few of these and have indicated in other instances that they do not wish to prefer charges. Their greatest difficulty is that of obtaining the necessary proof - but the same difficulty exists for military authority. ~~In view of paras 3, 4, 5 and 6 above and having especial regard to the fact that bigamy is essentially a civil offence, I do not believe these prosecutions should be proceeded with. It is my opinion that the expense and the loss in time involved should not be undertaken by the Cdn Army for the punishment of offences so basically civilian as these are.~~



First Marriage

An expert in the law of the province where the first marriage took place will give evidence that at the present time the Registrar is under an obligation to keep a record of all marriages. The Certificate of Marriage in the first instance is, therefore, admissible.

The expert will then produce a Certificate of the first marriage and will swear that it is in the form prescribed by the law of the province concerned.

The expert will then further swear that in his opinion the marriage, at the time it was performed, was a valid marriage (assuming the facts in the Certificate of Marriage to be correct).

Identity

A pay officer (Pay a) will produce MFM 16, (application for DA) properly certified under RO 3131, under AA 163. (This document contains an admission that the accused was married incidentally). MFM 17 (Assignment of Pay) will also be produced. This witness will also produce MFM 2 (attestation) and MFM 5 (particulars of family).

The unit paymaster will then produce an acquittance roll, or a pay book or some document signed by the accused and the signature on which he can positively identify as being that of the accused. He will compare this with the signature of the accused on the other documents and testify that the signatures, in his opinion, are identical. He will further testify that the accused has not applied for any cancellation of his DA.

Second Marriage

This will be proved by the production of the Certificate of Marriage. This document proves itself and can be obtained from the General Registry Office. This should be produced by:-

one of the witnesses to the second marriage who shall identify the accused as one of the parties to the second marriage.

First Wife Alive at Time of Second Marriage

Shall be done by evidence taken by Commission. The unit paymaster shall also testify as to this by stating that no application has been made for the cancellation of DA.

Commission Evidence

If possible the first wife should be called, but it must be remembered that she is not compellable, tho she is competent. If she gives evidence she should corroborate the first marriage and strengthen the identity angle by describing her husband, and, if possible, produce a picture or photograph of him.

If the wife will not testify then any witness to the first marriage can be called. Such a witness can give all the circumstances surrounding the first marriage and this will enable the expert witness to swear that the first marriage was definitely valid.

As to the actual question of the first wife being alive:-

a witness (the mother would be good) can declare that at the date of the second marriage, the first wife was alive. This witness can also swear that the first wife married a soldier, and if possible, can identify the husband by means of a description or picture or photograph. Can swear that the accused married first wife ~~on~~..... date and ~~that~~ on ~~some~~ date after the second marriage, the first wife was alive.







MADE LEGAL HISTORY

AMERICAN SOLDIER TRIED AT THE OLD BAILEY

"News of the World" Special

An American army sergeant, Anthony Edward Peter, 44, of Rochester, N.Y., is believed to have made legal history in being dealt with at the Old Bailey instead of by a U.S.A. court-martial.

He is thought to be the first American soldier to be charged at an English court. The reason for his appearance at the Old Bailey was that the offence—bigamy—was committed while he was a civilian. An authorisation of the Home Secretary was, however, produced in court before he was allowed to plead.

Mr. Bertram Reece, prosecuting, said that Peter served overseas in the Canadian army in the last war. Coming to England in 1917 he met Helen Mary Collis, whom he married at Brighton in 1919. The following year he joined the R.A.F.

His wife did not see him after December, 1921, when he was home on leave, until December, 1941, when he appeared at her Brighton home. He told her: "I've come 2,000 miles to see you," but she replied: "I cannot see you as I am getting a divorce."

During the 20 years Peter had contracted a bigamous marriage and taken the woman to New York, where a son was born. Later they returned to Scotland, where the woman died in 1932.

In March last year he bigamously married Margaret Ida Wheddon at Ellesmere Port, Cheshire.

Miss Constance Colwill, defending, said Peter's legal wife had "married" a man named Gerrard. She obtained a decree nisi in February, and when she obtained her decree absolute shortly she would be free to marry Gerrard legally and Peter would be free to marry Wheddon.

The Common Serjeant (Mr. H. L. Beazley) said that although he regarded bigamy as a "blasphemous mockery," he saw no point in sending Peter to prison. He bound him over for 12 months.

4. There are a number of additional files that will be passed to you as soon as more complete information has been obtained, but it is not expected that the total number of cases involved will exceed 80.



1. There are now on record 70 cases of bigamy. In three of these cases disciplinary action is being taken, or is under consideration, due to special considerations in these cases. The remaining 67 cases are noted, but no action is being taken pending N.D.H.Q. taking the necessary action to make available commissioned evidence for use in Canada.

2. Information is available covering the date of the bigamous marriage in most of the above cases - and an analysis appears hereunder.

3. The fact that prosecutions for bigamy have occurred, and the results published in Overseas R.Os., may have had some deterrent effect in reducing the number of bigamous marriages contracted during the last 15 months. A more probable explanation is, however, that the wives concerned have not yet become sufficiently curious about the lack of dependents allowance - as the large majority of cases of bigamy coming to light reached this Headquarters through the C.P.M. as the result of some application for dependents allowance or request for information.

4. It is understood that a draft P.C. authorizing the use of commissioned evidence in Canada was received from N.D.H.Q. some weeks ago, and returned without any suggestions for substantial changes.

5. In view of the number of cases in which prosecutions for bigamy are pending, it is recommended -

Evidence on Commission -
Courts-Martial Proceedings

1. Reference my letter of 2 Oct 42 (lo/Davidson, V.J./1), in reply to you HQ 405-D.115(A.D.1), wherein I suggested that consideration be given to the provision of a procedure, in the administration of military law, similar to that of taking evidence on commission as used in the Civil Courts.
2. I have to advise that the necessity for disciplinary action in certain cases overseas, makes it highly desirable that some legal provision be made in this regard. This Headquarters has under consideration, at the present time, a number of cases involving alleged bigamous marriages by officers and soldiers and, as well, there have been referred to this Headquarters, from time to time, cases involving disciplinary action against soldiers, now overseas, for offences alleged to have been committed in Canada.
3. A disposition of such cases is not possible under present means of proof because certain elements of the alleged offences occurred in Canada, and witnesses to prove the same are not available in the U.K.
4. It is, therefore, suggested that an appropriate P.C. Order be passed enabling the evidence of such witnesses to be taken in Canada on commission for use in courts-martial proceedings overseas. It may be desirable to draft such P.C. Order in such manner as would enable such evidence to be taken on commission in any circumstances, that is to say, there may be cases in the future in which similar evidence would be required for proceedings in Canada where the witnesses are overseas.
5. A somewhat similar provision is found in the Canadian Criminal Code, Sec. 997, which provides, inter alia, that whenever it is made to appear to the satisfaction of a judge, or magistrate, that any person residing out of Canada is able to give material information relating to any indictable offence, he may appoint a commissioner to take evidence, upon oath, of such person.
6. A draft P.C. Order, in this regard, has been prepared at this Headquarters and a copy thereof, with a copy of explanatory notes, is enclosed herewith for such use as you care to make thereof. It is now considered, however, that the matter might better be dealt with in a different manner, and it is suggested that a short P.C. Order be passed generally authorizing the use of evidence on commission in courts-martial and other disciplinary proceedings, notwithstanding any act, rule, regulation or law to the contrary, and providing that the Judge Advocate General, at N.D.H.Q., have power to make all necessary rules and regulations governing the procedure therefor, and that such rules and regulations, when published, have the same force and effect in law as if contained in the P.C. Order. It is considered that from experience gained in the practical application of such rules and regulations, from time to time, it may be necessary to make certain alterations therein and, consequently, it would be more convenient if such alterations could be made and published by the Judge Advocate

General, as occasion requires, rather than by an amending P.C. Order.

7. I would ask that this matter be given early consideration in view of the many cases presently pending, and further that any draft P.C. Order, in this regard, be submitted to me for consideration before it is presented to the Governor in Council.



BIGAMOUS MARRIAGES

From time to time reports are received at Defence Headquarters which indicate that bigamous marriages are contracted by personnel of the Canadian Army. Such marriages entail needless suffering on the part of those victimized, and result in the unlawful payment of dependents' allowance.

- 2. Bigamous marriages fall into two classes -
 - (i) married men, who, on enlistment declare themselves to be single, and subsequently obtain permission to marry;
 - (ii) single men who obtain permission to marry women who are already married. In some cases the fact that the woman is married is known to the soldier, and in other cases he believes her to be single.

3. More than one instance has occurred of a soldier, who, at the time of enlistment, declared he was separated from his wife - subsequently he applied for permission to marry and such permission was granted by his Commanding Officer. The granting of permission to marry under such circumstances clearly indicates neglect on the part of the Commanding Officer, who, had he personally checked the man's documents, would have discovered his marital status.

4. Before granting permission to marry, the Commanding Officer will ensure that the provisions of Routine Order 808, as amended by Routine Order 947, have been complied with. Referring particularly to para. 2(a) of Routine Order 808, the Commanding Officer will, if he considers such a course desirable, interview the intended wife or consult her parents or guardian. If this is not possible, through distance or objection on the part of the prospective bride, he will endeavour to obtain the necessary character reference through one of the social services at his disposal.

5. By rigid compliance with the regulations and conscientious inquiry into the bona fides of every case, there should be a material decrease in the number of bigamous marriages now reported.

1. I pass you this file which, as you will see, is rapidly accumulating ^a substantial list of offenders.

2. Recently we discussed the question ~~the~~ ~~question~~ of asking Canada to take the necessary steps to provide for the use of commissioned ~~offence~~ ^{evidence}, particularly for cases of this nature.

3. In bigamy cases, the necessity for proving the original marriage and the identity of the parties thereto, and also the subsistence of the marriage at the time the offence occurred, are likely to prove a bar to successful prosecution. Except in the few odd instances where such evidence may be obtained over here, or where there is circumstantial evidence of such a nature as to satisfy a Court on these points, it is practically impossible to secure a conviction.

4. I agree with you that it would be almost hopeless to try to dispose of these cases by way of bigamy charges unless and until commissioned evidence can be utilized.

5. Will you please expedite this matter and submit a draft cable setting out our request to Canada, and stressing the urgent need for early action.







MEMORANDUM

BIGAMOUS MARRIAGES IN U.K.

1. At folios 3,4, and 5, are listed the names of 20 soldiers who are known to have committed bigamy in the U.K. This list is by no means complete. (Off hand, I know personally of five additional cases). C.P.M. advises at Para-2 of letter at folio 3 that this Branch is to be informed of any future cases coming to light through Pay channels, although no such record has been kept in the past.

2. Disclosure has almost invariably come through the woman or her relatives going, or writing, to Acton or Lancaster enquiring why D.A. has not been paid. She has been informed that her "husband" has a legal wife in Canada and the file has been marked "P.A.". Paymasters in the Field have also given such information. Hence the number of actual cases would be much greater than indicated in Para 1 above.

3. I consider such bigamous marriages to fall roughly into three classifications -

(a) Where the soldier either through ignorance or erroneous information believes his previous marriage to have been dissolved.

Ignorance of the law may be no excuse, but nevertheless it sometimes plays an important factor in determining the degree of 'mens rea' in individual cases. For instance, I can think of a case in the Field, of a soldier, uneducated and of poor understanding, whose wife deserted him, after two days of marriage, for another man and who was told by his priest that the marriage would be annulled. This soldier, unable to see the distinction between an ecclesiastical annulment and a civil one, contracted a second "marriage" in the U.K. Another soldier was sued for divorce in Canada and his wife was awarded a decree nisi. He heard nothing further except that after 7 months his wife had re-married. He had a newspaper announcement which I saw. He then married, in the U.K. - and was subsequently informed that his wife had not obtained decree absolute and that he himself was bigamously married. In cases under this heading, there is never any D.A. in payment to the first wife.

(b) Where the soldier has made the woman pregnant, and in desperation marries her.

There have been several "marriages" of this "shot gun" variety, undertaken to save the woman's name in the community, or to protect her from the wrath of her own family. In more than one such instance the woman well knew that the soldier was already married.

(c) Where the soldier, while assigning pay to a legal wife in Canada, misleads a woman into what she believes is a perfectly legal marriage.

4. RECOMMENDATIONS -

(a) That every effort be made to list all Canadian soldier

cases of bigamous marriage in the U.K. I feel that should C.P.M. circularize all paymasters, that the number mentioned in Para 1. above would be at least tripled, or more.

(b) That cases be grouped into the three categories outlined in Para 3 above, or in additional categories, if resulting data so warrants.

(c) That prosecutions should not be undertaken in the cases mentioned in Para 3 (a) above, and that every such case should be studied for possible relief under D.A.B. provisions.

(d) That prosecutions should be undertaken in the cases mentioned in Para 3 (b) above only where the soldier has a bad army record, but that each case should be studied under the provisions of Article 88 (vi) F.R. & I. (Canada), with immediate applications for D.A. for the children concerned.

(e) That in all cases coming under Para 3 (c) above there should be prosecutions under Section 41 A.A., with recourse being made to the provisions of Article 88 (vi) F.R. & I. (Canada) if the woman concerned appears to be of good character.

5. This may not be the place to discuss sentences following F.G.C.M. convictions for bigamy, but I consider one of six months to be proper. Such a sentence would not penalize the innocent family in Canada, as D.A. and A.P. would continue for that period.

6. It is only my opinion, but I consider that the general official attitude in the U.K. to bigamy has at least not acted as a deterrent. Frequently are to be seen cases where bigamists get suspended sentences, or very short jail sentences, or even fines. For instance, last week, a woman bigamist was bound over to keep the peace for two years in the sum of £5.0.0. These cases make 'juicy' newspaper reading and the resultant trivial punishments are well publicized. *This identical sentence was given out in another similar case at the Old Bailey this a.m. 23/9*

7. It is to be noted that of the 20 cases mentioned at Folios 3, 4, and 5, only two have taken place during the current year. In other words, bigamy among Canadian soldiers is definitely on the decline, occasioned, I think, by (a) the stricter marriage regulations of Nov 41 (b) the reluctance of clergymen and registrars to marry Canadians who cannot produce official permission and (c) the publicity given to the sentence in the Coffey case.

(a) Reasonable efforts be made to complete over a statistics of such cases. (J.A. Edmison) Captain A.G.5a Canadian Military Headquarters

(b) Charges be laid in only the most flagrant cases

(c) Sentences be limited to maximum of 6 mos and average of 2 to 3 mos.

(d) There are a few other cases which should be carefully considered to ensure they are treated at least as strictly as OR's



BIGAMY IS WAR CRIME No. 1

Britain 'Worst Nation'

By CYRIL MARTIN

B RITAIN'S judges, alarmed at the growing number of bigamy cases, are imposing sharp sentences. Mr. Justice Charles, at Hampshire Assizes yesterday had 18 cases on the list.

He commented that substantial sentences would have to be given, and the first sentence he imposed was one of 12 months' imprisonment. At Manchester a man described by the police as a "professional bigamist" was sentenced to three years' penal servitude.

Twelve of the 18 cases before Mr. Justice Charles concerned Service men, and in each case an officer spoke of the man in the highest terms. "Evidently a good soldier but a bad civilian" was the judge's comment in one instance.

Mr. Justice Stable referred, at Liverpool Assizes recently, to what, he said, "seemed to be a popular impression that, provided a person was in uniform, bigamy did not much matter.

"I take a different view," he said. "Bigamy can be a very serious offence indeed, and in many cases I give long sentences.

Peak Figure

"I think that if the information was more widely disseminated that bigamy can carry a sentence of seven years' penal servitude it would, perhaps, have some restraining effect."

It will surprise many people to learn that this country has the worst record for bigamy of any European nation.

Although official figures are not available, it is estimated by legal authorities that more cases will come before the courts this year than at any time in the history of law.

Bigamy began to increase during the last war. In 1914-18 and the five post-war years, bigamy cases averaged four times the number in any year before 1914. Figures then decreased, but have never come down to the pre-1914 figures.

A well-known barrister told me last night that the ease with which it was possible to marry in this country was a contributory factor to the increase in bigamy, apart from the stress of war.

Effect of War

"In the majority of cases husbands and wives are separated for the first time in their married lives; they meet fresh people in different surroundings and give way to themselves," he said.

"In normal times they would not dream of such things.

"Of course, there are cases where a man or woman unhappy in their peace-time domestic life, have found their war-time separation a convenient means of ending their partnership and have met somebody to whom the attraction is mutual.

"That, however, is not an excuse for bigamy, because the law provides a legal procedure for dissolving marriages."
