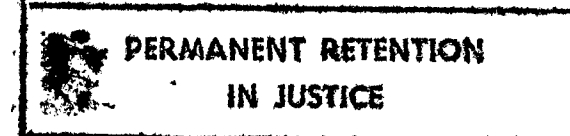

Sir,

I beg leave to enclose herewith copy of
an extract from a letter just received from Mr. P. L.
Naismith, Manager of the Alberta Railway and Coal Company,

I may say that the power of the medical inspector
on the frontier to cause the ejection of a passenger from
the train who refuses to be vaccinated before crossing the
frontier has been assumed by our officers in quarantining
against the United States and by the United States officials
in quarantining against Canada, but as Mr. Naismith now
raises the question of the legality of such action I beg
leave to submit the matter to you for an authoritative
opinion upon the subject the purport of which I may
communicate to him.

Copy of extract from a letter, dated 4th May, 1901,
from P. L. Naismith Esq., Manager, The Alberta Ry & Coal
Co., Lethbridge.

"There is one point which has been somewhat doubtful to us, and I would be obliged if you could put us straight on the matter. There has only been one case come up, but the question is liable to come up at any time, and that is, in the case of a party coming into Canada who refuses to be vaccinated, I would like to know if, on instructions from the Medical man, our conductor would be protected by the Government in ejecting a passenger from the train, who held a ticket through to Lethbridge, but who refused to be vaccinated before crossing the frontier. If you can set our minds clear on this point it would be appreciated."
