

re: Father Moss Separate School Health Scene.

To Whom It May Concern:

Enclosed you will find a list of pupils from Father Moss Separate School who possess either head lice (pediculosis), possibly scabies, abcessed ears, a rash, warts, or sores covering parts of their body.

As principal teacher of this school, I am most concerned with the physical condition of many of my pupils. It is quite difficult teaching these students when they are suffering from these health problems. At the same time I am aware that my role as educator does not compel me to become too involved in the mechanics of health in as they exist on the domestic scene. However, since I am deeply interested in the education aspect of the 216 pupils, I have gone to the effort of checking into this situation more thoroughly than I believe my role compels.

On April 18, 1973, Mrs. Carol Morris, Mr. Francis Kavanaugh and I, entered every classroom. Mrs. Carol Morris attempted to locate the medical problems of the pupils, while Mr. Francis Kavanaugh jotted down her comments. I was present in order that I might be aware of all proceedings.

On April 24, 1973 Mrs. Carol Morris again checked the concerned pupils. I also was present in order that I might be aware of all proceedings.

Conclusion:

These aforementioned facts strongly suggest that Father Moss School have better access to a nurse than presently exists. I am most pleased with the interest that Mrs. Gloria Meckley, Public Health Nurse, Northwestern Health Unit, has shown as she visits our school every Friday morning; however, I hope that the above named pupils will clarify my wish for a nurse who could spend much more time than her schedule permits.

She (this nurse) would almost have to be available for a certain number of hours every week and equally important have the necessary medical supplies required for the performance of her duties, (if she performed any duties beyond an assessment role).

Our school, as it exists as of this writing, fails to present the necessary health room and supplies required for such a desired nurse. Her understanding of this situation would facilitate her daily duties.

It is the duty of a school principal to

"refuse admission to the school of any pupil who he believes is infested with or exposed to communicable diseases ... until furnished with a certificate of a medical officer of health or of a duly qualified medical practitioner ..."

As principal of Father Moss Separate School, I have sent a form (enclosed) home with every pupil who I believed to have been infested with head lice.

AMENDMENT 11/76

MEMORANDUM OF AGREEMENT made this 23rd DAY OF May 1973.

BETWEEN: HER MAJESTY THE QUEEN in right
of Canada hereinafter called
'Her Majesty'

OF THE FIRST PART

AND KENORA SEPERATE SCHOOL BOARD, in the
Province of Ontario, hereinafter
called 'the Board'

OF THE SECOND PART

WHEREAS the Board has agreed to provide the accommodation described in this Agreement, which accommodation is necessary for the education of Indian children and to accept Indian children for enrolment in the Father Moss School;

WHEREAS the Board estimates the cost of providing that accommodation will be \$80,000.00 including construction and equipment.

NOW THIS AGREEMENT WITNESSES that, in consideration of the covenants and agreements hereinafter contained, the parties covenant and agree that:

1. In this Agreement
 - (a) 'Minister' means the Minister of Indian Affairs and Northern Development,
 - (b) 'present accommodation' means the school as it exists at the time this Agreement is executed,
 - (c) 'New Accommodation' means school facilities, including equipment, not in existence at the time this agreement is executed, and
 - (d) 'School' means the Father Moss School.
2. The Board shall admit to the School up to the total number of Indian children mentioned in section 3 and provide the following new accommodation; namely, a sewerage disposal system, construction to be commenced on or before the 15th day of June, 1973, and the Board to furnish the Minister with a copy of the construction contract as soon as it has been executed.

. . . 2

3. The Board shall accept up to 184 Indian pupils in the school in each school year during which this Agreement remains in force and shall provide each such pupil with the educational services suited to his needs.
4. Her Majesty shall pay to the Board \$ N/A in respect of the acceptance by the Board of Indian children into the present accommodation, this figure arrived at by taking the figure of \$ N/A as the total cost of the construction of the present accommodation less N/A % depreciation for each of the N/A years since that accommodation was built, multiplied by N/A / N/A, N/A being the maximum number of Indian children whom the parties agree the Board shall be required to accept into the present accommodation, and N/A being that maximum number added to the maximum number of non-Indian children whom the parties anticipate will be accepted into the present accommodation, and the lesser of \$73,600.00 or 184/200ths of the actual cost to the Board of the new accommodation mentioned in section 2.
5. Her Majesty shall, on the execution of this Agreement, pay to the Board the sum of \$ N/A which She is required by section 4 to pay for the acceptance of Indian children into the present accommodation and shall pay to the Board the amount which She is required by section 4 to pay towards the cost of the new accommodation as follows:
 - (a) thirty per cent upon receipt by the Minister of a copy of the construction contract referred to in section 2,
 - (b) thirty per cent upon receipt by the Minister, in a form satisfactory to him, of written proof of payment by the Board of fifty per cent of the total contract price of the new construction referred to in section 2,
 - (c) thirty per cent upon receipt by the Minister of a certificate in a form satisfactory to him of the completion of the construction referred to in section 2, and
 - (d) the balance upon receipt by the Minister of an audited statement in a form satisfactory to him of the total cost of that new accommodation.
6. Either party may terminate this Agreement at the end of any school year by giving written notice of termination to the other party at least twelve months before the date of termination.

. . . 3

7. If the Board gives notice of termination pursuant to section 6 the Board shall within three months after it has given that notice repay to the Minister an amount equal to the payment made to the Board by the Minister under section 4 reduced by one-twenty-fifth (1/25) of that amount for each full year that this Agreement will have been in force at the time that notice of termination is given.

8. The Minister may

- (a) postpone the date by which the Board is required by section 7 to make the repayment mentioned in that section.
- (b) allow the Board to make that repayment in installments, or
- (c) both postpone that date and allow repayment in installments.
- (d) enter into negotiations with the Board regarding alternative arrangements for compensation satisfactory to the Minister.

IN WITNESSES WHEREOF the Minister of Indian Affairs and Northern Development has hereunto set his hand and seal on behalf of Her Majesty in right of Canada and the Board has executed this Agreement by the hands and seals of its proper officers duly authorized in that behalf.


Dear Gordon:


Dear Sirs:

We are enclosing two photo-copies of a letter which we have received from Northwestern Health Unit, signed by Dr. P.F. Playfair, Medical Officer of Health.

Dr. Playfair says that in order for Father Moss School to remain open for the remainder of the current school year, the septic tank must be pumped daily or as required. We have already begun to have the tank pumped on a regular basis, but our funds and our expenditure ceilings will not allow us to continue with this practice for any appreciable length of time. We therefore request written permission from you to bill your Department for this item over and above tuition costs.

Dr. Playfair also says that in order for the school to re-open in September, a new and adequate system must be designed, approved and constructed. From conversations with him, we believe that he has no intentions of changing his mind or of allowing any extension in the time he has allowed. As you know, we had certain engineering studies done which indicate that a treatment plant is the best solution. This system must yet be designed and approved and tenders must be called. About six weeks are needed for actual construction after all the preliminary work has been completed. We must hear from your Department within a matter of days if we are to meet the September 1st deadline.

MEMORANDUM OF AGREEMENT MADE THIS 16th DAY OF March 1964
BETWEEN:

HER MAJESTY THE QUEEN in right of Canada
represented herein by the Minister of
Citizenship and Immigration, hereinafter
called "the Minister"

OF THE FIRST PART

AND

THE SIOUX NARROWS BOARD OF CATHOLIC
SCHOOL TRUSTEES in the Province of
Ontario, hereinafter called "the Board"

OF THE SECOND PART

WHEREAS the parties hereto entered into a written agreement dated March 10th, 1962, whereby the Board, in consideration of a contribution of \$86,026, made to it by the Minister towards the cost of construction of the Father Moss School, Sioux Narrows, Ontario, agreed to accept each year eighty (80) children of Indian status for enrolment in the said school;

WHEREAS the Board has made certain additions to the said school at an estimated cost of \$50,000, and the Minister has agreed to pay to the Board towards the cost of these additions, the sum of \$29,000; and

WHEREAS the Board has agreed to accept for enrolment each year in the Father Moss School, Sioux Narrows, Ontario, under its jurisdiction and control (hereinafter called the "school") an additional 35 Indian pupils residing on the Whitefish and Sabaskong Reserves.

NOW THIS AGREEMENT WITNESSETH that the parties hereto hereby covenant and agree each with the other as follows:

1. The Board shall

- (a) accept for enrolment each year in the school, those children of Indian status who are designated by the Superintendent of the Kenora Agency for enrolment, but the Board shall not be required to accept for enrolment more than 115 children of Indian status in any one year;

- 2 -

- (b) ensure that there will be no segregation in the school by reason of race or colour; and
- (c) quarterly forward to the Minister a statement of tuition fees to be paid with respect to the Indian children in attendance at the school.

2. The Minister shall

- (a) pay to the Board the sum of \$29,000, payable as follows:
Two-thirds of such share on the execution of this agreement and the balance of the share to be paid on presentation of evidence of progress of work or completion of the project to the satisfaction of the Minister;
- (b) endeavour to ensure the regular attendance of the Indian children at the school;
- (c) endeavour to maintain a standard of health, cleanliness and clothing among the Indian children attending the school comparable to that of the non-Indian children attending the school; and
- (d) pay to the Board tuition fees for each Indian child in attendance at the school, but the amount of the tuition fee charged shall not exceed the net average cost per child in operating the school.

3. Nothing contained in this agreement shall confer on the Minister any right to supervision over the curriculum, the administration and teaching personnel, the methods or materials of instruction or management generally of the school; provided the Minister or any person authorized by the Minister shall have the right to visit the school from time to time.

4. The parties hereto hereby release each other from the covenants and agreements set forth in the agreement dated March 10th, 1962, and this agreement is hereby substituted therefor. All rights and duties arising under the said agreement dated March 10th, 1962, shall be governed by this agreement.

HER MAJESTY THE QUEEN in right of Canada represented herein by the Minister of Indian Affairs and Northern Development hereinafter called "the Minister".

OF THE FIRST PART

AND

THE KENORA DISTRICT ROMAN CATHOLIC SEPARATE SCHOOL BOARD, in the Province of Ontario hereinafter called "the Board"

OF THE SECOND PART

WHEREAS the parties hereto entered into previous written Agreements:

- (a) Agreement No. 136 - dated March 10, 1962 on behalf of 80 Indian pupils at a cost of \$95,008.00 to the Department
- (b) Agreement No. 194 - dated March 16, 1964 on behalf of an additional 35 Indian pupils at a cost of \$35,446.76 to the Department.
- (c) Agreement No. 323 - dated February 8, 1967 at a cost of \$6,268.71 to the Department.

AND WHEREAS the Board is renovating classroom accommodation in order to provide improved facilities for its kindergarten programme and is remodelling two teacherages at the Father Moss School at an estimated cost of \$22,000.00.

AND WHEREAS the enrolment will be 174 Indian pupils in a total enrolment of 200 in the School.

NOW THIS AGREEMENT WITNESSETH that the parties hereto hereby covenant and agree each with the other as follows:

1. The Minister shall pay to the Board $174/200$ ths x \$22,000.00 an amount not to exceed \$19,140.00 under this Agreement.
2. The contribution referred to above shall be paid as follows:

One-third on presentation of evidence that a contract has been awarded and the balance of the cost to be paid on presentation of progress of work or completion of the project to the satisfaction of the Minister.

3. The Minister shall pay to the Board a tuition fee for each registered Indian child (subject to the provision of Section 4 (3) of the Indian Act) in attendance at the School.

The Board shall,

- (a) arrange forthwith for the agreed upon accommodation, and
 - (b) forward to the Minister upon completion of the construction of the School an audited statement of expenditures.
5. The Board shall accept up to 174 Indian pupils in the Father Moss School at the commencement of each school year and shall make every effort to provide an educational program suited to their needs.
 6. The Board will make every effort to involve the Indian community in School affairs and encourage active participation of Indian parents in the education of their children.
 7. Nothing in this agreement shall confer on the Minister any right of supervision over the curriculum, the administration and teaching personnel, the methods or materials of instruction or management generally of the School, provided the Minister or any person authorized by the Minister shall have the right to visit the School from time to time.
 8. The parties hereto release each other from the covenants and agreements set forth in Agreement No. 136, dated March 10, 1962 and Agreement No. 194 dated March 16, 1964 and Agreement No. 323, dated February 8, 1967 and this Agreement is substituted therefor. All rights and duties arising from Agreement No. 136 dated March 10, 1962, and Agreement No. 194, dated March 16, 1964, and Agreement No. 323, dated February 8, 1967 shall be governed by this Agreement.



either living with their mothers on a reserve or with
friends or relatives on a reserve.

- ii) illegitimate non-Indian children of Indian mothers, either living with their mothers on a reserve or with friends or relatives on a reserve.
 - iii) non-Indian children whose mother became Indian by marriage and who live on a reserve.
 - iv) non-Indian children legally adopted by Indian families and living on a reserve with the adoptive parents;
- (b) "Tuition fee" means a per pupil fee paid annually to the Board for each Indian pupil enrolled in the elementary and secondary schools operated by the Board.
- (c) "Minister" means the Minister of Indian Affairs and Northern Development.
2. Her Majesty shall pay to the Board an annual tuition fee for each Indian child and the basic fee shall be calculated as follows:
- (a) For those Indian children attending elementary schools, the fee shall be the total cost of operation of the elementary schools excluding costs related to the amortization of capital expenditures divided by the total enrolment of all children in attendance at the elementary schools;
AND
 - (b) Where the number of students permitted to enrol exceeds the total number of spaces purchased under joint school agreements, part a(a) shall apply and amortization of capital expenditures shall be included.
AND
 - (c) where negotiations between the parties hereto have resulted in the provision of special education services (Part 5) for Indian children and where the Board has incurred additional costs to provided such services Her Majesty shall pay to the Board an amount based upon the terms outlined for such services in Sections 5(8) and 5(9) upon receipt of a certified statement.
3. Her Majesty shall pay tuition fees as described in Section 2 as follows:
- i) On September 30th an amount equal to 100% of the tuition fee for the months of September, October, November and December at the previous year's per capital rate multiplied by the current pupil enrolment.
 - ii) On January 31st an amount equal to 100% of the tuition fee for the months of January, February and March at the previous year's per capital rate multiplied by the current pupil enrolment.
 - iii) On April 30th an amount equal to 100% of the tuition rate for the months of April, May and June at the previous year's per capita rate multiplied by the current pupil enrolment.
 - iv) Notwithstanding the foregoing the tuition fee rate for the then current school year may be applied as and when such is established by the Board and is accepted by the Minister at which time adjustments will be made for prior payments as indicated under (i), (ii) and (iii). A financial schedule shall be submitted to the Minister not later than fifteen (15) days following receipt of an audited financial statement by the Board for any adjustments that may be required for payments previously made.
 - v) The financial schedule referred to in (iv) shall be accompanied by a certified list of Indian pupils enrolled by months in the school(s) administered by the Board.

In any instance where in order to provide for the enrolment of Indian children in any school administered by the Board, it is necessary to construct new facilities, expand existing facilities or carry out major renovations, the title to the building(s) being vested in the Board, Her Majesty will enter into a separate agreement for the sharing on a pro rata basis of the capital expenditures arising therefrom provided that ..
.. the Band Council pass a Band Council Resolution indicating the Band's concurrence and provide the other parties hereto with a copy of the Band Council Resolution.

5. (11) These services to be provided by the Board and in return for these special services for Indian students Her Majesty shall pay to the Board an amount equal to the cost of such services on receipt of a certified statement outlining such costs.
- (A) Emergency taxi service to homes on the reserves where in the opinion of the principal or nurse the illness or accident is considered to warrant home care.
 - (B) Special articles of clothing, materials and equipment where required for such activities as gymnasium classes, home economics and industrial arts - in all cases parents must be given the opportunity to provide for the needs of their children and only where need is established should the school authorities provide such materials - a school inventory and supply should be maintained for carry over use of gym suits and shoes where provided by the Department of Indian Affairs and Northern Development.
 - (C) School lunches (at a per pupil rate subject to negotiation prior to September 1st each year or at the rate in effect the previous year.)
5. (12) The Father Moss United School Council which exists at present as an advisory committee to the Board on matters pertaining to Father Moss School and which represents the interests of the Indian Bands from which Indian students attend Father Moss School and the citizens of Sioux Narrows whose children attend Father Moss School, shall be recognized by the Board as an advisory committee the formation and purpose of this committee to be and include the following:
- A) The committee or council shall consist of 8 members:
 - (1) Five members shall be Indian representatives.
 - (2) Three members shall be from the community of Sioux Narrows.
 - (3) One of the five people in clause (a) shall be the Indian representative to the Board.
 - (4) One of the three people in clause (b) shall be the elected School Board member for the community of Sioux Narrows.
 - B) The chairman of the committee shall be a non-Board member and the chairmanship shall alternate annual between the Indian membership and the Xioux Narrows membership.
 - C) The Father Moss School principal and the Band's Social Counsellor shall be non voting invited guests at all meetings unless notified otherwise prior to a given meeting.
 - C) This committee shall hold meetings at the call of the chair, or on written request of two members of the committee and the chairman will have the right to present to the Board the recommendations of the committee in matters affecting the welfare of students attending Father Moss School. These matters which could affect the students welfare, the following

- (1) the responsibility to make the recommendations for items 5; 6; 7; 10 a, b, c, d; as listed in part 5.
- (2) It is understood that the four Bands concerned in this agreement have or will be employing, at cost to Her Majesty, full or part time social counsellors whose services shall be available to Indian students attending Father Moss School. These counsellors shall liaise with the appropriate educational staff of the Board and Her Majesty.

AND

other programs that the Department shall from time to time approve.

- 6. The Board shall make every effort to involve the Indian Community in school affairs and encourage active participation of Indian parents in the education of their children.

AND

The Board shall continue its present practice of accepting as a member of the Board a representative of the Bands selected by the Bands, such selection will be made in whatever manner the Bands may choose (i.e. election, appointment by Band Council, appointment by the school committee, etc.) and this trustee will have full voting powers.

- 7. (a) The Board shall retain jurisdiction over the administration, control and operation of the school(s) in which Indian children are enrolled under the terms of this agreement, including the supervision of teaching personnel and all matters related to the curriculum, methods of instruction and material used for instruction.
- (b) Nothing in the preceding clause precludes the right of Indian parents to exercise an interest in the educational matters of the schools attended by their children.
- (c) Education officials representing the Minister and the Band may, with the knowledge and approval of the Board assist in planning, developing or improving a cross-cultural educational program suited to the needs of Indian children and any person authorized by Her Majesty shall have the right to visit the school from time to time.

- 8. All notices or communications required to be given or sent under the terms of this agreement shall be deemed to be sufficiently given or sent if mailed or sent by telegram to the recipient party.

THIS AGREEMENT shall come into force on September 1st, 19___ and shall remain in force from year to year unless:

- (a) renegotiation is requested by any of the parties hereto in which case such request must be made by February 1st, of the then current school year and the renegotiations must be completed by May 1st, of the then current school year.
- (b) termination is requested by any party hereto, in which case such request must be made by January 1st, of the then current school year and be effective June 30th, of the school year following the then current school year.

(c) cancellation or termination of this agreement will automatically cancel or terminate any finalized related Capital Agreement referred to in section 4 of this agreement.

- D) Instruction in Indian life, government, history and culture.
 - E) Attendance counsellors approved by any of the four Band Councils.
5. (11) These services to be provided by the Board and in return for these special services for Indian students Her Majesty shall pay to the Board an amount equal to the cost of such services on receipt of a certified statement outlining such costs.
- (A) Emergency taxi service to homes on the reserves where in the opinion of the principal or nurse the illness or accident is considered to warrant home care.
 - (B) Special articles of clothing, materials and equipment where required for such activities as gymnasium classes, home economics and industrial arts - in all cases parents must be given the opportunity to provide for the needs of their children and only where need is established should the school authorities provide such materials - a school inventory and supply should be maintained for carry over use of gym suits and shoes where provided by the Department of Indian Affairs and Northern Development.
 - (C) School lunches (at a per pupil rate subject to negotiation prior to September 1st each year or at the rate in effect the previous year.)
5. (12) The Father Moss United School Council which exists at present as an advisory committee to the Board on matters pertaining to Father Moss School and which represents the interests of the Indian Bands from which Indian students attend Father Moss School and the citizens of Sioux Narrows whose children attend Father Moss School, shall be recognized by the Board as an advisory committee the formation and purpose of this committee to be and include the following:
- A) The committee or council shall consist of 8 members:
 - (1) Five members shall be Indian representatives.
 - (2) Three members shall be from the community of Sioux Narrows.
 - (3) One of the five people in clause (a) shall be the Indian representative to the Board.
 - (4) One of the three people in clause (b) shall be the elected School Board member for the community of Sioux Narrows.
 - B) The chairman of the committee shall be a non-Board member and the chairmanship shall alternate annual between the Indian membership and the Xioux Narrows membership.
 - C) The Father Moss School principal and the Band's Social Counsellor shall be non voting invited guests at all meetings unless notified otherwise prior to a given meeting.
 - C) This committee shall hold meetings at the call of the chair, or on written request of two members of the committee and the chairman will have the right to present to the Board the recommendations of the committee in matters affecting the welfare of students attending Father Moss School. These matters which could affect the students welfare, the following

I refer to the exchange of correspondence on the above project and, to a telephone conversation with Mr. Foss in which he explained to me the difficult situation he was in as a result of my letter of May 5 concerning our contribution to this school. It is most unfortunate that Mr. Foss did not inform me specifically that the teachers quarters to be attached to the school were exempt from provincial grant, since he knew this to be so and of course, I was remiss in not asking this question directly.

It is generally assumed by the party providing teachers quarters that they will be revenue earning. Through the rental charged, the party will eventually recover all or part of the investment. If such is the case at the proposed joint school at Sioux Narrows the Board should not expect a contribution from the Federal Government towards the cost of the construction of the teachers quarters. If, on the other hand, these quarters are to be provided free of charge to the teachers this would be reflected in lower salaries for the teachers and lower operating costs for the school so that, indirectly, the investment in the teachers quarters would be recovered.

Would you please contact the School Board and investigate the arrangements that are to be made with respect to the rental of the teachers quarters or the recovery of rental equivalent through reduced salaries and what affect this will have on operating costs.

I should appreciate your report as soon as possible when you have met with the School Board.

MEMORANDUM OF AGREEMENT MADE THIS 10 DAY OF March 1962

BETWEEN:

HER MAJESTY THE QUEEN in right of Canada
represented herein by the Minister of

THE SIOUX NARROWS BOARD OF CATHOLIC SCHOOL
TRUSTEES in the Province of Ontario,
hereinafter called "the Board"

OF THE SECOND PART

WHEREAS the parties hereto have agreed to share the cost
of construction of a four-classroom school with utility room for
Indian and non-Indian children at Sioux Narrows in the Province of
Ontario, which school is to be known as the Father Ness School
(hereinafter called "the school");

WHEREAS the Board estimates that the cost of construction
of the school, including architects fees, site, landscaping,
furnishings and equipment, will be ONE HUNDRED AND SEVENTY-TWO THOUSAND
AND FIFTY-TWO (\$172,052) DOLLARS;

NOW THIS AGREEMENT WITNESSETH that the parties hereto
hereby covenant and agree each with the other as follows:

1. The Minister shall pay to the Board 50% of the cost of construction
of the school but the Minister's liability under this agreement
shall not exceed the sum of EIGHTY-SIX THOUSAND AND TWENTY-SIX
(\$86,026) DOLLARS.
2. The share of the cost of construction of the school payable
to the Board pursuant to paragraph 1 shall be paid as follows:
Two-thirds of such share on the execution of this
agreement and the balance of the share on receipt
by the Minister of an audited statement from the
Board setting forth the expenditures with respect
to the cost of construction of the school.

3. The Minister shall pay to the Board a tuition fee for each Indian child in attendance at the school but the tuition fee charged by the Board shall not exceed the net average cost per child in operating the school.
4. The Minister shall endeavour
 - (a) to ensure the regular attendance of the Indian children at the school, and
 - (b) to maintain a standard of health, cleanliness and clothing among the Indian children attending the school comparable to that of the non-Indian children attending the school.
5. The Board shall
 - (a) arrange forthwith for the construction of the school, and
 - (b) forward to the Minister, upon completion of construction of the school, an audited statement of expenditures with respect to the cost of construction of the school.
6. The Board shall accept for enrollment in the school, at the commencement of each school year, eighty Indian children residing on the Whitefish Bay and Schaebsong Reserves and shall provide to such children the same educational facilities and instruction as it provides to the non-Indian children.
7. The Board shall ensure that there will be no segregation in the school by reason of race or colour.
8. The Board shall quarterly forward to the Minister a statement of tuition fees to be paid with respect to the Indian children attending the school.
9. Nothing in this agreement shall confer on the Minister any right of supervision over the curriculum, the administration and teaching personnel, the methods or materials of instruc-

Dear sir,

We the undersigned at a meeting legally convened at the Sabaskong Indian School on the evening of April 4, 1962 at 7:30 p.m. decided the following items and secured signatures enclosed to verify these decisions-

1. That when an earlier decision was taken regarding our school and pupils, there was a misrepresentation- namely that only a few persons signed and they were under the impression that the proposed new school at Sioux Narrows was for high school pupils only. The high school was emphasized and the people consulted were not fully acquainted with the English Language. Had it been put to them in our native language no such decision would have been made.

2. We also decided that we wish to have our children taught on the reserve, under our supervision, where Pagans, Protestants and Catholics share the modern school we have, which is well equipped with good teachers who have worked hard to obtain the present standard and enrollment. We feel that the children should be with us at home, share in our family life, and live in our environment in an Indian atmosphere.

We feel also that since most of us go trapping and guiding, we know our wives will see to our children at home where they share a mother's love and care. We feel that a school 40 miles away is not workable as the children would not be able to meet an early bus in sub-zero weather.

We feel also that the harmony now existing in this non-denominational school should persist as it is now and this we desire as parents and according to the Indian Act, paragraph II7.

3. We also decided that the custom which we have of sending our high school pupils to the Fort Francis Collegiate should continue as already agreed with the Indian Affairs Branch. We are aware of the futility of sending pupils to a school 40 miles away for one or two years and then have to eventually send them to Fort Francis for the completion of Grades II to 13. We feel that these decisions are the best for our children.

I refer to the exchange of correspondence on the above proposal. In my letter to you of March 22 I pointed out that the school plans would have to meet the requirements of the Department of Education before we could enter into agreement with the Sioux Narrows Separate School Board.

You expressed some dubiety about the teachers quarters in the plans submitted to this office. I am now informed by the Ontario Department of Education that the grant-earning portion of the school consists only of the classrooms and the playroom, the maximum cost of which is not to exceed \$60,000. Since the contribution of the Department can only be made on public school buildings approved by the Provincial Government, I have to inform you that our contribution can only be a portion of the \$60,000, and not, as earlier stated before the complete data was available, \$137,300.

Would you please inform the Board and advise me of their decision with respect to the joint school under these circumstances.

3. The Minister shall pay to the Board a tuition fee for each registered Indian child (subject to the provision of Section 4 (3) of the Indian Act) in attendance at the School.

That the Department of Indian Affairs and Northern Development make a commitment in writing to enter into a joint school agreement on a shared basis of 235/270ths of a building program mutually agreed upon by the Indian Bands whose children attend Father Moss School, the Kenora District Roman Catholic Separate School Board and the Department of Indian Affairs and Northern Development.
- 2. That in addition to this written commitment the Department of Indian Affairs and Northern Development make available at least \$50,000 as their share of capital costs absorbed in the past three years at Father Moss School and for the 1973 capital expenditures the Board must incur for a new sewage disposal system.
- 3. That the Department of Indian Affairs and Northern Development give special consideration to the following conditions:
 - (a) the Board is quite small and cannot finance an immediately needed (delayed a year already) sewage treatment plant;
 - (b) over 90% of the enrolment in this school is Indian;
 - (c) the Ontario Ministry of Education will give no approvals or allow debenture sale without a definite commitment from D.I.A.N.D.

The above figures do not include items such as audio visual and instructional equipment which costs have been included in your annual billings for tuition fees.

According to information supplied to us by Mr. P.C. Clarkin, during his term of office with you, your Department had paid \$142,517.00 prior to December 31, 1968 toward the cost of assets to that date based on an agreement to educate 115 Indian pupils. Since amalgamation on January 31, 1969, we have billed you \$21,773.97 on joint school agreement #522 which was based on the fraction of 174/200 of the cost of converting the manual arts building to classroom space and of remodelling teacherage accommodation.

According to surveys we have taken, the enrolment of Indian pupils will increase and the enrolment of Non-Indian pupils will remain stable with the possibility of a slight deduction.

An architect's estimate of the cost of the proposed addition was \$282,307.00. This estimate was done more than two years ago. It was based on a set of preliminary sketch plans which we hope to have changed substantially and it did not include the cost of a sewage treatment plant.

Some changes which should be considered are:

- inclusion of an approved kindergarten classroom together with related additional shelving and washroom facilities.
- inclusion of a cafeteria to replace the existing kitchen facilities and eliminate the use of the gym as a lunchroom.
- inclusion of an industrial arts shop and home economics room.
- an outside entrance to the library resource centre and related changes for the purpose of community use of the library.
- inclusion of showers.

We are enclosing a copy of a memo to our Mr. C. Morris outlining the need for the addition to the school.

The most urgent problem at the present time is the septic field which must be replaced by a sewage treatment plant this summer if we are to avoid having the school closed next winter by the health authorities. This problem was thoroughly explained in our letter of May 4, a copy of which is attached. A copy of the architects cost estimates which were sent to you on May 4, 1972, together with the engineering study is enclosed. The estimate of the cost of a sewage treatment plant made one year ago was \$55,000.00 excluding required plumbing revisions.

As we understood it, your Department will not enter into any joint school agreements until a tuition fee agreement has been signed. Our Board is willing to commit itself to signing such an agreement but we will require more time to study the proposed draft that you sent to us. The problem is that the sewage treatment plant cannot wait - it must be undertaken at once and our Board cannot finance such a project on its own. We cannot sell a debenture without Ontario government approval and such approval will not be forthcoming without a specific commitment from your Department because the school is mainly Indian in population.

We shall be pleased to furnish any additional information which may be required.

The following is the case that we have made with both the Department of Indian Affairs and the Department of Education for the proposed addition:

1. Regular classroom space -

- (a) Projections indicate that there will be an increase in enrolments.
- (b) Temporary classroom space is now overcrowded, removed from the rest of the school program and does not measure up to the Fire Marshal's requirements.

2. Kindergarten classroom -

The proposal calls for a classroom especially built and equipped for this purpose. The existing room is classified as sub-standard and was not originally built as classroom space.

3. Junior Kindergarten classroom -

The proposal also calls for a classroom especially built and equipped for this purpose. Educators believe that many learning problems can be avoided through such a program.

4. Library resource center -

Modern trends in education toward pupils doing their own learning through research, the use of audio visual equipment, etc. make a resource center more of a necessity than a luxury as it was in the past.

5. Kitchen facilities -

Inadequate because they were not built for the present enrolment. Should be cafeteria style to make for less disorganization at lunch time. Tables being located in the gym restrict the use of the gym for its intended purpose, namely that of carrying on a physical education program. (also the safety factor of the present system)

The sewer line from the teacherage had to be opened just below the building and raw sewage allowed to flow down a hill under the snow for several months. Because of our still limited space as living accommodations, we have been restricted to local residents who have their own housing for such items as cooking, attendance counselling and caretaking. Anyone hired from outside of Sioux Narrows will require housing. We have not been satisfied with the services provided by some of these people. We could undoubtedly have solved our noon lunches problem if additional housing had been available.

Also since our last agreement we have had to spend some \$3,500. on electrical work in the school. An inspection by a qualified electrician revealed that the wiring was unsafe and would probably be condemned if inspected by the Ontario Hydro. The electrician says that the lighting in the school is sub-standard and will require replacing which could be done when an addition is built.

Our Board recognizes that your Department has contributed heavily over the years, and we have always appreciated your co-operation. We would like your Department to recognize, when being asked to share costs by our Board, that our Board inherited the Father Moss complex on January 1, 1969 long after the damage had been done that we have set out to correct. Examples of the "damage" are poorly constructed teacherage buildings with rotting roofs and without foundations, improperly installed electrical and plumbing facilities, buildings that had not been painted for years and therefore had rotting window and door sills, etc. The list seems to get longer as we do more work.

In view of the urgency of the sewage disposal situation, would it be possible for us to enter into a separate joint-school agreement for this and some of the other items that we have mentioned.

Earlier I forwarded a rough draft for a tuition agreement at Father More which omitted part 5. I have now held discussions with the four Bands and attach copies of a tuition agreement as proposed by the Bands and which is forwarded with their consent for the consideration of the Board. Part 10 of section 5 dealing with shared costs of some special services has been left blank as to the percentage. It is our opinion that the Board, system and non-Indian students at Father More will benefit from these services as well as the Indian students and therefore this part has been left open to negotiation. We are aware of the approximate percentage of students at the present time but are also aware this could go either way and that the Board's overall system benefit beyond the actual percentage of students. I am rushing this draft in the hope of making the deadline of your February Board meeting. After the Board has had a chance to read and discuss the proposed agreement, I would be free to discuss it further.

TUITION AGREEMENT

THIS AGREEMENT made this _____ day of _____ 19 _____

BETWEEN: Kenora District Roman Catholic
Separate School Board
in the Province of Ontario
Hereinafter called "the Board".

OF THE FIRST PART

AND

THE INDIANS OF
Whitefish Bay Band
Sabaskong Band

as represented by the Chief and Council,
hereinafter called "the Bands"

OF THE SECOND PART

AND

HER MAJESTY THE QUEEN in right of Canada,
hereinafter called "Her Majesty".

OF THE THIRD PART

AND WHEREAS pursuant to Section 114 (I) of the Indian Act,
R.S.C. 1952, Ch. 149 The Minister of Indian Affairs and Northern Development
may enter into an agreement with the Board.

AND WHEREAS pursuant to Sections 37 (1, 2, & 3) and 72 of The
Schools Administration Act of the Province of Ontario, the Board may enter
into an agreement with Her Majesty the Queen respecting the Education of
Indian Children.

NOW, THEREFORE, THIS AGREEMENT WITNESSETH that the parties
hereto covenant and agree with each other as follows:

- 1. (a) Unless the context otherwise requires, in this Agreement
"Indian Child" means child of an Indian as defined in
the Indian Act (Canada), and includes
 - 1) non-Indian children of women of former Indian status
who return to reserves because of the desertion or
death of their husbands, or for other good reasons,
either living with their mothers on a reserve or with
friends or relatives on a reserve.

- ii) illegitimate non-Indian children of Indian mothers, either living with their mothers on a reserve or with friends or relatives on a reserve.
 - iii) non-Indian children whose mother became Indian by marriage and who live on a reserve.
 - iv) non-Indian children legally adopted by Indian families and living on a reserve with the adoptive parents;
- (b) "Tuition fee" means a per pupil fee paid annually to the Board for each Indian pupil enrolled in the elementary and secondary schools operated by the Board.
- (c) "Minister" means the Minister of Indian Affairs and Northern Development.
2. Her Majesty shall pay to the Board an annual tuition fee for each Indian child and the basic fee shall be calculated as follows:
- (a) For those Indian children attending elementary schools, the fee shall be the total cost of operation of the elementary schools excluding costs related to the amortization of capital expenditures divided by the total enrolment of all children in attendance at the elementary schools;
AND
 - (b) Where the number of students permitted to enrol exceeds the total number of spaces purchased under joint school agreements, part a(a) shall apply and amortization of capital expenditures shall be included.
AND
 - (c) where negotiations between the parties hereto have resulted in the provision of special education services (Part 5) for Indian children and where the Board has incurred additional costs to provided such services Her Majesty shall pay to the Board an amount based upon the terms outlined for such services in Sections 5(8) and 5(9) upon receipt of a certified statement.
3. Her Majesty shall pay tuition fees as described in Section 2 as follows:
- i) On September 30th an amount equal to 100% of the tuition fee for the months of September, October, November and December at the previous year's per capital rate multiplied by the current pupil enrolment.
 - ii) On January 31st an amount equal to 100% of the tuition fee for the months of January, February and March at the previous year's per capital rate multiplied by the current pupil enrolment.
 - iii) On April 30th an amount equal to 100% of the tuition rate for the months of April, May and June at the previous year's per capita rate multiplied by the current pupil enrolment.
 - iv) Notwithstanding the foregoing the tuition fee rate for the then current school year may be applied as and when such is established by the Board and is accepted by the Minister at which time adjustments will be made for prior payments as indicated under (i), (ii) and (iii). A financial schedule shall be submitted to the Minister not later than fifteen (15) days following receipt of an audited financial statement by the Board for any adjustments that may be required for payments previously made.
 - v) The financial schedule referred to in (iv) shall be accompanied by a certified list of Indian pupils enrolled by months in the school(s) administered by the Board.

....3

In any instance where in order to provide for the enrolment of Indian children in any school administered by the Board, it is necessary to construct new facilities, expand existing facilities or carry out major renovations, the title to the building(s) being vested in the Board, Her Majesty will enter into a separate agreement for the sharing on a pro rata basis of the capital expenditures arising therefrom provided that ..

.. the Band Council pass a Band Council Resolution indicating the Band's concurrence and provide the other parties hereto with a copy of the Band Council Resolution.

5. The Board shall accept for enrolment in its school, Indian children from the Bands and in addition to the program of studies for the Province of Ontario, shall provide for, or in respect of, the Indian children and the Bands the following services to the extent agreed upon by the parties to this agreement.
 - (1) All pupils of Whitefish Bay, Sabaskong and Northwest Angle Bands registered for classes in Father Moss School shall be enrolled in Father Moss School and the Board shall not transfer pupils resident on these reserves to any other school without the approval of the parents.
 - (2) The Board agrees that preference shall be given to Indian teachers in the matter of staff appointments to Father Moss School provided that qualifications and ability are judged to be equal.
 - (3) The Board will make recreational facilities at Father Moss School available to Indian groups for after school functions according to Board procedures and policy.
 - (4) Any equipment purchased as part of a capital sharing agreement for Father Moss School should remain use at this school unless otherwise approved by the Indian Bands
 - (5) The Board shall forward notices to the Whitefish Bay and Sabaskong office regarding employment possibilities for maintenance, janitorial, secretarial, construction, general labour, lunch or playground staff.
 - (6) The Board shall encourage teaching staff to engage in inter cultural studies through in-service training and summer courses to promote greater understanding of Indian students and thereby help the teachers in their understanding with the students.
 - (7) The inclusion of suitable course content providing information about and alerting the students as to the dangers of alcohol, gas and glue sniffing and hallucinatory drugs.
 - (8) Assiduous attention to the health and asychological services to answer the needs of Indian children.
 - (9) At the parents' request children will be excused from religious instruction or practices.
 - (10) These services to be provided by the Board and in return for these special services for Indian students Her Majesty shall pay to the Board an amount equal to per cent of the cost of such services on receipt of a certified statement outlining such costs.
 - A) An Indian primary classroom aide and a general classroom aide if suitable persons are available.
 - B) Training, as a second language, in either Ojibway or English at the recommendation of the Father Moss United School Council and within the provincial school legislation.
 - C) A library of books and materials related to Indian life and culture for research and recreational reading.

- D) Instruction in Indian life, government, history and culture.
 - E) Attendance counsellors approved by any of the four Band Councils.
5. (11) These services to be provided by the Board and in return for these special services for Indian students Her Majesty shall pay to the Board an amount equal to the cost of such services on receipt of a certified statement outlining such costs.
- (A) Emergency taxi service to homes on the reserves where in the opinion of the principal or nurse the illness or accident is considered to warrant home care.
 - (B) Special articles of clothing, materials and equipment where required for such activities as gymnasium classes, home economics and industrial arts - in all cases parents must be given the opportunity to provide for the needs of their children and only where need is established should the school authorities provide such materials - a school inventory and supply should be maintained for carry over use of gym suits and shoes where provided by the Department of Indian Affairs and Northern Development.
 - (C) School lunches (at a per pupil rate subject to negotiation prior to September 1st each year or at the rate in effect the previous year.)
5. (12) The Father Moss United School Council which exists at present as an advisory committee to the Board on matters pertaining to Father Moss School and which represents the interests of the Indian Bands from which Indian students attend Father Moss School and the citizens of Sioux Narrows whose children attend Father Moss School, shall be recognized by the Board as an advisory committee the formation and purpose of this committee to be and include the following:
- A) The committee or council shall consist of 8 members:
 - (1) Five members shall be Indian representatives.
 - (2) Three members shall be from the community of Sioux Narrows.
 - (3) One of the five people in clause (a) shall be the Indian representative to the Board.
 - (4) One of the three people in clause (b) shall be the elected School Board member for the community of Sioux Narrows.
 - B) The chairman of the committee shall be a non-Board member and the chairmanship shall alternate annual between the Indian membership and the Sioux Narrows membership.
 - C) The Father Moss School principal and the Band's Social Counsellor shall be non voting invited guests at all meetings unless notified otherwise prior to a given meeting.
 - C) This committee shall hold meetings at the call of the chair, or on written request of two members of the committee and the chairman will have the right to present to the Board the recommendations of the committee in matters affecting the welfare of students attending Father Moss School. These matters which could affect the students welfare, the following

- (1) the responsibility to make the recommendations for items 5; 6; 7; 10 a, b, c, d; as listed in part 5.
- (2) It is understood that the four Bands concerned in this agreement have or will be employing, at cost to Her Majesty, full or part time social counsellors whose services shall be available to Indian students attending Father Moss School. These counsellors shall liaise with the appropriate educational staff of the Board and Her Majesty.

other programs that the Department shall from time to time approve.

6. The Board shall make every effort to involve the Indian Community in school affairs and encourage active participation of Indian parents in the education of their children.

The Board shall continue its present practice of accepting as a member of the Board a representative of the Bands selected by the Bands, such selection will be made in whatever manner the Bands may choose (i.e. election, appointment by Band Council, appointment by the school committee, etc.) and this trustee will have full voting powers.

 - (a) The Board shall retain jurisdiction over the administration, control and operation of the school(s) in which Indian children are enrolled under the terms of this agreement, including the supervision of teaching personnel and all matters related to the curriculum, methods of instruction and material used for instruction.
 - (b) Nothing in the preceding clause precludes the right of Indian parents to exercise an interest in the educational matters of the schools attended by their children.
 - (c) Education officials representing the Minister and the Band may, with the knowledge and approval of the Board assist in planning, developing or improving a cross-cultural educational program suited to the needs of Indian children and any person authorized by Her Majesty shall have the right to visit the school from time to time.
8. All notices or communications required to be given or sent under the terms of this agreement shall be deemed to be sufficiently given or sent if mailed or sent by telegram to the recipient party.

THIS AGREEMENT shall come into force on September 1st, 19____ and shall remain in force from year to year unless:

- (a) renegotiation is requested by any of the parties hereto in which case such request must be made by February 1st, of the then current school year and the renegotiations must be completed by May 1st, of the then current school year.
- (b) termination is requested by any party hereto, in which case such request must be made by January 1st, of the then current school year to be effective June 30th, of the school year following the then current school year.

(c) cancellation or termination of this agreement will automatically cancel or terminate any finalized related Capital Agreement referred to in section 4 of this agreement.

Earlier I forwarded a rough draft for a tuition agreement at Father Mass which omitted part 5. I have now held discussions with the four Bands and attach copies of a tuition agreement as proposed by the Bands and which is forwarded with their consent for the consideration of the Board. Part 10 of section 5 dealing with shared costs of some special services has been left blank as to the percentage. It is our opinion that the Board, system and non-Indian students at Father Mass will benefit from these services as well as the Indian students and therefore this part has been left open to negotiation. We are aware of the approximate percentage of students at the present time but are also aware this could go either way and that the Board's overall system benefit beyond the actual percentage of students. I am rushing this draft in the hope of making the deadline of your February Board meeting. After the Board has had a chance to read and discuss the proposed agreement, I would be free to discuss it further.

In any case, we expect to receive your bill as soon as the matter
is settled one way or another.

We had another meeting attended by the Department of Indian Affairs,
the various Band Councils, etc. The Father Moss addition appears to
be still very much alive, but further progress will depend on Indian
Affairs as we have done all we can to this point. It appears that
there will be no Junior Kindergarten classroom in the addition as
the Indian people want this class conducted on the Reserve. It also
appears that there will be a kindergarten classroom, an industrial
arts shop and a home economics room, a library, a shower and change
rooms, a health room, a staff room, a principal's office and
secretary's office, as well as the regular classroom space and the
extension of the kitchen facilities. The library should be designed
with its own outside entrance for use as a community library. There
is a possibility that a cafeteria will be included so as to free the
gymnasium for its intended purpose. The regular classroom space may
be designed with open area features. Grades 9 and 10 will probably
not be included but the Indian Bands did ask at one time that they
be included. The sewage disposal plant will be included as will
the fill and landscaping required to provide adequate playground
space. The lighting in the existing building may all be changed
and included with the addition.



- (b) Nothing in the preceding clause precludes the right of Indian parents to exercise an interest in the educational matters of the schools attended by their children.
- (c) Education officials representing the Minister and the Band may, with the knowledge and approval of the Board assist in planning, developing or improving a cross-cultural educational program suited to the needs of Indian children and any person authorized by Her Majesty shall have the right to visit the school from time to time.

8. All notices or communications required to be given or sent under the terms of this agreement shall be deemed to be sufficiently given or sent if mailed or sent by telegram to the recipient party.

THIS AGREEMENT shall come into force on September 1st, 19__ and shall remain in force from year to year unless:

- (a) renegotiation is requested by any of the parties hereto in which case such request must be made by February 1st, of the then current school year and the renegotiations must be completed by May 1st, of the then current school year.
- (b) termination is requested by any party hereto, in which case such request must be made by January 1st, of the then current school year to be effective June 30th, of the school year following the then current school year.
- (c) cancellation or termination of this agreement will automatically cancel or terminate any finalized related Capital Agreement referred to in section 4 of this agreement.

TUITION AGREEMENT

THIS AGREEMENT made this _____ day of _____ 19 _____

BETWEEN: Kenora District Roman Catholic
Separate School Board
in the Province of Ontario
Hereinafter called "the Board".

OF THE FIRST PART

AND

THE INDIANS OF
Whitefish Bay Band
Sabaskong Band
Northwest Angle No. 37 Band
Northwest Angle No. 33 Band

as represented by the Chief and Council,
hereinafter called "the Bands".

OF THE SECOND PART

AND

HER MAJESTY THE QUEEN in right of Canada,
hereinafter called "Her Majesty".

OF THE THIRD PART

AND WHEREAS pursuant to Section 114 (I) of the Indian Act,
R.S.C. 1952, Ch. 149 The Minister of Indian Affairs and Northern Development
may enter into an agreement with the Board.

AND WHEREAS pursuant to Sections 37 (1, 2, & 3) and 72 of The
Schools Administration Act of the Province of Ontario, the Board may enter
into an agreement with Her Majesty the Queen respecting the Education of
Indian Children.

NOW, THEREFORE, THIS AGREEMENT WITNESSETH that the parties
hereto covenant and agree with each other as follows:

1. (a) Unless the context otherwise requires, in this Agreement
"Indian Child" means child of an Indian as defined in
the Indian Act (Canada), and includes
 - i) non-Indian children of women of former Indian status
who return to reserves because of the desertion or
death of their husbands, or for other good reasons,
either living with their mothers on a reserve or with
friends or relatives on a reserve.

- ii) illegitimate non-Indian children of Indian mothers, either living with their mothers on a reserve or with friends or relatives on a reserve.
 - iii) non-Indian children whose mother became Indian by marriage and who live on a reserve.
 - iv) non-Indian children legally adopted by Indian families and living on a reserve with the adoptive parents;
- (b) "Tuition fee" means a per pupil fee paid annually to the Board for each Indian pupil enrolled in the elementary and secondary schools operated by the Board.
- (c) "Minister" means the Minister of Indian Affairs and Northern Development.
2. Her Majesty shall pay to the Board an annual tuition fee for each Indian child and the basic fee shall be calculated as follows:
- (a) For those Indian children attending elementary schools, the fee shall be the total cost of operation of the elementary schools excluding costs related to the amortization of capital expenditures divided by the total enrolment of all children in attendance at the elementary schools;
- AND
- (b) Where the number of students permitted to enrol exceeds the total number of spaces purchased under joint school agreements, part a(a) shall apply and amortization of capital expenditures shall be included.
- AND
- (c) where negotiations between the parties hereto have resulted in the provision of special education services (Part 5) for Indian children and where the Board has incurred additional costs to provide such services Her Majesty shall pay to the Board an amount based upon the terms outlined for such services in Sections 5(8) and 5(9) upon receipt of a certified statement.
3. Her Majesty shall pay tuition fees as described in Section 2 as follows:
- i) On September 30th an amount equal to 100% of the tuition fee for the months of ~~September, October, November and~~ December at the previous year's per capita rate multiplied by the current pupil enrolment.
 - ii) On January 31st an amount equal to 100% of the tuition fee for the months of January, February and March at the previous year's per capita rate multiplied by the current pupil enrolment.
 - iii) On April 30th an amount equal to 100% of the tuition rate for the months of April, May and June at the previous year's per capita rate multiplied by the current pupil enrolment.
 - iv) Notwithstanding the foregoing the tuition fee rate for the then current school year may be applied as and when such is established by the Board and is accepted by the Minister at which time adjustments will be made for prior payments as indicated under (i), (ii) and (iii). A financial schedule shall be submitted to the Minister not later than fifteen (15) days following receipt of an audited financial statement by the Board for any adjustments that may be required for payments previously made.
 - v) The financial schedule referred to in (iv) shall be accompanied by a certified list of Indian pupils enrolled by months in the school(s) administered by the Board.

4. In any instance where in order to provide for the enrolment of Indian children in any school administered by the Board, it is necessary to construct new facilities, expand existing facilities or carry out major renovations, the title to the building(s) being vested in the Board, Her Majesty will enter into a separate agreement for the sharing on a pro rata basis of the capital expenditures arising therefrom provided that ...

... the Band Council pass a Band Council Resolution indicating the Band's concurrence and provide the other parties hereto with a copy of the Band Council Resolution.

5. The Board shall accept for enrolment in its school, Indian children from the Bands and in addition to the program of studies for the Province of Ontario, shall provide for, or in respect of, the Indian children and the Bands the following services to the extent agreed upon by the parties to this agreement.

- (1) All pupils of Whitefish Bay, Sabaskong and Northwest Angle Bands registered for classes in Father Moss School shall be enrolled in Father Moss School and the Board shall not transfer pupils resident on these reserves to any other school without the approval of the parents.
- (2) The Board agrees that preference shall be given to Indian teachers in the matter of staff appointments to Father Moss School provided that qualifications and ability are judged to be equal.
- (3) The Board will make recreational facilities at Father Moss School available to Indian groups for after school functions according to Board procedures and policy.
- (4) The Board shall forward notices to the nearest Indian Band office (Whitefish Bay) regarding employment possibilities for maintenance, janitorial, secretarial, construction, general labour, lunch or playground staff.
- (5) The Board shall encourage teaching staff to engage in inter cultural studies through in-service training and summer courses to promote greater understanding of Indian students and thereby help the teachers in their understanding with the students.
- (6) The inclusion of suitable course content providing information about and alerting the students as to the dangers of alcohol, gas and glue sniffing and hallucinatory drugs.
- (7) Assiduous attention to the health and psychological services to answer the needs of Indian children.
- (8) These services to be provided by the Board and in return for these special services for Indian students Her Majesty shall pay to the Board an amount equal to _____ per cent of the cost of such services on receipt of a certified statement outlining such costs.
 - A) An Indian primary classroom aide and a general classroom aide if suitable persons are available.
 - B) Training, as a second language, in either Ojibway or English at the recommendation of the Father Moss United School Council and within the provincial school legislation.
 - C) A library of books and materials related to Indian life and culture for research and recreational reading.

- D) Instruction in Indian life, government, history and culture.
 - E) An attendance counsellor approved by Whitefish Bay Band Council.
5. (9) These services to be provided by the Board and in return for these special services for Indian students Her Majesty shall pay to the Board an amount equal to the cost of such services on receipt of a certified statement outlining such costs.
- A) Emergency taxi service to homes on the reserves where in the opinion of the principal or nurse the illness or accident is considered to warrant home care.
 - B) Special articles of clothing, materials and equipment where required for such activities as gymnasium classes, home economics and industrial arts - in all cases parents must be given the opportunity to provide for the needs of their children and only where need is established should the school authorities provide such materials - a school inventory and supply should be maintained for carry over use of gym suits and shoes where provided by the Department of Indian Affairs and Northern Development.
 - C) School lunches (at a per pupil rate subject to negotiation prior to September 1st each year or at the rate in effect the previous year.)
5. (10) The Father Moss United School Council which exists at present as an advisory committee to the Board on matters pertaining to Father Moss School and which represents the interests of the Indian Bands from which Indian students attend Father Moss School and the citizens of Sioux Narrows whose children attend Father Moss School, shall be recognized by the Board as an advisory committee the formation and purpose of this committee to be and include the following:
- A) The committee or council shall consist of 8 members:
 - (1) Five members shall be Indian representatives.
 - (2) Three members shall be from the community of Sioux Narrows.
 - (3) One of the five people in clause (a) shall be the Indian representative to the Board.
 - (4) One of the three people in clause (b) shall be the elected School Board member for the community of Sioux Narrows.
 - B) The chairman of the committee shall be a non-Board member and the chairmanship shall alternate annually between the Indian membership and the Sioux Narrows membership.
 - C) The Father Moss School principal and the Band's Social Counsellor shall be non voting invited guests at all meetings unless notified otherwise prior to a given meeting.
 - D) This committee shall hold meetings at the call of the chair, or on written request of two members of the committee and the chairman will have the right to present to the Board the recommendations of the committee in matters affecting the welfare of students attending Father Moss School. These matters will include in addition to the regular day to day matters which could affect the students welfare, the following

(1) the responsibility to make the recommendations for items 5; 6; 7; 8 a, b, c, d; as listed in part 5.

(2) It is understood that the four Bands concerned in this agreement have or will be employing, at cost to Her Majesty, full or part time social counsellors whose services shall be available to Indian students attending Father Moss School. These counsellors shall liaise with the appropriate educational staff of the Board and Her Majesty.

AND

other programs that the Department shall from time to time approve.

6. The Board shall make every effort to involve the Indian Community in school affairs and encourage active participation of Indian parents in the education of their children.

AND

The Board shall continue its present practice of accepting as a member of the Board a representative of the Bands selected by the Bands, such selection will be made in whatever manner the Bands may choose (i.e. election, appointment by Band Council, appointment by the school committee, etc.) and this trustee will have full voting powers.

- 7. (a) The Board shall retain jurisdiction over the administration, control and operation of the school(s) in which Indian children are enrolled under the terms of this agreement, including the supervision of teaching personnel and all matters related to the curriculum, methods of instruction and material used for instruction.
- (b) Nothing in the preceding clause precludes the right of Indian parents to exercise an interest in the educational matters of the schools attended by their children.
- (c) Education officials representing the Minister and the Band may, with the knowledge and approval of the Board assist in planning, developing or improving a cross-cultural educational program suited to the needs of Indian children and any person authorized by Her Majesty shall have the right to visit the school from time to time.

8. All notices or communications required to be given or sent under the terms of this agreement shall be deemed to be sufficiently given or sent if mailed or sent by telegram to the recipient party.

THIS AGREEMENT shall come into force on September 1st, 19__ and shall remain in force from year to year unless:

- (a) renegotiation is requested by any of the parties hereto in which case such request must be made by February 1st, of the then current school year and the renegotiations must be completed by May 1st, of the then current school year.
- (b) termination is requested by any party hereto, in which case such request must be made by January 1st, of the then current school year to be effective June 30th, of the school year following the then current school year.

(c) cancellation or termination of this agreement will automatically cancel or terminate any finalized related Capital Agreement referred to in section 4 of this agreement.


The next regular meeting of The Kenora District R.C. Separate School Board will be held at Father Moss School in Sioux Narrows on Wednesday, December 13th.





BASEMENT PLAN




MAIN FLOOR PLAN


FATHER MOSS SCHOOL ADDITION




SOUTH ELEVATION



TYPICAL CROSS SECTION THROUGH CLASSROOM





EAST ELEVATION
