

Transfer of Federal Pupils to Provincial Schools

With reference to your telex of February 27, 1969 attached please find charts that have been developed showing our estimate of budget changes that would occur, should the "In School" program be turned over to the Provincial system within the next five years. Chart No. 1 shows the adjustment in budget amounts, chart No. 2 shows the man year adjustments and chart No. 3 outlines the transfer of pupils from Federal Schools to Provincial Schools.

Consideration was given to an adjustment of man years in Administration and Guidance and it was felt that any reduction in Administration Personnel would be offset by a similar increase in Guidance Personnel. The matter of maintenance of students and transportation was scrutinized and it was believed that the impact in these areas would not be sufficient to adjust amounts at this time.



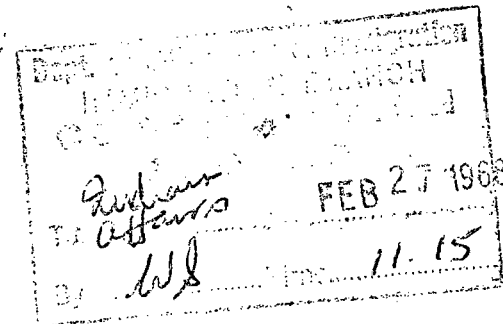

Although it could be expected our Federal School enrollment would decrease as a result of increased admissions to non-federal schools, nevertheless, the expansion of our Kindergarten and nursery program and the rapidly increasing population in isolated areas where integration is not possible counteracts any possible decrease.

As of December 31, 1968, prior to formation of the New County Boards, 6,500 Indian children were in attendance in the provincial school system. These students were served by over one hundred school boards, either through tuition arrangements or through one of the eighty-five prevailing joint agreements.

As of January 1st, 1969, many of the public school boards were absorbed by New County Boards, and, consequently, the old public school boards under whose jurisdiction the Indian children attended provincial schools do not now exist. (Excepted from this absorption were a good number of Separate School Boards and some city Boards in large metropolitan areas). The Department of Education has provided that any agreements or understandings with the old Boards will be honoured in every respect by the New County Boards.

It is imperative in the interests of good administration at District, Regional and Central Treasury levels that we now consolidate the situation which prevailed on December 31, 1968, into the situation which now applies as of January 1, 1969.

You are urgently requested to provide a list of school boards who extend educational services to Indian children in your jurisdiction and make this available at Regional Office by February 21.

This information for your District is to be consolidated on the enclosed sheet. A regional consolidation will be compiled and made available to the Department of Education, Central Treasury Office, and our Headquarters.

I am pleased to advise that Dr. J.R. McCarthy, Deputy Minister of Education, Ontario, has assured this Department of his full co-operation in our initial step in assisting County Boards to understand the implications of any arrangements previously made between school boards and this Department.

Possible County Administration of Birch Island

When Chief Nahequahbow visited me to-day on other matter, I took the opportunity of discussing the extension of self-government and band involvement to point out to him the steps that Walpole Island Council is taking to have their school system administered through the County Board. This step is also being taken in the Parry Sound area where the four bands have elected to come into the County Board, and all schools concerned and all education matters concerned will be dealt with by the County. In each case, the Department would make the school costs payable to the Band, who, in turn, would deal with the County.

I reviewed with the Chief the many advantages to this arrangement. The main advantage is that the Department of Education is hopeful of having new legislation provided that would permit this type of administration and would extend to the Indian community full voting rights in school board elections. Also Birch Island School would, through this arrangement, qualify the same as any other school in the system for professional, audio-visual, and any other special services. The Chief was most enthusiastic concerning this and indicated he wanted to look into it.

I am thoroughly convinced that this is the direction in which Indian communities must move where schooling is provided on the reserve if the Indian children are to obtain a standard of education comparable to that of the county children.

While from this letter, I do not believe you should take action, I believe it would be helpful for you to know of our discussions and I have asked the Chief to feel free to use your office or mine as he makes inquiries. I would be most anxious to see a community like Birch Island in your district make this first important move.

EDUCATION DIVISION LETTER NO. 47

I am enclosing a copy of Treasury Board Minute 601776 which outlines the conditions under which the Branch may enter into joint school agreements. The Minute stipulates that the Branch's capital contribution may not exceed an amount equal to the number of Indian pupils, divided by the total enrolment, times the total cost.

Departmental treasury officers have stated that they are unable to process accounts for payment unless the agreement under which the payment is requested is based upon this ratio.

Although we have, in the past, purchased accommodation for Indian pupils by paying for all of an addition to a school, this procedure will no longer be acceptable. It will now be necessary to show the total cost for the facilities being used by all the students under consideration.

In all future joint school submissions would you please include total costs and make sure that a ratio which is justifiable under the terms of this Minute is maintained.

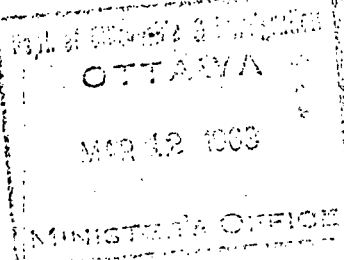

Joint School Program - Ontario Region

We enclose for return Headquarters summary of joint school statistics covering the Ontario Region with appropriate revisions. We also enclose typed revised statistical sheet with projected requirements and statement of present outstanding balances.

Because of the imminent reorganization of the province into county boards, it is most difficult at this time to project our joint school requirements. We anticipate that in keeping with the stated policy of the Ontario Department to equalize educational opportunity to all areas of the province, we will receive requests from boards for expansion to existing agreements to provide improved services to existing enrolment rather than expansions for additional enrolment. We also expect to become more involved in joint school agreements at the high school level. At the present time in many areas, our high school population is distributed in fairly small groups under several boards. As of January 1, 1969, these several boards will become one board and the cumulative total of Indian high school students within the system will be quite large and no doubt we will be asked to participate in any planned new construction within the system or area. I would cite as an example the Six Nations area where approximately 250 high school students are scattered in schools in Hagersville, Caledonia, Cayuga, Waterford, and Brantford. After January 1, 1969, two county boards will cover this whole area and the number of Indian students attending in each county's system will be quite substantial. Under these circumstances, our projection of funds required for joint schooling is very conservative.

With reference to your memorandum of September 19 regarding the Port Arthur High School project, I have discussed the matter of further payments required during this fiscal year with Mr. Dalzell.

Mr. Dalzell informed me that he has spoken to you recently in this regard; however, this will convey the information available in this office.

It is our understanding that the original agreement has been extended to provide for up to 200 students at a cost of \$350,000.00 two-thirds of which is to be paid now (less the \$99,896.00 already paid). The additional payment will be \$133,437.00. Mr. Dalzell informed me that most of the construction will be completed by March 31 or shortly thereafter, so that most of the balance (\$116,667.00 approximately) could be required within this fiscal year. He also stated that if arrangements could be made for the final payment to precede actual completion, the Board would be able to avoid borrowing to cover progress payments.



Indian Representation on School Boards

I am enclosing a copy of our circular letter No. 119 on the above subject for your information.

The amendment to The Provincial School Act represents the first concrete step towards a goal that has been under discussion for several years--the establishment of school districts or sub-units on Indian Reserves under provincial legislation. Discussions are now under way with all concerned to prepare the way for implementing the new legislation on Reserves which have, or will have, joint schooling in operation.

I might add that the Saskatchewan School Trustees' Association, Department of Education officials, Indian Affairs Branch, and provincial school superintendents are involved in the initial discussions with the Indian people. The initiative to form a school district on the Reserve must, of course, come from the Indian people.

Last year 4,338 Indian children were enrolled in provincial schools. This represents slightly under fifty per cent of the total Indian school population in Saskatchewan. The rapid increase in Indian enrolment in provincial schools has come about as a result of the interest the Indian people have shown in ensuring that their children receive the best education possible. At the same time, the provincial education authorities have demonstrated a growing awareness of their responsibility in Indian education.

One aspect of joint schooling of particular interest and concern to the Indian people has been their involvement in local school matters. They have been asking for a greater voice in the making of decisions that affect the education of their children. In order to permit the Indian people to play a more active part in local school affairs, it was necessary to amend The School Act of the Province of Saskatchewan. I am very happy to report that such an amendment received Royal assent on April 25, 1968, during the last session of the Provincial Legislature.

What change has been made?

The amendment to The School Act extends the definition of "ratepayer" in order to include residents of Indian Reserves in the province. The change makes it possible for an Indian Reserve to become a school district, if so requested by the residents. This would extend to the Indians the right to vote in school board elections, and to be elected as school trustees.

What is a ratepayer? (see attached Appendix)

A ratepayer means a person of the full age of eighteen years in a school district which includes an Indian Reserve, and who has resided in the district for a period of at least 5 months prior to the last preceding first day of June.

What is a school district?

It is an area of land which is approved by the Minister of Education.

What is required to form a school district?

It is necessary to have at least four ratepayers in the district and ten children between the ages of 5 and 16 years.

What is a school board?

A school board is a committee of 3 or more people who are elected by the ratepayers to direct the local school affairs of the district.

Who may be elected to the school board?

Any person who is 21 years of age or over, a British subject, resident ratepayer of the district, able to read and write and to conduct school meetings in the English language, and who takes an oath of allegiance.

Is it possible for a Reserve to join an adjacent existing district?

Yes--depending upon local circumstances and wishes of the people.

Is it better to form a school district or to join an adjacent existing school district?

This depends on the location and size of the Reserve, and the wishes of the people.

Do all ratepayers pay taxes for school purposes?

No, only those who possess titles to the land.

When a school district is erected on a Reserve, will Indian people have to pay taxes?

No. The Indian Affairs Branch will pay a grant to the appropriate school board in lieu of taxes.

What will Indian people gain from organizing a school district on a Reserve?

They will have the same privileges and responsibilities as other citizens of the province with respect to local school matters.

Is it compulsory to erect or join a school district?

No. The initiative for taking any action on this matter will have to come from the Indian people.

Where may more information be obtained?

(b) there are at least four ratepayers actually residing within the proposed district.

A new subsection is added to section 57:

(6) Where a proposed alteration affects an Indian Reserve the person or board applying for the alteration shall send by registered mail or deliver to each of the persons who are ratepayers within the meaning of subclause (vi) of clause (n) of section 2, and who are then residing on the lands proposed to be added to the district, a notice in form O.

Dear Harry:

During our last committee meeting you expressed some concern that there be a constant review of the education program offered by the Northern School Board and clause number nine of the new agreement was included to provide for this need.

I believe it was your suggestion that the proposed liaison should take place in Regina rather than Prince Albert and I assume that you and Walter Karashowsky would act as a permanent committee of two. The committee could of course be larger if you think it would be wise to include more people.

We were unprepared at the time, to establish any terms of reference for the committee and perhaps now is the appropriate time to give you some of my thoughts on which of the many vital aspects of the program require the most constant review.

We are all aware that the school program offered in Northern Saskatchewan cannot be a carbon copy of the program in the south if it is to be successful. I am consequently most concerned about those adaptations or additions which must be present in the north. It is my hope that the committee will concern itself particularly with designing both a long and short range program in the following areas.

- (a) Language arts and the teaching of English as a second language.
- (b) Special pre-service and in-service training of teachers.
- (c) Guidance services for all pupils in grade six or over.
- (d) A vocational training program in the north designed to increase the number of students leaving school with a vocational competence but which will decrease the number who must leave the north in order to obtain this competence.
- (e) A two-year kindergarten program for four and five year olds which will ensure that all pupils reach school at the age of six socially, psychologically and linguistically able to cope with the school program.

- (f) I believe the new grade organization in Saskatchewan ensures the continuous promotion of each child but if not perhaps that is another subject worthy of investigation.

It is more than possible that everyone who is involved in education for northern Saskatchewan residents has a separate and distinct list of priorities and there may be some real advantage to setting up terms of reference for this liaison committee early this fall.

Although you, Clarence, Walter and I are more than pleased to see the new agreement signed I'm sure your staff have some misgivings about the added responsibilities. If there is something which we of Indian Affairs Branch can do to assist during the transition stages please let Walter or me know.





MORE INVOLVEMENT OF INDIAN PARENTS IN EDUCATION OF THEIR CHILDREN

Ottawa, June 12, 1968 - The Honourable Arthur Laing said in Vancouver today that he hoped that Indian people in British Columbia will respond well to the opportunity of enrolling as electors for choosing school boards. They have until August 31 to enroll under recent amendments to provincial legislation. He also said that Indian parents whose children attend provincial schools must be given more voice over the education of their children.

"Over half the Indian school-age population is now attending provincial schools," Mr. Laing said, "and this will increase as more and more joint school agreements are negotiated between my department and local school boards to accommodate Indian students in provincially operated schools. Indian parents are going to have to play a greater role in the affairs of these schools if integrated education is to be fully effective." At present, legislation to permit the full participation of Indian parents in local school affairs has been passed in British Columbia, Saskatchewan, Ontario and New Brunswick.

For a number of years, the department has been providing classroom space for Indian students in schools operated under the jurisdiction of a province or territory, through a series of joint school agreements with local school boards. At present, 34,635 Indian students out of a total school population of 66,217 are attending such schools. Under these agreements, the federal government has made capital contributions, based on the number of Indian students to be enrolled, of over four million dollars annually toward the construction of schools across Canada.

Mr. Laing cited as an example the construction of additional classrooms at the Caledonia Secondary School in Terrace under a recent joint school agreement with the Skeena-Cassiar School district. A second agreement calls for a federal contribution of \$152,215 towards the construction of six classrooms, a covered play area and an activity room at the Windebank and Ferndale Elementary Schools in Mission City. This agreement will provide accommodation for one hundred and five Indian pupils in these schools.

There are hundreds of such agreements in Canada which are making it possible for Indian students to move into provincial schools. Now the department has entered into general agreements with the provinces of British Columbia, Manitoba, and New Brunswick, which will speed up the movement even further.

MORE CLASSROOM SPACE FOR 180 INDIAN HIGH SCHOOL STUDENTS IN PONOKA, ALBERTA, UNDER NEW JOINT SCHOOL AGREEMENT

Ottawa, June 19, 1968 - The Ponoka Elementary Junior High School, Ponoka, Alberta, is to be remodelled and expanded under a joint school agreement between the Department of Indian Affairs and the County of Ponoka to provide adequate accommodation for 180 Indian students attending the school. The agreement calls for the construction of three classrooms, one general purpose room, one industrial arts shop, two science rooms, counselling and administrative offices, and recreational areas. The Department is contributing \$2,210 for each Indian pupil for a maximum contribution of \$397,926. Estimated cost of the project is \$1,050,083.

Students from the nearby Samson, Ermineskin, Montana, and Louis Bull Reserves have been attending schools in Ponoka, 60 miles south of Edmonton, since 1959, but this agreement marks the first capital contribution made by the federal government to the country school system. Co-operation from the County over the past nine years in accommodating the Indian students has enabled the Department to close three classrooms at the Montana and Samson Day Schools as part of its program to provide Indians with the educational opportunities offered in provincial schooling systems. Indian enrollment in the Ponoka schools is expected to reach 425 by 1972.

JOINT SCHOOL AGREEMENT TO PROVIDE ACCOMMODATION FOR INDIAN STUDENTS IN MANITOBA PROVINCIAL SCHOOL

Ottawa, June 19, 1968 - The Department of Indian Affairs has entered into a joint school agreement with the Oak Lake Consolidated School District to provide accommodation for 120 Indian students at the Assiniboine School at Oak Lake, Manitoba. Under the agreement, the federal government is making a capital contribution of \$31,285 for the construction of a four-classroom addition to the nine-room school. Estimated cost of the project is \$103,500.

Students from the Oak River Reserve, 25 miles north of Oak Lake, began attending the Oak Lake school in 1963, following requests from their parents and the Band council that the day schools on the reserve be closed. Enrollment increased so rapidly, however, that the Department entered into a formal joint school agreement with the Oakwood School District the following year to construct a three-classroom annex for the school's 90 Indian students.

Now four extra classrooms are needed to accommodate a projected enrollment of 120 Indian students over the next three years. The Indian Affairs Branch, which is paying the costs of transportation and tuition for the 110 students presently attending the school, has already contributed \$10,428 to the project. The new classrooms are expected to be ready for the fall term.


Inquiries to the Department of Education have brought forward the following point:

"The provisions set out in Section 35 (3) of the Schools Administration Act are not in any way affected by the legislation providing for County Boards of school administration."

This point is covered in Bill 44, page 26, Section 100. which states:

"The provisions of The Public Schools Act and Parts II and III that are not inconsistent with this Part shall be read as part of this Part and shall apply to divisional boards, and so far as such provisions are inconsistent with the provisions of this Part, they do not apply to divisional boards".

This information should be used as your authority for reassuring Indian Band Members who may be concerned as a result of the County Board formation.

Survey - Joint School Agreements - Ontario Region

This is in reference to your memorandum of March 27 in which was enclosed a survey of formal joint school agreements entered into with various school boards in this region.

We are returning a copy of the above-noted survey on which we have noted major discrepancies in red ink. We have also attached a survey as drawn up from our records and changing the discrepancies noted in yours accordingly.

The major discrepancies are noted hereunder, however, there were some minor changes made as you will note on reviewing the attachments.

- 1960: Ridgetown, No. 92 - This agreement covered 51 pupils, however, the Howard-Harwick agreement (No. 263, 1965,) replaced this agreement with Ridgetown. The 51 pupils were part of the 85 pupils attending now at Howard-Harwick. The Ridgetown Board issued a cheque for \$23,639.65 and this cheque was forwarded to Ottawa in July, 1967, and effective date of buy-out was June 30, 1967. The 51 pupils were taken off the totals to avoid duplication.
- 1964: Moose Factory Island, No. 33 - This was not the usual type of joint school agreement, however, our records indicate it was allotted a joint school number and a school board became responsible for its operation. No capital cost was involved as it actually is the Branch's building, but 363 pupils were. The agreement of 1967 with this Board did not involve pupil spaces but an expenditure for teacherage accommodation.
- 1964: Sault Ste. Marie Public, No. 200 - This agreement reads that spaces will be provided for 60 elementary or 35 high school students. As it is presently being utilized for elementary students, we have placed it in the elementary totals.
- 1961: Fort Frances Separate, No. 112 - Our records indicate that no additional enrolment was involved in this agreement, but rather added services for the 110 pupils already covered by Agreement No. 22, 1955.

- 2 -

- 1965: Red Lake: This entry was left blank in your copy. Our records on this were scant as these agreements were completed directly between the Department of Education and Headquarters. The detail we have inserted was taken from a memorandum from Ottawa in reply to a request from this office for information for our records.
- 1967: C.R.C.S.S. Denison, Graham, Waters, No. 342. This Board was formerly known as Naughton (1964, No. 199). The 1964 agreement covered 40 pupils and the 1967 agreement made provision for an additional enrolment of 10 pupils and added services to all.
- 1967: St. Hubert - In 1957, Agreement No. 44, was made with Tarentorus Township School Board. This Board later became part of Sault Ste. Marie Separate School Board due to amalgamation. Agreement No. 44 made provision for 83 pupil spaces. The 1967 agreement was drawn up on a cumulative total basis and the 118 pupils you show on your summary is the cumulative total of pupil spaces for both agreements. Actually, the 1967 agreement made provision for 35 additional pupil spaces.

On reviewing the summary drawn up at your office, there appears to be some misunderstanding of the term "Senior Elementary" as versus "Junior High". A "Senior Elementary School" is one which houses Grades 6,7, and 8, or even just Grades 7 and 8, and is, therefore, an elementary school. A "Junior High School" on the other hand houses Grades 7,8, and 9. We have, therefore, moved the senior elementary schools into the elementary category on our revised summary. There are not yet any joint agreements in this region designated "Junior High School".

Your Study Paper - Walpole Island

This refers to your memorandum of April 25, 1968.

In general your summary is in order, however, I should like to suggest some change in choice of words in order that no wrong meaning be taken. Under "B", first sentence, I should prefer to read this way:-

"Unlike federal capital projects, joint school projects are not subject to the same capital regulations. Therefore, if a county board was to undertake construction of a school under the joint agreement plan, it is highly probable that funds would be made available.

- This alternate would seem an advisable time for the Band and the county board to negotiate maximum involvement of the county board in the education on the reserve and to make it as much as possible a part of the local county system.
- It is understood that members of the Indian Band may have some important aspects of the education program in mind that would pertain particularly to their community. Negotiations with the county would be the ideal time to review these matters and perhaps have them concluded in any final agreement. Such items as the construction date, consultation with the local School Committee as to school design, and representation of the Indian people on the Board.

I think the other points you have inserted are quite in order, but I do think your summary to the Band should be concluded with the following closing paragraph:

"It is understood that the points raised above would be a basis for discussions but at this time do not represent a commitment either by the Branch or the Indian people or the County. They are rather framework in which further discussions could be conducted".

AGREEMENT WITH MOOSE FACTORY ISLAND PUBLIC SCHOOL BOARD

MEMORANDUM OF AGREEMENT MADE THIS 14th DAY OF October 1964

BETWEEN:

HER MAJESTY THE QUEEN in right of Canada
represented herein by the Minister of
Citizenship and Immigration, hereinafter
called "the Minister"

OF THE FIRST PART

AND

THE BOARD OF SCHOOL TRUSTEES OF THE
MOOSE FACTORY ISLAND PUBLIC SCHOOL,
in the Province of Ontario, hereinafter
called "the Board"

OF THE SECOND PART

WHEREAS the Minister of Education of the Province of Ontario
has, pursuant to Section 66 of the Public Schools Act, Revised Statutes
of Ontario, 1950, chapter 316 (now Section 12 of the Public Schools Act,
Revised Statutes of Ontario, 1960, chapter 330) designated certain lands
on Moose Factory Island in the Province of Ontario to be a rural school
section and has appointed a board known as the Board of School Trustees
of the Moose Factory Island Public School;

AND WHEREAS the Minister has agreed to provide to the Board
for its use during the currency of this agreement the present classroom
and teachers' accommodation owned by Her Majesty the Queen in right of
Canada and under the jurisdiction and management of the Department of
Citizenship and Immigration of the Government of Canada, and situated on
Moose Factory Island;

AND WHEREAS the Board has agreed to provide accommodation and
classroom instruction to all children residing within the lands known as
Moose Factory Island Indian Reserve No. 1 and residing in the Hostel of the
Horden Hall Indian Residential School and to children of non-Indian status
in accordance with the provisions of this agreement;

AND WHEREAS the Minister has been authorized to enter into this
agreement by Order in Council P.C. 1964-12/1500 dated September 24th, 1964,
passed pursuant to sub-paragraph (iv) of paragraph (b) of Section 113 of the
Indian Act, Statutes of Canada 1951, chapter 29 (now paragraph (d) of

sub-section (1) of Section 113 of the Indian Act, Revised Statutes of Canada 1952, chapter 149);

AND WHEREAS the Board is authorized to enter into this agreement under paragraph (i) of sub-section (2) of Section 74 of the Public Schools Act, Revised Statutes of Ontario, chapter 330 as amended by Section 12 of Bill No. 22 passed at the 4th Session, 26th Legislature, Ontario, 11-12 Elizabeth II, 1962-63;

NOW THEREFORE THIS AGREEMENT WITNESSETH that the parties hereto hereby agree each with the other as follows:

1. In this agreement,
 - (a) "cost of Operation" or "operating costs" means the administrative costs, plant operation costs and classroom instruction costs that are incurred by the Board in the operation of the school;
 - (b) "school" means the Moose Factory Island Public School;
2. The Minister shall provide to the Board for its use during the currency of this agreement the classroom and teachers' accommodation owned by Her Majesty the Queen in right of Canada and under the jurisdiction and management of the Department of Citizenship and Immigration of the Government of Canada and situated on Moose Factory Island.
3. The Board shall maintain and keep repaired in good order the buildings housing and accommodation referred to in paragraph 2 hereof, except that no structural alterations will be made by the Board.
4. The Board may, with the consent of the Minister in writing, rent additional classroom accommodation on Moose Factory Island and such accommodation shall be made available for the instruction of children of school age in accordance with this agreement.
5. The Board shall accept for enrolment in the school and provide courses of instruction to all children of school age residing within the lands known as Moose Factory Island Indian Reserve No. 1 and residing in the Hostel of the Horden Hall Indian Residential School and to children of school age of non-Indian status.

6. All children enrolled in the school shall receive equal educational opportunities.
7. (1) The Minister shall pay to the Board each year the operating costs that are incurred by the Board on behalf of the children enrolled in the school who reside on the lands known as the Moose Factory Indian Reserve No. 1 and in the Hostel of the Horden Hall Indian Residential School.
(2) The Board shall each year make application to the Department of Education of the Province of Ontario for the legislative grants payable to the Board in accordance with the General Legislative Grants Regulation in effect, on account of the education of the non-Indian children enrolled in the school.
(3) The Minister shall pay to the Board each year the difference between the operating costs that are incurred by the Board on behalf of the non-Indian children enrolled in the school in the current year and the amount of the legislative grant received by the Board from the Department of Education of the Province of Ontario in the current year based on the General Legislative Grants Regulations in effect.
8. The Board shall conduct the financial operations of Moose Factory Island Public School subject to and in accordance with a budget that has been approved by the Minister in writing.
9. (1) The Board shall, on or before December 1st in each and every year during the currency of this agreement, submit to the Minister for approval a budget which shall set out in detail the items and the proposed operating costs under each item for the calendar year immediately following.
(2) The Minister shall, after receipt of the budget and on or before January 1st in each and every year during the currency of this agreement, notify the Board in writing of the items in the budget

and of the operating costs with respect to each item that are approved.

- (3) The Minister may, upon the approval of the budget, advance to the Board from time to time funds to meet the cost of operation.
10. (1) The Board shall conduct the financial operation of the school within the amounts approved by the Minister under each item of the budget.
- (2) The Board shall not incur any debts or liabilities in any calendar year which cannot be met from the budget approved by the Minister for that year.
- (3) The Board shall forward to the Minister each year, copies of all reports and returns which are required to be transmitted by the Board to the Minister of Education under paragraph 4 of Section 34 of the Schools Administration Act, Revised Statutes of Ontario, 1960, chapter 361, as amended.
11. (1) The Board shall account to the Minister for funds advanced to it from time to time under sub-paragraph (3) of paragraph 9 hereof.
- (2) Where the funds advanced from time to time by the Minister to the Board in any year exceed the Minister's share of the operating costs for that year the Board shall remit the excess to the Minister.
12. The Minister may at the end of each calendar year cause the books of the Board to be audited and for this purpose the Minister, or any person appointed by the Minister, is entitled to have access to all records, documents, books and accounts of the Board and is entitled to require from the Board and its members, servants and agents such information and explanations as the Minister deems necessary.
13. The Board shall not raise or attempt to raise any moneys by a local assessment without the approval of the Minister in writing.

Joint Schools - Band Self-Government - County School Boards

The existing policy of the Branch for entering into joint school agreements with neighbouring elementary or high school boards is well-known to you. There is no change in this policy, however, there are areas where modification of the policy must now be considered in the light of Ontario Department of Education Re-Organization. For this reason, I am attaching a recent communique from the Regional Superintendent of Schools to the District School Superintendent, London.

There is no doubt in my mind that children in rural settings will receive superior educational services under the County Board system. For this reason, every one of us working on behalf of the Indian people must do everything possible to foster the type of relationship between Band and County that will eventually lead to the extension of all available educational services to the Indian children.

I commend the approach in the attached letter to you, and would ask that you endeavour at every opportunity to foster an environment that will make this step possible.

Proposed Construction - Walpole Island Central School

This is further to your memorandum of March 22 with which you enclosed Band Council Resolution (Walpole Island) No. 38. It is noted that in your covering memorandum you mention the Band Council is considering hiring an architect to plan for their new central school in keeping with their local community needs.

This is a commendable attitude, and I see from it a clear-cut desire by the local people to undertake increasing responsibility for the planning of their school plant as well as the operation of the program.

This expression by the Band comes at a time when the new County Re-organization in the Ontario Department of Education is reaching its peak. It seems timely that I should ask you at this point to review with the Band several observations in which I believe they will be vitally interested and may like to make further inquiry.

The Band Council may not be aware that our engaging an architect for them, while resulting in a plant more in line with provincial standards, does not remove the project from being a federal capital construction project. This being the case, the project is still subject to falling in the program of priorities for federal capital projects and is subject to the Government Committee on Accommodation Standards which guides the Treasury Board. Both the federal Department of Public Works and our Branch Engineering Section are required to plan construction and specifications in the light of the Accommodation Standards Committee requirements.

Perhaps the Band Council has not given thought to achieving their goal through the channel commonly referred to as our joint school provisions. Undoubtedly, the Oneida Reserve will find itself in the midst of one of the new larger county boards by January, 1969. The aims and goals of the Department of Education in creating the larger county board are tremendously attractive and very much in line with the aims our Branch has for the Indian people. For this reason, I am thoroughly convinced that the Band would be very wise to consider the ways and means of achieving their educational goal through the new county board under our joint agreement provisions rather than through the normal Branch channels. In effect, this would mean that the Branch under the joint school provisions could make capital funds available through the county board for construction of the facilities required by the Band Council in very much the same manner as this would be done by the Branch. The advantage to such an approach would be removing the project from federal priority lists and the federal Accommodation Standards Committee, thus facilitating construction.

In the operational area, there would be the advantage of more local operation as well as the several special professional advantages that will come to all county areas as a result of the new Department of Education provisions.

This proposal at the outset may appear as a radical departure for the Band. It is not, however, without precedent in almost every other province, and I anticipate that the new County Re-organization will speed its occurrence in Ontario.

I would like to say in closing that the Walpole Island people have shown themselves in the past to be very forward-thinking and will, therefore, want to explore this suggestion to its limit. There is nothing about it that is compulsory and much about it that is desirable. Would you please take steps to take this matter up with the Walpole Island Band Council if at all possible prior to their April 10 proposed meeting, and please advise the Council that a representative from Regional Office will attend the meeting, but I should very much prefer to do this after you have had this opportunity for discussing this letter. I would like to suggest that a Headquarters representative be requested to attend a subsequent meeting.
