

Receipt is acknowledged of your letters of March 16 and 24, ^{5 1971} together with our recent telephone conversation have clarified a number of points in this estate, particularly with respect to the bid of Everest Tommy on the estate property.

You advised that the house on Everest's inheritance was built from Band funds with a contribution from Everest of \$400 plus his own labour. Thus it appears that Everest inherited approximately two acres, without improvements, plus the obligation with respect to Johnny Jameson. From what you described, the latter obligation is indeed considerable in the sense that Johnny, who was born in 1952, is retarded and causes considerable strain financially and otherwise on Everest who has faithfully maintained the child.

Your reports, therefore, correct our impression that Everest had inherited some improvement on the property from the estate and in the circumstances his bid can be viewed in a different light, particularly considering the fact that Everest had previously paid \$200 towards the estate debts on behalf of himself and Johnny Jameson. With the bid of \$20 he will have contributed \$220 towards the debts and part of that sum was previously distributed to the creditors. We should now have approximately \$90 plus interest to apportion on the remaining estate debts.

It is obvious that we cannot obtain a higher bid than that submitted by Everest and also that the latter cannot afford to make further payments towards the debts. We have attempted to collect funds for five years now for the purpose of settling the debts and the sale was the last resort. It is clear we cannot obtain sufficient funds to pay the debts in full, but unfortunately that is the situation. Accordingly, we are accepting the bid so that the creditors can receive partial payment and the estate finally concluded. We shall pro rate the estate funds among the three creditors who will then have received approximately 3/5 of their accounts.

The offer from Everest Tommy was for the remainder of the estate lands other than those to which Collins Pierre is entitled. Your report of March 24 identifies Collins' property as Parcel 124-1 on Plan 52745 and the property which Everest purchased is Parcel 124-2 and 124-3. We shall proceed with the transfer of these parcels and advise at a later date of what evidence of title can be issued to Collins Pierre and to Everest Tommy. The distribution of funds mentioned above will be made shortly and cheques will be forwarded care of your office for delivery to the creditors. When these two steps will have been completed, we shall be able to close this estate.

Your memo of March 13, 1967 refers & we wish to settle, as far as possible, your points.

In 1959 a welfare house was built on the most N. part of the Peter Pierre estate lands. The cost was slightly in excess of \$2500⁰⁰ - all from Welfare Funds. This is the house which is known as the house in U.S.A. Bollins Pierre has a tenant in this place at present as he works in U.S.A.

In 1960, a house was built on the Forest Tommy portion of the land - it was all still Peter Pierre's land - for Forest Tommy & family. The funds for this house were supplied from Bond Funds - \$9,144⁰⁰, and from Forest Tommy in the amount of \$400⁰⁰ plus his own labour. The Tommy's now reside in this house & have done so since it was built.

Now let us look at the Will of deceased. To my mind and my interpretation of the will, Forest Tommy got nothing except 1/3 of the land - about 2 acres - from the Peter Pierre estate plus 2/3 of the estate debts. The third party involved in this will does not enter into the picture for these very important reasons:

He is of non-Indian status. Forest Tommy also inherited the responsibility of the will. I have stated previously that Johnny Jamieson is well cared for by the Tommy's. To get back to the debts as to Mr Tommy's share of these debts, I feel he has paid far more than his just share. has paid much more than he received in land value from this estate even at present day land values.

Report dated October 17, 1962, states that Forest Tommy agreed to pay 2/3 of the outstanding debts - about \$363⁰⁰ as his contribution. The report fails to say if an interpreter was present at this meeting. The writer used the services of the chief of band for this purpose & Mr Tommy stated he has paid all he can and all he will pay. I consider he has done extremely well for one of the class he carries with poor health himself a reputedly unhelpful wife and more than one retarded children who require constant attention & much medical care.

The question of the offer of \$200⁰⁰ for the estate property being regarded unreasonably does not occur to me. The offer has been recommended for acceptance, should we make this recommendation if we were not honestly satisfied that it was a just and realistic offer made by a sincere and sensible man. I show Forest Tommy - not well and his wife less well. I have reported the case as I see it and in the full belief that what I have said is absolutely true. I have written Bollins Pierre & expect to have his OK to a division of the land to Bollins & 2/3 to Peter Pierre - his wife & that of Johnny Jamieson. Is this possible? Regarding the question of obtaining

signatures of the three creditors to a statement that they
to accept their ~~part~~ pro-rata share in full settlement of their claims
is not understood, must be the atmosphere and environment.

If this is all the assets we have for distribution then don't they
just take what we have to give. We fail to see where additional funds
may come from.

We have received your recent undated letter concerning this estate and the written offer made by Everest Tommy to purchase the estate property for \$20.00.

This matter has been the subject of review and discussion.

It has been reported that a welfare house is situated on that portion of the six acres of land in this estate which we presume would pass to Everest Tommy whenever a division of the land, related to a survey plan, could be achieved. We do not find anywhere on file the value given to this house or to the other house, which is occupied by Collins Pierre. Will you please give us an estimate of the value of these houses, especially the one occupied by Everest Tommy.

The offer of \$20.00 made by Everest Tommy to purchase the property he occupies from the estate has not been regarded favourably.

According to your report dated October 17, 1962, Everest Tommy agreed to pay 2/3 of the outstanding debts against the estate. We find that he is in arrears in the amount of \$143.00. We also find that he was able to make substantial payments on his obligation at one time. We wonder if sickness or some disability is the reason why he cannot resume payments and thus obtain a share of the property without the necessity of a sale. If he will agree to this, the \$20.00 he has tendered could be regarded as an instalment.

As Collins Pierre has paid his share of estate debts, we could issue evidence of title to him as soon as we have a sketch showing measurements and related to a survey plan. We enclose a sketch which we found on file for whatever assistance it might be in this matter.

It has been explained that we cannot ignore outstanding debts as long as assets exist in an estate. If there are valid reasons why it is

impossible for Everest Tommy to pay his full share towards the debts, the approximate \$90.00 now available in the estate, which includes the \$20.00 he has paid, would enable us to pay almost 50% of the original amounts of the outstanding creditor accounts. Before we could take this action, it would be necessary to obtain statements from the three creditors to the effect that they are willing to receive, pro rata, the amount available and will waive repayment of the outstanding balances. We shall expect any comments you may wish to make concerning this last suggestion in view of the overall problem.

This is in reference to the subject estate and we shall try to clear up the question of the \$20.00 which you mentioned in your memorandum dated January 18, 1967, under the above file number.

This money which is now in estate account 974-268 in the name of Peter Pierre was handed into the Agency office by Everest Tommy and was for his full purchase price of the Peter Pierre estate lands which had been offered for sale by tender. Obviously the Tender Form was overlooked because of pressure of work at the Agency office and also because of the fact that some members of the staff were away on seasonal holidays. It is for these reasons that the Tender Form was not submitted, but, we shall make a further search for this document and forward same for your perusal with our recommendations. It is ~~also~~ that an offer to purchase was submitted at the same time as the tender was paid at the Agency office on January 6, 1967.

If the offer to purchase of Everest Tommy is accepted and, we strongly recommend that it is, then the only action required would be to pay out this money on a prorata basis to the creditors, have Everest Tommy, and Collins Pierre reach an agreement regarding a division of the lands, have the estate property transferred to these beneficiaries and conclude the administration of this estate.

You will see from correspondence on file that Collins Pierre has already paid his share of the estate debts in full and transfer of his share of the property could have been effected as soon as an agreement had been reached between him and Everest Tommy. However, this agreement could not be forthcoming until such time as Mr. Tommy's share of the estate debts had been settled and we see no other way to have this done except than along the lines mentioned above.

According to the Will of Peter Pierre, Everest Tommy was to look after Johnny Jameson which he has faithfully done.

We shall endeavour to supply you with the offer to purchase from Everest Tommy, an agreement as to a division of the estate, and then an appropriate sketch at our earliest opportunity. If any further information is required please do not hesitate to ask us.

Mr. Sampson, the Superintendent, reports that Peter Pierre purchased the car on February 28th 1961 and not on September 28th 1961 as he had previously informed us and that he had paid only \$202.75 on the car. The vendor was obliged to pay Canadian Acceptance Corporation, who financed the transaction, \$692.75 to clear the contract, then took possession of the car, expended \$50.14 on repairs, charged a selling commission of \$55.00 and a small debt owing the firm by Peter Pierre. The car was sold for \$550.00 and the balance still owing by the deceased is \$251.44.

We concur with our Indian Superintendent that the transaction appears to be in order.

With respect to the other matters outstanding in this estate, we have ascertained that Collins Pierre has made application for a Veterans' Land Act grant of \$2,320.00 and if granted (as we expect will be the case) \$171.00 of the amount will be paid into the Pierre Estate and be applied to the debts. This matter was discussed with Mr. Gordon Hayes of the firm Hayes-Palmer Motors Limited whose premises are situated on a leased area on Cowichan Reserve #1. There appears to be no cause for alarm in this repossession and sale and we enclose a statement from the firm's ledger concerning this transaction. We note the late Peter Pierre purchased the car almost a year prior to his death, February 28, 1961, and not September 28, 1961, as mentioned in our letter of March 20, 1962, and that the deceased had paid only \$202.75 against the unit. The firm paid the finance company (Canadian Acceptance Corporation) \$692.75 to clear the contract, took possession of the car, made \$50.14 repairs to put it in good running order for resale, charged the selling commission of \$55.00 against the car as also a small account owed by Peter Pierre. The resale realized \$550.00 and the balance owing by the deceased is \$251.44.





We refer to your letter of December 13, 1962.

November 6, 1962, we wrote Collins Pierre in the U.S.A. concerning his share of estate debts to be paid to receive title to the northerly one third of the estate land assets. We presume he has received the letter as it was not returned. Collins Pierre has not answered our letter to date. We have received advice from Chief, Economic Development Division that it is possible for Collins Pierre to pay his share of \$171.50 of the estate debts through his Veteran's Land Act Grant (their file 39-6-34 (D-5) January 4, 1963). We hope to arouse some activity in Collins Pierre by writing him again and supplying good news. We will advise you further in due course of this part of the estate problem.

In November, 1962 Everest Tommy deposited \$50.00 in this office as first of a series of payments to be made by him to clear the remaining two thirds of the debts of the estate, namely \$343.02. This \$50.00 payment is being forwarded to the Department by our Receiver General Payments of January 15, 1963 for credit to this estate. 

Yours of 21st is appreciated.

Awhile ago I saw a Departmental statement of the Peter Pierre matter, but it left out important points which were so vital to Peter Pierre and showed the value of the legal services.

I did not attempt to correct the statement as the amount of dredging in the files & s would probably be a sheer waste of time of the Department had already made up its mind, regardless.

Mention might be made of two points (1) Peter Pierre had received definite and imperative written notice to get out by a certain date. This requires much effort to prevent.

(2) The local Indian office time and again insisted that it was determined to recommend the recognition of a certain woman as heir. This lady had lived "common law" with a succession of men and then married a white American and was residing in the USA.

I worked against that and, upon request of the Duncan office, I wrote and sent in a brief giving legal arguments against her recognition. Later, she was not recognized as heir.

As the Duncan office at that time, seemed so strongly against Peter Pierre, for no reason, I wrote to The Hon. Mr. Mayhew, at that time the nearest Minister (as my brother-in-law Lt.-Col. Forsythe, years ago knew him in the Services), and he and his office did much to try and prevent Peter Pierre's eviction and ~~all~~ of all his acreage 'c. The files of Mr. Mayhew's office would throw more light on the problems and the efforts made.

As I see it, the Department could pay my bill on either of two grounds:

- (a) All Peter Pierre's problems which he retained me to solve, were really the fault of the Department (or someone then there) and therefore the Department should pay my bill.
- (b) Without the legal efforts represented in my bill, Peter Pierre would not have any acreage there to pass to relatives, and hence the bill could be fairly considered in the light of an equitable lien on the acreage, which the Department could pay and add to the amount the heirs must pay to implement their ownership.

Thank you for trying, anyway.

I have your letter of November 14th 1962, and can assure you that your claim is not regarded with indifference and that we are doing all we can in a difficult situation to realize sufficient from the estate to pay your claim of \$195.00. Unfortunately it is not easy to realize cash from an estate which consists entirely of a parcel of land on the Cowichan Reserve.

Since writing to you on August 28th 1962, we have heard three times from Mr. R.H.S. Simpson, the Indian Superintendent at Cowichan Indian Agency. One of the reasons for the delay in settling this estate is the difficulty Mr. Simpson has experienced in contacting Everest Tomy and Collins Pierre, who, as you know, are the beneficiaries of the late Peter Pierre's will. Finally on October 17th Mr. Simpson wrote that he had reviewed the entire estate with Everest Tomy and that Everest has volunteered to pay into the Indian office at Duncan an amount equal to two-thirds of the unpaid debts, \$343.02. Mr. Simpson has not been able to contact Collins Pierre and to obtain his commitment to pay the remainder of the debts, \$171.50. Unfortunately Collins Pierre is still in the United States and is not expected home until Christmas.

We have written the Indian Superintendent that Everest Tomy and Collins Pierre should be told that they must attend to the debts without delay and that if they do not do so we will be obliged to sell the land in the estate.

- 2 -

Mr. Sampson has since replied that Everest Tossy hopes to make payments on the debts on a monthly or twice monthly basis in accordance with his receipt of wages. Mr. Sampson is writing Collins Pierre to obtain his undertaking to pay one-third of the debts.


We will write Mr. Sampson again and advise him that if Everest Tossy does not make reasonable payments toward the debts the land will be offered for sale by tender to the highest bidder. In this connection we must point out that the house erected on the parcel from public funds for Everest Tossy is not part of the estate and if the land is sold the house may be removed by Everest Tossy providing all debts are paid.

With reference to observations in your letter, there is no way that the Branch can pay your bill of \$195.00 and charge that amount on the estate land.

As you know, a judgment for a debt of this sort can ordinarily be registered in the Land Registry office and payment can be enforced by sale through a Court order to the Sheriff.


But often I have found that persons holding a 1st mortgage or 2nd mortgage or other encumbrance on the realty, will pay off a judgment.

Harrison has been pressing us for some payment on his claim of \$195 and we informed him last August (see our letter of August 28th) that Everest Tommy and Collin Pierre would be told that they must attend to the debts without delay and that if they could not make a satisfactory arrangement which would provide for payment of the creditors we would be obliged to offer the 6 acres for sale to the highest bidder amongst members of the Cowichan Band.

Mr. Harrison has been writing frequently to the Minister for action with regard to his claim and we do not think that we can ask him to wait indefinitely for payment but must give him some indication of the action we propose to take to settle his claim as well as those of the other creditors.

Will you please take this matter up with Everest Tommy and advise him of the position we take. If it is necessary to dispose of the property in order to pay the creditors do you think that a sale would realize enough to satisfy the claim?

We are refraining from writing to Mr. Harrison on this matter until we have heard from you. We would therefore appreciate an early reply.



In addition the writer, who has been attending to the estate, was away on holidays until a week ago and was faced with a considerable backlog of files on his return.

So far as your claim is concerned, we have recognized its validity but unfortunately assets in the estate are by no means liquid enough to permit immediate payment. We are however hoping that we can find the means to settle your claim in whole or in part in a reasonably short time.

It would appear that our letter dated March 26, 1962 was either lost in the mail or misplaced in your files. Please note that we have quoted in our letter File Ref. No. 152/37-2-3-352, whereas your latest correspondence refers to File No. 152/37-2-3-352A. This might lead to a duplication of files for this one estate. We are enclosing herewith a copy of our letter dated March 26, 1962, with a carbon copy of the account of T. Eaton Company for \$31.50 for clothing supplied for the burial.

We have noted your observations concerning the various claims against the estate and we therefore suggest that you pay first the funeral account of \$313.86 owing to Hirst Funeral Chapel Ltd. and the account of \$31.50 owing to T. Eaton Co. for clothing supplied for the burial, from the cash assets on hand in the amount of \$340.16.

As far as the other debts are concerned, we will have to be very patient before they could be fully paid by the heirs of the estate.

With regard to the land asset, we agree with your suggestion that an agreement should be reached between Collins Pierre and Everest Tommy dividing 1/3 interest to Collins Pierre with Peter Pierre's house and 2/3 interest to Everest Tommy together with his own house of which 1/3 will be held in trust for Johnny Jameson until he becomes of age.

I wish to advise that the surveyors are here and this would be the appropriate time to have the area properly subdivided by Survey

We recommend the approval of the Will - the disapproval of the will as suggested in your letter would be very unpopular and impractical.

We have your letter of April 27th and will now deal with the various points you mention.

Funeral expenses are a first charge on the estate and will be paid first out of the assets. There is no account from the T. Eaton Company for \$31.50 for clothing supplied for the burial. Incidentally the amount of cash on hand is \$340.16 since the Old Age Security payment was \$65.00, not \$55.00 in this case.

the estate
With respect to the claim of Mr. Harrison for legal services, since ~~these were~~ *these* law services performed within the six year period his account is not barred and is fully recoverable. The fact that he did not recover prior to the death of Peter Pierre does not invalidate it. We have no doubt that Peter Pierre was properly indebted to Mr. Harrison since we are familiar with the services performed by Mr. Harrison and the matter has been fully considered here.

The land asset of the deceased is answerable in the same way as other assets for its share of the debts and it cannot be transferred to anyone until it has borne its share of the debts. Consequently if Peter Pierre and Everest Tommy are to take the land they must first see that the debts in the estate are all paid before they can receive title.

It would occur to us that the will can only be properly construed by dividing the land 1/3 to Collins Pierre together with Peter Pierre's house, 2/3 to Everest Tommy together with his own house of which 1/3 will be held in trust by him for Johnny Jameson until the latter is grown up at which time his 1/3 must be sold and the proceeds paid to him. This is the only construction that we can place upon the will to which



practical effect can be given. Failing this course we think the Minister will have to be asked to disapprove the will under the provisions of the Indian Act relative to disapproval of wills and in that case the deceased will be presumed to have died intestate in which case his brother Etienne Pierre will come in as an heir and both Everest Tommy and Johnny Jameson will be excluded.

The agreement of Collins Pierre and Everest Tommy to divide the land equally between them seems to take no account of the interest which Johnny Jameson was devised by the testator of Everest Tommy's obligation to look after Johnny Jameson if he is to benefit by the will. In our view the agreement should provide that Collins Pierre will take 1/3 of the 6 acres together with Peter Pierre's house, Everest Tommy will take 1/3 together with his house and the other 1/3 will be held by Everest Tommy in trust for Johnny Jameson until the latter attains the age of 16 at which time his 1/3 shall be sold and the proceeds paid to him or to a guardian on his behalf. The agreement should further provide that title cannot be transferred until all the debts are paid.

In this connection we know of no reason why the claim of Hayes-Palmer Motors Limited should not be paid. Either the debt is legitimate or is not legitimate. If not legitimate it will not be paid. If legitimate the reason you give for not paying it is not sound. Unless therefore you can show us that the claim is fraudulent there is no way that we can avoid paying that debt in the same way as any other.

Receipt is acknowledged of your letter dated April 18, 1962 regarding the above estate.

Since you mentioned that funeral expenses are the first charge against an estate, the funeral account of \$313.00 owing to Hirst Funeral Chapel and the account of \$31.50 owing to T. Eaton Co. Ltd. for clothing supplied for the burial, could be paid first from the proceeds of the cash asset being some \$330.16.

You have advised that the account of Hayes-Palmer Motors and the claim of Mr. Harrison, Barrister, appear to be in order and legitimate and therefore should be treated on equal basis with the other debts against the estate. You further mention that the claim of Mr. Harrison is not outlawed since his last service performed according to his bill of cost was on April 7th, 1956, i.e. less than six years before the death of Peter Pierre.

Are we correct in stating that the claim of Mr. Harrison for legal services performed prior to March 11, 1955, i.e. more than seven years after the death of Peter Pierre is outlawed and therefore could not be considered as legitimate debt against the estate?

With regard to the land asset, we are certainly opposed of selling the six (6) acres parcel in order to pay off the debts. There are two Welfare houses on this parcel of land, one belonging to the late Peter Pierre and the other belonging to Everest Tommy.

- 2 -

It is our intention to have the six (6) acre parcel subdivided by Survey into two three-(3) acre parcels. As mentioned in our letter of March 20, 1962 Everest Tommy is looking after Johnny Jameson who is a non-Indian and we therefore recommend that the *boy* share of the be transferred to Mr. Tommy.

Collins Pierre and Everest Tommy were interviewed and they have agreed to have the six (6) acre parcels subdivided in two equal parcels. They further agreed to pay off through this office, the account of Overwaitea Ltd. and the account owing to Koksilah General Store. They are quite reluctant in paying the claim of H.R. Harrison and the account of Hayes Palmer Motors. They feel that the account of H. R. Harrison is outlawed, after all those years where Mr. Harrison could do something if he was really anxious to get paid from Peter Pierre's himself. As far as the account of Hayes Palmer Motors is concerned this firm has seized the car for default of payment and they certainly got their money worth in selling it with profit to someone else.

We shall await your further comments on the above matter before taking any action with regards to the outstanding debts against the estate.

We have your letter of March 20th 1962 together with the application for probate of the will of Peter Pierre, the will itself, and other documents listed.

We have reviewed the file and have read with care your comments.

Assets in the estate, outside of the house and land in Cowichan Indian Reserve No. 1, appear to be some \$340.16, and the debts are substantially in excess of the cash. In this connection we would point out that funeral expenses are the first charge on the assets of an estate and our file shows that there is a funeral expense of \$313.86 owing Hirst Funeral Chapel Limited after a cash payment of \$81.14 (by whom we do not know).

The other debts listed will all have to be treated on an equal basis, including those of Hayes-Palmer Motors Limited and H. R. Harrison, Barrister, unless you can show us that neither claim is legitimate, that is to say is false or fraudulent or of some similar nature, which we do not think likely. The claim of Mr. Harrison is not outlawed since the last service performed according to his bill of costs was on April 7th 1956, i.e. less than six years before the death of Peter Pierre.

In the circumstances we see little alternative but to place up for sale the six acre parcel in Cowichan Indian Reserve No. 1 and to use the proceeds for payment of the debts. If there is any surplus it will be disposed of in favour of the heirs or beneficiaries. In



this connection we find the will somewhat difficult to understand since by the first clause the late Peter Pierre purports to give his house and furniture to Collin Pierre and by the second clause what he describes as "my property" equally between Collin Pierre, Everest Tommy and Johnny Jameson adding that Everest Tommy is to benefit only on condition that he look after Johnny Jameson, who is a non-Indian. You will appreciate that this is not an easy will to interpret since the words "my property" include the deceased's house and furniture. Moreover we cannot treat the undated transfer of the house and one acre to Collin Pierre as having any force as not only was the transfer not approved - a requirement of the Indian Act - but the one acre is not identified in any way.

Do you have any objection to advertising the 6 acre parcel and the house thereon for sale by tender?

We note that in the application for probate you list two welfare houses and we take it that both of these houses are situate on the above 6 acre parcel, though one of them apparently belongs to Everest Tommy. This may cause some confusion. We shall await your further report.

By his last Will and Testament dated September 5, 1961, the late Peter Pierre devised his house and furniture to Collins Pierre and his property in equal shares between Collins Pierre, Everest Tommy and Johnny Jameson - Everest Tommy was to receive part of the above property on the condition that he would look after Johnny Jameson.

With regard to the account of H. R. Harrison, Solicitor, in the amount of \$195.00 for professional services rendered for the late Peter Pierre in the matter of the estate of James Kapeal, we feel that this account is out of claim after a period of seven years and should have been collected from Peter Pierre himself while he was living.

As far as our records are concerned, we have no proof that Solicitor H. R. Harrison did in fact render professional services for Peter Pierre. As far as I could read from Mr. Harrison's letters on the file of James Kapeal, these letters contain all kinds of allegations against the Indian Superintendent without proper justification. I am of the opinion that the claim of Peter Pierre against the estate of James Kapeal has been recognized and settled through the efforts of the Superintendent in his negotiation with the Band Council.

Your advice and comments concerning the above would be appreciated.




