INFORMATION

1. [redacted] a Provincial Executive Committee (P.E.C.) meeting was held on 20-11-69 at 9642 Jasper Avenue, Edmonton, Alberta with the following members in attendance:

- William TUOMI
- Harry STRYNADKA
- Doug TOMLINSON
- Bill ASKIN
- Peter ASKIN
- Mike UHRYN
- George SOLOMON (arrived late)

2. UHRYN was elected chairman and read the agenda as prepared by TUOMI:

- (a) Correspondence
- (b) Farm situation
- (c) Party youth problems
- (d) Organization

Bill ASKIN immediately made a motion, which Peter ASKIN seconded, that the youth problems be taken up first. TUOMI objected on the grounds that the youth problem was an Edmonton problem and they were, after all, a provincial executive and provincial problems should have priority over local problems. TOMLINSON supported TUOMI, as did STRYNADKA. Bill ASKIN then revealed that a comrade very involved in the youth problem, Tony SIMONS, was waiting downstairs. Peter ASKIN suggested a time limit be placed on the discussion which would allow time to discuss the other equally important topics on the agenda. SOLOMON arrived at this point and when he was apprised of the situation, agreed with the ASKINS, in view of the fact SIMONS was waiting and in SOLOMON's view, SIMONS had a right to be heard. It was finally agreed the youth problem would be taken up after correspondence. Peter ASKIN then made a motion, which was subsequently carried, that SIMONS be allowed a voice but no vote in this meeting.

3. Under correspondence, TUOMI read a letter from Bruce MAGNUSSON which requested the local Party organizations in the provinces prepare a political assessment of their labour federation conventions in order to assist the national office in its preparations for the Canadian Labour Congress convention to be held in Edmonton in May 1970. MAGNUSSON requested these reports within the next week or ten days. It was agreed that TOMLINSON, who was a delegate to the Alberta Federation of Labour convention,

with the assistance of fellow delegate Art ROBERTS would prepare this report. TUOMI briefly outlined a letter from Norman FROED which concerned the Lenin Centenary Celebrations to take place from November 1, 1969 to April 22, 1970. The letter generally outlined material available for the event and suggested various affairs which could be held. A copy of a poster and a request for the amount required was also included. The poster could be used for all affairs. After a short discussion, a motion to set up a sub-committee of the P.E.C. to make plans for the centenary in Alberta and order the posters based on those plans, was carried. The committee would consist of TOMLINSON, SOLOMON, and Bill ASKIN, with ASKIN as chairman. TUOMI then read a letter from the C.E.C. calling for the setting up of a Wheat for Vietnam Committee. The idea for such a committee had been a direct result of the recent tour of the two representatives from South Vietnamese Provisional Revolutionary Government who, on being told of the serious grain problem on the prairies had suggested a boatload of wheat be shipped to North Vietnam. The comrades had taken up the suggestion and, according to the letter, the possibility of the success of such a campaign is good if taken seriously. The idea was to set up a committee headed by people well known in the farm unions and peace movements who would sign up farmers to pledge so much wheat. This campaign would carry on through the winter and then in the spring, a delegation would go to Ottawa and request the government move the grain to the west coast where it would be loaded on a Soviet ship for Haiphong. The committee would need to be broadly based in an attempt to involve people from both the leadership and membership of the N.D.P., local prominent personalities, wheat pool officers, co-op spokesmen, etc. The letter noted the Women's Auxiliary of the National Farmers' Union in Saskatchewan have already taken up the project for humanitarian reasons. However, the campaign had important political consideration for the Party as it would provide a good project for the peace movement and a number of supporters in the farming areas to take up. The letter emphasized the need to act quickly in order to get the project under way and the importance of the Party becoming involved to make sure responsible and reliable people are involved in the initiation of the project. The Centre has offered assistance once the local committees are established. During a discussion of the proposed campaign, Peter ASKIN suggested that since it would be on two levels, among the farmers and in the peace movement which was mainly in the cities, if a really good campaign were conducted in the cities, possibly enough money could be raised to ship the grain to the coast without having to go to the government or Wheat Pool for assistance. STRYMDKA observed this would remove the politics from the whole campaign. The propaganda issue involved in trying to have the government ship the grain would be more worthwhile than actually getting the grain to Vietnam from a political point of view. TUOMI stressed the importance of having a broad committee since there was considerable opposition to the Party in the countryside and if they only relied on Party supporters to donate grain they would not even get a galley full. SOLOMON stated there would need to be much more

also agreed with the segregation of students from young workers. He cited his own involvement in a mixed group during his youth which he called "a very sterile experience" due to campus people being in the same group as young workers. Peter ASKIN called for organizational independence in Party youth work. He also questioned McFADDEN's calling of a Y.C.L. meeting at the same time as a Provincial Committee (P.C.) meeting was being held. He stated all P.C. members involved in the Y.C.L. were excused from attending the P.C. meeting. He knew the agenda for the P.C. was on the economic crisis but in the absence of the Y.C.L. members, the P.C. took up the youth question and also took it upon themselves to appoint FRASER as Provincial Organizer of the Y.C.L. Peter ASKIN stated these actions would be challenged at the next meeting of the P.C. He stated he would like to see re-affirmation of some of the basic principles of the foundation of the Y.C.L. at tonight's meeting as they had been re-affirmed at the Y.C.L. meeting on 12-11-69, and that these decisions be forwarded in the form of a memo to the National Youth Organizer of the Party.

6. TUOMI then took the floor and after stating the debate could not be completed at this meeting and that the whole situation arose as a result of the lack of communication between the young comrades and McFADDEN as well as a rather subjective approach to the question on the part of some of the comrades, he launched a blistering attack on the young comrades and their paper. He accused them of slandering the P.C., of allowing rumours of expulsion to spread and of being oblivious to Party discipline. On the matter of fraternal relations between the Party and the Y.C.L., he questioned how such relations could be established when Party members attend Y.C.L. meetings and attack the Party's right of authority. He commented that it was fortunate that the Y.C.L. membership was made up of Party members as these attacks on the Party in the Y.C.L. meetings would have left a very poor impression with non-Party people. TUOMI did not think the question of Y.C.L. structure could be discussed until the problems posed in the paper were aired out. In view of the fact the 20th Party Convention had agreed that a Y.C.L. be created and that the C.L.C. was to begin organization, then it was up to the Party to create a Y.C.L.

7. Bill ASKIN felt the idea of two Y.C.L. clubs did have merit but his objection was that McFADDEN had decided on a straight student worker decision rather than an intellectually oriented club and a worker oriented club. He agreed with TUOMI that lack of communication was one of the causes of the problems but he also noted personality clashes had a lot to do with it. At the Y.C.L. meeting at which this paper was accepted, FRASER made the statement that Peter ASKIN and SIMONS were to be excluded from the Y.C.L. Bill ASKIN got the impression this decision was made in consultation with McFADDEN and was possibly based on fake information fed to him by Paul and John GREENE who have personal dislikes for Peter ASKIN and SIMONS. In Bill ASKIN's view the Y.C.L. cannot be built on a personality basis. Peter ASKIN stated the Party was not being challenged, only

McFADDEN who in their view, completely exceeded the authority given him at the 20th Convention, in his approach to the Y.C.L. in Edmonton. Peter ASKIN agreed it was unfortunate the Party's dirty linen was displayed in public but the reception for the touring Vietnamese was the first occasion the Y.C.L. had to discuss McFADDEN's decisions. With regard to FRASER's statement on the exclusion of ASKIN and SIMONS, FRASER had stated this was a P.C. decision. TUOMI commented that was a "bloody, vicious rumour" but the ASKINS and UHRYN all heard FRASER make the statement. With regard to circulation of the paper in question, Bill ASKIN stated that other than the copies distributed at this meeting and the copy FRASER had taken while it was being printed and had given to TUOMI, all other copies are in the hands of the Y.C.L. secretary. When STRYNADKA commented on the anti-Party tone of the paper, UHRYN assured him they were not attacking the whole Party, only McFADDEN. In STRYNADKA's view, you cannot separate one individual from the whole Party. SIMONS stated he was very encouraged by the discussion and if he were in a position to make a motion he would move the debate continue but that the meeting be enlarged to include all Y.C.L. members and potential Y.C.L. members, and allow them voice and vote since they should have a say in structural discussions. The comrades generally disagreed with this idea although UHRYN suggested FRASER and Paul GREENE be invited to attend the next meeting since they are involved and have strong views on the subject. TUOMI became somewhat upset at SIMONS' suggestion because in his view the P.E.C. would be reduced to a consultation group and in this way the young comrades were attempting to make the Y.C.L. immune to Party control. He stated the P.E.C. had the right to assign people to certain fields of work. SIMONS observed that according to McFADDEN, the Y.C.L. groups set up in Winnipeg and Vancouver were mostly made up of non-Party people but here since the Y.C.L. members are Party comrades, McFADDEN was attempting to enforce Party discipline on the Y.C.L. which, in SIMONS' view, was not right or just. The Edmonton Y.C.L. members were being exploited because they were Party members. TOMLINSON made a motion that the P.E.C. continue this discussion in another meeting with the right to bring in witnesses for their viewpoints. Peter ASKIN seconded the motion which was passed in short order. They agreed to meet again on 27-11-69.

8. SIMONS left the meeting and the P.E.C. comrades continued with the farm question. TUOMI briefly reviewed the disastrous situation in the rural areas of the province. He stated he had been out in the Hollow Lake - Waskatenau area over the weekend and had seen for himself what it was like. He said there were ten million acres unharvested in the province and the only help the farmers are getting is a \$1 per acre P.F.A.A. payment. On the National Farmers' Union (N.F.U.) campaign he stated the comrades were all doing a good job on it. He stated the A.U.U.C. membership in the countryside had been urged to get into the campaign but he did not know what response there had been. With regard to the proposed tour of the Peace River area by Don SHARON as agreed to in the recent P.C. meeting, SHARON would be unable to go so TUOMI suggested he replace SHARON on the tour. A motion to this effect was carried. TUOMI would

try to make the trip during the week of November 24 to 28 providing he could finish preparing "Alberta Roundup" in time to go. TOMLINSON stated that when TUOMI makes the tour of the Peace River area he should advise the farmers that the Edmonton and District Labour Council (E.D.L.C.) representing the working class in the city, are very much concerned about the plight of the farmers and a resolution to this effect had been passed at a recent E.D.L.C. meeting.

9. With regard to "Alberta Roundup" it was agreed the issue must be prepared and mailed next week in order to try and influence delegates to the Farmers Union of Alberta (F.U.A.) Convention commencing December 8, 1969 in Edmonton. The cost of mailing would be \$300 which TUOMI guaranteed to raise. In the meantime, a motion was carried calling for a letter to be sent to all Party clubs in the province to send in a special contribution immediately to pay for the cost of Roundup.

10. On the question of Party organization, particularly as it pertains to Edmonton, TOMLINSON urged the reconvening of the Edmonton City Committee (E.C.C.) as there were a number of pressing civic issues to be taken up as soon as possible. These included rent control, a rental review board for the city and the ward system. It was agreed the E.C.C. would be reconvened as soon as possible. TOMLINSON announced a new club formed in the union movement called the Union Centre Club, was holding its first social function on 22-11-69. He invited all the comrades to attend. UHRYN announced a Teach-in was being held at the University of Alberta (U. of A.) on November 24 and 25 on the subject of U.S. domination of the Canadian economy. He suggested the comrades attend the evening panel discussions. Bill ASKIN submitted a Notice of Motion that providing the Y.C.L. did not take up all the next P.C.C. meeting, that the peace movement be discussed. He noted the Edmonton Committee to End the War in Vietnam (E.C.E.W.V.) was holding its executive election in December and in his view, this committee was too important to be left in the hands of the Trotskyists. He also noted the results of the November 15th protest should be discussed since a number of individuals were working at cross purposes which did not help the Party image or role in the peace movement.

It would appear the young comrades are right in assuming that FRASER, in consultation with McFADDEN, made the decision on SIMONS' and Peter ASKIN's exclusion from the Y.C.L. Our report on the P.C. meeting indicated the P.C. only agreed to FRASER's appointment as Provincial Organizer and SIMONS' exclusion from one particular meeting. See report on [redacted] dated 25-11-69. Further information on the Y.C.L. situation will be reported on the appropriate file.

15. With reference to para. 8, it has been learned that TUOMI attended a C.P. of C. Hollow Lake Club [redacted] meeting on 16-11-69.

16. With reference to Bill ASKIN's remarks in para. 10 regarding the November 15 demonstrations, it is known the Party was to hold a meeting on that day in the Corona Hotel but the reservation was cancelled at the last minute with very few comrades being advised of this change.







3. MAKOWECKI advised that he had visited several clubs on the issue of the Berlin crisis and the international situation. He continued that he had met with the Myrnam, St. Paul and Two Hills-New Kiev Clubs, as well as with the Provincial Committee members at Wainwright.

4. MAKOWECKI then outlined the following points concerning his tour:

- (a) The purpose of the trip to Myrnam had been to get the Club into action. The Club membership had agreed to have a public meeting on the 27th October, 1961 and it had turned out successful with approximately forty-five people in attendance.
- (b) According to MAKOWECKI, the Wainwright Club is very active and had hold a public meeting which included a 1 1/2 hour question period. The members had petitions prepared for signature and had sent telegrams in connection with the Berlin situation.
- (c) In respect to the St. Paul Club, it was felt that the problem was that of getting the membership to hold

meetings. The attitude of the Club was that of working independently rather than collectively under the guidance of the Provincial executive. MAKOWECKI felt that more attention should be given to this Club.

- (d) According to MAKOWECKI, the Two Hills-New Kiev Club ^{et al.} have not met since February, 1961 and felt that they should be asked whether or not they are going to meet. He has suggested that the comrades advertise and popularize Association of United Ukrainian Canadians work for the older members while the comrades at Two Hills should get Party work done on their own initiative.
- (e) ^{op. cit.} The Warburg Club had been meeting regularly once a month even during the summer months. At the present time they are meeting even more often than that.

In summarizing, MAKOWECKI advised that Nelson CLARKE would be arriving in Edmonton on the 21st November, 1961. In accordance with a secretariat decision, it had been tentatively arranged to hold public meetings at St. Paul on the 22nd November, 1961 and Two Hills on the 23rd November, 1961 with CLARKE in attendance. According to MAKOWECKI, neither St. Paul or Two Hills had held a public meeting for quite some time and he felt that the proposed meetings would do much to generate new interest in the two clubs. In answer to a question concerning Hollow Lake, ^{op. cit.} MAKOWECKI advised that a fair public meeting had been held, as well as a good Party club meeting, at which two new members had been recruited.

5. At this point, TUOMI advised that there are a number of people at Warburg in their thirties and forties who are very close to the Party and get along well with Party comrades. He felt that they would not be recruited into the Party unless action was taken by the Party in Edmonton. He suggested "John", as well as Edwin and Hazel BROADBENT as examples of that type of person. He concluded that these persons should be visited on the next organizational trip and attempts made to recruit them into the Party.

6. TUOMI then presented the following summary of his southern Alberta tour. In Calgary the war crisis, as well as the Berlin crisis had been discussed and it had been noted that each club was tackling the problems in a way which suited themselves. As an example, he stated that the Mathew Popowich Club had immediately drawn up a series of petitions. He added however, that the Calgary Party clubs were doing a fair job, but were working independently of the City Committee. TUOMI felt that there was a possibility of some good work being done in Calgary, but added that more work should be done with the Clubs and assistance given to the Calgary City Committee.

7. TUOMI advised that he had spent part of an afternoon with a number of officials from the Calgary Labor Council, including the president, Leo CHIKINDAS. He felt that their disposition was quite different from the Edmonton

Labor Council in that they had their separate and strong opinions on international affairs however, they were also prepared to listen and do so with great care. The chairman of the Calgary Labor Council had requested a special meeting to discuss the Berlin situation. TUOMI was of the opinion that the Calgary Labor Council did not seem to be under the thumb of the Canadian Labor Congress as was the Edmonton Council. He continued that in Calgary there were at least two young fellows, who worked for the Calgary transit system, who were ready for the Party.

8. ^E TUOMI advised that a house meeting had been held in Blairmore, Alberta with about a dozen people in attendance, many of whom were connected with the movement in the thirties. *CP file*

9. Concerning Lethbridge, ^E TUOMI disclosed that the secretariat of the Party had made some decisions prior to his southern tour. The secretariat had decided to divide the present membership in Lethbridge into two separate clubs; organize a Lethbridge City Committee and re-organize the work of the clubs on a totally different basis. He continued that during four days spent in Lethbridge, he saw each of the Party members individually and did a good deal of leg work. As a result of his canvassing, discussions and visits, there had been four new members recruited into the Party. Two new members had been taken into each club, giving Lethbridge a total membership of seventeen; nine in one club and eight in the other. The Lethbridge City Committee had been organized and included George SANTA, Mike KOLIASKA, Mary KUN and William ROMANIUK. ^E TUOMI felt that the situation had improved, but the Lethbridge Clubs would need a lot of help and assistance as the City Committee members were not capable of handling any crisis which might arise. The clubs would function properly for awhile because the idea of two clubs would be new and novel, but he felt that the old grievances were so deeply ingrained that they might erupt at any time. According to TUOMI, the Lethbridge area would require quite a bit of attention from the Provincial office. TUOMI disclosed that he had conversed with Alex and Mary KUN on the Hungarian work. The Kossuth Sick Benefit Society (I.M.B.F.) in Lethbridge had practically disappeared due to a drain on finances and the fact that people were not turning out to meetings. He added however, that the press campaign was supported. The Hungarian organization had no broad mass organization other than the I.M.B.F. which made it very difficult for the Communists. He continued that with assistance from the Party executive in Edmonton, the membership of the I.M.B.F. could be revived by adding to the cultural and social activities. TUOMI felt that there was a good possibility of the Party gaining new recruits in the Lethbridge area as there were a number of Party supporters who had been sympathetic for years. *CP file*

10. ^E TUOMI advised that during the Drumheller-New Castle Club meeting, Party recruiting and the Canadian Tribune were discussed. At the beginning of the meeting, the local comrade had agreed to recruit three new members, as well as obtain eight new Canadian Tribune subscribers. He advised that durin

itself, including Party organization; leadership; recruiting; press work, etc. TUOMI felt that this section should not be too detailed as MAKONIECKI would be giving an organizational report to the conference.

16. Concerning Federal election tactics, TUOMI read a letter from the National Executive Committee (N.E.C.) wherein it was requested that in view of the forthcoming Federal election, Saskatchewan, Alberta, Manitoba and Quebec consider nominations in Federal constituencies and advise the N.E.C. of their proposals. According to the letter, Nelson CLARKE had been appointed Federal campaign manager and would communicate with the different provinces. The N.E.C. felt that a number of candidates should be nominated in selected constituencies in the light of the over-all tactic of supporting New Democratic Party candidates. It was suggested that where N.D.P. candidates' records and attitudes did not deserve progressive votes, the Party should say so and not support them. The letter stated that three candidates will be nominated in British Columbia and two in metro Toronto, while other possibilities are under investigation in Ontario. It added that all proposed nominations must be passed on by the N.E.C. The letter emphasized the need for the Party to distribute the Party manifesto and platform in all constituencies. It was suggested that emphasis be placed on "No War Over Berlin".

17. After a general discussion, it was decided to take Peace River, Vegreville and Edmonton East (under active consideration for Federal nominations. SOLOMON stated that if there was a chance of a Party member being nominated as N.D.P. candidate in Vegreville, he would agree with it. In the Edmonton East constituency, SOLOMON felt that a pre-nomination campaign would be required with assistance from every possible comrade.

18. In respect to the Cuban campaign, SOLOMON suggested that due to the length of the meeting, it be referred to the secretariat for consideration.







that Art ROBERTS will not be a delegate but Steve ANDROS would be there. SWANKEY alleged that Dave ROBERTS and ENGLISH will be the only two that the Party could depend upon at the Convention as ANDROS tends to lean to the right and is not a proper person to negotiate on any matter. He expressed the hope that Dave ROBERTS would not make any more of his bad speeches. SWANKEY again stressed the fact to TUOMI that the Party must come out of the Convention in an United Front with District #18 regardless what demands are made by them.

7. SWANKEY further informed TUOMI that apparently some possibility exists for establishing the Blairmore-Belleue Club and as TUOMI would be going to the Crow's Nest right after the Miners' Convention, the matter of organizing this club should be given his full attention on this particular trip to the Crow. Regarding members who could be considered for this club, he listed the following:

- E Tony PATERA
- E Charlie SHAW
- E Jack PERESSINI
- Mrs. PATERA
- Mary WAKAJUK

and JOE BACHURA from Hillcrest. SWANKEY informed TUOMI that he did not know how the Party could expect any strong leadership from this group as there were strong antagonisms amongst them however the Party would give it a try. He singled out BACHURA as being the best one among this group, stating that BACHURA was steady and reliable, not a leader but who would do any job given to him however lacks organizational leadership. SWANKEY further suggested that a leading member from the Coleman Club possibly Steve MALANCHUK could work with the Blairmore-Belleue Club for a period of three to six months as MALANCHUK worked with them on A.U.U.C. work.

8. Concerning the Lethbridge Club, SWANKEY advised TUOMI to drop in and see them if time permitted however he did not know how things were going with them as he had not contacted this particular club for several weeks. He asked that TUOMI arrange a public speaking trip to the Crow for him in about three weeks time.

9. SWANKEY then gave a lengthy outline of Party plans for the May Day and Canada Day celebrations which were sent out to each Province by the N.S.C. Concerning May Day affairs, it had been suggested that United Front affairs should be planned and if this cannot be arranged, the Party should arrange their own affairs. SWANKEY reported that the stress this year is on labour and people's unity and that a strong call for Socialism has been added this year. He added that he had written to the Crow telling them that they should arrange for the Calgary A.U.U.C. orchestra to attend their May Day function which is being held in Fernis-Michel this year.

10. TUOMI informed the other members in attendance that he would be leaving for Calgary on the morning of the 11th. He was instructed by SWANKEY to have Bill TARASOFF
