This is to advise you that Allan Archie Hill, age 33 of R.R. 2 Ohsweken, was remanded until January 8 when he appeared before Magistrate John T. Shillington to-day on a charge of manslaughter.

Mr. Hill is charged in the fatal beating of Allan Decaire, age 24, on the Six Nations Reserve on December 19, 1963. Decaire has lived on the Six Nations Reserve most of his life but is not a member. It is believed he is a member of Gibson Reserve.

Mr. Hill is a married man with two children.

You are, no doubt, aware that this Department does not provide legal assistance to Indians charged with manslaughter. The only case in which defence counsel is provided by the Department is where an indigent Indian is charged with capital or non-capital murder.

Mr. Hill may, if he is without financial means to engage a lawyer, request assistance from The Legal Aid Society, Osgoode Hall, Toronto.

Party Ends in Death

IN MONT

Manslaughter Charge Laid

Allan Archie Hill, 33, of R2 Ohsweken, was remanded until Jan. 8 when he appeared before Magistrate John T. Shillington today on a charge of manslaughter.

Hill is charged in the fatal beating of Allan DeCaire, 24, on the Six Nations Reserve.

Bail was set at \$10,000 cash or \$20,000 property bond.

Provincial police said DeCaire was found unconscious in the snow outside the home of Larry VanEvery, R1 Ohsweken, early Saturday morning.

He was taken to the Lady Willingdon Hospital in Ohsweken and later was transferred to St. Joseph's Hospital in Hamilton.

He died about 5.30 a.m. Sunday. The cause of death was severe head injuries.

Police said a fight oc-

curred following an all-night party at the Van Every home Friday night.

Hill was arrested on the reserve Sunday morning.

Inspector Ray-

mond Devereaux of the criminal investigation branch of the provincial police arrived on the reserve on Sunday to take charge of the investigation.

He is being assisted by Constable Roy Anderson of the Brantford detachment.

INSTRUCTIONS

1. This cover must not be folded under.
2. File should be retained no longer than is absolutely essential. If a file is frequently needed at short intervals, it is better to B.F. it for two or three days than keep it out of Central Registry indefinitely. This ensures its being completed and kept in order and also gives other officers an opportunity of using it.
3. Central Registry must be notified whenever a file is passed directly between one official and another.
4. All outgoing letters should bear the official file number and originator's designation.
5. ONE SUBJECT—ONE COMMUNICATION—Where the contents of outgoing letters necessarily refer to more than one subject, the originator will prepare additional copies for attachment to relevant files.
6. Correspondence must not be removed from file, except as provided in the regulations governing the conduct of correspondence.
7. Incorrectly filed material will not be removed without notification to Central Registry.
8. Official office designations are to be used for routing purposes.
9. Disposal entries on file jackets must be initialled and dated.
10. Urgent Tags, flags and other markers will be removed in Divisional Offices as soon as appropriate action on the folios has been taken.
11. Officials are reminded that strict adherence to the security regulations is essential when dealing with classified material.
