We refer to your letter dated January 9, 1961, concerning the above estates.

1. We entirely agree with you that - as you point out in the last three lines of your letter - settlement of these estates would indeed prove difficult if the former Band Council Resolution is to be rescinded in favour of a new resolution in favour of the Estate of Nicholas Wheatsum as was demanded in your letter of February 3, 1958, on the Nicholas Wheatsum file.

Such action would simply lead to the creation of an insoluble paper problem which does not exist in fact.

2. We are not prepared to recommend approval of the Band Council Resolution dated October 3, 1956, by which the N.W. $\frac{1}{4}$  and the S. $\frac{1}{2}$  Lot 33 and a part of the E. $\frac{1}{2}$  of Lot 31 was allotted to Alice Wheatsum for the following reasons:-

(a) The description in the Band Council Resolution is not correct. The alleged property consists of part of the N.W. $\frac{1}{4}$  and part of the S. $\frac{1}{2}$  of Lot 33 and part of the E. $\frac{1}{2}$  of both Lots 31 and 32.

(b) Practically the entire area is simply thick timber and bush land.

3. Amelia Bob, the sole heir of the Estate of Alice Wheatsum, has her house on Lot 31, close to the Trunk Road. We are prepared to recommend an allotment of this homestead plus the immediate surrounding area to her and we feel that this can best be done when the survey is completed. There is no problem on the ground at the moment.

4. If you are prepared to accept the above recommendations, then both the estates of Nicholas Wheatsum and Alice Wheatsum (Bob) can be concluded as there are no outstanding problems.



We have your letter of 29th November, 1960, on the estate of Alice Wheatsum in which you tell us that you still have in your agency the sum of \$27.86 for distribution to the heirs of the late Alice Wheatsum.

Under the will of Alice Wheatsum the land in Quamichan Village, Lot No. - was devised to her daughter Amelia and all her personal belongings to Amelia Bob also. Accordingly the cheque you hold should be delivered to Amelia Bob as sole beneficiary of the will of Alice Wheatsum.


You tell us now that the alleged interest in the N.W. 1/4 of Lot 33 and the S 1/2 of Lot 33 and part of the S 1/2 of Lot 31 all in Cowichan Indian Reserve No. 1 which have been dealt with previously in these various estates are involved not only in the estate of Nicholas Wheatsum but also of Alice Wheatsum and Veronica Daniels whose file reference you give as 9152-177. The file reference for Veronica Daniels is in fact 9152-169. We are at a loss to know how Veronica Daniels is involved in the estate. The information given on the file of Nicholas Wheatsum indicates that his heirs were his daughter Alice Wheatsum Bob, Mrs. Adam Jisay, and Mrs. Louisa Daniels. Is Mrs. Louisa Daniels also Veronica Daniels?

The correspondence on file indicates that the Band Council allotment of the above land in favour of Alice Wheatsum Bob dated 3rd October 1956 (to be found on file 9152-53) was not recommended for approval by the Administrator of Estates by reason of an Order in Council of 20th November, 1940, which directed that compensation for certain land said to be assets in the estate of the late Nicholas Wheatsum should be apportioned to Alice Wheatsum, Mrs. Louisa Daniels and Mrs. Adam Jisay in certain proportions.

If the Band Council is now prepared to allot the land in question in favour of the late Nicholas Wheatsum then we take it that it will pass to the estate of the late Alice Wheatsum one-half, to Veronica Daniels estate 1/4 (assuming that Veronica Daniels is Louisa Daniels) and to Mrs. Adam Jimmy 1/4. As has been pointed out previously Alice Wheatsum by her will devised her land in Quamichan Village Lot No. -- to her daughter Amelia but we take it that the land in Quamichan Village Lot No. -- cannot be construed to include the land in Lots 39 and 31 which will therefore pass as residue-so far as the one-half interest of Alice Wheatsum is concerned - to her son and daughter. The former of these, Frances Bob is a non-member of the Cowichan Band and cannot of course hold land on the Cowichan Reserve. We can foresee that settlement of the title to these parcels of land may prove difficult if the former Band Council Resolution is to be rescinded by the Band in favour of a new Resolution in favour of the estate of Nicholas Wheatsum.

In response to your memo of November 10th and previous follow-ups; apparently there was no action taken regarding your memo of August 7, 1958, that is to disburse the \$26.65 made payable to the Cowichan Indian Agency Trust Account for distribution. A review of our records indicates that the \$26.65 in savings account 152-198 in 1958, now totalling \$27.86, is still in trust at Ottawa and if it is sent here, we will see that it is distributed.

Regarding the land assets, it would appear that there is need for cross reference here between this estate and that of Nicholas Wheatsum, File 9152-53, and also the Estate of Veronica Daniels, File 9152-177, since it is noted that Amelia Bob will have the interest of Alice Wheatsum in the lands comprising the Nicholas Wheatsum Estate and, further, that the Veronica Daniels Estate holds an undivided interest in part of Lot 33 and Lot 31 from the Nicholas Wheatsum Estate. To date no agreement has been reached amongst the heirs concerned regarding the division of land assets. 162

We note that in the estate of Nicholas Wheatsum, a request was made on February 3, 1958, for a rescinding of Council Resolution dated October 3, 1956, granting title to Alice Wheatsum, alias Bob. Accordingly, we have drawn up a new resolution for Band Council's signature at their next meeting with the view of obtaining confirmation of these land assets in favour of Nicholas Wheatsum estate, as requested.

You will be further advised if this is received favourably by Band Council.







Enclosed is the approval of the will of the late Alice Wheatsum.

The late Alice Wheatsum died testate on the 28th of April 1958 leaving as her sole heirs and next of kin her son Francis Bob and her daughter Amelia Bob. The assets in her estate consist of the property she inherited from the estate of Nicholas Wheatsum that is a  $\frac{1}{2}$  interest in the northwest quarter and the south half of Lot 33 and a portion of the east half of Lot 31, Cowichan I.R. No. 1; Old Age Assistance and Old Age Security cheques totalled \$75.00 and \$1.34 from Savings Account in the Bank of Montreal, Duncan B.C.

The debts in the estate of Alice Wheatsum consist of one of 6 dollars owing to Dr. J. S. Goodbrand and one of \$42.35 owing to Peoples Credit Jewellers, Nanaimo.

Under separate cover cheques will be sent you in favour of Dr. Goodbrand and Peoples Credit Jewellers.

The land assets in the estate will pass to Amelia Bob while the balance of the cash remaining falls into intestacy and will be shared equally between Francis and Amelia.

Please refer to our last letter on the Estate of Nicholas Wheatsum file 9152-53 in which we requested a Band Council Resolution to cover the property and an agreement of heirs of the Nicholas Wheatsum estate. Amelia Bob will take the place of Alice Wheatsum in that Agreement.



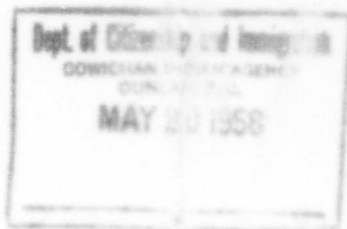
