1. On 11 Apr 07, the lead vehicle in a 3-coyote patrol struck an Improvised Explosive Device, which injured one and killed two Canadian soldiers, in the vicinity of Zhari district of Kandahar Province, Afghanistan.
2. On 12 June 07, CO 2 RCR BG ordered a summary investigation into the injury of Cpl Dicks. He did not order an investigation into the deaths of MCpl Stewart or Tpr Pentland.
3. Pursuant to QR&O 21.47, a SI relating to an injury or death must contain findings as to: the cause of the injury or death, whether the deceased or injured member was on duty at the time of the injury or death, whether the deceased or injured member or any other person was to blame for the injury or death, and whether the injury or death was attributable to military service.
4. The TOR requested the investigating officer to make a number of findings. These included, but were not limited to, those findings required by QR&O 21.47.
5. **SI Report.** On 30 Jun 07, the investigator submitted the SI report. The report made all findings requested by the TOR and made four recommendations that related to TTP. On that same day, CO 2 RCR BG endorsed the findings and recommendations of the report.

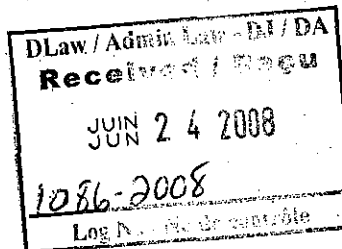

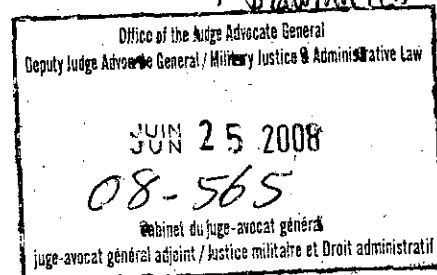
