Thank you for your letter of June 29, 1992 regarding [REDACTED]

An official of the Canadian Government spoke to [REDACTED] in Sarajevo on September 1. [REDACTED] indicated that he was well, that he was working in a local hospital, and that he did not wish to leave Sarajevo at this time. His mother has been given this information.

[REDACTED] has been located and visited by a member of the International Red Cross. He also has been included by the Croatian authorities on the list of prisoners of war they wish to exchange with those holding him. It is my understanding that a major prisoner of war exchange may take place this month and I hope that [REDACTED] will be included in this exchange, should it occur. As you are aware, [REDACTED] who is a Croatian as well as a Canadian citizen, was taken prisoner while fighting as a member of the Croatian army. In these circumstances, the International Red Cross and the Croatian authorities are the appropriate bodies respectively to ensure his well-being and to secure his release.

I have given serious consideration to the financial implications of Canada's enforcement of the United Nations-mandated embargo for those, such as [REDACTED], who have travelled, or had planned to travel, with Yugoslav Airlines (JAT) from or to Canada. Accordingly, I have approved the issuance of certificates to JAT authorizing it to refund Canadian residents and travel agents holding unused or partially used tickets acquired prior to the embargo. JAT has also been authorized to pay other carriers to return to their countries of origin foreign residents currently in Canada who arrived in this country with JAT return tickets. There thus are no longer any embargo-related impediments within the jurisdiction of the Canadian Government to such action by JAT. There is no guarantee, however, that JAT has sufficient funds in Canada at the present time to cover all contingencies, or that it will be able to transfer funds from accounts elsewhere which are under the jurisdiction of other national authorities.

Dear Madame Minister:

As the situation is rapidly deteriorating in Bosnia-Herzegovina and further strategies are being considered to stabilize matters, including armed intervention, I ask you to take immediate measures to ensure the safety of Canadian civilians in the area of Yugoslavia. *JPD*

I also urge you to review the impact on Canadians and Canadian enterprises of sanctions against Serbia and Montenegro, with a view to alleviate, as far as possible under the terms of the Economic Measures Act, any loss or damage they may have suffered as a result of these sanctions.

First, there appears to be no clear plan to safely evacuate Canadians from Sarajevo. To date, they have been encouraged by our mission in Belgrade to not attempt leaving the Capital for fear that they could get hurt. While sensible in some ways, I believe this policy must now be revised in light of a potential escalation of hostilities. I would therefore like to know what measures, if any, have been set in place to provide for their safe relocation.

I would particularly like to ask about [redacted] a young Canadian who was completing his doctorate in medicine at the University of Sarajevo when the conflict broke out. [redacted] nother has expressed very deep concern over the government's lack of assistance to ensure the safe return of her son to Canada. Please tell me what specific steps will be taken to ensure this young man's safe return.

I am also enclosing a copy of a letter from Nancy Manning which details the case of [redacted] a Canadian taken prisoner at the POW camp at Knin in Croatia. I am informed that the only assistance offered by your department to ensure the fair treatment and/or release of [redacted] was to contact the International Red Cross to see if they could locate him. In light of the fact that it may take months before the Red Cross finds [redacted] and considering the mistreatment inflicted on prisoners in these camps, I urge you to do more. For instance, will official representations be made by the Canadian government to the Serbian authorities, and other concerned parties? I would appreciate receiving a detailed report on the government's actions in this case.



With respect to the impact of sanctions applied against Serbia on Canadians, I ask you to give every consideration to the situation of [REDACTED] a Canadian whose long awaited dream of travelling to Europe has been shattered by the suspension of the licences on Yugoslav Airlines (JAT) for air services between the two countries, and the freezing of Yugoslavian assets. [REDACTED] has been informed that Canada must respect the terms of the UN economic measures resolution against Serbia, and thus, cannot unfreeze parts of the Yugoslavian assets to allow for the reimbursement of [REDACTED] tickets.

In the wake of the ratification of Bill C-53 which grants the Canadian government more authority and flexibility in the imposition of sanctions against foreign states, and in the aftermath of the recent unfreezing of Iraqi assets for humanitarian purposes, I urge you to further review [REDACTED] request. Hopefully, a more human response can be developed for someone who may have lost years of savings, and who is now prevented from seeing family and friends after a long separation.

I thank you for your attention to these matters and await your reply at your earliest convenience.

Dear Mr. Axworthy,

I am contacting you on behalf of the Croatian Community of Edmonton. On May 5, 1991, one of our members, Canadian citizen [REDACTED] was taken prisoner and is now being held by the Serbian Chetniks at the P.O.W. camp at Knin, Croatia, which is now occupied by the Serb Army. We have every reason to believe that he is being mistreated according to reports from prisoners who have recently been released from this same camp.

We ask that you take this matter up in the House of Commons with these specific goals:

- 1) Canadian intervention to free Canadian citizen [REDACTED] from the Serbian P.O.W. camp prison at KNIN.
- 2) Ensure that [REDACTED] treatment as P.O.W. prior to release is in accordance with the Geneva Convention.

This matter is of the utmost urgency, since we believe that any Canadian inquiry about this Canadian citizen would certainly help provide some assurance of fair treatment by the Serb Army.

Mom prays*son*survives in*Sarajevo*

Liliana Gliha spent*Mother's*Day pacing the living room of her Toronto home, praying for the phone call that signals her*son*is still alive.

Gliha's eldest*son,*Michael, 26, a medical student in war-torn Bosnia-Herzegovina, has not been heard from in 10 days.

"I don't have any more tears to cry," Gliha said yesterday, her voice cracking with emotion. "I don't know what else to do; I feel totally helpless."

Michael Gliha is in his fourth year of studies at the Medical University of*Sarajevo,*a city now under siege by Serb forces.

Ethnic Croats and Muslims voted to declare Bosnia's independence in February. They have since clashed with minority Serbs and the federal army, both of which are opposed to Bosnia's secession from Serb-dominated Yugoslavia.

At least 600 people have been killed in the fighting which now centres on*Sarajevo,*the site of the 1984 Winter Olympics.

Gliha's*son,*Michael, is somewhere in the middle of it.

"The last time he called, he told me he was trying to get out; he had almost no food left and that was 10 days ago.

"But I know it's worse than even he would say. He wouldn't tell me everything because he knows I am beside myself with worry."

'He said, 'Don't panic.' He didn't realize things were going to explode.'

Gliha has appealed to Canada's external affairs department and the United Nations for help in rescuing her*son.*But they have both told her there's nothing to do but wait.

Canadian consulate officials have warned Michael Gliha not to

attempt to flee by land since Serb forces control much of the countryside.

Western agencies have been unable to bring emergency food supplies through blockades that ring the city. The airport remains closed and under the control of the Yugoslav army.

Yesterday, telephone lines to Sarajevo were inoperable.

Michael Gliha had a chance to leave the city more than a month ago, but decided against it because final exams were approaching.

"Mom, I have been here the whole year at school, I can't throw it away," Gliha quotes her son as saying. "He said, 'Don't panic; don't be unreasonable.' He didn't realize things were going to explode.

"He's a student; he's not involved in politics."

Michael Gliha began his studies in Sarajevo four years ago after failing to qualify for medical school in Canada. "He said medicine was the only career he wanted in life. He didn't care what sacrifices he had to make."

Liliana Gliha was born in Belgrade, Yugoslavia, and fled the country with her family in 1963. She went to Switzerland, where Michael was born, then emigrated to Canada in 1967.

In her Cabbagetown home where she lives with her husband and two other children, Gliha yesterday kept vigil beside the phone while watching television to digest the latest reports from Sarajevo.

"For Mother's Day this year, I want my son back. Alive," she said.
