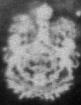

Further to our letter of September 5th dealing with Lot 62, we stated in that letter that all that was required was the quit claim from Agnes Flores which would enable us to transfer the land to Johnny Cassel and Stanley Modeste in accordance with the division made by them.

We should have mentioned, of course, that the small parcel Stanley's portion occupied by Sarah Modeste should be quit claimed by Stanley to Sarah and as Sarah's guardian is Louise Georgeson she should sign on behalf of Sarah.

This is in reply to your letter of July 17th, 1961 concerning Lot 62 which is involved in all of the above estates. In the conclusion of your letter you state that it is your understanding that a quit claim from Agnes Flores, a daughter of the late Ernest Modeste (9152-204) is all that is required before title to Lot 62 can be confirmed in the name of the three Modeste boys Johnny, Cassel and Stanley.

We have reviewed the material and it would appear that you are correct. All of these having an interest in the undivided 2/27 interest held by the estate of Ernest Modeste, with the exception of Agnes Flores, have quit claimed in favour of Johnny Modeste. It is true that Ernest's widow Mary Modeste who took an undivided 1/3 interest in Ernest's estate upon his death intestate has not quit claimed in favour of Johnny but that is because Mary died intestate on the 31st March, 1940, and we believe her entire interest devolved to her four children, all of whom with the exception of Agnes have quit claimed in favour of Johnny. You say that Johnny himself has not quit claimed but inasmuch as he is the beneficiary of the quit claims by the others no quit claim on his part is of course necessary.

The undivided 2/27 interest, *is* the three daughters Chief Modeste, namely, Alexandra, Susan and Mabel have been quit claimed by the three women. In view of the above therefore it would clearly appear that all that is now required is a quit claim by Agnes Flores who has an insignificant interest. If it is not possible to obtain a quit claim from her because of her absence we are prepared to act upon the material we have, more particularly in any event since it would appear that the three boys Johnny, Cassel and Stanley have occupied the land in question for more than 30 years so that if necessary an order could be obtained

We refer to pages 1 and 2 of your letter dated May 14, 1957, concerning the above Estates.

We enclose a sketch plan showing the division of Lot 62 Cowichan I.R. 1. The lines in ink show what is shown on the Provisional Survey, i.e. nothing but the bare outline of the whole lot and the lines in pencil show the internal sub-divisions. We cannot understand why the Surveyors did not attempt to show these internal divisions, as on the ground they are obvious and well marked.

You will be aware that the house and garden lot on which it is situated in the South-west corner is the property devised to Sarah Modeste by the will of the late Marion Modeste (9152-223).

Our review of these files indicates that we still have to obtain a quit claim from Agnes Flores, a daughter of the late Ernest Modeste (9152-204), before title to Lot 62 can be confirmed in the names of the various Modestes. We have written to her at her last known address in Seattle and will forward the quit claim if and when received.

Would you please review your files to check that this is the only action required to confirm title to Lot 62 as far as it can be determined at the moment.

We acknowledge receipt of your letter of the 14th May, 1957, on the above noted estates.

The answers to the questions raised in your letter will, of necessity, by the subject of more than one letter in reply. This letter is mainly on the subject of the North $\frac{1}{2}$ of Lot 63 (see pages 2 of your letter and 3) the division of this lot in the Willie Louie estate should be determined by the Creek running through the Northern part of the Lot. That part North of the Creek was the land devised to Tommy Modeste; that part South of the Creek was that devised to Adeline, since sold to Alphonse Billy for which Certification of Possession 2712 was issued. Certificate of Possession 2712 does not cover all of the land devised to Alphonse Billy and we are therefore returning the Agency copy of the Certificate along with a statutory declaration by Alphonse Billy to the effect that the original copy cannot be located.

We recommend that a new Certificate be issued to Alphonse Billy to cover all of Lot 63, South of the Creek.

Contrary to what was stated in our letter of the 29th April, 1957, paragraph 3, the house of Tommy Modeste which his widow Marion J. Modeste bequeathed to her grand-daughter Sarah, is reported to be in Lot 62, rather than Lot 63. This will be determined exactly when we are able to get the agreement between Stanley Modeste and Mrs. Louise Georgeson, the Guardian of Sarah Modeste, to exclude from the devise to Stanley the house and the parcel of land which will necessarily go with it.



When all the above consents are obtained the Officer in charge of Individual Land Holdings will be requested to issue Certificates of Possession to the three beneficiaries of the Agreement of February 18th, 1954, in accordance with its terms. It will be necessary for you to return to Branch headquarters the Agent's and locatee's copy of Location Ticket 745.

2. North $\frac{1}{2}$ of Lot 63 (or 7 acres thereof between the Creek and Dwelling House)

By Band Council Resolution of June 8th, 1951, on file 9152-65 (the estate of Mrs. Willie Louie) the late Willie Louie, No. 52 of the Quamichan Band was recognized as the owner of Lot 63, Cowichan Indian Reserve #1, and the said Band Council Resolution was approved on behalf of the Minister by the will of Willie Louie on file 9152-52, also approved by the Minister. Willie Louie devised to Chief Tommy Modeste "that piece of my land in Quamichan which is between the Creek and Tommy Modeste's place", and to his widow, Louise, "my land in Quamichan Reserve which is between the Creek and Mr. Young's place".

Mrs. Willie Louie sold her portion of the land described as the South $\frac{1}{2}$ to Adeline Alupay and the latter subsequently sold the land, similarly described, to Alphonse Billy. The Agreement of Sale is on file 9152-65 dated 16th January, 1952, and describes the property as containing 9.75 acres more or less. On January 10th, 1957, Certificate of Possession 2712 was issued to Alphonse Billy for the South $\frac{1}{2}$ of Lot 63 described as containing 9.75 acres more or less.

File 9152-128 contains a Band Council Resolution dated December 19th, 1957, by paragraph 4 of which the following land is located to the late Tommy Modeste "7 acres on Lot 63, Cowichan Indian Reserve #1". By the will of Tommy Modeste on the same file dated July 29th, 1946, the testator devises to his wife "that part of Lot 63 between the Creek and my dwelling house willed to me by Willie Louie". By the will of Judith Modeste, the widow of Tommy Modeste, dated May 30th, 1955, she devised the above land to her son Stanley, excluding "my house with the lot, which I bequeath to my grand-daughter Sarah Modeste". According to Agency letter of April 29th, 1957, the house in question is on the West side of the Lot, North of the Creek.

It should also be pointed out that by the will of Willie Louie on file 9152-52 the testator bequeathed to Cassel Modeste "the share I have in a big house at the Quamichan Reserve near the river and close to Charles Charlie's place". According to Agency letter of April 29th, 1957, this house is South of the above mentioned house. In Agent Moore's letter of March 2nd, 1942, on file 9152-52, the above two houses are referred to and the suggestion is made that Cassel should have about an acre of land surrounding his house.

Having regard to the foregoing comment, it is necessary to determine the following:

- (1) How much land in Lot 63 was devised by Willie Louis to Tommy Modeste?

Was it the North $\frac{1}{2}$ of Lot 63 or the portion of Lot 63 between the Creek and the dwelling house, which apparently is only 7 acres. If the latter is correct then was the devise to Mrs. Louise Louis merely the South $\frac{1}{2}$ of the Lot comprising some 9.75 acres or was it of the portion of the lot South of the Creek. If there is any error as to the description of the land covered by Certificate of Possession 2712 it can be corrected.

- (2) An Agreement should be arrived at between Stanley Modeste, the devisee of the land in question and Cassel Modeste for the exclusion from the ~~devise~~ of the house and surrounding lot occupied by Cassel Modeste's house which may also be made the subject of a separate Certificate of Possession.

- (3) An arrangement should also be arrived at between Stanley Modeste and Mrs. Louise Georgeson, on behalf of Sarah Modeste, if the latter is still a minor, for the exclusion from the ~~devise~~ to Stanley of the house and lot, excluded therefrom in favour of Sarah under the will of Mrs. Mary Modeste.

3. 9.8 acres in Lot 86, held under Location Ticket 8365 in the name of Tommy Modeste.

The above land was devised by Tommy to his widow and by his widow to Stanley and all that is required to be done is to cancel the above Location Ticket and issue a new one in the name of Stanley. Will you kindly obtain the Agent and Locatee's copies of the Location Ticket and return them here for cancellation.

We may point out that the Band Council Resolution of 19th December, 1951, on file 9152-128, by which the above land is located to Tommy Modeste is a nullity.

4. 5 Acres in Lot 88

On file 152/32-3-1-6 there is a Band Council Resolution dated 26th March, 1947, recognizing Tommy Modeste as the owner of the South $\frac{1}{2}$ of Lot 88 as purchaser from George and Willie Michell and a copy of the Agreement of Sale dated 1921 is attached thereto. There is an Agency letter under date of 29th May, 1947, describing the above land as the S.E. portion of Lot 88 and a copy of a Leasing Agreement dated 24th April, 1947, is attached by which Tommy is recognized as the owner of the land under the signature of the Deputy Minister. We would imagine that the above constitutes a Band Council allotment of the land to Tommy Modeste and the approval thereof on behalf of the Minister. Accordingly the Band Council Resolution on file 9152-128 dated

19th December, 1951, by which Tommy Modeste is located to 5 acres in Lot 88 is without effect.

In view of the above we imagine that the Officer in charge of Individual Land Holdings will be prepared to issue a Certificate of Possession to the above land to Stanley Modeste as ultimate beneficiary thereof under the wills of his father and mother, as above set forth.

5. North $\frac{1}{2}$ of Lot 61

The North $\frac{1}{2}$ of Lot 61, Cowichan Indian Reserve #1, is held under Location Ticket 8307 in the name of Ernest Modeste. The above Location Tickets are still on file 152/33-3-61-1 and may now be cancelled and substituted by Certificates of Possession in the name of the new owner or owners. According to the Application for Administration of the estate of Ernest Modeste furnished by you on April 12th, 1957, the surviving heirs of Ernest Modeste are his three daughters Clara Irene Charley, No. [redacted]; Lillian Elvina Modeste, No. [redacted], and his son Johnny No. [redacted], each of whom is entitled to an undivided $\frac{1}{4}$ interest in the said land. Will you kindly interview the heirs and ascertain what are their wishes in regard to this parcel.

We advised you May 8th, 1957, that Johnny Modeste had been receiving all the rentals for the above parcel under the lease of the land to T.F. Davies, totalling \$720.00 to the present time. As we mentioned in our letter Johnny was not entitled to the whole of the rentals and this is a matter which should be settled when discussing the disposition of Lot 61 with the four children of Ernest Modeste.

6. Lease of Lot 62 and Lot 63

The South 7 acres of Lot 62 and the North 7 acres of Lot 63 are under lease No. 1452 to Mrs. Mary Young from April 1st, 1955, to March 31st, 1958, at \$280.00 a year and all rentals have been paid up to the end of 1956. The last three rental payments were made to Stanley Modeste as the presumed devisee of the land. Stanley Modeste is entitled to the North $\frac{1}{2}$ (or North 7 acres) of Lot 63 and he has an interest in the South 7 acres of Lot 62 under the Agreement of 18th February, 1954, signed by some only of Chief Modeste's heirs. It would follow that the heirs, namely, the three surviving daughters of Chief Modeste, who have not yet acquiesced in that Agreement are entitled to $\frac{6}{27}$ of the rentals received for the land. Consequently, in obtaining their consent to the Agreement of 18th February, 1954, they should be asked also to consent to the payment of the rentals to the beneficiaries under the said Agreement. Otherwise, Stanley Modeste would be indebted to his three aunts for $\frac{6}{27}$ of the rentals he has received, as above described.

7. Timber Land on Section 14, Range 3, Quamichan District, and on West 1/2 of Section 13, Range 5, 13 acres or more less.

The above two parcels were allotted to the late Tommy Modeste by Band Council Resolution of December 19th, 1951, on file 9152-128, and we will submit the Resolution for the consideration of the Officer in charge of Individual Land Holdings who no doubt will require further information.

8. Band Council Resolution of December 19th, 1951.

In view of what has been said above, we do not think the Band Council Resolution of December 19th, 1951, is in an acceptable form since it purports to deal with 6 different parcels of land, some of which were dealt with in previous Band Council Resolutions and some of which are under Location Ticket. Consequently, we would request that you approach the Band Council with the request that they rescind the said Band Council Resolution and pass individual Band Council Resolutions locating the late Tommy Modeste to the following parcels:


- (a) The timber land on Section 14, Range 3, Quamichan District;
- (b) The timber land on the West 1/2 of Section 13, Range 5.

Further to our letter of April 12th, 1957, and in reply to your letter of the 28th February, 1957, we wish to give you the following information.

It will take a little while to get the releases requested from the various members of the family; one however, that of Louise Georgeson, is enclosed.

On page 2 of your letter in the third paragraph you ask whether the property described in the will of Mrs. Tommy Modeste (Marion J. Modeste) your file 9152-223, as "my house with the lot" is situated in Lot 62. The house is in Lot 63 on the west side of the lot and north of the creek. Stanley Modeste has a small shack beside it and further south again is the house of Cassel Modeste, referred to in the estate of Willie Louie, your file 9152-52. We can find no record of the description of the property which Cassel received with the house from the estate of Willie Louie; it appears as if it will have to be measured again and an agreement drawn up between Cassel and Stanley Modeste regarding this small parcel. The same would be true of the land around the house bequeathed to Sarah Modeste by Mrs. Tommy Modeste.

Under the heading of the estate of Tommy Modeste on page 2 of your letter you list 8 parcels of land and ask whether or not it is correct as a list of the land owned by the late Tommy Modeste. That numbered 7 in your list, 8 acres in Lot 89 purchased from Jack Seymour, refers to the land listed under No. 1 in your list, 9.8 acres on Lot 86 under Location Ticket 8365. If you check your records and the correspondence leading up to the issuance of Location Ticket 8365 you will see that the land here was purchased

from Jack Seymour. The 4 acres on Cowichan Indian Reserve No. 1 listed under No. 8 refers to the five acres in Lot 88, Cowichan Indian Reserve, No. 2 in your list; this is the land purchased from Willie Mitchell. For the records of his ownership of the land would you please refer to Agency letter of the 29th May, 1947, on your file 13152-79; the correspondence at that time was for the purpose of leasing 4 acres of the land purchased from Willie Mitchell. Apparently the Department was satisfied because the money from the lease was paid to Modeste. It was leased again in 1951 with Council approval. Your same file reference would reveal this.

Again in the third paragraph of page 3 of your letter you ask for our views in regard to obtaining Band Council Resolutions allotting the land to the estate of Tommy Modeste; enclosed is a Council Resolution which was found on the file of Marion J. Modeste; we do not know why it was not sent to the Department when it was passed on the 19th December, 1951. It is noted that the Resolution includes the timber lands referred to in paragraph 3 of page 3 of your letter.

The other questions raised in your letter will have to be subjected to further research before we can give you an answer.

We will try to get the releases requested in your letter and will send them on to you when we have done so.

- (4) Find out if Mrs. Tommy Modeste's "house with the lot" which she devised to her granddaughter Sarah Modeste is situate on Lot 62. If so, Mrs. Tommy Modeste's devise would be without effect if all of Chief Modeste's heirs agreed to the division of the lot as above stated. *No other*

- (5) Tommy Modeste was devised a parcel on Lot 63 between the creek and the dwelling house by Willie Louie (see file 9152-52). Willie Louie was recognized as owner of Lot 63 by Band Council Resolution of June 8th, 1951. (See file 9152-65), which states that Tommy Modeste acquired the North half and Mrs. Louisa Louie the South half. The said Band Council Resolution was approved by the Director but apparently has not been noted by the Officer in Charge of Individual Land Holdings. *and 63*

- (6) Check Lease #1452 regarding Lots 62 and 63 to Mrs. Mary Young for three years, April 1, 1955 - March 31, 1958 at \$280.00 a year file 152/32-3-1-30.

(7) Check lease of part of Lot 88, Lease No. 1531, to Mrs. Mary Young for two years, April 1, 1955 - March 31st, 1957, at \$100.00 a year and get lease file.

(8) Get land files for all of parcels claimed as assets in estate of Tommy Modeste.

(9) Check Savings Account 152-173 and 152-191.

This estate will be considered wound up with the disposition of Lot 62, Cowichan Reserve, now covered by Location Ticket 745 in the name of the above deceased.

Chief Sehellitun died intestate July 5th, 1926, and it is not clear whether he was survived by his only son Chief Modeste but he was survived by the latter's widow, now Mrs. Sarah Williams, and 9 children of the marriage, namely, Ernest, Thomas, Cassel, James, Wesley, Ellwood, Alexandra, Susan and Mabel. Each of the said children was entitled to an equal undivided interest in the land, either ~~one-ninth~~ if the old chief survived his son, or two-twenty-sevenths if Chief Modeste survived his father (in which case Chief Modeste's widow would have a one-third undivided interest). By a document executed on 18th February, 1954, by Chief Modeste's widow and Wesley, Cassel, Ellwood and James, it was agreed that the North 1/3 of Lot 62 should go to Johnny Modeste, the eldest son of Ernest (who had died in 1928); that the centre 1/3 of Lot 62 should go to Cassel and that the South 1/3 of Lot 62 should go to Stanley, the only surviving son of Thomas who had died in 1951. It is understood that this agreement was given effect by a ~~division~~ division of the land amongst the three intended donees. However, as the agreement was not signed by all of the heirs it is not binding upon those who have not signed. Accordingly, will you endeavour to have the three daughters of Chief Modeste, namely, Alexandra, Susan and Mabel, sign a document to the following effect

I..... hereby relinquish any interest I may have acquired in Lot 62, in Cowichan Reserve, on the death of my father and/or grandfather in favour of Ernest, the son of Johnny Modeste, Cassel Modeste and Stanley, the son of Thomas Modeste.

It will also be necessary to obtain from the widow of Ernest and his children other than Johnny and also from the children of Thomas other than Stanley a document to the following effect, similarly executed under seal and properly witnessed.

I,..... hereby relinquish ~~my~~ interest ~~to~~ may have in Lot 62, Cowichan Indian Reserve, by inheritance from ~~my~~ father in favour of my brother Johnny, (or Stanley as the case may be).

Failing such an agreement some other course will have to be adopted.

Would you be good enough to endeavour to ascertain the date of death of Chief Modeste although this is possibly of no great importance inasmuch as Chief Modeste's widow has relinquished any interest which she had acquired from him by the document dated February 18th, 1954. Would you also be good enough to file an Application for Administration of the estate of Ernest Modeste as we cannot have a Certificate of Possession of his portion of Lot 62 issued until we know who his heirs are. The will of Mrs. Tommy Modeste (see our file 9152-223) gives all of her property to her son Stanley except what she describes as "my house with the lot, which I bequeath to ~~my~~ granddaughter, Sarah Modeste, who shall reside in it and to ~~be~~ looked after by my daughter, Louise Georgeson, until of age." Would you be good enough to advise whether the property described above as "my house with the lot" is situate on Lot 62 or otherwise.

Estate of Tommy Modeste - file 9152-128.

Tommy Modeste died May 15th, 1951, having by his will devised all of his property to his widow. His assets were some agricultural machinery and implements, household effects, and \$3.98 in the Bank of Montreal at Duncan, Account No. 4548. His assets also consisted of the following land holdings.

- (1) 9.8 acres on Lot 86, Cowichan I.R. No. 1, under Location Ticket No. 8365 in the name of Tommy Modeste.
- (2) 5 acres in Lot 88, Cowichan I.R. No.1, (no Location Ticket)
- (3) 7 acres in Lot 63, Cowichan I.R. No. 1, between the creek and dwelling house (see files 9152-52 and 9152-65).

The land in Lots 62 and 63 is presently under Lease No. 1452 to Mrs. Mary Young for three years from April 1st, 1955 at \$280.00 a year. (See file 152/32-3-1-30). We also understand that a parcel in Lot 88 has been leased to Mrs. Mary Young for two years under Lease No. 1531 from April 1st, 1955, at \$100.00 a year. Rents from these leases have been paid into Savings Account No. 152-173 and we understand have been paid out to Stanley which is probably correct.

Would you kindly advise us whether the above list of land holdings is correct so far as your information goes, and let us have your views in regard to obtaining Band Council Resolutions allotting the land to the estate of Tommy Modeste, or otherwise. So far as the timber lands are concerned we believe this question of individual land holdings is now under consideration by the Branch and we will take this matter up with you later.

Estate of Mrs. Marion (Mary) Modeste - 9152-223.

Mrs. Marion (Mary) Modeste, the widow of Tommy Modeste, died on June 5th, 1955, and by her will gave all of her property to her son Stanley, save the house with the lot referred to above in dealing with the estate of Chief Sehellun, and a bequest of \$100.00 to her youngest daughter Alice which has been paid. This estate will be concluded at the same time as the Tommy Modeste estate as the assets in both estates are identical.

Estate of Jim and Julia Gullseston - 9152-88.

This estate would appear to be concluded with the issue of Location Ticket No. 8374 and Location Ticket No. 8375 for the South half of Lot 61 to Ross Modeste and James Modeste, and there is no reason why Location Ticket 8307 for the North half of Lot 61 should not be issued to Ernest who acquired the said North half of the lot by virtue of the will of Jim Gullseston dated April 30th, 1910, the locatee thereof under Location Ticket No. 747. We are making a search at Branch Headquarters for Location Ticket No. 8307, and will forward it to you. We may point out that the



1. Chief Sehellton died intestate on July 5th, 1926, leaving no debts and one asset, namely, Lot 62 in the Cowichan Reserve of about 20 acres held under his name under Location Ticket 745.

He was survived by the widow of his only son (Chief Modeste) who later married again and her name is Mrs. Sarah Williams. There were 9 children, to wit:

- (1) Ernest, who died in 1928, (see file 9152-204) survived by a widow and 6 children;
- (2) Thomas, who died May 14th, 1951, (see file 9152-128) survived by his widow Mrs. Marion Judith Modeste who died June 5th, 1955, both Thomas and his widow being survived by 8 of their 10 children;
- (3) Cassel;
- (4) James;
- (5) Ellwood;
- (6) Wesley;
- (7) Alexandra;
- (8) Susan;
- (9) Mabel.

Devolution of Lot 62

He died.
It is not known whether Chief Modeste survived his father Chief Sehellton, If so, then his widow Mrs. Sarah Williams would be entitled

to 1/3 of the lot and the 9 children entitled to the remaining 2/3rds. If Chief Modeste did not survive his father, then Chief Modeste's widow would have no interest in Sehelltun's estate. This, however, would appear to be of no importance if the document referred to below dated 18/2/54 is given effect.

By the said document of 18/2/54 the widow of Chief Modeste and the 4 surviving sons, namely, Wesley, Cassel, Ellwood and James agreed that the 20 acres in lot 62 would be divided as follows:

- (a) The N1/3 to Johnny Modeste, the son of Ernest;
- (b) The center 1/3 to Cassel;
- (c) The S.1/3 to Stanley (the only surviving son of Thomas).

Apparently this arrangement was carried out and the land actually divided 6½ acres to Johnny; 6½ acres to Cassel and 7 acres to Stanley. According to a letter of the Agent dated November 1st, 1954, on file 9152-205, this arrangement was the express wish of Chief Sehelltun on his death bed - (though obviously Chief Sehelltun desired the N1/3 to go to Johnny's father Ernest, who was alive on Sehelltun's death and the S1/3 to Thomas).

The above agreement was not signed by the three surviving granddaughters of Sehelltun, namely, Alexandra, Susan and Mabel, *and the*

Ernest Modeste died intestate in 1928 survived by his widow and six children and no Application has yet been made for administration of his estate.

Ernest's estate is also entitled to the N½ of Lot 61 (10 acres) under Lease # \$180.00 per year - which has been paid to Johnny. (see file 152/32-3-1-94)
Location Ticket 8307

As mentioned above the original understanding was that Thomas was to have the S.1/3 of Lot 62 and the agreement made 18/2/54 after Tommy's death which gave that portion of the land to Stanley was apparently an effort to give effect to the original agreement. Tommy always considered the lot his own because by his will dated July 29th, 1946, he specifically devised the land to his widow and the will was approved May 30th, 1952. His widow by her will devised the parcel in question either to Stanley or to her granddaughter Sarah Modeste. (It is not clear to whom she devised the land since her will devises everything to Stanley excluding "my house with the lot" and there is reason to believe that that is part of Lot 62.

- (1) Have Application made for Administration of Ernest's estate and ascertain what disposition is to be made of his assets.





All this portion of the twenty acres is under lease at the present time.

I believe the questions you ask in your Page 2, Paragraph 4, are now self-explanatory. Wesley, Elwood, and James Modeste, are three grandsons of Seheelton; Mrs. Sarah Williams is the mother of Wesley, Elwood, James, Tommy, Ernest and Cassel (Not the Phyllis of the Tommy Modeste Estate.) The reason that Louise, Mrs. Georgeson, did not sign the agreement is that she does not live in the area now.

Your Page 2, Paragraph 6 question is now answered, the James you mention was in fact a grandson, not a son of Seheelton.

It is hoped that at least some of your questions have been answered, and we trust that the bringing in of more relatives has not further complicated these Estates.

The land distribution of the twenty acres is as you mention in Page 2, Paragraph 4, Johnny has the North 1/3, Cassel the centre 1/3, and Stanley and his sisters the South 1/3. There is no objection as things now stand and it is therefore hoped that these estates may be settled, as the Tommy Modeste and Marion Modeste Estates are directly hinged to them.



The reason that Louise, Mrs. Georgeson, did not sign the agreement is that she does not live in the area now.

Your Page 2, Paragraph 6 question is now answered, the James you mention was in fact a grandson, not a son of Scheelton.

It is hoped that at least some of your questions have been answered, and we trust that the bringing in of more relatives has not further complicated these Estates.

The land distribution of the twenty acres is as you mention in Page 2, Paragraph 4, Johnny has the North 1/3, Cassel the centre 1/3, and Stanley and his sisters the South 1/3. There is no objection as things now stand and it is therefore hoped that these estates may be settled, as the Tommy Modeste and Marion Modeste Estates are directly hinged to them.

In our endeavour to conclude the administration of the above estates, our investigation has disclosed the following circumstances in connection with which it is requested you give us additional information.

Chief Sehelten is reported to have died intestate on July 5th, 1926.

There are no treaty or annuity lists whereby we could establish the genealogy of Chief Scheelten and his heirs. From the information and such evidence as is obtainable on the estate land and lease files connected with these estates, it would appear that at the time of his death, Chief Scheelten was survived by three grandsons, namely,

Ernest Modeste, Grandson, (died 21st Feb., 1928, our file 9152-204)
Tommy Modeste, Grandson, (died 15th May, 1951, file 9152-128)
Cassal Modeste, Grandson.

The only asset in this estate is a parcel of 20 acres in Lot 62 as described in Location Ticket 745 standing in his name. Assuming for the time being that Ernest, Tommy and Cassel Modeste were the late Chief Scheelten's sole heirs, the distribution of this parcel of land would be 1/3 to each.

On February 21st, 1928, Ernest Modeste died. The only

correspondence on his estate file 9152-204 is a copy of a letter dated June 21st, 1954, referring to Agency letter dated June 2nd, 1954, on your file 152/32-3-1-94 in which it was requested that an Application for Administration and Approval of Will Form be filed. We have not received this filing to date and consequently do not know who the wife and children of Ernest Modeste were, except for a son Johnny who is referred to on several files as a son of Ernest Modeste.

On May 15th, 1955, Tommy Modeste died intestate and was, according to the information on his estate file 9152-128, survived by his wife Mrs. Judy Marion Modeste, Stanley Modeste a son, and two daughters Louise, Mrs. Georgeson, and Phyllis, Mrs. Williams. *3 sons & 2 daughters*

According to the will filed in the Tommy Modeste estate, he devised among other assets $\frac{1}{3}$ of the 20 acre parcel described as being under Location Ticket 745 above, to his wife during her lifetime or until she remarries and then $\frac{1}{3}$ of this property was to go to his son Stanley and the balance to his daughter.

On February 18th, 1954, an agreement signed by a number of persons described as heirs to Chief Scheelten and the Ernest and Tommy Modeste estates was submitted to the Department for approval respecting the division of the 20 acre parcel. This document was signed by Wesley, Elwood, Cassel, Stanley, James, and by Mrs. Sarah Williams purporting to divide the 20 acres in favour of Johnny, son of Ernest Modeste, the N. $\frac{1}{3}$; to Cassel Modeste the centre $\frac{1}{3}$, and to Stanley Modeste, son of Tommy Modeste the S. $\frac{1}{3}$. We do not know who Wesley, Elwood or James Modeste are and you might inform us in this regard as well as letting us know whether Mrs. Sarah Williams who signs is supposed to be one and the same person as the daughter Phyllis referred to in the Tommy Modeste estate. We note Louise, Mrs. Georgeson, has not signed this agreement and as she is reported as a daughter of Tommy Modeste, would you be good enough to explain this omission.

The family tree of Chief Scheelten is quite incomplete according to the information we have been able to piece together.

There is a reference in the estates of Jim and Julia Qullseston on our file 9152-88 to a nephew of Julia, namely, James Modeste. If Julia Qullseston was Chief Scheelten's sister, James could be Chief Scheelten's son or did Chief Scheelten have other brothers.

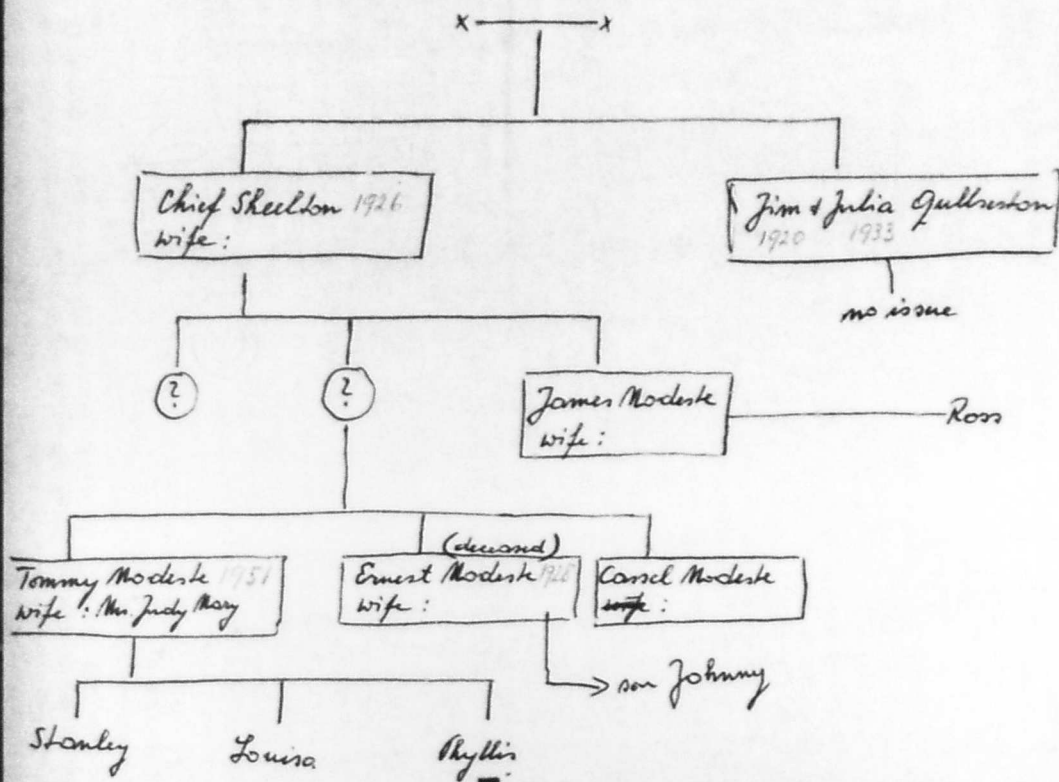



We are therefore forwarding under separate cover, care of your office a cheque for Mrs. Marion Judy Modeste in the sum of \$140.

In reviewing the estate file, we note that Tommy Modeste refers to in his will that a piece of land of approximately 7 acres was left to him by his grandfather, Chief Schelton. Is this one and the same person as Chief Schelton whose estate is being dealt with on our file No. 9152-205 and which you have received a letter concerning in the last few days.
