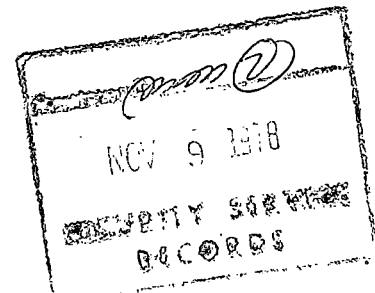

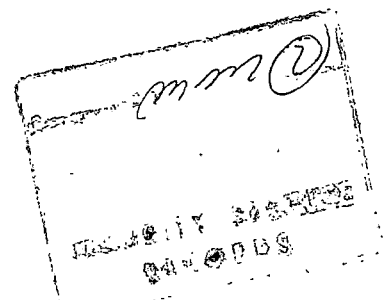

There have been some requests from Security Service personnel to purchase Police Community Relations Crests for wearing with civilian apparel, a sample Crest is attached.

There are really two concerns with regard to members of Security Service acquiring these Crests:

- the matter of personnel involved in covert operations being identified with the RCMP, and
- the question of greater civilization for Security Service.

I am advised by Material Management Branch that members of the Force including S/Csts. are entitled to purchase articles on repayment and this is the method to obtain these Crests. I feel disposed to recommending that our members in Security Service be allowed to purchase this item since it is a means of reflecting their involvement as members of the Force in Community Related Programs. However, because of the earlier mentioned concerns I would appreciate the benefit of your direction of this matter.

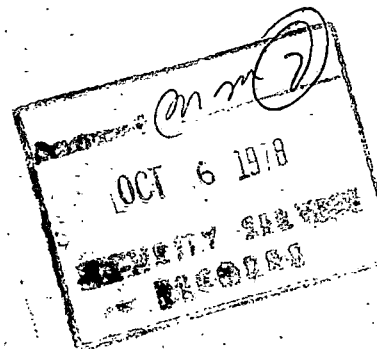
