
Dear Sirs:

AMENDMENT dated this 18th DAY OF October 1972.  
to the Memorandum of Agreement dated February 18, 1971.

BETWEEN:

HER MAJESTY THE QUEEN in right of Canada  
represented herein by the Minister of  
Indian Affairs and Northern Development,  
hereinafter called "the Minister".

OF THE FIRST PART

AND

THE KENORA DISTRICT ROMAN CATHOLIC SEPARATE SCHOOL BOARD  
in the Province of Ontario  
hereinafter called "the Board".

OF THE SECOND PART

WHEREAS the Memorandum of Agreement dated February 18, 1971 between Her Majesty  
the Queen in right of Canada and the Kenora District Roman Catholic Separate School  
Board provided that the Minister pay to the Board a contribution of \$19,140.00 towards  
the construction cost of the Father Moss School operated by the Board in the Province  
of Ontario.

AND WHEREAS the Board has now reported that the actual cost of this project was  
\$3,027.00 more than the amount set forth in the above mentioned Agreement.

THEREFORE, the Minister agrees to pay the Department's share, 174/200 of this  
additional cost, namely \$2,633.49 making a total contribution of \$21,773.49.

This Memorandum is to be read with, and attached to Memorandum of Agreement dated  
February 18, 1972.

- I am pleased to attach a three page summary of costs relating to this
- project as prepared by the Business Administrator and a letter from
- Prageau & Ouellette, auditors for the Board, advising that this summary
- is correct and in agreement with their audited statement. Also attached
- is the form G52(h) which verifies the accuracy of the statement.

It is noted that additional costs to the G52(h)-1970 have been certified correct by the auditor \$518. - \$357. federal sales tax rebate. Thus from the G52(h)-1970 capital distribution sheet col. 5 (\$12,500) + col. 6 (\$12,366) is (\$24,866) + 1971 costs \$518 - sales tax rebate \$357 equals total cost of project \$25,027. It may appear that the federal sales tax rebate is small but most of the material was purchased out of revenue funds separate from the contract and no federal sales tax paid.

It is noted that the total cost of the project now comes to \$25,027 rather than the agreement figure of \$22,000. The Board wishes to claim 174/200 of \$3,027 (\$3,027.55) or \$2,633.97 over the balance owing of \$12,760.00.

Joint Schooling - Father Moss School  
Kenora District R.C. Separate School Board

When I arrived in Kenora last year a memorandum from your office recommended I investigate a request from the above-named Board regarding a new joint school agreement at Father Moss School. This request had been misplaced in the Toronto office and hence no action had been taken during the spring of 1971. There was apparently some confusion regarding it because two other joint school agreements were already active with this Board. One of these involved Father Moss.

New Joint School Agreement

It appears that over the years a piece-meal school complex was constructed at Father Moss School. Very little of this construction was planned or constructed in a permanent or organized manner. As a result several joint school agreements have been amassed over a span of ten years. The Kenora District R.C. Separate School Board inherited this school in 1970 from Sioux Narrows Board and as yet have not corrected the many problems inherited. In my initial meetings with the Board they expressed a desire to enter into a new joint school agreement for an extensive renovation and addition. I expressed a desire to have the Board investigate their total needs at this school and project this into the future so the trend of a new joint school agreement every two or three years could be replaced by a long range agreement. At the time, the Board agreed that this was a sound idea and proposed to plan a rather extensive building program to develop the school into a permanent, complete and functionally acceptable establishment which would serve the need for several years.

As a result of some friction between the Board, the parents from the local reserves and Sioux Narrows non-Indian people, over the replacement of the principal at Father Moss School, a few months delay was incurred before discussions began with the Indian Bands regarding the new addition to Father Moss. Several meetings were held between Whitefish Bay Band, the Board and our Department to establish the facilities which were desirable. On December 31, 1971, Whitefish Bay Band passed a Band Council Resolution indicating their support for the addition to include classrooms, health room, pre-kindergarten, library, showers, staff room, principal's and secretary's office, larger kitchen and playground improvements. Sebaskong Band indicated their support in a Band Council Resolution dated January 28, 1972. Their interests do not include a pre-kindergarten as they do not wish the federal school on their reserve closed to the kindergarten, grades 1, 2 and 3 classes attending school there. (the two resolutions are attached).

We have been proceeding rather slowly with further negotiations on this project because of advice that capital joint school funds were short and because of poor public relations developing over other joint school agreements in the district which have been negotiated and are either awaiting formal agreements or final payments. We have advised the Board that the Bands have submitted resolutions supporting the addition and the discussions can proceed. At the same time the Board is aware of the problem they face in getting an agreement without tendering the contract and have indicated that they are unable to proceed with the project without a clear policy on our Department's participation prior to even approaching the architect. To understand their dilemma I will explain further. In very rough figures, there are over 200 Indian children to about 20 non-Indian children. This means that about 90% of the cost will be borne by our Department. As the Board is relatively small they are not in a position to commit any funds past preliminary drawings to the project and will not proceed without a commitment by our Department on paper indicating participation by our Department on a pupil proportion ratio.

#### Basic Plan to New Joint School Agreement

1. Board to prepare or have prepared an appraisal of the value of lands and buildings comprising Father Moss School (Question: Should this be present value or cost at time of purchase?)
2. The amounts provided by the Department of Indian Affairs should be deducted from the value established in (1) to determine an amount upon which our Department should pay a share to bring our share up to date. (Question: Should this be done for the overall Board operation summarizing for Kenora and Sioux Narrows? Although this is done for most Boards, Father Moss is 90% Indian enrolment while Kenora Schools have about a 4% Indian enrolment) - (the Board apparently has separate tax bases for the two areas).
3. Father Moss Project
  - (a) Renovate old sub-standard classroom which is part of present main school to provide for principal's office and kitchenette.
  - (b) Construct 2 regular classrooms, a kindergarten and a pre-kindergarten room.
  - (c) Construct a library resource centre.
  - (d) Extend present kitchen facilities, clerical, storage and washroom areas.
  - (e) Add a health room.
  - (f) Provide a sewage lagoon or sewage disposal system.
  - (g) Possible addition of ancillary room or extend playroom.
  - (h) Living accommodation for teachers is in question at the moment as a proposal for a private group to provide this is being considered.
  - (i) Replace sub-standard lighting.

\* It was originally considered by the Board that certain aspects of this building and renovation program be done in stages through 3 or 4 joint school agreements. It was requested by Regional Office and thoroughly supported by the District Superintendent of Education, Kenora-Pt. Frances, that one big

joint school agreement be developed to cover the total building and renovation program which the Board plans. The Board officials felt this was a good plan and hoped to abide by it. Because of events the Board is now placed in a position where some decision must be made to clarify the situation with regard to capital assistance from the Department of Indian Affairs and Northern Development. The situation is outlined below under heading "Urgent and Immediate Needs Father Moss School".

(B) Immediate and Urgent Need - Father Moss School

For some time the septic field at Father Moss School has been leaking. This was unsatisfactory as far as local health authorities were concerned. Last winter the sewer line from a teacherage had to be opened and raw sewerage allowed to flow down a hill under the snow for several months. Health authorities have advised the Board that they will close the school in September if nothing is done.

The Board engaged Ranta and Tett Architects, to make preliminary sketch plans of the proposed addition and to examine and make recommendations with regard to their sewage disposal system. This firm in turn hired Procter and Redfern Ltd., consulting engineers, to do a study and make recommendations. I have a copy of their report to the Board and have personally viewed the site where the septic beds are leaking raw sewage within 25 feet of the school and within a couple feet of the highway. Although the Board intended the study and recommendations to form a part of the new joint school addition, their idea must be shelved to provide a new sewage disposal system this summer and prior to school opening. Time does not permit a further delay in this matter and since our Department is involved for about 90% of the cost the Board wishes to obtain our concurrence and financial support since the costs involved are not shared by the Kenora taxpayers. I enclose a sketch of the sewage disposal system recommended by the consulting engineer and pre-

liminary cost estimates amounting to \$55,000. The Board's administrator advises that the \$55,000 estimate does not include rock blasting and removal or revisions to existing plumbing. His rough estimate ranges from seventy to eighty thousand dollars. Both the Board and this office agree that this cost could be included in a proposed new joint school agreement even though it is done prior to actual construction of the addition. This, however, does not answer the Board's immediate need for cash or at least assurance that cash will come in a relatively short time. Since we have no capital funds available, the answers must come from your office or headquarters. It is my personal opinion from discussions with the Board's business administrator that, if assurance in writing of our financial support were given, that the Board has borrowing power and could proceed. In any event, the job has to be done or the school will be closed by the health department. I am aware of the problem regarding available department funds and the present delays in obtaining joint school agreements, thus we are starting discussion on tuition and special services agreements immediately so a joint school submission on the proposed \$400,000 to \$500,000 project at Father Moss School can be submitted for approval. I understand the Business Administrator from the Board was in contact with you by phone regarding the urgent sewage problem, hence this submission is forwarded to give you the background of what has occurred in the field over the past year.

I would appreciate your thoughts regarding the two questions I have raised in the section "Basic Plan for New Joint School Agreement", and a letter directly from your office to the Board regarding our position on financial assistance for the new sewage disposal system at Father Moss School. I would also appreciate your thoughts regarding an agreement prior to tendering on the large addition as I outline in this memorandum in paragraph no. 3 under "New Joint School Agreement".

The enclosed plan calls for the conversion of the one sub-standard classroom into extended kitchen facilities, a corridor into the new addition and office space for the Principal and his secretary. The addition includes four classrooms which would provide three additional classrooms to the present number. The Principal's office, health room, staff lounge and library resource centre have been needed for some time.

The architects' estimate of the cost of the proposed addition and alterations is \$282,307.00 made up as follows:

One change to the enclosed plan which seems likely is the provision of approved kindergarten accommodation in one of the new classroom areas shown in the plan. This would involve some additional costs for shelving, washroom facilities, an exit, etc. according to approved specifications issued by the Ontario Department of Education.

Consideration may also be given to providing for a pre-kindergarten classroom in the area shown as unfinished on the plan. This change would also affect the above estimates.

The total cost of fixed assets at Father Moss School at December 31st, 1968 (the date of amalgamation of the various School Boards in the District) was \$321,388.00 according to the audited statement of that date. This amount is made up as follows:

According to information that you gave to us over the telephone, your Department has paid \$142,517.00 toward the cost of the above-named assets based on an agreement to educate 115 pupils.

The figures for existing assets are listed at Dec. 31st, 1968 so as not to include the cost of improvements that our Board has made since that date. We have sent you a separate request, dated Nov. 24, 1970, to participate in the cost of these improvements and we prefer to deal separately with these items for budget purposes.

The Ontario Department of Education has informed us that we must obtain certain commitments from your Department before they will give any consideration to approving our building proposal. These commitments are:

- (1) The amount that your Department will pay toward the cost of the proposed addition based on the estimate of \$282,307.00.
- (2) The percentage that your Department will pay toward any costs which may be incurred in excess of the estimates.


The reason for the Department of Education's ruling in this case is that the enrolment of Father Moss School is made up primarily of Indian pupils.

Construction costs have a way of increasing with the passage of time and are much higher in winter than summer.






The sewer line from the teacherage had to be opened just below the building and raw sewage allowed to flow down a hill under the snow for several months. Because of our still limited space as living accommodations, we have been restricted to local residents who have their own housing for such items as cooking, attendance counselling and caretaking. Anyone hired from outside of Sioux Narrows will require housing. We have not been satisfied with the services provided by some of these people. We could undoubtedly have solved our noon lunches problem if additional housing had been available.

Also since our last agreement we have had to spend some \$3,500. on electrical work in the school. An inspection by a qualified electrician revealed that the wiring was unsafe and would probably be condemned if inspected by the Ontario Hydro. The electrician says that the lighting in the school is sub-standard and will require replacing which could be done when an addition is built.

Our Board recognizes that your Department has contributed heavily over the years, and we have always appreciated your co-operation. We would like your Department to recognize, when being asked to share costs by our Board, that our Board inherited the Father Moss complex on January 1, 1969 long after the damage had been done that we have set out to correct. Examples of the "damage" are poorly constructed teacherage buildings with rotting roofs and without foundations, improperly installed electrical and plumbing facilities, buildings that had not been painted for years and therefore had rotting window and door sills, etc. The list seems to get longer as we do more work.

In view of the urgency of the sewage disposal situation, would it be possible for us to enter into a separate joint-school agreement for this and some of the other items that we have mentioned.





I am enclosing a copy of the laboratory report on the sewage analysis taken from the Father Moss School. Unfortunately the sample noted as S.T.P.-Effluent, was taken from the siphon chamber and indicates the quality of the effluent leaving the septic tank rather than the effluent leaving the filter bed. We have asked the Commission to take another sample however it will likely be two or three weeks before the results are available. These results are much better than we would normally anticipate, however they represent only a single sample. It is quite likely that a composite sample taken over a 24-hour period would provide less favourable results.

Basically the problem lies in the fact that the natural ground does not lend itself to absorption of the liquid leaving the filter bed. The staff dwellings which have been connected to the school system generate a substantial portion of the total volume of sewage entering the system with the result that frequent leaching is evident. A short term solution lies in extending the filter bed; however, we understand that considerable increases to sewage flows are anticipated from a number of sources including the addition of showers, the extension of the school, together with an increase in the student body, as well as the possibility that more dwellings may be connected to the system.

We understand that evidence of pollution has already been noticed in the lake in the vicinity of the school and we suggest that it would be in your best interests to consider revising the sewage treatment system.

On Drawing No. B-71270-G1, we have indicated our suggestions regarding proposed sewage treatment facilities. Revisions would be made to the existing plumbing to divert sewage from the septic tank to a sewage lagoon to be constructed to the northwest of the school site. This lagoon would be large enough to hold the entire sewage flow generated over an 8-month period. In the summer months, sewage would be permitted to enter the septic tank and the filter bed for a period of time. This would eliminate the necessity of constructing a two-celled lagoon which is normally required to separate incoming sewage from treated lagoon effluent which would be discharged via spray nozzles to a selected irrigation area. Normally sewage lagoons are located 1,500' from the nearest residential development. You will notice that this site has been shown at a distance of about 600'. It might be well to inspect this location in the field to confirm that it would not be particularly obvious from the staff dwellings. Lagoons are normally odour-free except for a period in the spring when the ice cover melts and aerobic conditions are re-established. In the summer months, the liquid level of the lagoon would be lowered by pumping into a network of light-weight piping assembled on the surface and discharging through special spray nozzles. As an area becomes saturated, it is possible to relocate the surface piping in another area at minimal expense. The degree to which spray irrigation will be required to dispose of lagoon effluent will depend to a great extent on the weather in any particular summer. Conservative design criteria are used to ensure that it will be possible to provide adequate storage in the lagoon for the following eight months. By using the existing septic tank and filter bed in the summer, we mentioned that it would be possible to separate sewage from the treated effluent in the lagoon to permit spray irrigation. Should the filter bed begin to leach, it would be a relatively simple matter to collect the effluent from the filter bed and pump it back to discharge in the gravity line leading to the lagoon. In this way, the existing septic tank and filter bed would be employed as a pre-treatment facility to produce an effluent which could then be spray irrigated.

The proposed system is by no means inexpensive. Unfortunately the receiving body of water is of such a nature that the O.W.R.C. will not permit any sewage treatment facility to discharge to it. Accordingly, a process must be implemented which has no effluent discharging to the lake. The spray irrigating of the treatment plant effluent is one method of disposing of the liquid. The combination of evaporation and ground absorption prevents contamination of the lake. Unfortunately it is only possible to carry out spray irrigation over the summer months which means that a holding



basin must be provided, in this case the sewage lagoon which also provides an acceptable degree of sewage treatment.

We have attached our preliminary cost estimates for the work which indicate the total estimated cost of the gravity sewer, sewage lagoon, and spray irrigation system at \$55,000.00. We have not included any allowance in this figure for any major revisions to the school plumbing with the exception of putting in a Tee and installing a valve in order to by-pass the septic tank. Although the drawings we have do not indicate the plumbing actually installed at the time of construction, we believe that this will be all that is necessary. In addition, we have not included any allowance for rock excavation which may be necessary to construct the gravity sewer line. The estimated costs are based on costs we have experienced in similar work in other remote areas. At the time the work is done, earth moving equipment may be readily available locally which would tend to reduce costs. On the other hand, the time of year that the work is carried out can affect the costs considerably. Since a substantial portion of the cost is due to labour, it may be possible to carry out this work under one of the Winter Works programmes similar to those which were in existence this past winter. Earth moving can be carried out in part of the winter and in fact, the excavation of the lagoon floor would best be done at this time of the year since it will likely be located in the swampy area. We would suggest that the berms should be planned for construction at the start of a Winter Works period since it will be necessary to excavate clay material from borrow areas and haul it to the site. Once frost has set in on the lagoon floor sufficient to hold up equipment, it would then be possible to excavate the floor and place the excavated material along the inside of the berms. Any ditching which may be necessary to drain the area around the lagoon would also be best carried out when some frost was in the ground. If this project is accepted as a Winter Works project, it would be possible to provide needed winter employment in your area and at the same time substantially reduce the cost to the School Board.

Prior to commencing with any detailed engineering, we would suggest that a meeting be held at Father Moss School to review the relative location of the proposed facilities and to take another look at the existing plumbing. If our recommendations seem

reasonable following this inspection, we suggest that a preliminary application be made to the Ontario Water Resources Commission. The application need contain little more than this report and the accompanying drawings together with certain design criteria. This would permit the O.W.R.C. to incorporate any changes which they may feel necessary.

All of which is respectfully submitted for your consideration. Please let me know if we can be of further assistance in this matter.

We have now had an opportunity to inspect and assess the sewage disposal system for the Father Moss School in The Improvement District of Sioux Narrows and wish to report as follows:

We understand that at present, the student body numbers about 200 and with the proposed extension will increase to about 300 in the coming year. Consideration is being given to providing shower facilities. In addition to the school, provision should be made for the connection of ten private dwellings who will share a common laundry facility which may be located at the school. Domestic waste from the private dwellings will be connected to the school's system by a sewer system.

At the present time, sewage treatment facilities are provided by means of an above-ground filter approximately 6,000 sq. ft. in size located between the school and an access road which parallels the highway. The tile field was renewed about 5 years ago and the local Health Unit has indicated that it is no longer functioning in an acceptable manner.

Upon investigating the existing filter, we find that the filter media consists of a good clean sand and has apparently been constructed in accordance with recommended procedures. The filter bed is apparently located on top of a relatively

impervious clay till material which has probably very little depth over bedrock. While above-ground filters are often used in this circumstance, it is common to collect the effluent from such an installation and convey it to a chlorine contact chamber for treatment before it is discharged to the receiving stream, particularly if the absorption capacity of the ground together with the rate of evaporation are not sufficient to eliminate the waters received by the filter. Filters are normally surrounded by a clay dike or a masonry wall to prevent leaching of the liquid.

On the occasion of my visit on November 24th, it was apparent that the clay dike surrounding the filter was leaching around the entire perimeter of the filter. While it would be possible to increase the area of the filter by about 50%, this would merely create the same situation for the larger student body as exists today.

We are asking the Ontario Water Resources Commission to obtain samples of the sewage as it enters and after it leaves the filter in order to determine whether the filter is effective at all in reducing suspended solids or b.o.d. (i.e. whether or not it is effective as a sewage treatment unit)

At the present time, we see two alternatives to providing sewage treatment facilities for the school:

1. Extension of the above-ground filter combined with a system of under drains to collect the effluent and deliver it to a chlorine contact chamber for treatment prior to discharge to the lake. The disadvantages to this alternate are that samples of the treated effluent must be taken frequently to confirm that the system is functioning properly. A filter is always subject to plugging, freezing and short circuiting which could lead to its rejection as a sewage treatment facility by the O.W.R.C. We should also review the proximity of water intakes (particularly the school's) to any possible point of discharge.
2. Another method of treatment would be the conversion of the existing ~~septic tank to a pumping station delivering the sewage to a lagoon to be constructed in the swamp behind the existing hockey rink.~~ A spray irrigation system would probably

be required to dispose of the lagoon effluent, although it may be possible to utilize a dual cell lagoon, one-half of which could be discharged annually during spring run-off.

As soon as the test results are received from the Ontario Water Resources Commission, we hope to be in a position to complete our preliminary report which will include cost estimates for the various alternates.





- 1) Three page summary of costs relating to this project as prepared by the Business Administrator.
- 2) Letter from Fregeau & Cuellette, auditors for the Board, advising that the above-noted summary of costs is correct and in agreement with their audited statement.
- 3) The audited G52(H) with auditor's covering letter verifying the accuracy. For your convenience we have photocopied the pertinent page and inserted it separately. Your attention is drawn to col. no. 5 and col. no. 6 which relate to this project. These costs are broken down on page 2 of Mr. McMillan's summary letter for a detailed breakdown.

It is noted that additional costs to the G52(h)-1970 have been certified correct by the auditor \$518. - \$357. federal sales tax rebate. Thus from the G52(h)-1970 capital distribution sheet col. 5 (\$12,500) + col. 6 (\$12,366) is (\$24,866) + 1971 costs \$518 - sales tax rebate \$357 equals total cost of project \$25,027. It may appear that the federal sales tax rebate is small but most of the material was purchased out of revenue funds separate from the contract and no federal sales tax paid.

It is noted that the total cost of the project now comes to \$25,027. rather than the agreement figure of \$22,000. The Board wishes to claim the additional 174/200 of \$3,027 (\$3,027.55) or \$2,633.97 and are prepared to wait for this portion.



This is just to review some aspects of topics which have arisen over the past few months and to bring yourself and members of the Board up to date.

Joint School Agreement No. 552  
Father Moss School

On January 11 I advised you that an audited statement was required by our Department before the final payment could be forwarded to your Board. Subsequent to that letter you advised that this would be available before March 31, 1972. Would it be possible to phone me on March 14 to advise whether funds should be reserved for this fiscal year which ends March 31. I understand funds are limited for next year so it might be to our advantage in regard to funds for the new Father Moss project.

Joint School Agreement No. 497

You have advised that an audited statement will be available by March 15, 1972, on this project. As the same information noted for Agreement No. 552 above applies to this agreement, perhaps we can discuss progress on this one on March 14.

St. Mary's Residence School

When I approached our regional office regarding the request from your Board for costs involved, I was advised that the school will probably be declared surplus to the needs of our department and headquarters requested to turn it over to Crown Assets Corporation, Gov. of Canada. This Crown Corporation would negotiate with parties interested. I would recommend, therefore, that the Board submit a letter to me, which I will forward, outlining their interests, hopes and thoughts regarding the school. This letter will either be acted upon by our Department or passed on to Crown Assets Corporation.

Dear Sirs:

In reply to your letter dated Feb. 11/72, we do hereby submit the following information for your consideration.

Mr. P.O. Clarkin has reported to you, upon your request, that on certain days, the buses have been late and that for a short period of time, there was only one bus making the routes. The reason for this unsatisfactory situation was that due to severe weather conditions one bus "froze up" and could not be operated. This made it necessary to have it towed to Keno for repairs and adjustments. Pawitik Corporation attempted to rent another bus from Kenora in order to meet their responsibility but were unsuccessful due to the fact that the Kenora bus lines were also experiencing difficulty in the operation of their buses and the spare buses were being used to replace their own buses not in operation. Pawitik was also unable to get gas for several days for their pumps as Kenora Gulf Oil's delivery truck was out of commission; as were Sioux Harrow's trucks; on several occasions during the cold weather, we were unable to get gas from Sioux Harrows when we needed it as the pumps were frozen.

We do not have heated garages for our vehicles and thus it is difficult to operate and maintain equipment, especially under severe temperatures. The bus drivers do warm up their buses, however, it would take hours to completely heat them up when they have sat for fifteen hours under 40 - 80 degree below temperatures.

During the Christmas holidays, every one of Pawitik Corporations buses went through a complete mechanical fitness examination and repairs made according the regulations of the Ontario Department of Highways. Therefore all buses were in A-1 working order and would not have experienced difficulty in their operation had it not been for the weather.

The Band Council felt strongly that the Father Moss School should have closed when the weather conditions were so extreme; for the safety of the children as well as eliminating the problems with buses etc. The principal should have used common sense in this respect; he only has 15 steps to get to the school, we have to travel 15 miles.

As far as the buses being late once in awhile, there are various reasons causing this, such as waiting for late children, road conditions, traffic, etc. Unforeseen circumstances do arise and should not be used against the efficiency of anyone.

As far as Father Moss School running in an orderly fashion, it has NEVER been more disorganized; never has there been so many accidents and broken limbs, never has there been such poor supervision and administration since Mr. P.C. Clarkin arrived on the scene. There has been a complete communication break-down, a lack of understanding and co-operation in most situations and as far as we can analyze from your letter, "ignorance" on both the part of the Board and the Principal, in not finding out the circumstances, using common sense and understanding when situations arise and working them out together rather than throwing up your arms in dispare and giving up.

Surely you do not think that we are so ignorant to try to make things difficult and deliberately neglect our responsibilities.....

Your Board has absolutely no authority to call for tenders for the transportation between Whitefish Bay Reserve and Father Moss School-- you are completely over-stepping your jurisdiction. Our Band Council have this transportation program and are acting accordingly. The Dept. of Indian Affairs have entrusted our Council with the funds and the responsibility because they have confidence that we will administer both accordingly. There is no possible way of you receiving this responsibility or the funds.

You have to work with the Band; if you find funds to pay for the bus transportation, hire your own buses and do not work with us, we will have no alternative but to forbid entrance to the reserve. Anyone coming onto the reserve has to receive permission from the Band Council.

Granted we all need to be reminded of our responsibilities and perhaps in some instances need to "pull up our socks", and we accept this advice and appreciate constructive ideas, but to suggest that we have completely failed in our duties and you are taking over because of a misunderstanding or unavoidable situation is inexcusable.

Our bus drivers have tried to communicate with Mr. Clarkin whenever a problem arises but have been unsuccessful and they too have become very frustrated.

We should be pleased to meet with you at your convenience to discuss this matter further.

Dear Sirs:

At the request of the Business Administrator, Mr. P. C. Clarkin, Principal of Father Moss School, has kept a written record of the bus service provided by Pawitik Corporation between Whitefish Bay Reserve and Father Moss School. A report, covering the period January 14th to February 2nd was read to our Board at a meeting held recently.

The report indicates that on 7 days during the above period one bus made no trip. The big bus went back for a second load and delivered pupils at 9:45 A.M. This occurred on January 14th, 17th, 24th, 25th, 26th, February 1st and 2nd. Also one bus arrived at 9:05 A.M. and the other at 9:15 A.M. on January 27th. The report says that complaints have been voiced by the parents regarding these irregularities and that they also complain that the vehicles have not been warmed up when pupils embark in the morning.

This kind of service is wholly unacceptable to our Board.

We understand that the contract for transportation is between The Whitefish Bay Band Council and Pawitik Corporation and that the Department of Indian Affairs and Northern Development pays a grant to Band Council to cover the cost of transportation. This arrangement leaves our Board with the responsibility of providing for the education of children in its system and for the related responsibilities of attendance and the orderly running of the school, but without the necessary control over the bus operation. Our Board takes its responsibilities to its pupils very seriously. Clearly the school cannot be run in an orderly fashion nor can pupils be given full educational opportunities if we are to continue to have the kind of bus service outlined above.

If the Board is to discharge its responsibilities, it must take steps to effect control over the bus operator unless the bus service is permanently improved and brought up to proper standards. In this connection, the Board passed a

motion requiring that this letter be written to you, informing you that unless the bus service is improved to its satisfaction, the Board will call for tenders for transportation between the Whitefish Bay Reserve and Father Moss School and sign a contract with the successful operator effective September 1st, 1972.

The Board made it clear that this action would not preclude the likely possibility that such a contract would be signed with Pawitik Corporation. If the contract were signed with Pawitik Corporation, such action would have the effect of transferring control over the service provided to the Board in order that the Board could carry out its responsibilities.

The possibility of such action by the Board could be avoided, but only if Pawitik Corporation will see to it that their buses are warmed up before pupils get on the bus and insure that all of the buses leave Whitefish Bay Reserve in time to arrive at Father Moss School at 8:45 A.M. at the very latest on every school day. It is the responsibility of the bus operator to insure that all of its buses are in working order and in a state of mechanical fitness and also to see that its drivers arrive for work on time.

In the event of an occurrence beyond the control of the bus operator which makes it impossible for him to meet the Board's requirements, the operator should phone both the school and the Board Office with a complete explanation.

We trust that the contents of this letter will be taken in the spirit in which it is intended which is to make it clear that the Board is determined to provide the best possible educational opportunities for all of the children in its system and to point out clearly that in this connection the Board must have the co-operation of all concerned.





Gentlemen:

Some time ago students of elementary school age from Schaackong began attending Father Moss School at Sioux Narrows and at the present time about 47 children are enrolled in that school. These children along with about 137 children from Whitefish Bay make up about 90% of the total enrolment. Over the years the Department of Indian Affairs and Northern Development, at the request of the Indian people, has made large capital contributions for various parts and additions to the school at Sioux Narrows based upon the number of students of Indian status who were enrolled. This year the Kenora District E.C. Separate School Board have approached the two reserves concerned and our department asking for our assistance and agreement to put an extensive addition onto the school.

On October 5th, 1971, I forwarded a letter to your reserve advising you about a meeting to be held at Sioux Narrows on Friday, October 13th at 7.30 p.m. At that meeting about 25 people from Whitefish Bay Reserve raised several items of concern to the School Board with considerable success. Plans for the new addition to the school were discussed and the Board asked the Indian people to consider the plan. A committee of Indian people and Sioux Narrows residents was formed to meet regularly and bring matters of concern at Father Moss School to their attention. I believe the Whitefish Bay people have contacted people from Schaackong Reserve to attend some of these meetings.

Last week, your band, Whitefish Bay Band, and the committee, were invited to a School Board meeting in Kenora. At the meeting the Chief and Council from Whitefish Bay stated that they were in favour of the addition but indicated that the playground must be improved as part of this plan. They were in favour of a pre-kindergarten room for four year old children, showers, library and health room being added. I attach a copy of the Band Council Resolution which they have passed and forwarded so we can proceed with negotiations and planning.

The new addition planned includes about 5 new classrooms, library, health room, offices, showers and a classroom for four year old children.

I realize the situation is different on your reserve because you have a federal classroom in operation which includes kindergarten, grade 1, grade 2 and grade 3, and you will probably not be interested in sending four year olds to this new proposed classroom. Since a number of grade 2 and 3 students from your reserve do, however, attend Father Hoss School, you may wish to consider sending all grade 1, 2 and 3 students so we could set up an arrangement in Sabashong School to send four year olds each morning and kindergarten either in the afternoon or all day. Since this could change the number of students at Father Hoss you might like to discuss any change you wish and let us know whether you wish things left as they are or whether the parents wish to discuss or consider any change at either school.

In order that the Kenora District E.C. Separate School Board can proceed with their plans, I require your wishes expressed in a Band Council Resolution. If you wish any changes in what classes go to the local reserve school please phone 460-5541 collect, and I would arrange to meet with the Chief, Council and parents at your earliest convenience. If there are no changes desired, a Band Council Resolution indicating your wish in this matter would be appreciated at the earliest possible date as the Board feels they must have our agreement in principle in early January if they are to get anything done for September 1972.

Please feel free to call on me at any time if you have any questions on this or other school matters.




We would like to begin construction of the above-named project in the early spring. Before construction can start, we must have the plans finalized and we must obtain several approvals from various government departments. This process will take several months.
