As you are aware the above noted child was committed to our care in February, 1965, and has been continued in foster home care since that date. We bill your Agency for the maintenance of Paul in his foster home.

On June 29, 1967, Paul was legally adopted, which would normally result in a termination of billings to your Department for maintenance on his behalf. However, Paul was adopted only by virtue of a new policy which we are hoping to introduce in our Department, that of "subsidized adoptions".


In fact, Paul has been legally adopted by a husband and wife who, without the assistance of some subsidization for his continued care would not otherwise have been able to do so.

In this event, we will therefore be continuing to bill your Department for his maintenance, as in fact his legal adoption does not lose him his Indian status. To ensure confidentiality, we will continue to bill you on Paul's behalf, using his natural name and not his adopted name.


