

LABOUR PROGRESSIVE PARTY - British Columbia

1. On January 21, 28, and 31st, 1953, Sgt. A.E. Thomas, Cst. W. Kowtun, Cst. A.S. Hobbs, Csts. J.H.B. Johns, R. R. Spray, E. J. McCollum, K.R. Ohly, H.D. Hyslop, E.A. Gullason, L.J. Jones, L.W. McGregor, and the writer conducted three (3) Special Branch operations which resulted in the obtaining of a considerable amount of further documentary material. This material has been allotted numbers 11479 to 11664, inclusive, which material is described hereunder as follows:

Exhibit No. 11479: Is a letter from Barney BLAKEY to Alf. DEWHURST dated January 21st, 1953, dealing with Party activities in the Victoria area.

Exhibit No. 11480: Contains the names of Party candidates nominated to run as L.P.P. candidates in the forthcoming Federal Elections.

Exhibit No. 11481: Is a typewritten letter dated December 1st, 1952. The author of this letter is considered to be Nigel MORGAN and is addressed to "Paul" undoubtedly, Paul PHILLIPS. The letter deals with current Party activities.

Exhibit No. 11482: Is a typewritten letter dated November 17, 1952, from Paul PHILLIPS to Nigel MORGAN. The letter discusses Party preparations for the forthcoming Federal elections.

Exhibit No. 11483(1)(2): Is dated December 19, 1952, and is a typewritten Autobiography of Ernest LARRIE, the B.C. Provincial organizer of N.F.L.Y. who is entered as an L.P.P. candidate in the Federal riding of Vancouver East. Exhibit No. 11483 (3): Is a photograph of Ernest LARRIE attached to Exhibit No. 11483 (1) and (2)

Exhibit No. 11484(1)(2)(3)(4): Is a letter dated November 1952 to Alf. DEWHURST from Leo BRADY, White Rock, B.C. The letter contains an autobiography of BRADY who is entered as an L.P.P. candidate in the Federal riding of Westminister for the forthcoming federal elections.

Exhibit No. 11484 (5): A current photograph of Leo BRADY is attached to Exhibit No. 11484 (1)(2)(3)(4).

Exhibit No. 11485: Is a handwritten note believed to be the handwriting of George EDGAR. The note indicates that the following people have all been good Party members in the past but of late months have been drifting. - Cato G. Grassy Plains, B.C., Mr. and Mrs. Seymour TORESCHUC (?), Francis Lake, B.C., Alf. SJODEN, Burns Lake, B.C., Mrs. Mary NEILLY, Decker Lake, B.C. Beneath this name is the notation "This one was never a Party member but should be." This exhibit also contains an L.P.P. application for membership form and bears the name of Miss Renee RONAYNE, Alozzar Hotel, Vancouver, B.C.; occupation Journalist. An additional slip of paper contains the name of Mrs. RONAYNE, Pemberton, B.C. --Mrs. RONAYNE may be related to Miss Renee RONAYNE.

Exhibit No. 11486: Is a statement from the Bank of Toronto in Vancouver for the period ending December 31, 1952, and shows the banking transaction of the L.P.P. Vancouver Com...

The other members of the Commission are Harvey MURPHY, William STEWART, Jack PHILLIPS, Homer STEVENS, John HINES, Charles M. STEWART, Jr. and Alex DORLAND.

Exhibit No. 11581: Is part of a letter submitted to the Bank of Toronto in Vancouver by the City Committee instructing that the following have been authorized to sign for the L.P.P. in the capacity named:

Exhibit No. 11582(1)(2)(3): Is a financial statement of the Vancouver City Committee for the period Jan. 1 to Nov. 24, 1952; and the Vancouver City Committee's budget for 1953. The draft budget for 1953 totals \$15,100.00.

Exhibit No. 11583: Is a typewritten letter dated Jan. 15, 1953, from W.A. MacLEOD to Nigel MORGAN. The letter is marked "Extremely Urgent" and outlines the immediate tasks which must be taken up by the Party under the auspices of the League for Democratic Rights in campaigning against "Bill 93."

Exhibit No. 11584(1)(2): Is an extract from the "Cash Disbursements of the Vancouver City Committee of the Party for the period Dec. 1st to 31st, 1952, showing the Vancouver City Committee as having paid wages to the following: Mary CHORNY, Ed ZLOTNIK, Maurice RUSH. Other items relate to payments made for current operating expenses.

Exhibit No. 11585: Is a one page exhibit in the printed handwriting of Nigel MORGAN and consists of the B.C. itinerary of Leslie MORRIS while that individual was in B.C. during the latter part of January and first part of February, 1953.

Exhibit No. 11586: Is a press release by Nigel MORGAN dated January 1953, regarding the Leslie MORRIS tour of the Province.

Exhibit No. 11587(1)(2): Is a 2-page letter in the handwriting of Jack HIGGIN Royston, B.C. to Nigel MORGAN. The letter is dated Jan. 11, and deals with plans for the appearance of Leslie MORRIS at a meeting in that area.

Exhibit No. 11588: Is a handwritten letter from Sam ENGLISH to Nigel MORGAN dated 8th Jan, 1953, same dealing with Party and Union activities in the Crows Nest Pass area.

Exhibit No. 11589: Is a typewritten letter dated Jan. 9, 1953, from Barney BLAKEY to Nigel MORGAN and it discusses the visit to Victoria of Leslie MORRIS.

Exhibit No. 11590: Is a letter to the B.C. membership written by Nigel MORGAN on the 5-1-53, regarding plans to be made regarding the tour of Leslie MORRIS.

FORWARDED for your information. It is considered that all of the above exhibits are of interest and importance inasmuch as they, in common with previous material of this type, have added much to our knowledge of the party structure, membership, and methods of operating in this province.

2. Particular attention is drawn to the exhibits dealing with the National Registration of the various party clubs in Greater Vancouver and throughout the province.
3. Attention is directed to Exhibit #11524, same being the minutes of the August 2, 1952 meeting of the B.C. Provincial Committee, at which meeting the current Provincial Audit and Review Committee was appointed.
4. Emphasis is also placed on Exhibit #11527, same being the roll call sheet of the B.C. Provincial Committee for the current year. This exhibit is a most important one inasmuch as none of our other current sources of information are in a position to be able to furnish with any degree of accuracy the composition of the 1953 Provincial Committee. Similarly, Exhibit #11528 contains the roll call of the 1952 B.C. Provincial Committee.
5. Exhibit #11580 is of similar importance in that it shows the composition of the Trade Union Commission which operates under the direct control of the B.C. Provincial Executive. This Commission is a most important one in view of the party's current concentration in building party strength on an industrial level.

6. The exhibits obtained [redacted] are invaluable [redacted]

The exhibits will assist greatly in the furthering of investigations in many phases of Special Branch work, not only in the Vancouver Special Branch but in Special Branches located at other points. The obtaining of the exhibits described in the above report reflects a great deal of initiative and perseverance on the part of the members of the Vancouver Special Branch.

2. The comments noted in paragraph 6 of the Officer Commanding Vancouver Sub-Division memorandum, are concurred in as the material obtained [redacted] cover the following information presently not in our records and out of the sphere of our present contacts.

(f) Executive of the forthcoming L.P.P. Bazaar Committee. (This annual Bazaar grosses approximately \$10,000.00 each year.).

(g) Various minutes of the meetings of the Provincial Committee of the L.P.P. formulating Party Policy.

(h) Listing the members of the Provincial Review and Audit Committee, (four members). This is of considerable importance.

(i) Listing members of the 1953 Provincial Committee (27 in all). Also listing the 1952 Provincial Committee members (25).

(j) Subscribers to the National Affairs Monthly, which is of importance in as much as the National Affairs Monthly is considered to be the top Party policy publication in Canada.

(k) National Directives and Provincial Directives of the 1953 membership registration, also 39 of the B.C. Clubs registration forms completed in detail.



1. With reference to memorandum from the Insp., Officer i/c Special Branch "E" Division dated Victoria, B.C., February 11, 1953 with Documentary Exhibits Nos. 8335 and 8341 attached, together with forwarding minutes of the Officer Commanding Nelson S/Division, Nelson, B.C., 13-2-53, relative to the above, following is a report in an effort to identify the Party members referred to in the above Exhibits.

2. Doc. Exhibit No. 8335 (1-13) is a letter written by Adolph POTHORN to Alf. DEWHURST of the L.P.P. Prov. Headquarters Vancouver, B.C. This letter was written from P.O. Box 366, Natal, B.C. which was rented by James Emil POLASKI while he was at Natal. POTHORN was located in the Crows Nest Pass District for several months during the latter part of 1951 as a Party Organizer in conjunction with the B.C. and Alberta Committees of the L.P.P. This letter deals with Party activity in the Crows Nest Pass area. In Ex. No. 8335(2) he mentions having to stop over in C & T. This would refer to Cranbrook and Trail. He arranged for a Club Org. meeting in Bell (Bellevue, Alta.) Friday 13th plus a full Area meeting on Sunday in BL or B.C.? which refers to Blairmore or Clairmore, Coleman, Alta. He had a final class in P. (Pernia) on 12th.

3. The S. mentioned in Exhibit No. 8335(3) refers to Sam ENGLISH Michel, B.C. He mentions S. numerous times in Exhibit 8335 (3&4) as being responsible for weakness in the local Clubs and also that ENGLISH is loaded with T.U. (Trade Union) work, Lamp Edit. Board. ENGLISH writes articles for the shop paper Lamp published by the L.P.P. in Edmonton, Alta., Hospital etc. POTHORN mentions the general trend is for S(ENGLISH) to be Chairman and T.U. (Trade Union) Director for area.

4. In para. 2 of Exhibit No. 8335(4), it is mentioned that S. suggested to POTHORN "What about J. as area Org. This refers to James Emil POLASKI who succeeded POTHORN as Party Organizer at Natal-Michel. The initials St. contained in para. 2 of Ex. No. 8335(6) refer to Stefan (Steve) HARMATNY Natal, B.C.

There are also references to St. in Ex. No. 8335(7) pertaining to HARMATNY's work in the Mass Organizations, referring to the W.B.C. and Federation of Russian Canadians etc. In Exhibit No. 8335(9) is a reference to "Jim's" shack. This refers to James E. POLASKI who rented a shack from Rosa HYRACHUK Natal. POLASKI is referred to in the same page as J. as being

AS BEING suggested by S. (Sam ENGLISH) ✓ Jim (POLASKI) ✓ is referred to in Ex. 8335(10) as having a best grasp, Coast Experience?, etc. Other references in the letter deal with the Party situation in F. (Fernie) and Nan(Nanaimo)

5. In Ex/ No.8335(13) he refers to Roberts speaking well. Arthur ROBERTS ✓ of Drumheller, Alta. addressed a meeting in the UNION Hall, Natal, B.C. on Sunday, Dec.9th, 1951, 2 days before the letter of POTHORN's was written. ROBERTS was a member of the Canadian Trade Union Delegation to the Soviet Union representing the United Mine Workers. He refers to the attendance at the Natal meeting and also at BL (Blairmore, Alta.)

6. Dec. Exhibit No.8341 is another letter written by POTHORN to Alf DEWHURST ✓ on Sept. 10th, 1951 dealing with Party activities in the Natal-Michel, B.C. area. Fernie and the Alberta towns of the Crow's Nest Pass. In Ex. No.8341(1) he refers to B. (Blairmore), C (Coleman). In para. 2 he mentions that Ben is to be in the Crow's Nest Pass from Friday afternoon till Monday on recruiting drive trip and that POTHORN will be with him. Ben refers to Ben SWANKEY ✓ Prov. leader of the LPP in Alberta. In para. 3 he refers to the situation in M.E (Michel Natal) and mentions only one of us i.e Steve with foreign accent. This refers to Stefan (Steve) HARMATY ✓ Natal, B.C. In Ex. No.8341(2) reference is made to Sam and Jim, these being Sam ENGLISH and Jim POLASKI. In para. 3 POTHORN states that "Old George" of course won't go near the classes. This refers to George GASKOFF ✓ Natal, B.C. In para. 4 is another reference to Steve (Steve HARMATY) ✓

7. In Ex. No.8341(3) he asks DEWHURST to tell Steve that they will have a youth club set up. In the opinion of the writer he is referring to Steve ENDICOTT, formerly of Vancouver, B.C., who has visited Natal-Michel as an M.E.L.Y. organizer. POTHORN ends his letter with a message to Rossie (Rosaleen ROSS) ✓ of the Prov. offices of the L.P.P.

Since June 1st, that is, during the last six months, our Party in Alberta has recruited 24 new members in the following areas:-

You will note that 12 were recruited in the cities, 1 in the mining camps and 11 in the farming areas. The outstanding example of good work has been Lethbridge, which had a quota of 5 and recruited 8 and which brought in one third of the new members in the Province.

We need to compare our progress in party building with the plans laid at our Provincial Committee meeting last June. At that time we set ourselves an objective of 111 new members by the end of the year, as follows:

To-date we have achieved 22% of our Provincial objective.

Experience thus far indicates, that wherever recruiting has been looked upon as very important work, where it has been tackled with enthusiasm and consistency, the results have been good.

What has been our main problem and weakness? Not all clubs and leading committees have yet had a serious discussion on party building, but even where a good discussion took place, where a list of prospective members was drawn up and where clubs members were assigned to visit them a collective check-up was not carried out with the result that not all prospective recruits were visited and new names were not added to the list. This lack of check-up applies not only to the clubs; it applies even more to the city and regional committees and particularly the provincial secretariat which is in charge of the drive. Lethbridge, which drew up a list of 22 names and saw to it that these people were visited and asked to join, got results- but only because there was a good check-up.

But it would be wrong to regard lack of check-up as only an organizational weakness. It comes from a failure to regard Party Building as a Political Task, a job of primary importance, that can't be put on the shelf because we also have other important tasks.

In this connection I would kindly direct your attention to our Divisional memorandum directed to you under date of October 24th, 1961, captioned as: Labour Progressive Party, Alberta, our reference [redacted] particularly remarks quoted opposite Exhibit No. 4783, which would appear to substantiate that Pothorn is presently the organizer in that mining area.

3. Pothorn's physical description is quoted as follows:-

Age 47 yrs, 5 ft. 10 ins, 165 lbs. Build - heavy set. Clean shaven. Hair - black. Complexion - dark. Eyes - hazel, heavy hooded eyelids, left eyebrow raised, right eye half closed. Nose - straight, medium size. Mouth - large, close shut down at corners, lips - thin upper, slightly protruding lower lip. Chin - receding, round, slight dimple. Ears - large. Walks with a stoop, usual type of dress, shabby, dark suits, striped shirts.

4. It is possible that Pothorn may be operating an old Model Ford bearing B.C. Licence No. 171-884, our records, however, disclose that he has not renewed his B.C. Drivers Licence since 1941.

5. I might mention that the activities of this individual insofar as this Division is concerned are receiving attention by our Nelson Sub-Division, Cranbrook Detachment Special Branch member. In order to assist your Special Branch Personnel in conducting their duties, attached hereto are photographs of Adolph Pothorn. It will be appreciated that should this man's actual location be established, we will be apprised thereof, please.

4. Bevy HENKEI made an appeal for donations to the Hungarian Orphans Fund and in this connection \$44.00 was raised.

5. After the expenses of the entertainment were paid the clear sum of \$120.00 was realized. This will go to the Labor Progressive Election Fund. At present the Bellevue local of the LPP still owes \$200.00 to a member of their club who loaned same during the last provincial election. It is likely that the \$120.00 raised at this affair will go towards paying off this debt.

1. Further to reports of the marginally noted dates re. the above matter. Touch has been kept with same throughout the detachment area. It is found that conditions pertaining to communism are quiet and very much as this detachments informant reports, disorganized. This is due possibly to the fact that no outside organizers have been in this area, working for some time. With an outsider in charge however the party would soon get together again. With present heads of the party this organization will not cause any trouble as long as they are in control.

2. There have been strong rumours about the Pass that Enoch Williams, present Mayor of Blairmore and head of the communists in this area had quit the party, on checking this down I find that Williams is just as interested in the party as ever and is still the head. Williams has political ambitions and I am of the opinion that this rumour was started within the party, with one end in view that being in the event of the present government going to the country before their full term is completed, Williams will go after the nomination from the labor party and run in opposition to the present sitting member

3. Meetings have been held at Blairmore, Bellevue, Coleman and Hillcrest during the past few weeks, all very sparsely attended, the only business apart from routine matters being the Padlock Law of Quebec. As a result of meetings Nick Ukrawitz, Pete Zur and Mrs. Polski all of Coleman, are circulating a petition about the district securing names for presentation to the Hon. the Minister of Justice, calling for the repeal of the Quebec padlock law. My information states that this committee already have two foolscap sheets full of names, [redacted] the committee in charge of this work are finding some former communist adherents are refusing to sign the petition

4. Blairmore still remains the headquarters of the party in the Crow's Nest. with the odd meeting being held at Mrs. John North's. A meeting of the district was held at her home during the past week when it was decided to again try and get an outside organizer, this in order to put "pep" into the party locally. The organizer from Sask, supposed to be coming to Blairmore has been sent to other points.

1. With reference to the above matter, during the past two weeks a survey has been made of the Communist situation in this district, and I am continuing same this present week. I have found that very little of interest is being done by the party, for a time the organization were active in connection with the demonstration of May 1st. 1938, and then they have been active in connection with the organization of the Coleman Camps to the U.M.W. of A. It has been noticed that members of the party from Bellevue, Maple Leaf, Hillcrest and Blairmore have been active among persons of their own tongue at Coleman. At their meetings held at Blairmore, and Bellevue the usual resolutions have been passed re. the Quebec padlock laws, the Spanish Situation and resolutions re. unemployment etc. etc.

2. Contrary to the previous attitude of Communists, i.e. supporting Social Credit, a vast change has come over the party members during the last three weeks, they are openly condemning the present Government of Alberta, and this matter has been discussed by them at their meetings as well as on street corners and beer rooms. It has been current among party members that a Provincial Election is in the offing, either this fall or spring (1939) and with this in view efforts are being made to Head office of the party to obtain the services of an outside organizer with two purposes in view, one of which is that Coleman, which has fallen down during the past two years in so far as communism is concerned, should make fruitful ground for organization with the right man, and again to completely reorganize the party in this section of the Pass in preparation for a Provincial election. Nick Ukrovitz, of Coleman was re-elected secretary of the Coleman branch at their last meeting. Enoch Williams of Blairmore is still the general secretary of the party throughout the Pass, but it has been found that with so many other duties demanding his attention, he has been unable to devote the time to the party organization, and the party has suffered. Hence the request for a full time organizer.

3. I will continue to make a complete survey of the communist situation and further reports will be submitted.

2. The general secretary of the Party in the Rocky Mountain constituency is Enoch Williams, mayor of Blairmore. He is also secretary of the Blairmore branch which has a membership of seventy. Party meetings are held in the Miners Hall, usually twice a week.

5. Due to better working conditions and consequently less unemployment, Coleman has only a membership of ten. The name of the present branch secretary is not known.

6. These figures represent the number of members in good standing. Under the present system within the Party, a member in arrears of three months' dues is automatically expelled but may rejoin without paying the amount outstanding providing that he is able to obtain the necessary recommendations, as in the case of a recruit. In addition to this total, there is a large number of radicals in the Crows Nest Pass sympathetic to the Party but who are not paying dues and therefore cannot attend meetings.

7. At the present time the work of the Party in this area is the organization of the unemployed. In Blairmore, the president of the unemployed is Tony Fondelicik, a C.P. member. This man is working under the direction of Williams and appears to be most active local organizer, operating chiefly in Blairmore, Bellevue and Hillcrest. At Coleman, the unemployment question is less acute and there is but little activity in this connection and among the Party members at that point. At Bellevue, the president of the unemployed is William Serra and at Hillcrest, Thomas Fontaine.

Communist Party, the Pass unemployed associations, the officials of which are Party members, have adopted the following demands for the improvement of their condition:-

- (1) The purchase of more Canadian coal in Canada and an embargo on U.S.Coal, with a reduction of freight rates in order to improve the eastern market.
- (2) No taxes to be paid unless adequate work is available.
- (3) Immediate work relief for the unemployed by carrying out the hard surfacing of the highway through the Crows Nest Pass.
- (4) Increase in relief rates, particularly clothing.
- (5) Clearing and cultivation of land between Blairmore and Coleman as a work relief programme in order that the unemployed can grow their own produce.
- (6) A six hour day, four day week schedule of labour for all trade union workers through Government legislation.
- (7) Unemployment to be a National responsibility and the adoption of unemployment insurance.

9. In order that these demands be granted and to draw to the attention of the Dominion and Provincial governments the necessity of improvement in conditions, the unemployed associations in Blairmore, Bellevue and Hillcrest intend to hold frequent demonstrations similiar to the one staged on April 18th until some measure of satisfaction has been obtained.

10. There appears to be some ill feeling towards some of the Hillcrest unemployed on the part of those at Blairmore and Bellevue on account of work being done in the bush by them for low wages, less than the amounts allotted under the relief scale. I understand that most of these men are employed by Charles Sartoris, a contractor of Blairmore who supplies mine props and timbers to the coal companies in this area.

11. For the annual May Day celebration this year, it is proposed that all units taking part in it converge on Hillcrest, the demonstration to be held at that point on April 30th, May 1st falling on a Sunday.

12. In respect to the M.W.U.A. the officials of the Union in the Pass are members of the C.P. The miners are still working under the old agreements but are in favour of the demand of District 18 of the Union (Alberta and British Columbia) for a 20% wage increase as opposed to a suggested 10% cut by the operators. If the present conciliation board negotiations fail, it is proposed to call a general strike in the two Provinces during the Fall of this year. In the event of new agreements being signed, the Union officials have been instructed to have them expire in the Fall of the year instead of the Spring as hitherto as strike action carries more weight at this period of the year.

- 13. John L. Lewis of the C.I.O. is expected to visit Alberta in June or July of this year to attend the Alberta Federation of Labour conference and it is anticipated that he will visit the Crows Nest Pass during his stay in Canada. The M.W.U.A. is affiliated with the C.I.O.
- 14. With reference to the report of Calgary C.I.B. under date of April 12th, Mike Danyluk @ Ure Daniels is at present in Coleman as an organizer for the Independent Mutual Benefit Federation. He is a Party member. He took the place of Oscar Morgan, who returned to Montreal about one month ago, and proceeded from Calgary to the Pass with Joe Muller. The latter stayed two days and returned to Calgary, later proceeding east via Lethbridge and Taber. Small Slav sections of the I.M.B.F. have been established at Blairmore and Bellevue and a Hungarian section at Hillcrest. Danyluk is now organizing in Coleman in an effort to affiliate the Italian society there with the I.M.B.F. as, I understand, the society is in straightened circumstances financially. As far as is known, he is the only outside organizer in the Crows Nest Pass at the present time.
- 15. As stated, the main task of the C.P. in the Pass is the organization of the unemployed. Members are also actively engaged in recruiting for the Party itself and the Clarion drive. Following the mine strike in 1932 and after Harvey Murphy and Pat Lenihan left, Party membership declined sharply until only nine were left in the Blairmore branch. Of late, however, it has sprung into prominence again and is taking advantage of the unemployment situation to strengthen the ranks. Consequently membership is increasing, but no trouble is anticipated at present.

1. Referring to my report re the above matter of the 5.4.38 re. activity of the party about Coleman. Since the meeting of the 3rd. April 1938 in the Ukrainian Hall at East Coleman, two meetings have been held over which George Gassoff presided, the attendance at the meeting of the 9th. inst. was similar to that already reported on, another attempt was made to hold a meeting on the 17th. inst. and the response was poor, Gassoff stated however the meetings would be continued and again impressed the necessity of each member bringing a new member. Conversations with some of those who have attended the meetings referred to leads me to believe that the attempt to organize the Y.C.L. will fail. Touch is being kept with this matter and reports will be submitted. With warm weather coming on there is not much prospect of this organization continuing much longer.

2. Ure Daniels, also known as Mike Danyluk, has left the district supposedly for Calgary, the subject M.E. Smetaniuk mentioned in same report and again in report of the 7.4.38 has written to a person in Coleman and said that he was going to YMIR, B.C. (close to Nelson B.C.).

3. Communist activities at Blairmore, Bellevue and Hillcrest have been quiet since last report, with very little activity shown.

4. Reference report of this detachment under date of 30-3-38 para. 4. thereof the subject mentioned therein "Comrade [REDACTED]" and again referred to in detachment report of the 5.4.38 para. [REDACTED] has been located staying in a house on the river bottom at Hillcrest, his organizing ability was poor and he only lasted a few days about Coleman, Alta. his activities have consisted solely of visiting the Lithuanian's of the district, this nationality is poorly represented there being a total in all of 11 persons, [REDACTED] collected the sum of \$1.00 from each family and it is the impression among those from whom he collected that he has used the money for his own use. This man was a former inmate of the relief camp at Bellevue, Alta. [REDACTED] it is found that this man is leaving the district at once for Ontario, some place where tobacco is grown, and is not returning to this district.



- Further to my report of the marginally noted date. Due to other activities and heads of this party being out of the district for a time, matters have been slow.
- Reference the man [redacted] mentioned in para. 2 of previous report, I am informed that due to his age, i.e. being under 21 yrs. he is having difficulty in making the necessary arrangements for his Pass port etc. he is still in Blairmore.
- Enoch Williams, Mayor of Blairmore and mentioned in para. 3 of previous report has returned to Blairmore. Since his return I have been informed that another organizer of the party is coming to Blairmore, and the name of Harvey Murphy, very active in Communist and labor matters during the years 1932, 33 and 34 and presently somewhere in Ontario is mentioned as being the one slated for the job. I feel however that with the record that Murphy left in the Pass district that there will be strong opposition to this appointment. From what I can gather Murphy's name is the only one mentioned to date. Murphy's wife was formerly a Miss Rae of Blairmore, whose parent's are strong adherents to the party.
- Reference report of L/Cpl. Naylor of Fincher Creek Detachment under date of January 5th. 1938. para. 2. I would request if possible the maiden name of [redacted], it is mentioned that this woman is from the Crow's Nest Pass. I do not know the man [redacted] para. of same report mentioned [redacted] this man resides where stated in report, he was formerly a resident of this district and was active in Communist and radical matters, he often visits with friends in this area. In the summer time his place on [redacted] is frequently visited by middle aged men of the Pass particularly on Sundays who go to his place for a drunk. He is also visited frequently by members of the Party as well. All of his friends in this area are radicals. He is not however of the dangerous type.
- Meetings of the party at Blairmore have been solely held at the home of Mrs. John North and those attending have been those known locally as the heads of the organization. Other activities of the party consists of card parties etc. to raise funds for members of the Mc Kenzie -Papineau battalion in Spain, admission to same being either in cash or cigarettes or tobacco.
- [redacted] mentioned in Lethbridge Report of the 14th. Dec. 1937 has not been seen about the Pass since my last report, he is reported as having left for Lethbridge or Calgary.
- I will keep in touch with matters and reports will be submitted in due course.

1. The above organization has continued to show more activity, outside speakers of the party including the following have paid visits on each occasion called for a meeting. Rev. A.E. SMITH of Toronto, JIM LAKEMAN and L. ANDERSON of Edmonton, Alex Young, local communist secretary and organizer acted as chairman for all meetings, same being held in the Union Halls at Bellevue and Blairmore and the Ukrainian hall at Coleman. The meetings mentioned were all public meetings and with the exception of the Blairmore meeting were not largely attended. The subjects spoken on were solely the Spanish situation, the British foreign policy and the "Padlock" law in Quebec. The padlock law of Quebec has become a pet hobby of Alex Young and he speaks on same at every opportunity. At the Smith meeting a collection was taken in aid of the Spanish Loyalists amounting to \$30.15.

Alex Young local Communist organizer has left on the 28th inst for Toronto, Ont. where he is slated to take an educational course locally reported as six months, [REDACTED] would be away approximately four months, his wife left Blairmore on the same train and whilst it is reported that she is accompanying her husband to Toronto [REDACTED] her ticket only read Calgary, Her home is at Calgary she being a sister of Mrs. Pat Lenihan. During the past month matters within the party at Blairmore in particular, but the whole of the Pass as well have not been going to smoothly, first the members of the party whom I am informed at the present time consists of 250 persons are objecting to too many assessments being made on them to support the organization. All employed members of the party have been paying 45¢ per week towards a fund to pay Young, when he has been sent to conventions etc. the employed men have been assessed as high as \$10.00, with small pays etc. the assessments were coming to often and too high. The local communists have decided that they will do without the services of an organizer, they feeling that local heads are capable of carrying on the work themselves. This has been recommended to the party headquarters. Again friction has crept into the party due to the fact that the more radical ones think the party has become too soft in their actions, the "blood and thunder type" however are in the minority, and Enoch Williams and Alex Young both of the quiet type and will not stand for any rough stuff still have been able to carry the meetings in their way. As a result of this friction Frank Leary an old time communist has quit the party and is doing considerable talking among the communists and working underhand and considerable dissention is noticed. Williams is going after Leary hard over some shortages of furniture etc. from the communist old quarters, now closed up. 28-12-37 (1)
