CANADIAN ARMED FORCES AEROBATIC DISPLAY TEAM
DISPOSAL OF AVRO 504K VINTAGE AIRCRAFT

1. Three AVRO 504K aircraft are currently held in storage at CANMATMAINT (6RD), Trenton. Disposal action is required on these vintage aircraft which had been purchased and re-built for flying display with the Golden Centennaires aerobatic team. With the completion of the CAFAT Canadian tour on 29 October 1967, there is no longer a need to retain these aircraft in the Canadian Armed Forces.
2. Two 504K's (CFEI and CFCK) are in flying condition while GCYFG has been re-furnished to museum standards. The three aircraft are the end result of two special purchases charged to the Golden Centenaire centennial project (CD692906) at a cost of \$22,100.00. Current value of the two airworthy models is estimated at \$40,000.00 each.
3. DSUPA (Mr. Tweed) informed DXD that their office had an agreement in principle to place all vintage aircraft and obsolete military stores, which may have some museum or other display value, under the administration of the Secretary of State Department. A submission pertaining to proposed custody records of the Aeronautical Collection in general was being forwarded to the DM.
4. The continued use of these vintage aircraft for DND participation or display in community activities is not being considered. It is recommended that GCYFG be assigned to the Aviation and Space Museum of the National Museum of Canada and that CFCK and CFEI be turned over to the Rockcliffe Museum. The return of loaned engines or spare parts should be assured, prior to aircraft disposal.

PLANNED PHASE OUT OF SABRE TRANSITION UNIT

Reference: A. V 1111-51-6 TD 7310 (DAFORSF) of 8 November, 1967.

1. In your memorandum to the Minister at reference A, it is noted that, in para 3, you indicate it will not be possible to close out the Sabre Transition Unit at the end of this fiscal year. Also, it is suggested that the retention of this unit could be funded by the deletion of the Golden Centennaires.

2. We wish to point out that the estimates for 1968-69 do not include any funds for the operation of either of these units beyond the end of this fiscal year. Furthermore, I believe you stated, at a meeting of Defence Council subsequent to 8 November, that we could get along without the Sabre Transition Unit after 1 April, 1968. In any case, under the circumstances, it would seem that we should deactivate this unit by the end of the current fiscal year if at all possible.

3. In view of the fact that it is intended to close Zweibrucken and to reduce the number of aircraft in the Division to approximately 88 no later than the summer of 1969, it would seem that the requirement for new pilots for the Air Division in the summer of 1968 might be met by other means, such as voluntary extension of tours, re-cycling of pilots who have had a previous tour on CF 104s, etc. If the date for reduction of the Air Division should be advanced to the summer of 1968, presumably there would be no problem of pilot replacement since it should be possible to replace tour expired pilots in the remaining squadrons by redistribution of non-tour expired pilots within the Division.

4. I am not aware of any detailed study having been made of this particular situation. May I suggest that such a study should be made before we firm up on any proposal to retain the Sabre Transition Unit beyond the end of this fiscal year. Pending your reply, we will make no plans to allocate funds for the continuation of this activity beyond 31 March, 1968.

1. My reference memorandum had ministerial concurrence in the retention of the Golden Centennaires until the fall of 1968. However, due to our current budget restrictions, this decision must now be re-considered.
2. It had been hoped that the aerobatic team could double as flying instructors and coupled with the presentation of limited air shows next year, reduce the overall O&M costs. This has not been considered possible and monies estimated at close to one million dollars would have to be found to continue the team through 1968. Their current tour has been supported by 1967 Centennial funds.
3. Additionally, as you are aware, there has been a slippage in the CF-5 delivery schedules. This will preclude the planned close out of our Sabre Training Unit at the end of this fiscal year. Its retention for a few more months is imperative and the added cost could be offset against any proposed expenditure for the Golden Centennaire's operation.
4. Therefore, reluctantly, we must reverse our earlier decision and recommend the disbandment of the Golden Centennaire aerobatic team following completion of their current United States of America tour. Your early concurrence of such a decision would be appreciated so that CP can action personnel postings and CTS arrange for the re-configuration and transfer of the teams aircraft.

1. The retention of the Golden Centennaires until the fall of 1968 was confirmed by Reference A. Both references B. and C. refer to using the Centennaires on "productive" work and restricting their appearances to major show areas.

2. It will not be possible to double hat the team and produce both instructors and aerobatic display specialists. Personnel branch has indicated that unless the pilots were qualified flying instructors, they could not be effectively used in the 3-4 winter months of their availability. If we are to retain an aerobatic team this time period is essential to re-group and re-train in preparation for 1968. Following the termination of the USA tour the team was going to be stood down for the month of December to accommodate joint annual and special leave. Four of the pilots from this year's team were to be replaced. Following new selection trials in January the team was then to undergo a concentrated training period requiring three flights daily on a seven day week schedule for the following three months. At the same time the aircraft were to undergo certain maintenance requirements, dynamic stress tests, stripping and re-painting etc. It had been planned to be ready for public presentation on 24 May 1968, schedule 60 shows and terminate by the end of September, 1968.

3. The figure of 60 shows for 1968 is considered a maximum/minimum necessary to retain the team's expertise and at the same time, not jeopardize flight safety by either reduction of aerobatic practice or over exposure of the team in the 4 summer months.

4. If the Golden Centennaires can not be retained as a single unit with a single mission until their disbandment in the fall of 1968 then their retention should be re-considered. In view of the current

Reference: A. V 1775-4210/0 (VCDS), dated 5 October, 1967.

1. I have read reference A and its attachments concerning the plan to continue operation of the Golden Centennaires through to the end of calendar 1968. It strikes me that this item is one that we should consider carefully in view of its high cost and the austere financial position which faces us next year.

2. The Golden Centennaires involve 16 Officers and 38 Other Ranks, 12 Tutor aircraft and 2 T33 aircraft operating at 25 MFR. Disregarding personnel costs, which exceed \$430,000, the operation of these aircraft as planned in 1968 would cost an estimated \$400,000 at standard aircraft operating costs. Because of the strenuous type of flying involved and the logistics costs of supporting these aircraft in a variety of locations, however, the true cost of this flying program is likely to be considerably in excess of the \$400,000 figure. Some logisticians say that the cost might be twice that figure and I am inclined to agree. Accordingly, total PO&M costs for this activity are likely to be in excess of one million dollars in FY 68/69. No provision has been made for this item in the new year estimates under review because the previous plan was to disband them this year and this fact was displayed in the Program Review Document (Book II - Section 44-1, refers).

3. If we were to discontinue the Golden Centennaires this year as previously planned, we would not only have the 16 Officers and 38 Other Ranks available for other duties but also we would save at least one-half million dollars in other O&M costs and this money could pay for a further addition of 60 Service personnel.

4. While I appreciate that there are some benefits from continuing the operation of the Golden Centennaires it would be my view that the matter should be carefully weighed in light of the above financial considerations.



CONTINUATION OF CANADIAN ARMED FORCES
AEROBATIC TEAM (CAFAT) AFTER 1967

1. A submission raised by the OC of the Golden Centennaires for the continuation of a Canadian Armed Forces Aerobatic Team on a permanent basis after 1967, has been examined by this Headquarters and is supported in principle.
2. Since WW II, several aerobatic teams have been formed and disbanded. Some of the teams were established units, while others were formed on a seasonal basis as a secondary task to a primary function. The Sky Lancers, Goldilocks, Gimli Smokers, Prairie Pacific and the Golden Hawks will be well remembered by many. These teams demonstrated a standard of professional flying that was an inspiration to both military and civilian pilots. Certainly, the Golden Hawks, an established flying unit, developed the skills, talents and teamwork which resulted in highly professional air shows that were acclaimed by thousands throughout Canada and the USA.
3. In each case the aim was to demonstrate aircraft and the combined abilities of both air and ground crew to operate and maintain the aircraft. The Services undoubtedly gained considerably through the public relations achieved by these teams. Also, it is believed that the performances by the teams stimulated many young Canadians' interest in flying and in joining the Armed Forces in a flying capacity. A permanently established aerobatic team should serve to:
 - a. Continue to stimulate young Canadians' interest in military flying;
 - b. Demonstrate to both the public and other military pilots a high standard of professional flying ability.

- c. Provide the public with a colourful, exciting and thrilling spectacle;
- d. Enhance the public image of the Canadian Forces.

4. The relative merits of an aerobatic team, particularly in terms of Service effort, have been argued for many years. The "pros" appear to have won out in most instances with the formation of the several teams. If public response over the past years, and more recently at Golden Centenaire displays, is used as the criteria upon which to base the decision for a team, undoubtedly a team would continue to exist (a reported 100,000 crowd turned out at London, Ontario for the 6 May show).

5. Although it is not possible for TCHQ to determine the total costs involved in organizing and disbanding display teams, on the surface it would appear to be less costly to maintain a permanent team, with the added advantage of maintaining continuity in the expertise required for this specialized field of flying. Also, this unit could form the nucleus for expansion, if needed, and within it train, control and administer all aspects of demonstration flying for the Services. As part of the unit, but operating singly, as he does at present, should be included the Red Knight.

6. Although it is considered desirable that a permanent Aerobatic Team or Unit be maintained within the Canadian Armed Forces, the following are some of the practical considerations from a TCHQ viewpoint, which must also be taken into account.

- a. Appropriate personnel, aircraft and equipment establishments would be necessary. These should come from the overall Service establishment rather than from individual Command establishments; and
- b. The support of Tutor aircraft will be critical for at least another year and will remain marginal for the year or two following. If Tutor aircraft were to remain in an Aerobatic Team inventory, this would place an additional burden on the resources, especially engines and spare parts, required to meet the flying training commitment.

7. On balance, although certain problems may arise in retaining the aerobatic team using Tutor aircraft, it is considered the advantages far outweigh the disadvantages and it is requested that favourable consideration be given to establishment of a permanent Canadian Armed Forces Demonstration Unit or Team which would maintain the present expertise in aerobatic flying for demonstration purposes as required to meet future needs.



1. The subject contained in reference A. was discussed with W/C O.B. Philp, OC Golden Centennaires and Red Knight on 13 Jan. S/L P. Bissky of Training Command was at this meeting and he confirmed that to date there was no organization order/establishment for the Red Knight. It was determined that in the past Training Command provided the nucleus for a small Red Knight Aerobatic Team from within TC resources. This convenient situation can no longer prevail, it would seem, as CFB Moose Jaw complained to Training Command at the end of the 1966 season that unit resources were so stretched that the Base could no longer operate the Red Knight without the proper establishment.

2. As a result, Training Command moved the Red Knight to CFB Portage la Prairie and determined that the Red Knight activities could best be supervised by the OC Golden Centennaires. At this point it became apparent that the observation raised in reference B. is valid and now if the Red Knight is to operate in 1967 the necessary establishment and organization action will have to be taken.

3. W/C Philp interviewed A/C W. Carr, DGAF, on this matter 13 Jan. DGAF has ordered DAFOR(CF) to arrange the necessary establishment and organization action including the approval. DGAF's wishes are reflected in Minute 3 to reference A. attached. DGAF suggests that approval is the responsibility of DG Cen but that he is prepared to order DGAFOR(CF) to arrange the necessary establishment and organization.

4. It is recommended that DG Cen approve the establishment of the Red Knight and forward this approval and the authority of DGAF to DAFOR(CF) for their action.

1. I refer to your memorandum P1111-51-6 (DG Gen) dated 8 February 1966, which I had assumed had been returned to you with a notation but which has apparently been lost or mislaid.
2. While I fully agree that "Centennaires" is an appropriate title for our armed forces aerobatic team, I believe that "Golden Centennaires" is a stronger title and one which has considerable more appeal from a public relations viewpoint. Moreover, since 1967 will be the 50th anniversary of military aviation in Canada, it is not unreasonable to recognize it in this way. I understand that DIS, some weeks ago, asked you and the CDS for your views on the title "Golden Centennaires" and he reported that neither of you had any objection. DIS, therefore, authorized an item for the issue of the Sentinel which is now on the press, which will say that the team will be named "Golden Centennaires".
3. With regard to a French language title, it appears that the word "Centenaire" has such a strong connotation in French of old men, it would not be suitable. It was, therefore, the Associate Minister's recommendation that the French language title should be "Les Paladins du Centenaire". I believe this is a good title and DIS has been instructed to include an announcement to this effect in the Sentinel as well.
4. In view of the decision to use the English title "Golden Centennaires", it would be appropriate to paint the planes 'gold' - perhaps along the general lines of the paint design used for the Golden Hawks, which was most colourful and effective.

1. Logistic support of the proposed aerobatic team does not at this time suggest problems which cannot be dealt with as the operational concept for the team is developed by VCDS staffs. In one area however, I consider that we are not making the best use of the significant investment involved in this undertaking and that is in the matter of the JN-4's.

2. While I appreciate the desire to portray contrasts between the aircraft types selected for the team, I cannot with prudence agree with the assumption which appears to have been made respecting our ability to have a pair of JN-4's produced in the time frame indicated. While drawings are known to exist, the actual construction of the aircraft and its engine is not possible in the time available and I would also suggest that it could not be undertaken for the cost indicated.

3. It would in my opinion be a better investment both for the display team and our museum if the funds available could be utilized in the procurement of flyable World War I aircraft, i.e., AVRO 504K, Bristol Fighter, or SE-5 which are still available on the market. They could be reconditioned to the extent required in the intervening months and a certain amount of spares could also be gathered up and/or fabricated. The time thus saved could be devoted to devising quick disconnect arrangements for wings and the like which would permit these relics to be air transported should the display schedule so require.

4. In addition to ensuring availability on time, aircraft such as the AVRO 504K and SE-5a have a closer association with Canadian Defence Forces than the JN-4. The aircraft received in 1919 for use in the Canadian Air Board (and later in the CAF) were composed largely of 504K's and also included some SE-5a's. These types would therefore represent the first trainer and fighter type aircraft in the Canadian Forces, for comparison with the current types which will be in the display. Finally, acquisition of these types would considerably enhance the museum, whereas additional JN-4's would add little to the excellent example of this aircraft which already exists.

5. Such an arrangement would permit the public to see the bona fide article when on the ground and hopefully, on cessation of operations,

The manufacture of 2 JM-4's even if possible and in such a manner as would provide an aura of authenticity when viewed from the ground, would not obviate a requirement for their being air transportable nor would it inherently guarantee any greater degree of reliability/serviceability/performance than could be obtained from the bona fide article in top shape.

6. I therefore strongly recommend that:
- a. further consideration of manufacture of 2 JM-4's be dropped;
 - b. funds now available for this manufacture be utilized to procure 2 flyable World War I aircraft and such spares as may be available;
 - c. these aircraft on receipt be reconditioned as required and modified to the extent practicable or necessary to assure they are air transportable;
 - d. on completion of flying operations they be issued to our museum.

1. Formation of the Canadian Armed Forces Aerobatic Team which was proposed for the 1967 Centennial celebrations has now been approved. The Team is to be fully operational by the 27th April, 67, and if time permits, a brief itinerary for a full dress rehearsal during the late summer and fall of 1966. The Team shall consist of 10 Tutor aircraft, 1 CF 104, and 2 JN 4 replicas which are to be manufactured.

2. In view of the organizational experience gained during the period that the Golden Hawks were in existence, it is considered essential that a Wing Commander be established as an officer commanding the Aerobatic Team. This would be a strong point, particularly when dealing with Station Commanders and supervising administrative and disciplinary details. Training Command has been requested to select the pilots for the Tutors which they will submit to this HQ for final approval. The following is a breakdown of personnel for the Aerobatic Display Team.

- a. Tutor - One S/L Team Leader
Seven F/L or F/O Pilots
- CF104 - One pilot
- JN4 - Two Pilots

Commentators - Two officers with a flying background; at least one to be bi-lingual.

- b. Maintenance and servicing personnel, plus support personnel adequate to maintain the aircraft and provide the necessary administrative services.
- c. The positions of the Officer Commanding and the Commentators be established as annotated flying positions. (This was found to be advantageous when the Golden Hawks were operational).

3. The proposed establishment is referred to you for consideration. It is requested that this Directorate be advised of your decision at the earliest possible date.

AND AIRCRAFT COLOURING

1. The Canadian Armed Forces Aerobatic Display Team is being created as part of the department's contribution to Canada's centennial celebrations in 1967. For purposes of promoting and publicizing the event, the team should be given a name compatible with the occasion, easily remembered, and readily associated by the public with the Armed Services generally and with the team in particular. The name suggested is:

"The Centennaires"

2. This title is neither French nor English in origin and composition, but is manufactured from both languages' terminology for the occasion of Canada's 100 years of confederation and is a readily recognizable combination of both.

3. This title would be an exclusive one and should appeal to both French-speaking and English-speaking people. For example, it would preclude the mixture of French and English which arose during the days of the RCAF's "Golden Hawks" when the team was generally referred to in the French language as "Les Golden Hawks" as opposed to the literal translation of "Les Eperviers Dorés".

4. It is further suggested that the aircraft used by this team be painted red, one of Canada's official colours, and thereby provide maximum contrast for public viewing against clouds and sky.

5. Approval is requested for the use of the title "The Centennaires" and for red as the aircraft colour.



Reference: A. Memorandum P 1111-51 (IG Cen) over P 1111-51-6 dated 29 Dec 65 from CDS to the Minister, copy to the Associate Minister.

1. A copy of reference A. is enclosed.
2. The creation of the Canadian Armed Forces Aerobatic Display Team, consisting of 10 Tutor (CF114) aircraft, one CF104 aircraft, and two JNA replicas specially manufactured for the purpose, has now been approved. The sum of \$925,000. covering the estimated cost of this project has been included in departmental estimates for 1966/67 under Vote 200, Primary 92, Sub-Allotment 30, Object 126.
3. The IG Centennial has been responsible for developing this project as one of a series of four National Projects being undertaken by the department as part of its contribution to the centennial celebrations in 1967. There is now only one area of the centennial planning aspects of the project remaining to be completed, namely the itinerary which the team will follow throughout its 1967 tour and, if time permits, a brief itinerary for a few full-dress rehearsal presentations in the late summer and fall of 1966.
4. Included in the development of the 1967 itinerary will be the integration of the team's appearances in various locations with the plans currently under preparation by a number of Service Commands for local Armed Forces participation in provincial centennial programmes. There are also the requests of various exhibition associations, local airshows, and major organizations at present planning their activities for 1967 (e.g. ESO 67, the Pan-American Games Society) who will probably bid for the appearance of the team at the special events which they are currently preparing. This must be considered in conjunction with the provincial programmes mentioned above.



5. The itinerary as a whole will be directly dependent on the suitability of the proposed performance centres in relation to satisfactory accommodation for public viewing, legislation affecting aerobatic displays, and air field and maintenance facilities, and the DG Centennial will be responsible for ensuring that the itinerary which he finally recommends for approval meets all of these criteria. However, because of the highly specialized and technical nature of constituting, equipping, and training this team to the point where it can undertake the itinerary designed for it by DG Centennial, the Office of Primary Interest (OPI) must necessarily shift as of now from DG Centennial to an appropriate operational division within your branch. This will mean that the division so selected as the OPI will be responsible for co-ordinating all activities concerned with ensuring that the team can begin its itinerary for 1967 in April of that year with, if at all possible, some full-dress rehearsals at a few major public events scheduled for 1966.

6. Copies of this memorandum have been sent to CTS and to CG to enable them to determine, in advance, the divisions and directorates likely to be directly concerned with the development of this Aerobatic Display Team. Information on the office selected as having primary interest in developing this project would be appreciated in due course.

1. Para 1a of reference B. states that you agree in principle to the formation of a Canadian Armed Forces Aerobatic Display Team as recommended in para 9 of Annex A to reference A, subject to approval of the types and number of aircraft to be used by the team.

2. CTS now advises that he has consulted with Training Command, the staff of Deputy Chief (Operations), Central Experimental and Proving Establishment and an ex-Golden Hawk pilot/commentator. There is unanimous agreement that 10 Tutor (CT114) aircraft should be assigned as the principal vehicles for such an aerobatic display. Ease of maintenance and the aircraft's ability to remain close to the viewing stands during performances are its chief advantages. At certain selected performances CTS sees the need to add one high-speed and one low-speed aircraft, such as the CF104 and the JN4, respectively, to show contrast between the old and the new and between the operational aircraft and the trainer.

3. Since the centennial year is also the 50th Anniversary of military flying in Canada, a JN4 replica (the first trainer used in 1917) is, perhaps, the most appropriate type of low-speed aircraft to accompany the team. Two JN4 planes, manufactured specially for this purpose, could move under their own power from one performance centre to the next, leap-frogging, so that one aircraft would be available for each show. The cost of manufacturing and operating these two aircraft (approximately \$65,000), was included in the overall estimates of \$925,000 for this project as presented in reference A.

4. In view of the foregoing, it is recommended that:
- a. the Canadian Armed Forces Aerobatic Display Team consist of
 - (1) 10 Tutor (CT114) aircraft;
 - (2) 1 CF104;
 - (3) 2 JN4 replicas;
 - b. authority be granted to tender immediately for the manufacture of the two JN4 replicas.

Lead-times entailed in construction and training require early approval, as requested above, especially as a limited number of performances are scheduled for the Fall of 1966.
