This has reference to the subject matter and will acknowledge receipt of your memorandum dated July 6, 1966, under the above file number.

Please be informed that we have checked out the question of the late Irene Joe owning any property in her own right at the time of her death on Cowichan Indian Reserve. The results of these enquiries are negative and we are satisfied that the late Irene Joe died intestate without any assets. In the circumstances, as there are no assets for distribution, we do not consider that our file in this case should be kept open any longer.

We regret the error in informing you on a previous date that we have no information or particulars regarding the payment of the funeral account in this case. The funeral account in the amount of \$150.00 was vouchered through this office and was paid from funds from our Welfare Division. It was due to a change in staff and some new personnel who were not familiar with the procedure at this office who provided the erroneous information that we had no record here of the payment of this funeral debt. We trust that this is to your satisfaction and that it will not be repeated.

Although we have posted notice to creditors in this case we have not received any other claims and in the circumstances it must be presumed that there were no other debts, with the exception of the funeral account which was paid for as mentioned above.

As there are no assets in this case we propose to close this file but shall not take this action until you advise us to this effect. We trust that this is to your satisfaction and we shall await your early reply and direction.
