He goes to school regularly with his foster brothers and sister. He did not adjust too well in school at the beginning of the term however, he seemed more settled in the last six months.

He is growing taller and eats with a ravenous appetite (especially at commencement of placement). He has never tried in anyway to leave this home and has never given the foster-parents any trouble.

In summary we feel that this is an excellent placement for James and we are pleased to have found Mr. & Mrs. Mork's home for him.


