

ASSISTANCE TO CIVIL AUTHORITIES
Report Winnipeg Blizzard, 4 to 10 Mar 66

1. Notification has been received from Canadian Forces Headquarters that, based upon the report made by this Headquarters to the Directorate of Reserves (D Res) in May 66, various directorates were queried as to the feasibility of obtaining additional snow removal equipment for Fort Osborne Barracks and of field units holding tire chains for 25% of their vehicles. Extracts of the report are attached at Annex A.
2. Director Base Maintenance (DBM) advised that it is DRM policy to recommend that bases hold sufficient snow clearing equipment for their total requirement rather than rely on contractors. DBM records show Fort Osborne Barracks holds one industrial tractor equipped with a small snow blower. He agrees that this is NOT sufficient for the type of emergency of 4 Mar 66 and that CFB Winnipeg should submit recommendations for snow removal equipment entitlements.
3. The Directorate of Supply Administration (D Sup A) advised D Res that tire chains for 1/4, 3/4 and 2 1/2 ton SMP vehicles are reflected in the EIS for these vehicles as separately demandable items. Field units may hold tire chains for 25% of their vehicles and need only demand. The deficiency will be brought to the attention of Mobile Command to ensure it does not recur in the future.
4. D Res recommends that arrangements be made between CFB Winnipeg and Headquarters Manitoba District for priority to be given to Fort Osborne Barracks for additional snow removal equipment. This Headquarters will provide as much supporting data as possible, if required.

RECOMMENDATIONS

8. HQ Manitoba District is charged with the responsibility of assistance to Civil Authorities and Aid to Civil Power which includes immediate reaction to calls in assistance from the Stony Mountain Federal Penitentiary. Additionally, units of Mobile Command are located in the Fort Osborne Barracks area, who may at times have urgent operational commitments, therefore, it is recommended that Fort Osborne Barracks maintain at least a limited snow clearing ability.

9. It is further recommended that field force units be required to maintain in unit stores enough tire chains to equip at least 25% of their vehicles.

COSTS

10. Service costs for the blizzard period, in accordance with CAO 11-1 Annex 'J', amounted to \$1571.85. Detailed costs are itemized at Annex 'A'.

CONCLUSION

11. While initial reaction to the requests for assistance to the civil authorities was slow because of the reasons stated above, the assistance of the Army was much appreciated and considerable favourable comment on our action was made, in particular, by Winnipeg Hydro, the Chief of the Winnipeg Fire Department and the Chief of the Winnipeg City Police. It was reported that the use of Army 4-wheel drive vehicles in conjunction with police and fire emergency vehicles was instrumental in saving of two lives.



When it became necessary to remove the superstructure, the bows were broken off rather than removing them in the proper manner.

After-Action Report
Severe Storm 4-6 Mar 66

1. This report will be a summary of events since the aid supplied during the blizzard was of such variety and dispersion that detail co-ordination was impossible.

2. The aid supplied involved the following:

3. The trucks were involved at various times with breaking trails for civilian emergency vehicles, picking up emergency medical cases for evacuation to hospitals, standby-by duties at various local fire stations until released by fire chiefs and for pick-up and return of stores from 16 ROD on various occasions.

4. Many of the above operations often occurred simultaneously. Trucks, although despatched as far as possible in packets and groups, soon became separated and requirements were largely for single vehicles as explained above. With no communication except by telephone and other civilian facilities it was impossible to maintain control and keep track of operations in detail until after tasks were completed and trucks returned.

5. The 4 Tpt Coy POL Point was open on various occasions servicing mainly unit vehicles. However, as a result of the storm, vehicles from 1 Loc Bty and 213 Wksp RCEME were also refuelled on occasion.



Aid in a Civil Emergency
Blizzard 4 Mar 66

1. 3 RCHA involvement in the operations arising from the blizzard which was experienced by WINNIPEG this past weekend, focusses attention on a number of matters affecting the operational readiness of this Regiment.
2. A matter of six hours elapsed before 3 RCHA could play its assigned role. This was not due to any manning difficulties. In spite of the fact that, early on the morning of 4 Mar, the Regiment had been stood down, 150 all ranks who live in barracks, were alerted and ready within a matter of minutes. The decision to stand the unit down was a wise one. There was no point in compounding the difficulties which were already evident on the public thoroughfares by encouraging some two to three hundred members of the Regiment to travel to unit lines. In any event, the public transportation situation was such that the majority would not have been able to report for duty. Some minor difficulties were encountered in conveying the CO and his staff to HQ and in assembling certain individuals who held keys to the various stores in which tire chains were kept. These difficulties were minor and were soon overcome by use of the unit's APC's. By approx 1600 hrs, or within 2 1/2 hours, a Command Post had been established and a number of vehicles (many of them radio equipped) with tire chains were ready to be placed at the disposal of your headquarters.
3. The major difficulty was encountered in getting the vehicles out of Building C-4 and out of the ME Compound. The only large door which was free of snow has been inoperable since 6 Jan 66; the other was blocked by a 10-foot snowdrift and the required snow clearing equipment did not materialize until approx 1930 hrs. The matter of the inoperable door deserves further examination and will be the subject of a separate communication.

4. Since 4 Tpt Coy and 3 RCHA are both faced with the same responsibilities and operational problems, it might be advisable to place 4 Tpt Coy under 3 RCHA command for such emergencies. This would also narrow the span of command of your Headquarters.
5. While it is conceded that some may consider that the Army was slow in reacting, a worthwhile job was nevertheless done. A large number of people worked long hours and cheerfully exerted themselves to aid the local authorities. Yet very little of this effort has been publicized.

6. This unit is apt to be asked to perform tasks in aid of the Civil Power; because of our prevailing climatic conditions, it is more than likely that such tasks will be performed in severe winter conditions. In spite of this the Army in Winnipeg does not hold any oversnow capability. While the APC's can negotiate snow, they are not really suitable for use in built up areas. Indeed, our drivers are to be congratulated for doing such splendid work without causing any damage to property.

7. The following recommendations are made:

- a. The North main door to building C-4 should be repaired immediately;
- b. Both main doors to building C-4 be made manually operable immediately;
- c. The military snow clearing capability in the Winnipeg Garrison be studied;
- d. 4 Tpt Coy be placed under 3 RCHA command for emergency operations of this nature; No!
- e. The publicity aspect of these operations receive more attention;
- f. A minimum of two oversnow vehicles of the NODWELL type be held in the garrison.

8. A further detailed report including the costs required by CAO 14-1 will be forwarded.


