





RE - WORKERS' PARTY OF CANADA.  
MEETING OF THE CENTRAL EXECUTIVE COMMITTEE.

Sir :-

The annual meeting of the Central Executive Committee of the Workers Party, as provided for in the constitution of the party, took place at Winnipeg Man. commencing June 30th.

The meeting was called to order by W. Moriarty ( Toronto ) at 5 p.m. on June 30th at the Ukrainian Labor Temple, Winnipeg; the following delegates being present:

- A. Members of the C.E.C.
  - Henderson, ( Winnipeg ) Bruce, ( Regina )

- B. Delegates from the Ukrainian Bureau.
  - M. Popovich, Kolisnyk ( Winnipeg )
- C. District Organizers.
  - H.M. Bartholomew, ( Winnipeg ) R. Morgridge, ( Edmonton ) and G. Tether ( Vancouver ).
- D. Fraternal Delegates.
  - W. Hammond ( Winnipeg ) J.W. Esselwein ( Regina ) W. Mill, G. Barron, ( Saskatoon )
- E. Women Bureau.

It was decided, after a lengthy discussion that all the members of the C.E.C. be seated with full voting power and that all the others be seated with voice but no vote.

Then the Agenda was read by the Secretary and adopted, and T. Buck was nominated to preside at the meetings.

The chairman then called upon the representative of the Finnish section to report.

A. T. Hill then reported on behalf of the Finnish section. He gave a short outline of the activities of the 57 branches of the Finnish section, stating that they were solid behind the Workers' Party. He also pointed out that the youth movement was well advanced in the various branches of his section and also that the women are taken considerable interest and part in the movement.

The meeting agreed to that and the meeting was then adjourned until 9 a.m. on the following ( Saturday July 1st ) morning.

The meeting was called to order again the next morning at 9.20 a.m. by T. Buck who then called upon Popovich to render his report.

Popovich then continued with his report outlining that the Workers Party is well entrenched in the various branches of the Ukrainian Labor Temple Association and the members of the various branches well disciplined and fairly well educated on the question of the R.L.U.I. and the Third International. He also pointed out that the membership of the Ukrainian section of the Workers' Party consists of the cream of the radical Ukrainian Labor movement.

The next order on the agenda was the reports of the various districts.

Moriarty reported on behalf of district NO 1; he stated that while there are no branches in existence in that district, the movement although has progressed considerable since the Toronto convention. He claimed that considerable pro Workers Party sentiment exists among the miners of Nova Scotia among the miners belonging to District NO 26 of the United Mine Workers of North America. These miners are now affiliated with the existing Labor Party there and it will be very likely that they will come over in to the Workers' Party in a body. The miners, especially the more radical element, ~~are~~ strongly in favor of affiliation with the Red Labor Union International; it is estimated that 75 % of the miners will vote in favor of affiliation with Moscow. MacLaghlan is now working in the interest of Moscow ( R.L.U.I. ) and it is very likely that he will be one of the fraternal delegates going to Moscow to attend the forthcoming convention of the R.L.U.I.

The report on behalf of District NO 2 was very short; Moriarty stated that there are hardly any changes in the movement there since the last convention. Miss Buhay stated that at Montreal the anarchists which are rather strong and ~~and~~ besides the Workers Party, the only real revolutionary organization, are opposing the Workers Party bitterly but she ( Miss Buhay ) was of the opinion that they ( anarchist ) will accomplish very little because the ordinary worker of radical tendencies is opposed to their tactics which she described as terrible.

T. Buck reported on behalf of district NO 3; he stated that in that district there are in existence 46 branches with a total membership of 1947 of which there are 847 paid up members that is members who pay their dues regularly. He also dealt with some individual organization work and ~~and~~ also with the work of the D.E.C. there. He stated that he had been instructed by that D.E.C. to submit to the C.E.C. the decisions arrived at by the various branches in that district, including the D.E.C., in regard to the question of affiliation to the Ontario section of the Canadian Labor Party. The decision of the membership of District NO 3 were in favor of affiliating with the Canadian Labor Party and he was instructed to request the C.E.C. that district NO 3 be permitted to affiliate with the Ontario section of the Canadian Labor Party. Buck then suggested that this matter be taken up under the heading of Party Organization which was then concurred in.

Then Morgridge of Edmonton reported on behalf of district NO 5. His report was a lengthy one consisting of (a) District organizers report and (b) Industrial

Director's report. These reports were supplemented by a number of letters sent to the D.E.C. of that district by P.M. Christophers, R. MacDonald and Joe Stubbs; these communications dealt mainly with the miners situation in the crews nest pass. Generally speaking, Morgridge's report was a detailed report of the entire situation in district NO 5. As far as Edmonton is concerned, the Workers' Party is in absolute control of the labor movement there; at Calgary the Workers Party is suffering by the opposition from side of the Socialist Party and the O.B.U. in particularly. In district 5 there are in existence two english branches ( a ) Edmonton with a membership of 60 and ( b ) Calgary with a membership of 20, three Ukrainian branches, one Italian Branch ( at Edmonton ) and eight Finnish branches. The Workers Party in the mining district is being carried out in the form of an underground movement because the leaders there find it inadvisable to start anything openly as long as the ~~stike~~ strike is on, but as soon as the stike is settled they will come out in the open and line the entire membership of District 18 of the U.M. of N.A. up in the Workers Party. The leading lights of the miners there are the ones that are pushing the Workers Party there; they are Joe Stubbs, P.M. Christophers, R. MacDonald, one named ~~Sam~~ Sherman and a few others. It is expected that Sherman will be elected president of the U.M. of N.A. District 18 at the next election. It was outlined by Morgridge that these few men control the entire miners situation in the district. Nucleis of the W.P. are in existence at all the principal mining centres including Blairmore, Colman Hillcrest and Frank. It is an absolute certainty now that the miners there will not secede from the United ~~M~~ Mine Workers but will remain in it and fight for affiliation with Moscow. It is expected that Miners District 18 will sent a delegate to Moscow for the forthcoming convention of the R.L.U.I.; R. MacDonald is the prospective delegate. Calgary, Morgridge explained, is in need of an good Workers Party propagandist and organizer as the Workers Party situation is not very good there due to the fact that the S.P. of C. has a number of good speakers with whom no local W.P. man can compete. The Industrial Directors report ( compiled by Lakeman of Edmonton ) dealt ~~with~~ mainly with the Edmonton situation chiefly as far as the Trade Union movement is concerned; it was pointed out that the left wing movement there is well under way giving a diagram of the standing of same in the various Trade Unions. Generally speaking, R. Morgridge's reports, which were typewritten indicated that the Workers Party movement is the most advanced or the best organized of all the district. Morgridge also indicated that the W.P. in District 5 will have, at the next Alberta Provincial election, at least ten candidates in the field of whom most of them will run on the U.F. of A. ticket.

Following Morgridge's report, T. Bell reported on behalf of District NO 6. His reports also were Type-written consisting of ( a ) report of the political situation, ( b ) Industrial situation. The political report, wa although very lengthy and very nicely compiled contained no matters of very much interest, it indicated that great apathy prevails among the workers in that district and pointed out all the difficulties which are in the way of the Workers Party there. According to that report the Workers Party there has not progressed in the last way but has become more or less inactive. This is largely due to the fact that members are too busy ~~and~~ fighting each another over personal matters in the party; there are two main factions in the party namely Kavanagh and followers and Wells and followers. In district 6 there are 11 branches in existence with a total membership

of 390 members.- The Industrial report indicated that the Trade union movement was in a state of disorganization and that the average worker does not care very much about joining any union at all; while this is so, it was pointed out in the report, the majority of them are utterly dissatisfied with the present rate of wages and with the present standard of living in general. The only real live organization is the Unemployed Association which is practically in the hands of the Workers Party. Left Wings are operating in various Trade Unions but have accomplished very little ~~due~~ due to the inactivity of the particular union itself. The D.E.C. propose to concentrate in the immediate future on the unemployed association and on that apparent dissatisfaction among the laborers in general. The report also dealt in particular with the Lumber Workers' Organization; this organization too is badly disorganized, no cohesion between the various branches, and organization work is badly needed. Finances however do not permit at the present time to do very much organization work but they hope that the time will come when the Lumber Workers will be again organized strong and effectively. The report of District 6 was, that is from an Workers' Party point of view, not very encouraging.

Then Bartholomew reported on behalf of district NO 4. District NO 4, although very active, is not organize the way it should be, that is there is no centralization lack of cohesion and cooperation between the branches and the C.C.C. and the D.E.C.. It was quite evident that the men at the head of this district are not functioning properly. The District Organizer himself ( Bartholomew ) admitted ~~that~~ that he was not fit to do the work of an District Organizer. He dealt at some length with the industrial face of the Winnipeg situation in particularly with the question of the O.B.U. vers. Workers' Party and its recent activity in that respect. He pointed out that the majority of the Workers' Party member are in the O.B.U. and only a small number are active in the A.F. of L. He also dealt at some length with the election campaign carried on by the Winnipeg C.C.C.; he was of the opinion that the Workers Party candidates have just as good a chance of getting elected as any of the rest of the Labor Candidates have.

Following Bartholomew's report it was moved and seconded that the meeting adjourn until 2 p.m.

The meeting was called to order again at 2.20 p.m. and the first order of business was the " Young Workers League " or the " Youth " movement.

The first man to speak on this matter was Hill of the Finnish section. He submitted a provisional program and platform for consideration. This program was in conformity with the program of some of the Young Communist Leagues already in existence, such as the Young Workers League of America .

Following his address a discussion took place in which most of the delegates participated. The majority of the delegates were of the opinion that the best way to organize the youth would be along the same lines as all the existing youth movements such as the Y.M.C.A. and others similar to that. After some discussion it was decided to take up this question under " Party Organization ".

The next order of business was the report of the General Secretary. Moriarty then gave his report which indicated that per-capita is not being paid as it should be; District #4 he claimed had not turned in any per-capita yet nor has there been a complete report turned in by the Ukrainian Bureau. He also reported on the

matter of Supply and Literature handled by the Head Office. Following his report several of the delegates made certain suggestions including Popovich who thought that the Ukrainian Branches instead of paying their percapita to the Ukrainian Bureau should pay same to the respective C.C.C.; after some discussion on the matter it was decided act according to the rules laid down in the constitution as the C.E.C. has no jurisdiction over the matter, this matter will have to be discussed at the next convention.

The next order on the agenda was " Party Press " It was decided to take up the business policy first.

Trevar Maguire reported on behalf of the " Worker ". He pointed out all the difficulties ( financial ) in connection with publishing the Worker, stating that some means will have to be found to keep the paper going. He maintained that the paper cant be kept on the money that is coming in in the form of subscriptions, so far the Worker had been mainly kept by money donated by the various branches. He suggested that the C.E.C. sent bulletins to the various C.C.C and isolated branches to raise funds whenever they are necessary. After some discussion on the matter it was decided to set a month aside during which an extensive campaign for the paper be held. October was chosen as the " Red " month for the paper at which time every member will be instructed to get one new subscriber, and during which time meetings are to be held for the purpose of raising funds for the paper. Maguire also suggested that the position of the paid business agent for the worker be liquidated and that instead of keeping an business agent sufficient help be given to the General Secretary who could then easily manage the paper also. His recommendation was concurred in.

T. Bell then reported on behalf of the B.C. Federationist. He stated that 10,005 shares out of 20,000 are held by the Workers Party but stated that the B.C. Federationist is to either pass out of existence or to handed over to the printers who are the main creditor of the paper. He stated that negotiations are being carried on with the printers who declared themselves willingly to assume all liabilities if ~~that~~ the paper is handed over to them. Bell pointed out that nearly all the directors of the paper are Workers Party men and in case of liquidating the paper these men will have to appear at court and stand the responsibilities; in reality the W.P. controls two thirds of the shares but the shares are of no value. The directors were in favor of handing over the paper to the printers providing the Workers Party will have control over the Editorial Policy of the paper. Bell also pointed out that it is not known that the W.P. controls the B.C. Fed. After some discussion it was decided to appoint a committee of three to go over the entire situation and submit a report at the next session.

At this juncture Miss Buhay, who during the afternoon was absent addressing a meeting of women at the Bon-Accord Block, came in and it was decided to hear her report on behalf of the Women Bureau.

She stated that she succeeded to organize a Womens Association in Winnipeg; ~~and read the constitution and program of the said association as follows:~~

Name of Organization

The name of the organization shall be the WORKING WOMENS ASSOCIATION OF WINNIPEG.

Aims and Objects.

To protect women of the working class from the evils from which they especially suffer under

Capitalism; to organize them to struggle against the conditions under which they are forced to live and to work for the establishment of the CO-operative Commonwealth.

Programme.

1. To combat the evil effects of unemployment upon women and children by organizing women to protest against these conditions, demanding work or full maintenance. On all relief committees women should be included.
2. To demand equal pay for equal work so that the living conditions of the whole working class should not be lowered.
3. To encourage working women to join Trade Unions for the protection of their own class interests.
4. To secure for union men the co-operation and assistance of their wives in the daily struggle between the working class and their employers by active support during strikes, lockouts, etc.
5. To educate women to political consciousness and to participate intelligently in all ~~class~~ activities of the class struggle.
6. to demand State Protection of Motherhood and the conservation of infant life.
7. To develop along intelligent lines the social activities of the women of the working class so that the social lives of the people might be brightened through the medium of social entertainments.

Miss Buhay stated that this organization will not be officially or directly linked up with the Workers Party but will be controlled by women who are members of the Workers Party and who are also the executive of the said organization. Along these lines, she stated, will the Women Bureau of the Workers Party build up a womens movemnet through-out the country. Besides Winnipeg and Toronto the Women Bureau has acomplished very little.

The report of Miss Buhay was accepted and the policy re organizing the women approved.

The meeting then adjourned until 9.30 p.m. time of adjournment 8 p.m.

The meeting was called to order again at 9.30 and the first order of business was the report of the committee appointed to look into the matter of the B.C. Federationist. The committee recommended that propositio NO 2, namely that the B.C. Fed. be handed over to the printers, be adopted. The meting then after some discussion concurred and it was decided to sent a night letter to Vancouver informing the directors of the decisions of the N.E.C.

Then Spector reported on behalf of the editorial board. He outlined the evolution of the editorial board, the evolution of the paper itself and urged the necessity of having one men in charge of the editorial policy e of the paper. He spoke for about one hour admitting some of the mistakes that were made and illustrated how the papers is being improved upon gradually under the prevailing unfavorable conditions.

Following his address several of the delegates spoke in an rather constructive manner and it was then dedcked to appoint Spector sole Editor of the paper.

The meeting then adjourned until Monday ( July 3) morning.

On the following morning ( Sunday morning ) most of the delegates attented the conference of the Famine Rekief Committee and in the course of the afternoon they all attented the Picnik of the Workers Party held at one of the parks in+the outskirts of the city.

On Monday the entire session was taken up, under the heading of Party Organization, with the request of the District NO 3 to be permitted to affiliate 000032

with the Ontario Section of the Canadian Labor Party.

The Eastern delegates supported the request and the western delegates opposed it. In this discussion all the delegates present participated and it looked for a while a split in the party was inevitable. The discussion centered around the question of tactics. The Western delegates maintained that nothing could be gained by affiliating with the C.L.P. on the contrary the Workers Party would lose the identity as a Communist movement. The Eastern delegates although maintained that this would not be the case and pointed out the ~~actual~~ material ~~effect~~ effect of that step. It was also pointed out that "Charlie", in a telegram of only a few days prior to the meeting, consented to that proposition. It was also pointed out that it was in absolute conformity with the tactics prescribed by the Executive of the Third International. This same policy is being adopted also in England. The Eastern Delegates pointed out that by affiliating with the C.L.P. the Workers Party has a better chance of reaching the organized ~~masses~~ masses in Ontario and also a better chance of exposing the so-called reactionary labor leaders.

When the vote was put at 7.p.m. all the C.E.C. members voted in favor of affiliation with the C.L.P. under one condition namely that publication of this resolution be withheld until after the ~~Winnipeg~~ Manitoba Provincial Election.

The meeting then adjourned until the next morning; a number of the delegates were detailed to speak at election meetings at night. A committee was also elected to meet in the course of the evening to hear the grievances of a few of the members of the English branch.

The meeting was resumed again on the next morning under the heading of Party Organization.

It was decided that T. Buck shall stay in the West for about two months, T. Bell to stay at Winnipeg until Buck has returned from Edmonton and Calgary, Bartholomew to go East to travel as Workers Party propagandist and take in the Labor Colleges in the East, and Trevar Maguire to go East immediately.

The touring of speakers in the various districts was also discussed and it was decided that the matter be referred to the various districts.

Then Jack Johnson of Chicago addressed the meeting in the interest of the "National Trade Union Committee for Russian Famine Relief".

He pointed out that this organization is nothing but an offspring of the American Friends of Soviet Russia. It had been formed for the purpose of reaching the more conservative minded trade unions, unions which could not be reached through the Friends of Soviet Russia. This committee, he stated, was formed as a result of the decision arrived at at the last convention of the Workers Party of America.

The aims and purpose of this committee, he explained are as follows:

1. To get financial support for the Famine Stricken
2. To give Russian affairs and the Famine publicity.
3. Circulate sympathetic stories about Russia among the conservative Trade Unions in an well organized manner.

Following his address several of the delegates asked questions but no action was taken due to the fact that the Canadian Famine Relief Committee for the Drought Stricken in Soviet Russia had only two days previously affiliated with the Canadian Friends of Soviet Russia.

The meeting then adjourned until 2 p.m.

The first order of business during the afternoon session was "Party organization", the matter of how to organize the youth. It was moved and seconded that

the provisional platform submitted by Hill at one of the previous sessions be adopted. A long discussion followed with the result that it was finally decided that the Administrative Council appoint a Young Workers Bureau, and that this Bureau appoint District Organizers and that the provisional platform as submitted by Hill be worked out to be applicable to the Canadian Situation. This Young Workers organization so organized will then organize different clubs etc. ~~which will offer some attraction~~ which will offer some attraction to the young workers and thereby getting them together which give them a opportunity to inject carefully the right kind of propaganda.

Then the question of how to organize the Migratory Workers came up for discussion and after having discussed the matter for some considerable length of time no one could offer a satisfactory solution to the problem; in discussing this question several of the western delegates reviewed the industrial situation in the West and it was found that under the present circumstances the idea of organizing the Migratory Workers will have to be abandoned, that is to say organizing them industrially.

The meeting adjourned then until 10 a.m. the next morning.

Wednesday morning (July 5th) the meeting was called to order again at 10 O'clock.

During the entire morning and afternoon session the Situation ( industrial ) of Winnipeg being discussed; special attention was paid to the question of the One Big Union in Winnipeg and outside points.

After hearing all the discussion on the matter a resolution was passed to the effect that the Meeting goes on record affirming the policy embodied in the resolution re Labor Unions which was passed at the Toronto convention and that Workers Party members should join if possible the A.F.L.

Another resolution was passed to the effect that Left Wings operating within the O.B.U. units of which they think a split could be accomplished within a reasonable length of time should continue to remain in the O.B.U. for only that purpose only.

Another resolution was passed which was to the effect that the District Executive Of District 4 be instructed to make a clear survey of the entire situation concerning the O.B.U. and submit a full report to the A.C. and to submit also suggestions as to how to deal with the matter.

Then the meeting adjourned; during the evening all the delegates attended W.Z.Fosters meeting at the Board of Trade Building.

The delegates met again Thursday morning at the Ukrainian Labor Temple for the purpose of hearing W.Z. Foster.

Whilst at Winnipeg every one of the delegates addressed some election meeting; speeches were delivered at the Market Square, Victoria Park, during Sunday afternoon at the picnic and other places.

The above covers in brief the proceedings of the entire meeting of the C.E.C.

In conclusion I may state that all the sessions were held at the Ukrainian Labor Temple.

Most of the outside delegates left Winnipeg on Thursday evening, July 6th; Hill of the Finnish sect went to Port Arthur, from there he will visit one or more places on his way to Toronto; Bell remained at Winnipeg, Buck left for Edmonton and Calgary, Spector and Moriarty left direct for Toronto, Miss Buhay will remain at Winnipeg until the election day, Tether, Morgridge, Bruce, Mill, Esselwein, and Barron left for their home towns.

I beg to report having learned [redacted] the following particulars of the Central Executive Committee meeting held in Winnipeg. From Toronto W. Moriarty, M. Spector, T. Buck & A. T. Hill were present. Others in attendance were Bartholomew, Mogridge, Bruce & T. J. Bell: the latter secured credentials from Vancouver.

The C. E. C. decided that District Executive Committees should apply for affiliation with the Canadian Labor Party in all districts where the Canadian Labor Party is already organized. This matter was brought to a head by the action of the Ontario District Committee in recommending affiliation. The C. E. C. feared that when the party becomes more numerous and powerful then the C. L. P. will not be so willing to allow the affiliation. The western delegates were not favourable at first to this suggestion.

Another decision of importance was concerning the policy of the party towards the O. B. U. Hitherto the policy, at least outwardly, was to work within the O. B. U. to foster the spirit of unity with the view of ultimately bringing the O. B. U. back to the American Federation of Labor. The attacks on the party by Russell and Mace of Winnipeg have brought about a change of policy. In future in those units of the O. B. U. where the party has influence, will be urged to affiliate at once with the A. F. L. and break up their O. B. U. organization. In other words the general policy is to break up the O.B.U. as soon as possible. This reflects to some extent the feeling of security and influence which the C. E. C. has in some O.B.U. locals. C. E. Scott, it will be recollected, had arranged with certain O.B.U. leaders that they should work for the party, while still in O.B.U. pay. The general opinion is that the O. B. U. is fast approaching general liquidation, and that when the present base-ball competition in the O. B. U. Bulletin is finished, then the only financial support of the organization will be gone. The C. E. C. feel that the influence of the O.B.U. does not extend beyond Winnipeg and that even there the influence is on the wane.

Arrangments were made that T. Buck of Toronto should remain in the west for two months to carry on work as Industrial Organizer. He will concentrate on the Trade Union Educational League work, and endeavour to form groups of same.

Another arrangement was that T. J. Bell & B. Buhay should remain at Winnipeg to assist in the provincial election campaign.

[REDACTED] states that the meeting was on the whole a successful one. The former jealousy seems to have dis-appeared and the old suspicions of east against west and vice-versa are dead and gone. There was some tendency on the part of Bartholomew to attack the editor of The Worker on his policy, etc. This was avoided by Spector's report on the paper, which satisfied all present.

In summing up the situation in the west [REDACTED] states "they have a better rank and file movement, but lack organizing ability".

I have not yet obtained definite information re. the question of fraternal delegates to the Comintern, but will report as soon as I am certain.
