DEAN ALLISON (MP - Niagara West-Glanbrook): Good afternoon everyone, and welcome. I would like to extend that warm welcome to all the hardworking entrepreneurs and small business owners who are here with us today. Small businesses are the foundation of any local...strong local economy and an integral part in keeping our community strong and prosperous. The Niagara region especially has some outstanding small businesses that stand out amongst their larger competitors. Your great creativity and dedication to your businesses and the local community are to be commended.

It's right here in Niagara that companies are applying their knowledge and talents to solving some of the most pressing problems of the 21<sup>st</sup> century. With over 26,000 small to medium-sized enterprises in the Niagara region, there are many innovative companies that stand out. I think of in Fenwick, *Accipiter Radar Technologies* is on the cutting edge of surveillance systems globally. I think of *Moyer's Farms*. In 1799 it was started and spent a little bit of time on "Dragon's Den" trying to raise some money recently for their candy apples with Paul Moyer. And so when I think of small and medium-sized businesses, I think strength, prosperity, and growth. Small business is the foundation of the community here in Niagara and all of Canada. So I want to thank you for all your hard work and dedication. Now I have the pleasure of introducing my colleague and my friend, the Member of Parliament for St. Catharines, Mr. Rick Dykstra to the stage.

RICK DYKSTRA (MP - St. Catharines): Well, thank you Dean for that kind introduction. You know there's a really good local Member of Parliament when regardless of national announcements or otherwise, he's here bragging about his riding, so that's the Dean Allison I know.

I certainly want to thank everyone for being here today. It's my great pleasure to introduce a man who, after serving as the leader of our country for going on nine years, really needs no introduction. And going on nine years, we're actually just two days short of our election from 2006, so he was here three times during that campaign. House of Commons. Two colleagues who have been around a long time, now very experienced and highly respected by their colleagues from across the country. You're really lucky to have them here so let's give them one more big hand.

I also want to welcome Laura Jones and our other friends who are here today from the Canadian Federation of Independent Business who are once again this year marking Red Tape Awareness Week. Clearing the clutter of regulations that can hamper hardworking Canadian businesses is something that our government supports wholeheartedly.

Now that's what brings me here today. Our government has long understood the importance of Canada's small businesses. From the coffee shop on the way to work, to the garage where you get your car serviced, from the bakery that's been a local institution for decades, to the new start-up that gave your teenager a summer job. Taken individually, these small businesses are the fabric of our communities. Taken as a whole, however, take them as a whole and a dramatically different picture emerges.

These businesses also employ almost eight million Canadians—that's almost 70% of the private sector workforce. And they're responsible for creating four out of every five private sector jobs. They are—small business certainly is—the fabric of our communities. But when I look at these numbers, another metaphor comes to mind.

That's why we've made it a priority to make life easier for the men and women who run small businesses. Not that running your own small business is ever going to be easy, as I should say as Laureen and I—my wife and I--both know from personal experience since we both ran small businesses before I got back into politics, and I know many entrepreneurs who will joke that running their own small business is the most rewarding minimum wage job they've ever had.

But, seriously, it's because we understand the challenge of running a small business that our government has taken the actions we have to support small business.

Our government will always choose jobs and growth over taxes and red tape. And last year alone, the tax relief that we had brought in for small business amounted to more than two billion dollars. That's in one year alone. Our support... (applause begins) ... Go ahead.

Our support for enterprising Canadians is also why we've encourage more investment in small business by increasing the allowable lifetime capital gains allowance, and indexing the new limit to inflation. It's also of course why Canada now leads the G7 in the lowest overall tax rate on new business investment. In fact, according to KPMG, compared to the rest of the G7, no country's total tax costs are as friendly to business as are Canada's.

And, of course, keeping these taxes down, friends, keeping these taxes down over the long term is one of the reasons we've made it a priority to return our budget to balance, something which we will do as scheduled this year.
