

I. VISIT OF SIR KENNETH STRONG  
DIRECTOR-GENERAL OF INTELLIGENCE  
BRITISH MINISTRY OF DEFENCE

(CONFIDENTIAL)

1. The Chairman welcomed Sir Kenneth Strong to Ottawa and the Canadian intelligence community. He noted Sir Kenneth's new status and outlined areas on which Sir Kenneth might speak to the Committee.

2. Sir Kenneth began by expressing his appreciation for the invitation to make the visit which gave him an opportunity to meet old friends and gain new thoughts. He went on to suggest that he might first discuss the changes in the organization of British defence intelligence.

3. Sir Kenneth stated that the reorganization of the intelligence structure in the British MOD benefited from the influence of Admiral Mountbatten who understood and used intelligence, and that the status of intelligence had been enhanced. The unification of intelligence agencies could have been accomplished in a number of ways but the solution adopted preserved Service interests and the interests of economic and scientific and technical intelligence agencies.

4. Sir Kenneth noted the seniority of the Service deputy head of intelligence and his status as Deputy Chief of the Defence Staff. He indicated that intelligence would stand closer to the heads of the Services and that more junior intelligence workers would be kept more aware, than had been the case in the past, of the thinking of Service chiefs. He went on to say that intelligence was now more readily available to operations at all levels, has acquired a new authority and has begun to receive more attention, material and demands for intelligence product. Intelligence was more closely identified with world events and the government's needs, though many service aspects, and particularly the channel between individual intelligence directors and their Service chiefs, had been preserved.

5. The Director-General then described how scientific and technical intelligence had been combined into one agency. He stated that the Director of Scientific and Technical Intelligence has been made more independent and that his effectiveness has been enhanced by membership in the Scientific Research Committee where he both advises on intelligence and stays in touch with western scientific developments. The Director also has links with operational research which has been concentrated in the Ministry of Defence.

6. Two new entities had been established in the intelligence organization, a Director of Procurement and Administration and a Director of Defence Intelligence Coordination. The former will be concerned with establishing

a measure of control over intelligence sources, to ensure that the acquisition of intelligence reflects the requirements of users. The latter will coordinate intelligence produced by the various Service, economic and scientific elements and might be regarded as a chief of staff.

7. Sir Kenneth explained the contact that the Director-General has with the Chief of the Defence Staff and the Secretary of State for Defence as well as other senior officials. He indicated that the Secretary of the Cabinet had the right to levy non-defence intelligence tasks on the defence intelligence organization. He added that, in view of the existence of the service deputy, the Director-General dealt with the CDS only on broad questions. One of the benefits of the new organization was that the civilian Director-General provided continuity and, from his position of knowledge of the subject, could deal with numerous minor administrative and other chores, thus relieving the service deputy of concern over such details and allowing him to concentrate on intelligence during his comparatively short period in the field.

8. In response to questions, Sir Kenneth indicated that at the moment, security remains a separate field but is under study. He would not want intelligence to become involved with security but appreciated that intelligence has interests in security and would require that these interests be safeguarded. Sir Kenneth stated that he was not in favour of careers in intelligence for service officers and preferred service officers to come into intelligence from normal operational appointments. Civilians on the other hand, would be regarded as career intelligence workers and would be acquired through careful departmental selection. Service attaches have been attached to the central organization but continue to retain a link with their parent service as well.

9. Sir Kenneth included his talk with a brief survey of the situation and the intelligence problem in various parts of the world.

10. The Chairman then thanked Sir Kenneth for his talk and extended an invitation to return in the future.

Dear Jim,

The announcement was made on Friday that I have been appointed to succeed Sir John Maud as Ambassador to South Africa and High Commissioner to the three Protectorates. I would have wished to have been able to write to you and tell you that this was happening before the announcement was actually made, but in fact I had no opportunity to do so for which I hope you will forgive me. I shall not actually be leaving until the end of April or beginning of May though I may have to give up my J.I.C. duties towards the end of March.

My successor as Chairman will be Sir Bernard Burrows who since the end of 1958 has been Ambassador at Ankara. He has served in his earlier years for a considerable time in Cairo and, after a spell in the Foreign Office, was Counsellor in Washington from 1950 to 1953. He then spent over 5 years as Political Resident in the Persian Gulf before his appointment to Ankara. He will do the job of Chairman of the J.I.C. quite admirably.

I myself, of course, am very sad to go though I am looking forward to my new job immensely. The relationship between your community and ours is quite remarkable and I have an enormous amount to be thankful for in the support and friendship which I have always found from your side of the Atlantic. I do hope that you will be paying us a visit in the not too distant future and in any case before I have to go.

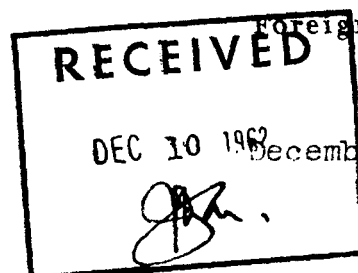

Dear Jim,

The announcement was made on Friday that I have been appointed to succeed Sir John Maud as Ambassador to South Africa and High Commissioner to the three Protectorates. I would have wished to have been able to write to you and tell you that this was happening before the announcement was actually made, but in fact I had no opportunity to do so for which I hope you will forgive me. I shall not actually be leaving until the end of April or beginning of May though I may have to give up my J.I.C. duties towards the end of March.

My successor as Chairman will be Sir Bernard Burrows who since the end of 1958 has been Ambassador at Ankara. He has served in his earlier years for a considerable time in Cairo and, after a spell in the Foreign Office, was Counsellor in Washington from 1950 to 1953. He then spent over 5 years as Political Resident in the Persian Gulf before his appointment to Ankara. He will do the job of Chairman of the J.I.C. quite admirably.

I myself, of course, am very sad to go though I am looking forward to my new job immensely. The relationship between your community and ours is quite remarkable and I have an enormous amount to be thankful for in the support and friendship which I have always found from your side of the Atlantic. I do hope that you will be paying us a visit in the not too distant future and in any case before I have to go.



In a telegram dated April 30 of which we were given a copy by the Foreign Office, the United Kingdom Ambassador in Moscow made the same general comments about the Baku speech as those made by Mr. Drinkall in the Foreign Office and reported to you in paragraph 5 of our telegram under reference: it was a tough speech but not a particularly threatening one by Khrushchov's standards. It was more like a restatement of a strong bargaining position before the Summit meeting, partly provoked by American speeches and intended also to counteract any tendencies to proceed at the Summit as if Berlin could be safely shelved. The Ambassador noted with interest that nothing had been said in Moscow about General de Gaulle's views on this point: Soviet criticism of the Western attitude was concentrated almost entirely on the United States.

2. On balance, the Ambassador thought that the Baku speech did not outweigh the other indications that Khrushchov would accept an interim arrangement for Berlin, for as short a term as he can get and coupled with some provision for all-German discussions. The speech, however, made it seem more difficult for Khrushchov to acquiesce in a completely negative result from the Summit meeting as regards Berlin. The Soviet leader might be able to mask this if there was notable progress about nuclear tests and disarmament. But in this respect, the Soviet Government seemed at present bent solely on extracting the maximum propaganda advantage and the Ambassador saw no sign of the Russians taking any other line at the Summit.

3. The United Kingdom Ambassador concluded that Khrushchov thus seemed to be making more acute the dilemma which he had himself created: Khrushchov did not want a crisis or even a setback in the détente, nor did he want to jeopardize President Eisenhower's visit. Both of these constituted good cards for the West against the Soviet advantage of geography. The Ambassador thought that a good deal might depend on President Eisenhower's willingness to exact a price for his visit.

During the last week of January, a CIA team led by Mr. Cooley of the Office of National Estimates of CIA paid its annual visit to London. As is usual on these occasions the basis for the conference with U.K. officials was the annual National Intelligence Estimate on Sino-Soviet Capabilities and Intentions. I was invited to attend most of these meetings and the three appendices attached to this letter contain an outline of some of the highlights of the discussions.

2. The agenda of the Conference was as follows:

I. Soviet Domestic Policy. I did not attend.

II. Soviet External Policy. See Appendix A.

III. Sino-Soviet Relations. See Appendix B.

IV. Bloc Policy Towards Under-Developed Countries. I did not attend.

Discussion with the U.K. JIC of JIC Paper 10(2) of 1959. You will be receiving copies of this Paper through Earncliffe. The U.S. team was in general agreement with it.

VI. Discussion of U.K. JIC Paper 59(69) Final of October 29/59 entitled "Possibility of Hostilities Short of Global War up to 1970". You received copies of this paper last November. For discussion see Appendix C.

There were no great differences between the two sides during these discussions. Of most interest to the Department of External Affairs were the remarks about Soviet policy towards Berlin and Germany (Appendix A) and Sino-Soviet Bloc Relations (Appendix B), and of particular interest to the JIC was the discussion of limited war during a period of mutual nuclear deterrence (Appendix C).

APPENDIX A

SOVIET EXTERNAL POLICY

MEETING WITH CIA TEAM  
U.K. FOREIGN OFFICE JANUARY 26, 1960

The leading part in this discussion was taken by Mr. Brimelow, Head of the Northern Department of the Foreign Office. The two subjects of greatest interest during this meeting were the Soviet View of the Balance of Forces between East and West and Soviet Policy towards Berlin and Western Germany.

I The Soviet View of the Balance of Forces

Brimelow pointed out that there was some ambiguity in Khrushchev's public and private statements as to whether or not he realized that the world was entering a period in which the two Great Powers found themselves in a position of mutual nuclear deterrence. Brimelow thought it likely that Khrushchev would be aware of the dangers of global war and of the enormous destructive capacity of U.S. retaliatory power. But at the same time this new balance of forces was bound to increase the confidence of the Soviet leader and to make him aware of his own power both to carry out and therefore to threaten all-out nuclear attack. The U.K. Foreign Office believes that Khrushchev does not want war. On the other hand he undoubtedly believes in the indestructibility of "Communism" and in "historical evolution" towards a world of Communist-ruled nation states. The problem, therefore, for him and Soviet foreign policy is to try to produce conditions in which the world will evolve towards this end.

At present Soviet policy was designed to create an international climate of co-existence between governments in order to reduce as much as possible the danger of global nuclear war while permitting the Soviet Union to pursue its objectives by such means as subversion, economic penetration and the process of negotiation in itself. Khrushchev might well hope that because of the new balance of forces and the lessening of international tension the West might be persuaded to itself draw the consequences of this balance and be more amenable from the Soviet point of view in negotiations. He would probably have been encouraged in this view over the last year by the evident differences in Western policy towards the Soviet Union.

CIA was in general agreement with this line but were inclined to think that Khrushchev would view the new balance of forces in more dramatic terms. CIA suggested that under the umbrella of mutual nuclear deterrence Khrushchev might well consider that there was room for a much more active policy particularly in areas such as Berlin where he would consider himself to be in a position of strength. He might well argue, particularly in the light of recent experience, that over such problems as Berlin the bluff of the West could well be called as he

might estimate that in the last resort the U.K. and perhaps France would try to restrain the U.S. from adopting too tough an attitude. CIA therefore were inclined to emphasize the dangers that might result from this sort of assessment by Khrushchev and suggested that in Berlin the West for the first time was being asked to draw the consequences of the new Soviet view of the balance of forces.

## II Berlin and West Germany

Brimelow suggested that Khrushchev in his speech of November 1958 bearing in mind the changing balance of forces and the strong Soviet position in Berlin, might well have thought that he was showing some regard for the Western position and that there was some possibility that the West could be brought to negotiate on Soviet terms. When the Geneva talks failed Khrushchev then changed the international climate by visiting the U.S. but at the same time did not alter the basic Soviet position with regard to Berlin with the hope that he would achieve his objectives at a Summit meeting.

Khrushchev probably would prefer an interim arrangement on Soviet terms in Berlin to a breakdown of negotiations and a separate peace treaty with East Germany. If an interim arrangement was negotiated on Soviet terms it probably would be honoured. However to the Soviet Union the status of "free city" would mean the gradual incorporation of Berlin into the German Democratic Republic, while the removal of "organs of Western subversion" would in effect mean Communist control of press, radio and political parties. If there was no agreement on Berlin, Brimelow was certain that the Soviet Union would return to its pressure tactics and sign a separate peace treaty with the DDR. The Soviet authorities would hand over control of access to Berlin to the East Germans who would be instructed at first to be most correct but it could be expected that there would be a gradual build-up of pressure on the Western Powers to deal with senior DDR officials and eventually the DDR Government on matters of access to Berlin.

CIA generally agreed with these views but pointed out that Berlin was in fact a lever used by the Soviet Union in order to achieve its objectives in West Germany as well as to obtain Western recognition of the East German regime. The Soviet Union probably believes that by negotiating on Berlin and giving the impression of being willing to negotiate on the whole of Germany it might be able to persuade the West Germans (particularly a post-Adenauer Government) that there was a chance to negotiate the reunification of Germany in return for leaving NATO. In other words, the U.S. sees the Berlin issue as a Soviet lever to change the situation in West Germany and detach her from NATO and as a test for the unity of the Western Powers. CIA were of the opinion that as far as tactics were concerned over the Berlin issue Khrushchev may be in somewhat of a quandary as he would wish to apply sufficient pressure on the Western Powers in order to bring about a solution satisfactory to the Soviet Union but not so much pressure as to unite Western Europe again in the face of a new Soviet menace. CIA believes that

Khrushchev has been impressed by the suggestion that Stalin was the main architect of NATO.

The U.S. team were doubtful about Brimelow's suggestion that Khrushchev once the Geneva talks failed had changed the international climate by visiting the U.S. The Americans were more inclined to believe that Khrushchev took advantage of the change in the U.S. position (it was the U.S. Government that invited Khrushchev) which gave him an out insofar as the ultimatum aspect of the Berlin issue was concerned without his having to make any vital concessions on Berlin itself.

There was a brief discussion of the reported statement by Khrushchev to the West German Ambassador concerning the withdrawal of Soviet forces from Hungary and Poland as well as reductions and eventual withdrawal from East Germany. It was generally agreed that while accounts of this discussion were by no means clear it was probably one of the many pre-Summit gambits that could be expected from Mr. Khrushchev in the next few months and could even presage a Soviet proposal to the Western Powers of some form of European regional disarmament agreement, perhaps a variation of the Rapacki Plan. This proposal might even go some way to meet Western views with regard to inspection and control in a specified European zone provided Soviet territory itself was not involved.

SINO-SOVIET RELATIONS

MEETING WITH CIA TEAM  
U.K. FOREIGN OFFICE JANUARY 27, 1960

The discussion last year emphasized the close relations between the two countries and the likelihood, since it was in the interest of both parties, that the alliance would continue for a good many years to come. This year it was again agreed that there was no likelihood of a break in the Sino-Soviet alliance at least in the next five years and the usual economic and military reasons were cited, but rather more attention was paid to the differences that had become evident between China and the Soviet Union in recent months.

In ideological matters it was agreed that the Soviet Union was probably not too concerned by Chinese deviations as long as they were made in response to purely Chinese circumstances. However in cases (i.e. the communes) where China claimed that her solution to a particular problem was a new and great step forward to the ultimate goal of 'communism' then the Soviet Union was bound to object. In other words, the Soviet Union would insist on primacy in all matters of ideological authority within the Bloc, though in Poland as well as China she appeared willing to countenance national solutions to specific problems.

In economic matters it was expected that Soviet aid would continue at about the same level. It was not thought that the Soviet Union would be worried by the emergence of China as an industrial power, at the end of the next decade as the Chinese economy even by 1975 would still be in approximately the same relative state to the Soviet economy as it is today. It was agreed that Chinese population pressure would not present difficulties for the Soviet Union at least for many years to come as there were still large areas of China to be fully settled. It was also thought that as long as Chinese agricultural production kept ahead of population growth as at present, there would be no economic pressure from China to expand into the Soviet Far East.

Last year it was thought that the problem of whether or not the Chinese should be given nuclear weapons was bound to be a matter of concern to the Soviet Union. This year it was generally agreed that the Soviet Union so far had shown no signs of such concern and it was possible that she might have given China some rockets and perhaps even tactical nuclear weapons though she would be most likely to have kept control of the nuclear warheads. It was also expected that China would continue with her own nuclear programme which could produce a nuclear capability some time in the next five to ten years.

Mr. Dalton, the Head of the Far East Department of the Foreign Office, suggested that the West was too inclined to be impressed by the various advantages which would keep the Sino-Soviet alliance from falling apart in

the foreseeable future. He thought that it was necessary to take account of the "Chineseness" of the Chinese, by which he meant their arrogance, xenophobia and obscurantism, which made China a very difficult ally for the Soviet Union to live with. Dalton thought that both the Sino-Indian border dispute and the Sino-Indonesian dispute were good examples of China following a "national" policy no matter the embarrassment caused to the Soviet Union. It was agreed that these aspects of the Chinese character made her a difficult ally but in themselves were not likely to break up the alliance though when taken with other divergencies that could arise in the future there would well be a steady deterioration in the alliance.

The argument was advanced that the neutral position taken by the Soviet Union over the Sino-Indian border dispute, Khrushchev's forthcoming visit to Indonesia at a time of strained Sino-Indonesian relations, and the continuing tough line taken by the Chinese towards Taiwan and the U.S. at a time when Khrushchev is promoting the "spirit of Camp David" were all signs of Sino-Soviet differences over policy in South East Asia. The American team said that there was one school of thought in Washington that argued that this was all part of a long range Soviet plan to contain the Chinese in South East Asia. It was generally agreed, however, that all these apparent divergencies should be looked at in the light of Chinese and Soviet national policies in South East Asia at a given period in time.

In India, for instance, the Soviet Union at least in the short term wanted a neutral and alliance-free India and had made considerable financial investment in India to ensure this. China, because of her geographical position and the trouble in Tibet, had exacerbated the frontier dispute with India and while it undoubtedly caused some embarrassment to the Soviet Union, Chinese policy apart from the dispute itself was also to maintain friendly relations with a neutral and alliance-free India. The Indonesian dispute was provoked by the Indonesian Government and the Chinese Government was involved because of the displacement of large numbers of the Chinese community in Indonesia. However, both Chinese and Soviet objectives in Indonesia were similar for as Indonesia might well be the next large Communist state in South East Asia, both China and the Soviet Union had an interest in keeping the present Indonesian Government neutralist and alliance-free while aiding the Indonesian Communist Party. The present Soviet policy of improving relations with the U.S. could well revert to a more hostile policy if no agreement is reached at the Summit, in which case Chinese and Soviet policy would again be in line. In any case, the Soviet Union probably recognizes that China has legitimate claims to Taiwan and that it is consistent for her to maintain these claims even during a period of relative detente. It would therefore be unwise to regard the apparent Sino-Soviet divergence in policy towards the U.S. at the moment as a real or lasting one.

The U.S. team stated that there was growing concern in Washington about the threat that would be posed to the West in the coming years by an alliance of Soviet science and industry with Chinese manpower. For this reason there was now a tendency in Washington to integrate Soviet and Chinese experts, to encourage Russian and Chinese

language experts to learn each others language. There was also increasing coordination at the planning and assessment level in CIA and the Pentagon.

APPENDIX C

POSSIBILITY OF HOSTILITIES SHORT OF GLOBAL WAR UP TO 1970  
U.K. JIC (59) 69 OF OCTOBER 29, 1959

MEETING WITH CIA TEAM  
U.K. MINISTRY OF DEFENCE JANUARY 29, 1960

The meeting was chaired by the Honourable Peter Ramsbotham, Chief of the Planning Section of the Permanent Under Secretary's Department of the Foreign Office. It was agreed by both sides that the most difficult problem faced by military planners in the period of mutual nuclear deterrence was how to assess correctly the type of hostilities in which Western countries might be involved.

It was first necessary to assess the likelihood of hostilities short of global war. The U.K. (paragraphs 12-14 U.K. Paper) were relatively optimistic that the Soviet Union would "refrain from undertaking hostilities which might involve it in critical situations carrying the risk of hostilities with the West". This would not preclude the Soviet Union from feeling free to take advantage of revolutionary or guerilla type situations (i.e. Laos or Iraq). However if a situation arose where the Soviet Union might think that they could intervene with overt military support (i.e. Korea) without provoking a nuclear response the U.K. does not think that the Soviet Union would in fact intervene.

The U.S. had different conclusions. CIA argued that in a period of mutual deterrence the Soviet Union might well be willing to take more risks by concluding that in a situation where there is a stalemate (i.e. Berlin) the West would not be willing to risk all-out nuclear war. The Soviet Union might then decide that since the West had "atomized" its forces and therefore had a limited capacity to intervene with conventional weapons (whereas the Soviet Union had nuclear and conventional forces and could intervene at all levels) the Soviet Union could call Western bluff with relative safety on the assumption that the West would not be willing to risk global war by committing its nuclear forces. CIA pointed out that by this sort of reasoning the Soviet Union might well misjudge a Western response to a given situation and this could start both sides on a series of moves and counter-moves (the fashionable U.S. term is "escalation") leading to nuclear war. A further danger during this period would be in a revolutionary or guerrilla situation where the Soviet Union might decide it could intervene covertly to obtain its objectives without risking similar Western intervention, and where the West might decide in order to counter Soviet intervention that it also must intervene but could only do so by overt military means. The U.S. landing in the Lebanon was an example of the West responding by an overt military act to a revolutionary situation. Here again CIA argued the danger of "escalation" to nuclear war was high.

The U.K. response to these arguments was that they were over-subtle and that in a period of mutual deterrence Khrushchev would take less risks because he

believes that in the long run Communist objectives will in any case be achieved whereas in the short run he is committed to a policy of detente and is also impressed by the destructive power of the Strategic Air Command. Both sides agreed, however, that the best way to cut down the risks of Soviet miscalculation is for the West to build up conventional (fire-brigade) forces in order to deter Soviet intervention at all levels. The U.S. team pointed out that we were in such a transitional stage that their arguments might well not apply by next year. For instance if Khrushchev meant what he said and was now going to depend entirely on his nuclear deterrent alone and run down his conventional forces (neither the U.K. nor U.S. believes that he will in fact do so) the Soviet Union would itself in a few years time be unable to intervene militarily at all levels as at present.

Both sides agreed that during this same period the Chinese would be less impressed by the danger of nuclear war and more willing to run risks. However it was likely that the Soviet Union would act as a restraining influence and a Chinese nuclear capability was not expected during the period. The U.S. team pointed out that insofar as the Taiwan Strait itself was concerned this was one area where because of the stretch of water between the two forces tactical nuclear weapons could be used to destroy enemy forces without the necessity of using these weapons elsewhere on the mainland and that the conflict might therefore be limited. This of course would only apply until such time as the Chinese acquired a nuclear capability and the means to deliver it.

DISCUSSIONS ABOUT THE CHINESE ACHIEVEMENT OF A NUCLEAR CAPABILITY WITHIN THE NEXT TEN YEARS WERE RATHER CONFUSED WITH DIFFERENT VIEWS BEING EXPRESSED AND NO REPEAT NO FIRM CONCLUSION BEING REACHED EXCEPT THAT THE CHINESE WOULD NOT REPEAT NOT ACHIEVE AN OPERATIONAL NUCLEAR WEAPON CAPABLE OF BEING DELIVERED. THIS IS WHAT THE LAST PARAGRAPH OF APPENDIX C IS SUPPOSED TO REFLECT.

2. ON THE OTHER HAND PARAGRAPH 4 OF APPENDIX B REFERS TO THE ACHIEVEMENT OF THE NECESSARY NUCLEAR KNOW-HOW. DIVERGENT OPINIONS WERE EXPRESSED AS TO WHETHER THE CHINESE MIGHT GO ON TO EXPLODE A NUCLEAR DEVICE (AS THE FRENCH HAVE LAST WEEKEND) IN ORDER TO DEMONSTRATE AND PUBLICIZE THEIR PROGRESS OR WHETHER THEY WOULD SIMPLY CLAIM NUCLEAR POWER STATUS I.E. WITHOUT TESTING IF TESTING PROVED INADVIEABLE IN THE INTERNATIONAL SITUATION THAT WOULD PREVAIL AT THE TIME. FOR INSTANCE TESTING COULD ADVERSELY AFFECT THE CONDUCT OF SOVIET POLICY OR MORE SPECIFICALLY CHINA'S RELATIONS WITH RUSSIA AND PRECIPITATE OR REVEAL A CONFLICT WHICH WOULD BE IN THE INTEREST OF NEITHER POWER.



22. The representative of each Intelligence Directorate comes to the meeting with a prepared paper which is used as a basis for the preparation of the draft Weekly Intelligence Review. They do not work from a common draft as is the practice in the Canadian JIR.

23. Two reports are produced at the Heads of Section meeting:

- (a) the Grey Book which receives wide distribution with a special supplement; and
- (b) the Red Book which is compiled from all sources and which, on being approved by the JIC (UK) is given a very limited distribution.

The draft Weekly Survey of Intelligence is sent to the JIC (Canada) and the CIA by wire. At the Thursday meeting of the JIC (UK) the Draft Survey is approved. The CIA is able to comment in detail on the Weekly Survey in time for the CIA representative to make a useful contribution at the JIC (UK) meetings. The JICLO(L) however, does not receive the Canadian WIR until about one half hour before the meeting. This enables him to make a useful contribution if a difference of view exists on any particular item but makes it difficult for him to form a considered view because of the short time available.

24. Mr. Black informed the Committee that the Canadian WIR is not distributed throughout the UK intelligence community and is only read in the JIC Secretariat. He stated that it should be understood clearly by Canadian intelligence authorities that the only way for Canadian views on matters of current intelligence to reach higher level in the UK is for the JICLO(L) to present this view at the weekly meeting of the JIC (UK). The Canadian views may then be reflected in the Red Book. He proposed that the draft Canadian WIR which is prepared at the Tuesday meeting should be sent to him by wire to enable him to prepare a considered Canadian position in time for the Thursday meeting of the JIC (UK) and that JIC (Canada) corrections to the WIR be sent to him on completion of the weekly meeting of the JIC (Canada). This procedure would not only give him the time required to prepare for the JIC (UK) meetings, but would also give him some idea of the background to JIC (Canada) thinking on certain subjects.

25. DNI proposed and the Committee agreed to defer a decision on this matter until the meeting of the Committee to be held on Wednesday, 25 Nov 59.

26. JICLO(L) informed the Committee that he is in close contact with Captain P.E. Haddon who is the alternate JICLO(L). Although the Chairman, Joint Staff (London) is not able to retain special material in his Headquarters, he is regularly briefed on all items of interest.

27. Mr. Black requested that members or deputy members of the Joint Intelligence Committee inform him of intended visits to London because there are often items of interest which could be usefully discussed with him or with appropriate members of the JIC (UK) and that advance warning would enable him to arrange meetings as necessary.

28. The Committee agreed that in future JICLO(L) would be informed of the intended visit of any member of JIC or his deputy to the United Kingdom.

He also requested that should the Committee want the UK intelligence authorities to comment on Canadian JIC papers, this should be specifically stated when the papers are forwarded to him because comment would not otherwise be forthcoming.

35. He also informed the Committee that he was kept informed by the Secretary, JIC (UK) of those items under consideration by the JIC (UK) at their weekly meetings which were of interest to Canadian intelligence community and asked if similar arrangements were in force to keep the UK Liaison Officer in Ottawa similarly informed.

36. The Committee agreed that the Secretary should determine from the Committee at the end of each meeting those items which he should inform the UK Liaison Officer were considered or under consideration.

Dear John,

Thank you for your letter of March 26 regarding the provision of intelligence to the Joint Staff. I am pleased to have the chance to outline to you the arrangements in London for providing intelligence to the CJS.

Before mentioning these arrangements, may I say that as the JIC's representative I have always regarded my responsibility for keeping the CJS informed on current and/or indications intelligence in the same light as my responsibility to the High Commissioner, subject to the CJS's own wishes and the arrangements then worked out with the Executive Staff Officer, who is also the alternate JIC representative.

In the year I have been in London, my relations with Group Captain Burgess, the alternate JIC representative, have been excellent and we both believe that the arrangements now in force for intelligence be passed to the Joint Staff are adequate. These arrangements are as follows:

1. Canadian Papers

- a. JIC Papers - 1 copy to CJS
- b. JIC Minutes - 1 copy to CJS

We each keep the other informed during an alert and subject to the type and length of it, special arrangements can be made, i.e. the regular meeting of the various intelligence liaison officers during the Middle East crisis last summer and the present arrangements with regard to the Berlin crisis.

There is one weakness in our liaison arrangements in London as no codeword material can be kept in the Joint Staff building. G/C Burgess informs me that there are good physical and security reasons why an appropriate area cannot be established and that these reasons have been fully explained to Ottawa. This situation, therefore, will continue for the foreseeable future. However, neither Burgess nor I believe that it greatly affects our liaison provided he and I keep in touch with each other and the arrangements outlined above continue to be carried out.

I have discussed this letter with G/C Burgess and George Ignatieff.


