As indicated in our SES 559, dated 1 August, 1958, the following is an official report on the accident in the Organic Laboratory on the 31 July, 1958, involving Dr. J.L. Ferron.

1. Dr. J.L. Ferron was injured in a laboratory accident on 31 July, 1958, in Room 224 of the Central Laboratory building.
2. Nature of the reaction and equipment involved in the accident.

The general reaction is carried out in the following manner - Three reagents eg.  $PCl_3$ ,  $AlCl_3$  and  $CH_3Cl$  are added to a Parr, pyrex glass pressure bottle at Dry Ice temperature and the bottle is stoppered with a rubber bung which is held in place by wiring or a clamp arrangement. The bottle is placed on its side in a horizontal laboratory shaker box, clamped into position and shaken until the reaction is complete.

The reaction proceeds as follows. The accumulated frost on the outside of the bottle gradually disappears, the bottle starts to warm as the exothermic reaction proceeds,  $AlCl_3$  dissolves forming a fluid pale yellow liquid which solidifies as the reaction nears completion. The product is chloroaluminate complex.

3. Safety Aspects

It has always been recognized that the reaction presents a potential hazard to personnel since unreacted methyl chloride is present

in the mixture at temperatures of the order of 40 - 60°C (exact peak temperatures are not known). It is noteworthy however, that during the past ten years that we have been carrying out this reaction, we have never had a pressure bottle fail.

Heavy gloves and face-shields are employed by persons handling the bottles at the beginning and end of the reaction, while during the reaction, the shaker is placed inside an isolated fumehood away from personnel and the fumehood door of half inch plexiglas is kept closed.

Pressure bottles which have been scratched are discarded and in fact it has been ascertained that two new bottles were employed on the day of the accident.

#### 4. Accident

Dr. Ferron was carrying out a duplicate synthesis on the day of the accident, both bottles being clamped into the shaker together. He successfully checked the reaction at five minutes and ten minutes after starting and noted that both bottles were frost-covered indicating a lack of vigorous reaction and thus little or no pressure. On his third check he noted that the bottle on the far side of the shaker was still frost covered so he opened the safety shield to see the nearer bottle which was hidden by the side of the shaker box. The explosion took place at this precise moment. Dr. Reesor was across the hall in the Organic Lab. at the time and reached the door as Dr. Ferron staggered out from the fumehood and fell. Since the complex is readily hydrolyzed by moisture to give hydrochloric acid and can be regarded as readily available acid, Dr. Reesor pulled Dr. Ferron under the "quickspill" shower and washed him thoroughly. He was in the shower within 15-30 seconds after the explosion. Medical attention was being given to him within two-three minutes of the accident.

5. The inspection of the bottles at this particular stage of the reaction has never been considered hazardous and Dr. Ferron was not wearing a protective eye shield or goggles. He had not been instructed to do so and accordingly was not contravening any local safety precaution.

As stated above, protective equipment is worn whenever the bottles are handled outside of the shaker and in view of our experience with the reaction we consider that a few-seconds check of the reaction to be actually far less hazardous than the handling of extremely percutaneously toxic agents in the laboratory on an almost-daily routine basis.




