



2. Nick NICHOLUK started the conference with the announcement of the beginning of the A.U.U.C. Organizational Campaign for Finances. He said that the quota for the Province had been set at \$1500.00 and 30 new members.

3. Bill KINAL advised the meeting that the students (Combined Universities Campaign for Nuclear Disarmament - Communist Activities Within, Montreal, Quebec \_\_\_\_\_ were organizing a march to Ottawa during Easter week-end. He said that the purpose of the march is to protest the establishment of nuclear bases on Canadian soil and to urge the Canadian government to take an active stand for disarmament. He urged those present to support this march.

4. Eugene PLAWUTSKY described the organization called the "Voice of Women". (Re: Voice of Women, Communist Activities Within, Montreal, Quebec, [redacted]) He said it was composed of progressive people who were trying to bring to the public view the dangers involved in the nuclear arms race. He said that the group was founded with a view to including people of all political colors and religious viewpoints. He appealed to the persons present to support the organization and suggested that the women of the A.U.U.C. and W.B.A. should take a leading part in the Voice of Women.

5. Nick MICHOLUK announced that tickets were ready for the A.U.U.C. Provincial Shevchenko Festival being held in the Victoria Hall in Montreal on June 3rd 1961. They ranged in price from \$1.25 to \$2.00. He appealed to all persons present to sell as many tickets as possible. [redacted] both Eugene PLAWUTSKY and Bill KINAL took 50 tickets between them. MICHOLUK said that 50 dancers and singers from Toronto would take part in the concert. He said it was planned that 120 persons from Montreal would also take part in the concert.

6. MICHOLUK stated that arrangements had been made for the train fare to the A.U.U.C. National Shevchenko Festival in Toronto July 1st, 1961 [redacted] He said the return fare would come to \$11.70 and the return limit would be 16 days. He asked all branches to canvas members and friends to obtain as many persons as possible to make the trip.

7. Max ROSHKO stated that the A.U.U.C. Provincial Committee [redacted] had discussed and set out a breakdown of the A.U.U.C. Organizational Campaign Fund Quota amongst the branches in the Province. After discussion the Quotas were adopted by the people present:

2. The Chairman of the meeting was John MICHOLUK, and Mike STEFIUK was the Secretary.

3. John WEIR gave a short talk on the aims of the Ukrainian Canadian. He said that the work of this paper was very important in bringing Ukrainian Culture to all persons of Ukrainian origin in Canada. He appealed to all present to support the Campaign.

5. After a short discussion the quotas were accepted by the meeting.

6. Alexander KOWALUK stated that he and about 4 or 5 others were ready to join the A.U.U.C. provided that the A.U.U.C. was ready to adopt views which would include a broader outlook towards the Canadian way as well as the old Ukrainian way. He made some criticism along the same line concerning the Editorial and other content of the Ukrainian Canadian. KOWALUK talked for a long time and that during his talk some discussion took place. John MICHOLUK summed up by saying that some of the points brought out by KOWALUK were constructive and would be taken into consideration. He pointed out that all members of the A.U.U.C. were expected to abide by decisions and to accept the guidance of the A.U.U.C. Executive.

7). To hold a provincial Shevchenko festival in May or June.

8). To make acquainted with the Shevchenko celebrations all members of the AUUC and WBA as well.

9). To call a conference for January 22 to discuss and to verify the progress of preparations to the Festival.

10). To mark the month of Slav solidarity by various undertakings, next January.

9.50 P.M. **As above** Male person, believed to be <sup>1</sup>John BOYCHUK [REDACTED] got off C.N.R. Rail-liner and was met by OLESCHUK and HAWRYLUK. After an exchange of greetings, they went directly to OLESCHUK's auto which was parked near the station platform and driving via Dodd Street, Prince and Welton Streets, arrived at HAWRYLUK's home.

11.45 P.M. **As above** OLESCHUK's auto left HAWRYLUK's home and BOYCHUK was observed with him. They drove via Welton, Prince, Dodd and Dorchester Streets to Charlotte, where they drove in a Southerly direction, turned right on Townsend, left on Esplanade and via Kings Road and Route 5, directly to OLESCHUK's home at Coxheath.

12.15 A.M. **As above** Arrived at OLESCHUK's residence.

7 Dec 60

7.35 A.M. **As above** OLESCHUK was observed driving his truck along Kings Road and he drove directly to the Bay Street Parking Lot of Dominion Steel and Coal Corp., where he parked the truck and went into the confines of the plant.

8.15 A.M. **As above** OLESCHUK was noted driving through Coxheath on Route 5, in the direction of Balls Creek and North Sydney. Comment: Due to traffic conditions, OLESCHUK was lost, although it is very likely that he turned off on a side road before reaching North Sydney

OLESCHUK returned home. He was alone.

11.00 A.M.  
As above

OLESCHUK, BOYCHUK, Ann HASIUK [redacted] who is OLESCHUK's Common Law wife, left the OLESCHUK residence and drove to WILLIS' Service Station at the intersection of Route 5, where a passenger was picked up (believed to be OLESCHUK's hired farm hand) and drove directly to Sydney via Kings Road and Esplanade. They turned right on Dorchester Street, stopped in the first block and discharged the passenger and drove directly to the intersection of George and Dorchester Streets.

Note: Surveillance was lost at this point due to traffic conditions.

11.50 A.M.  
As above

OLESCHUK and BOYCHUK were located driving North on George Street, near the intersection of Byng Avenue. They continued along George Street, turned right on Prince and right on Mitchell Street. Here they stopped at the service entrance of MacEACHERN's Electric Shop.

11.55 A.M.  
George

(Ronald George MacEACHERN [redacted] was observed working on the motor of an auto and OLESCHUK stopped about ten feet away from him. BOYCHUK and OLESCHUK spoke to MacEACHERN momentarily.

12. Noon  
Jordan, George

OLESCHUK and BOYCHUK drove away, followed directly by MacEACHERN and a passenger, presumably his son. Both vehicles turned East on Prince Street with OLESCHUK leading, and driving considerably faster.

Note: OLESCHUK and BOYCHUK were lost at this point as it would have been necessary to pass MacEACHERN to follow them. Mac EACHERN went directly home.

2.30 P.M.

Autos belonging to OLESCHUK and John EVASUK [redacted] were noted parked behind the home of Daniel Michael SALYZYN [redacted], Beacon Street, Glaco Bay.

5.50 P.M.

OLESCHUK's auto left SALYZYN's home, with three male passengers. He drove via Beacon Street, Argyle Street, Queen Street and Mc Koon Street to Main Street, where the auto was parked across the street from the N.S. Liquor Commission Store. OLESCHUK went into the liquor store.

OLESCHUK came out of the liquor store carrying a large carton, likely two dozen pints of ale. He deposited his purchase in the trunk of the car and drove off, turned right on Commercial Street, right on Union Street.  
Note: Quarry was lost at this point. He was not at the homes of EVASUK nor SALYZYN, when subsequent checks were made and it is likely OLESCHUK and BOYCHUK returned to Sydney

6.45 P.M.  
George

OLESCHUK's auto, with three men, left OLESCHUK's home, drove in direction of Sydney and stopped at "Lucky Dollar" Store in Coxheath. OLESCHUK, BOYCHUK and an unidentified male went into the store, made a purchase and drove on towards Sydney.  
Note: Quarry was lost at traffic lights at intersection of Kings Road and Alexander Street.

7.45 P.M.  
As above

OLESCHUK drove up to A.U.U.C. Hall on Mount Pleasant Street, parked across the street and went into the Hall. He was alone.  
Comment: It was not possible to see what was happening inside the Hall and attempts to look in the windows failed as a woman residing across the street became disturbed by the presence of the surveillance party.

9.40 P.M.  
Jordan, George

Four men came out of the Hall, three of them got into OLESCHUK's car. The fourth, believed to be Steve ANDRUSYSHYN @ "Black Steve", who lives in part of the Hall, stayed on the driver's side of the auto and talked for a few minutes.

9.45 P.M.  
As above

Drove away, on Mount Pleasant Street, left on Langan Road, right on Hankard to Victoria, left on Victoria to Welton and on Welton Street to HAWRYLUK's residence.  
Note: OLESCHUK's car was not observed leaving HAWRYLUK's home. It was last seen behind the house at 10.30 P.M. and was not there at 11.30 P.M. Subsequent check made at OLESCHUK's residence revealed that all the lights were out and it is likely that he and BOYCHUK were in bed.

Automobile belonging to John EVASUK, with EVASUK driving and BOYCHUK in the front seat, with unidentified man in back seat, left OLESCHUK's residence and drove to Sydney via Kings Road, turned right on Byng Ave., right on George Street and directly to Louisbourg.

10.45 A.M.  
As above

Arrived Louisbourg, drove directly to Museum, parked the car and went into the Museum.

11.15 A.M.  
As above

Left the Museum and drove directly back to Sydney, entered Sydney via George Street, turned right on Prince Street, left on Dodd and parked by the C.N.R. Station. BOYCHUK went into the Station, came out in a few minutes and got back into the car. EVASUK turned the car and drove back on Dodd Street, left on Prince, left on Disco, left on Victoria Road. Here they drove to Whitney Pier, parked near the ROXY Tavern and entered the tavern.

2.40 P.M.  
As above

EVASUK, BOYCHUK and unidentified man left tavern, got in car and drove off. They turned right on Mount Pleasant, right on Lingan Road, right on Muggah, left on Victoria Road, right on Disco, right on Prince, right on Dodd, left on Dorchester, left on Esplanade and via Kings Road and Route 5 to OLESCHUK's residence.

Note: OLESCHUK did not come home from work until later. It is likely that BOYCHUK and EVASUK dined at the OLESCHUK residence.

7.30 P.M.  
As above

OLESCHUK and BOYCHUK left OLESCHUK's home in OLESCHUK's car, closely followed by EVASUK. They drove directly to Sydney via Kings Road and Esplanade and turned right on Townsend Street. They stopped in front of MANSON's Iron City Pharmacy where BOYCHUK went into MAC's [REDACTED], came out in a minute, went into the Pharmacy and came out in a moment and got back into the car. They drove via Townsend Street, Prince and Welton Streets to HAWRYLUK's home. EVASUK did not stop at the store and his auto was noted at HAWRYLUK's on the arrival of OLESCHUK and BOYCHUK.

KOROL stated that, as of November 3, the edition of the "Ukrainian Life" publication would be doubled; namely, it would be edited twice a week instead of once a week, as it was, up to that date. The cost of subscription to this publication would now amount to \$5.00 per annum. KOROL intimated, that in 1955, the A.U.U.C. received a complete printing unit (a printing machine) as a gift from the U.S.S.R. The production capacity of this printing unit, however, was comparatively small. Recently, the A.U.U.C. had this printing unit modernized, and its production capacity increased up to the Canadian standard. The overhaul of this printing unit costs the A.U.U.C. \$12,000, however, the production capacity of this unit has increased so much, that they have since undertaken the printing of all other Slavic progressive press, in Toronto, on it.

5. After several discussions, the conference established the quota of \$3,100 and 16 new subscribers, to be fulfilled by the Province, in the present campaign, for the "Ukrainian Life" publication. This quota has been divided amongst the A.U.U.C. branches, as follows:
