Today, Mr. Blackwood, Probation Officer from Victoria, called regarding the above young man.

Apparently [redacted] was mixed up in an assault charge along with another young fellow from Songhees and is now under Mr. Blackwood's supervision.

We know [redacted] failed his grade 1K at Mission, and is not able to return there. However, Mr. Blackwood has suggested that [redacted] should attend school in Victoria, and possibly you could provide Welfare Assistance to an Uncle he would presumably be living with. Would you correspond directly with Mr. Blackwood on this matter.

A further request from Mr. Blackwood was for a copy of [redacted] final Report from Mission, as this would be required prior to his enrollment at a Victoria School.



[redacted] was born of a common-law union with a non-Indian and this child was not included on the band lists at the time of birth. When band membership lists were posted in 1951 and persons not registered on band lists were given an opportunity to apply for membership, no application was made on behalf of this child and, therefore, he was not included on the 1951 band lists and is considered of non-Indian status.



Dear Mr. Letcher.

In reply to your letter dated 16th inst. in re the m/n Committee, wherein you state that a comprehensive explanation and assessment of the project may prove helpful to your Ottawa Head Quarters, I am pleased to submit the following analysis :

Background.

Up to the year 1956 the number of delinquencies committed by Juvenile members of the Sechelt Indian Band were relatively few and consisted chiefly of petty shoplifting and other misdemeanors for which release of the child to its parents with suitable probationary restrictions and a few added chores, appeared adequate punishment and sufficient deterrent.

However, from 1956 on, the situation rapidly went out of hand. Not only was an alarming increase in the number of delinquencies committed experienced, but the nature of delinquencies took the form of offences creating a definite peril to persons and property in neighbouring Communities. Indian children, ranging in age from 10 to 17 years of age, formed themselves into gangs terrorizing other children, white and indian, committing assaults, B & E and thefts, and wilful damage to property. In one instance a 14 year old white girl was dragged into an old shed on the Reserve and gang raped by boys 14 to 17 years of age.

CAUSES.

The upsurge of delinquencies among Indian children may be attributed to various causes. The chief contributory factors being, in my opinion :

- a). The opening of Beer Parlours to Indians. Parents frequenting these establishments, located several miles from the Reserve, usually stay until the establishment close about midnight, leaving their children to their own devices without supervision or control of any kind.

- b) The increased use of alcohol and attendant intoxications increased friction in the homes between parents with resultant deterioration of home environment and discipline.
- c) The general prosperity of the past few years enabled many families on the Reserve to obtain automobiles and T.V. sets. The former enabled youngsters to roam far from the confines of the Reserve and the latter, with its many pictures depicting crime, undoubtedly inspired gangsterism in the immature minds of the children resulting in the commitment of the many serious offences.
- d) Expansion of stores in the neighbouring Village of Sechelt, displaying a wide variety of items desirable to any underprivileged child, may account for the increase in B & E and theft from shops and stores.
- e) Chief and Band Council ignored the deterioration of morale among members of the Band and exhibited no responsibility whatsoever in the discharge of their duties in regard to the Band in general or the Juvenile Delinquent problem in particular.

I urged upon the Chief time and again to co-ordinate the efforts of parents who earnestly desired to curb the rising tide of delinquencies, but to no avail.

Finally in January 1960, shortly after the election of a new Chief and Band Council and at a time when I a short time prior had occasion to commit a gang of 6 Indian children to Brannan Lake Industrial School for Boys, I was able through the co-operation of the Indian Superintendent to lay my proposals before the Band, its Chief and Council. The suggestions I made were well received and as a result, after several meetings with the new Chief and Council, a committee was formed to deal specifically with the problem of Juvenile Delinquency. For your information I enclose a copy of initial suggestions submitted to this Committee, which were adopted as its "Constitution" and form the basis of the Committee's work. Since its inception this Committee has been known as the "YOUTH GUIDANCE COMMITTEE".

The Modus Operandi of the Committee is as follows :

- a) The Committee meets weekly in the Indian Hall on the Reserve at which time complaints in regards to Juveniles are discussed and decisions reached as to what action the Committee will adopt in each case. Reports of work done by the various Committee members in the week previous are submitted and dealt with. The Committee's secretary takes notes during the meeting and a copy of the minutes is forwarded to me for my records.

- b) If a juvenile fails to heed directions given him by a Committee member, he is brought before the weekly meeting of the Committee, or he may be brought before me unofficially at my office for admonition. One of the child's parents is also present at such times.
- c) Curfew at 8:00 o'clock P.M. during the Winter months and 9:00 o'clock P.M. during the Summer months for all children under 16 years of age is strictly enforced. The bell in the Indian Church is rung and the Committee checks the grounds to see that all children return to their respective homes.
- d) Periodical checks are made by Committee members of the Pool Hall and Bowling Alley in the Village of Sechart to prevent loitering and breach of Curfew.
- e) With the co-operation of parents, youngsters are from time to time checked as to the contents of their pockets and knives, chains, slingshots etc. found are confiscated by the Committee.
- f) Conditions of release on probation of any child committed by my Court as a delinquent to the care of its parents is supervised by the Committee to ensure that the conditions are carried out.
- g) Where parents are allegedly criminally negligent in the care of their children such conduct is reported and if, after investigation by the R.C.M.P., sufficient cause is established charges are preferred against the offenders. One example of such conduct on part of parents was a case reported to me by the Committee where it was found the parents had left 6 children aged 11 months to 12 years old without food in the house and taken off to Vancouver for a 4 day drinking spree.

ASSESSMENT.

The project may be termed most successful. During the first 10 months of the Committee's operation only one case of Juvenile Delinquency among Indian children was dealt with officially by my Juvenile Court as compared with conditions existing prior to the formation of the Committee, outlined on page 1 of this report under "Background".

Further, a noticeable measure of personal pride

and family responsibility has been evidenced as a result of the Committee's work. I attribute this to the opportunity given the Band in general to cope with this problem by exercising their own Jurisdiction and autonomy in this matter through their Youth Guidance Committee, in the spotlight of the Court and other authorities.

The assistance given this experiment by Rev. Fr.s Bernardo and McWade of the Sechelt Residential Indian School has been invaluable. There are strong clanish feelings between the different larger families on the Reserve which at times creates difficult situations for the Committee to overcome. Independent advice by someone capable of viewing an incident objectively and impartially is often a must in resolving such difficulties and to reach a decision compatible with justice.

The present work of the Committee must be considered as an initial stage only. It has proven itself an effective deterrent to Juvenile Delinquency by constant vigilance on the part of the Committee in respect of the behaviour of the younger members of the Band. However, the goal must be to create a positive action to the problem within the means and capabilities of the Band members themselves to give an incentive to the juveniles to occupy their leisure hours with organized sports and workshops. As the Committee through the passing of time becomes more firmly established as an integral part of Community life on the Reserve, this may be possible to achieve through the formation of Auxilliarries.

The task of bringing any organized form of self-reliance into being among the Indian people is one that calls for time, patience, understanding and a willingness to work with the Band without appearing officious or dictatorial. The Indians must be made to feel that they are accomplishing something worth-while and that every decision made is theirs and theirs alone in the exercise of their duties on the Committee. It requires prodding, praise and perseverance while maintaining yourself the dignity you are hoping to impart to all with whom you are dealing.

The compactness of most Reserves, where Band families lives close to one another separate from neighbouring white Communities, and bound together with bonds of identical interests as to race, creed and economic status, lends itself to the system of autonomy and control of the juvenile members of the Band as adopted by Sechelt Reserve # 2. It is perhaps not unreasonable to assume that such a system would meet with equal success on other Reserves.

Surely the rewards are there in the satisfaction of accomplishment and the knowledge that the Indian youth of today, with proper guidance, will become a useful, law-abiding citizen who on reaching maturity will assume his responsibilities to the Band and enhance his peoples desires for cultural advancement.

If you should require any further information in this matter I shall be pleased to be of service at any time. For your convenience I am enclosing a duplicate of this report.

Further to our discussions in re the m/n I am pleased to submit the following suggestions as a guide for your Council to form a Committee to deal specifically with the prevention of Juvenile delinquency :

1. Name. YOUTH GUIDANCE COMMITTEE
2. Authority. The Committee shall be appointed by and be responsible to the Chief and Council of the Sechelt Indian Band. Representation on the Committee with full privileges of voice and vote shall be invited from the resident Rev. Frs. Bernardo and McWade, O.M.I.
3. Purpose. To promote respect for Law and Authority among all juveniles residing on the Reserve and to discourage acts and behaviour contributing to any child being or becoming a Juvenile Delinquent.
4. Duties of Committee) To assist the Juvenile Court by supervising delinquents residing on the Reserve and to assure that the probationary conditions imposed by the Court are strictly adhered to.

To maintain a close liason with the Juvenile Court and local law Enforcement Officers with a view of dealing informally with cases that in the best interest of the child and the community can so be dealt with.

To assist any family living on the Reserve and requesting the Committee's help in regard to control, discipline, conduct or behavior of any juvenile that the parent or guardian find themselves unable to deal with.

To report to the Band Council any conduct on the part of a Parent or Guardian of a child, that in the opinion of the Committee may constitute neglect of such child which may directly or indirectly contribute to the child being or becoming a juvenile delinquent.

To recommend to the Chief and Council of the Band the enactment and enforcement of such Band Rules as in the opinion of the Committee would tend to prevent or act as a deterrent to the committing of delinquencies.

To maintain a close liason with Religious, Recreational, Arts and Crafts and other groups whose aims and objects concern the welfare and proper training of children.

To make the Committee's purpose and duties known to all families on the Reserve and at all times solicit the full support of every member of the Band in the Committee's efforts to aid and guide the younger members of the Band towards a better understanding of their duties and obligations towards their Parents, the Band and Society in general.

Dear Parents:

The Youth Guidance Committee has been in operation now for some months. The Committee and the parents now have a chance to see and to judge whether the operation of the Committee will be successful or not. I think we can truthfully say that this experiment has been more or less successful. It can achieve greater success - but only with the fullhearted cooperation and backing of all the parents. Most of the parents have given the Committee their full support, and have backed its actions; however there is, at the same time, a danger that the good work of the committee will be frustrated by the attitudes and even the actions of a minority of the parents.

It is for this reason that we are writing this letter to explain to you once more the purpose for which the Committee was formed, and the reasons for its activities and meetings. As you well know, the Committee was formed at a time when this Reserve was in a very sad state. This Reserve had the highest delinquency rate in all Canada. At the time of the formation of the Youth Guidance Committee, six youthful members of the Band were confined to a school of correction. This Committee was formed to remedy that situation, and to prevent its recurrence.

This Committee received the approval and the support of the Magistrate, the Police, the Juvenile Court, and even of the Attorney-General. The main purpose of the Committee is to prevent juvenile delinquency, and to assist the parents to control the behaviour of the children.

It is quite true that since the Committee was formed, some children have sometimes behaved in a way which could have been declared delinquent by the juvenil court; however the court and the police are quite willing to let the Committee handle all such actions and situations, so long as the Committee proves that it is capable of handling and solving them in a satisfactory manner. You can easily see that in order for the Committee to prove this, it must have your full cooperation - and support - and good-will. And if the Committee cannot carry out its duties, then of course, the Police must step in and take proper action.

That proper action will be that not only the children, but also the parents might be declared delinquent, and receive whatever judgement may be declared by the Court, fitting under law. You can see then, that if you do not help the Committee carry out its duties, that both parents and children will once more be appearing in court and receiving its judgements. Also, you can see, that it is to your benefit and the benefit of your children that you give the Committee every support and encouragement.

The work of the Committee is hard and often unpleasant, but the members of the Committee will be glad to serve, if they know that they have your help and enthusiastic support.

The Committee then, asks you for your help, so that it can prove that the Indian People are able to solve some of their problems and govern themselves, if given a chance to do so.

It has also been intimated by Mr. Caldwell that these youngsters are causing a fair amount of trouble in your area. If this is the case I would suggest sending them home by warrant by Union Steamship from Vancouver Thursday noon or Campbell River the same day or by Northland Navigation leaving Vancouver Tuesday at 8 P.M.

If such action should not prove necessary the following are statistics on these boys:

Both these lads through behaviour and performance are not acceptable for re-admission to the Alberni Residential School. [REDACTED] will not be [REDACTED] until [REDACTED] and theoretically should be required to attend school. This boy is quite a problem as he prefers the Boys' Industrial School to Alberni so he would be most pleased to be sentenced there and I am quite sure he will prove to be a disturbing influence at any school he is made to attend.

If he is gainfully employed I would suggest leaving him where he is, but, as I have stated, if he is a source of annoyance send him home.



You were reminded in previous years that these children should be adequately clothed before returning to the School, either through purchases made from Welfare Appropriation at the Agency level or by the parents accepting full responsibility.

I would suggest that wherever possible the parents be reminded of their responsibility and where the costs can be met by the parents you should collect and make payment direct to the store.

Where this is not the case, however, voucher should be submitted in the usual manner indicating the circumstances of the family to substantiate the purchase from the Welfare Vote.



SCHOOL HEALTH SERVICE

Dear Parent:

Attached to this letter is a "Consent for Immunization" form which gives you the opportunity to sign one permission slip for most of the immunizations your child will require during his school life.

These immunizations will not be given all at once and you will be notified when clinics are being started in the school.

Diphtheria and Tetanus Toxoid - provides protection against diphtheria and tetanus, commonly called lockjaw, and is first given in a series of three doses one month apart plus a fourth dose three months after the third. Following the original series, a reinforcing dose must be given at regular intervals (at least every five years) in order to keep the protection effective.

Smallpox Vaccination - provides protection against smallpox. Revaccination should be done at least every five years to keep the protection effective.

Immunization clinics are held in the schools for pupils new to the Metropolitan area, and for those in Grades I and VI only. Therefore, even if the above times have not elapsed since your child's last dose, we recommend that you take advantage of the clinic when held in the school.

Patch Test for Tuberculosis:

As a part of the health examination of grade One pupils, the School Health Service is including the Tuberculin Patch Test. The test consists of applying a piece of medicated adhesive tape (that looks like a band-aid) to the child's chest or back. The tape is removed two days later and the test "read" two days after that. If a positive reaction occurs, the school nurse will talk over with you any further action that should be taken. A positive reaction does not mean your child has Tuberculosis.




It has been the practice of officials of the Brannan Lake School for Boys to formulate release plans through Probation Officers and Provincial Social Workers, which procedure has inevitably entailed considerable delay in many cases because the contact with the Indian Superintendent concerned is not made immediately. Such contact is, in most cases, essential as no one other than the Superintendent has, or is able to secure, complete details with regard to family background, relatives, home conditions etc. It has, therefore, been decided, following a meeting with the Superintendent of the School that correspondence from the School with regard to rehabilitation planning in the case of Indian boys, will be directed to the Superintendent concerned with a copy to this office, and a copy to the Probation Officer or Social Worker. As much time as possible will be allowed for the exchange of correspondence to whatever extent is necessary for rehabilitation planning but as in most cases it is undesirable for boys to remain at the school beyond a certain stage of development, it is essential that a satisfactory rehabilitation plan be formulated as quickly as possible. Furthermore, as release plans must be referred to the Superintendent of Child Welfare for approval and subsequently to the committing Judge before discharge can be effected, some delay is unavoidable. It would be appreciated, therefore, if you

would deal with correspondence from the Superintendent of the Brannan Lake School for Boys as quickly as possible.

Probation Officers and Social Workers involved will co-operate with you to the greatest possible extent.
