On the other hand, those dealers in Newfoundland who may import some of these items from other countries and the few producers of them should be given a reasonable period, say six months, to adjust their activities to conform with the Acts mentioned. It is suggested also that dealers, particularly of pesticides and binder twine be given one year to dispose of any shelf goods which do not conform with the respective Acts. Such was necessary in Canada when the Pest Control Products Act first came into effect.

For bringing about a reasonable and smooth adjustment of the trade in conforming with the Acts mentioned, it would appear necessary to send to Newfoundland at the proper time one or more

officers of Plant Products Division. They would bring together the members of the different classes of the trade and in cooperation with them bring about a satisfactory application of the Acts.

We have yours of October 20th with reference to the application of regulatory work in Newfoundland, pending the adoption of the necessary supporting legislation by the Government of the Province of Newfoundland.

Insofar as concerns regulations governing the grading of poultry products, it would be our intention to apply such regulations only after the necessary legislation has been enacted in Newfoundland. In fact, we could not operate otherwise because we can only apply the regulations governing the grading of poultry products in any province for local use under the authority of Provincial legislation. Newfoundland does not export any poultry products and, therefore, that field of our legislation, which comes under Federal jurisdiction, would not be a matter of concern in the case of Newfoundland.

MEMORANDUM FOR FILES

Re: Newfoundland Statutes

Attached is a table showing Newfoundland Statutes covering the same field as Canadian Statutes. This list is not necessarily correct and is by no means complete and it is intended only to give a general picture. Little account has been taken of amending sections and no attempt has been made to find individual sections that are in conflict with Canadian Statutes. Particular attention should be made to Export Acts. There are a good many statutes of this kind in Newfoundland and in a sense would conflict with the Export and Import Permit Act.
