"Maintiens Le Droit—"

THAT is the simply worded motto of the Royal Canadian Mounted Police. Those who know the Mounties in other than their screen version are well aware that it is more than a high-sounding phrase to the men of the force.

It's a simply worded motto, but not always so simple in the upholding, as material included in the current issue of the Royal Canadian Mounted Police Quarterly will quickly convince the reader.

The contents of the Quarterly range from fictionalized fact stories to reports, but a group of case reports covering several convictions will doubtless provide the most absorbing reading for many "crime story" fans.

AND it is here that the complexity of modern police work is most strikingly revealed. Bringing the accused persons to book in the cases recorded was not a matter of trailing "badmen" through the Arctic night, but of scientific detection and painstaking legal preparation.

These modern Mounties often "get their man" through knowledge of the law.

One of the most intriguing items in the Quarterly is the story of an oldtime Indian killer written by Mike Mountain Horse. Long-since hanged, the killer concerned has found an able apologist in this skilled Indian author who, wounded during the last war, is today lecturing on behalf of the Red Cross.

RETURNING to the motto of the force, Acting Corporal R. F. Karrow has this to say in an article:

"The possession, alone, of a motto is not enough. We must so perform the duties of our office that we create in the minds of all people, no matter what station in society they occupy, a complete confidence that right will be upheld.

"The mere adoption of a high-sounding slogan does not accomplish this, but the proper attitude toward our work and those with whom we come in contact will go far to convince the public that such a motto has a meaning for us.

"We must show ability to perform our duties in an efficient and impartial manner; we must display sympathetic understanding; to all we must exhibit courtesy and tact, and a firm determination to ascertain and report facts. Ours is not an easy task . . ."

No, it is not an easy task, but we think the Mounties have lived up to their splendid tradition.

Dear Superintendent Thrasher,

I am afraid that it has taken rather a long time to provide the information you requested in connection with badges of rank common to the Army and the Royal Canadian Mounted Police.

As you know, from the inception of the North-West Mounted Police in 1873, officers of the Force have worn military insignia of rank similar to that worn by officers of the British Army. However, various changes have taken place in these insignia.

These changes, and various particulars concerning the Crowns and Stars ("pips"), are recorded in an article entitled "The Evolution of the Badges of Commissioned Rank of the British Army", by Lieut. N. P. Dawnay, in the Journal of the Society for Army Historical Research, Vol. XVI (Winter 1937), Pages 218-234. A photostatic reproduction of this article is enclosed for your retention.

I hope that this information may prove useful for your purposes. Please do not hesitate however to let me know of any further requirements you may have regarding this matter.

Dear Sir:

The following pertains to what little we know about your crest. We hope that it might be of assistance to you.

It would seem that "Honi Soit Qui Mal-Y-Pense" is the only wording used along with the Royal Garter therefore you should have on your crest a plain Annulus bearing the words "Maintiens Le Droit."

Some years ago, in speaking to Asst. Commissioner Gagnon, he remarked that the crest should really have four and a half maple leaves on each side totalling nine for the provinces. If this origin is correct then the indication is that any future crests should have five maple leaves on each side.

Since the time of George V which we believe is when you received your Prefix Royal, the Kings of England have had what is known as the Imperial Crown so you will be relieved to know that you are quite in order in this department.

The writer hopes that the above remarks may prove to be of assistance to you. If there are any others that you think we may be of assistance to you, please let us hear from you.

- THE BADGE OF THE ROYAL CANADIAN MOUNTED POLICE -

ERRORS

Crown: Should not be curved at the base. It should not rest on part of the oval, and the ribbon at the base of the crown is incorrect. No ribbon is required.

Animal: The late J. P. Turner was of the opinion that the animal should be shown as a North American bison, and not a buffalo. There is a basic structural difference between the two types of animal.

Garter with Buckle Around the Motto. The presence of a buckle on a garter has been held by some heraldic authorities to be part of the insignia of the most noble of the Order of the Garter, and exclusive to that Order.

Maple Leaves: The twelve leaves are not correctly placed, because they should be brought in more towards the words "Canadian", and "Mounted", which would imply that they were tied together at the base.


The Scroll: The scroll bearing the words "Royal Canadian Mounted Police" is not continuous. The central design separating the title below is meaningless. All the lettering is too heavy and should be of antique style.


DESCRIPTION OF THE INSIGNIA -

This design is definitely a badge, and not a crest. A badge is defined by heraldic authorities as being a figure or heraldic device without a shield. A crest is a heraldic device, resting upon a wreath (consisting of six pieces of twisted silk) or a cap of maintenance, which is a velvet-lined cap with peaks on each side, upon which the crest stands.

Description: The heraldic description of the present badge reads as follows:-
A bison's head, affrontee, surrounded by a garter bearing the motto, MAINTIENS LE DROIT, all within a wreath of twelve Canadian maple leaves. In a scroll below, the words, ROYAL CANADIAN MOUNTED POLICE. The whole surmounted by an Imperial crown, proper, with the name, CANADA, in a scroll below.

Dear Sir Algar:

I am taking the liberty of forwarding to you two enlarged copies of the badge or crest of the Royal Canadian Mounted Police which, as far as I know, has never been submitted to an expert for scrutiny to see if it is properly formed.

In this connection I should like to ask the following questions:

Crown:

Is it not improper to curve the base of the crown, as shown in the attached sketch, and to have a ribbon on it at the base. Should the word Canada appear as it does or at all?

The Animal:

It has been considered by some that there is a distinct difference between a North American bison and a buffalo, but what the difference is I am not sure. The original animal was supposed to be a bison, as you will see later from the definition of the badge or crest.

Garter with Buckle containing the Motto:

Is this garter and buckle permitted, or is it confined to the Noble Order of the Garter?

Maple Leaves:

It is considered that the twelve maple leaves shown are not correctly placed and that they should be brought in more towards the word Canadian and the word Mounted, which would imply that they were tied together at the base.

The Scroll:

The present scroll does not appear to be continuous and, on account of this, would seem to be improper.

The present description of the present badge is as follows:

This definition is not correct - see P & R 1928 Para 300 (a)

A bison's head, affrontee, surrounded by a garter bearing the motto, MAINTIENS LE DROIT, all within a wreath of twelve Canadian maple leaves. In a scroll below, the words, ROYAL CANADIAN MOUNTED POLICE. The whole surmounted by an Imperial crown, proper, with the name, CANADA, in a scroll below.

I believe the description is that of a badge and not necessarily of a crest and while we know so little of what is proper in this matter, it has occurred to me that you may be willing to give us the benefit of your advice in any of these matters. At the moment we have no idea as to whether the wording as now shown as "Royal Canadian Mounted Police" follows the proper style or whether the word "Mounted" should be where the word "Police" now is, or how many maple leaves should surround the badge or crest, or if there is any restriction in this regard at all.

If you will be so good as to give us the benefit of your advice in this matter, it will be sincerely appreciated and we shall be able to correct any errors which are now obvious to you.

One more question. Should the crown be changed every time there is a change in sovereign?





With further reference to your letter G.219-3 of December 22nd, 1950, I have considered the points you raise.

Crown: The crown shown is sufficiently correct. The curved base is permissible. The scroll in front of it, bearing the word "Canada", does not belong to the crown (is not part of it) and seems only to be a designer's fancy. I see nothing against it except it not being very well designed and is as a result rather confusing.

Animal: This may not be a very good representation of a bison's head and it is only a question of re-drawing it, if desired. There is no registered or official version of the R.C.M.P. badge here.

Garter: Strictly speaking it is not considered right or proper to use the Garter form in such things and this I think ought to be re-drawn, in the form of a riband or scroll.

Maple Leaves: I think this is purely a matter of taste.

Scroll: I agree this could be better drawn to show more continuity.

The description is that of a device or badge: it is not a Crest.

I assume that this badge, more or less in the form depicted on the sketch you sent, has been in use a long time. I think it would be a pity to change it, except in detail such as I suggest above, which is no more than rectification of detail and improvements in design.

But I do think it would be a good idea to have it re-drawn here carefully, and I also think a copy of it should be enrolled here so that it is always available for reference both by Canadians and by any others concerned or interested.

Unfortunately, the cost of doing this (a really well drawn design in black and white would cost £16.16.0, and enrollment in the archives of the College of Arms would cost £7.7.0) would have to be met by you since there are no public funds available here to cover such things.

If you want a coloured and illuminated copy, the cost would be considerably higher.

I beg to return one of the designs.

Dear Sir George:

1. Please accept my thanks for your letter of May 15th, enclosing a pencil design of the badge of the Royal Canadian Mounted Police.
2. We would like to retain the use of twelve maple leaves, chiefly because the R.C.M. Police is a Federal Force which operates in ten provinces and two territories, a total of twelve, - that is to say throughout the whole Dominion.
3. I cannot say that I prefer the buffalo head as shown in the attached pencil sketch which is returned herewith in preference to the one shown in the enclosed photograph of our badge, and if you care to reproduce the one we now have, it will be quite satisfactory, except that I believe the horns have been slightly misplaced to get them more easily into the picture.
4. I am enclosing several photographs of a buffalo, together with one full faced, which I hope will be of use.
5. In the circumstances, I shall appreciate it if you will kindly have a pencil sketch prepared with the twelve maple leaves and a new buffalo head. While on this subject, may I refer to your letter of the 18th January last regarding the word "Canada" to make sure that it is quite correct to have it in the sketch, and insofar as the maple leaves are concerned, as you probably know, these could be either green, which is the colour in the springtime, or variegated and many-hued, as in the autumn, and I shall much appreciate it if you will express an opinion as to which of these two should be chosen.
6. I thank you sincerely for the trouble you have taken in this matter.

RE: R.C.M.P. Badge

1. You will note from recent correspondence on this file that the Force is interested in establishing something definite on the construction of the R.C.M.P. crest, or badge.
2. It is believed that a crest of the Force, approximately three feet square, would be most appropriate for a portion of the background for our display at the forthcoming Ontario Police Association Convention in Toronto.
3. With this in mind, I instructed Cpl. Abbott to cast such a badge. We have taken the liberty of incorporating some of the ideas that were brought to light upon perusal of this file. Generally speaking, there is no great change in the appearance of the badge. However, sculpturing an object such as this is altogether different to making a drawing.
4. Owing to the fact that the Force is interested in establishing authority for certain construction of the badge, I would ask that favourable consideration be given to setting up a Board of Officers to examine Cpl. Abbott's work before it reaches the final stages.
5. It is further suggested that this matter be referred to the Deputy Commissioner and that he be asked to select the Officers, as soon as possible, to examine the work in its present state.



My dear Belcher:

1. Some time ago the question of the R.C.M. Police badge or crest was gone into with a view to establishing something definite along these lines, and it was found that we have never at any time had any expert opinion given on the badge that we presently use. A letter was addressed to Sir Algar Henry Stafford Howard, K.C.V.O., C.B., M.C., Garter King of Arms, London, England, but it was found that Sir Algar had retired from office and his successor was The Honourable Sir George Bollow, C.V.O., who said he would go into this question for us. Further correspondence from Sir George was to the effect that the Crown was sufficiently correct and that the curved base was permissible; the scroll in front of it bearing the word "Canada" did not belong to the Crown, is not a part of it and seems to be the designer's fancy. However, he could see nothing definite against it except it not being very well designed and as a result rather confusing; that the bison's head was not a very good reproduction and it was a question of re-drawing it. Regarding the Garter, it was not considered right or proper to use the Garter form in such things as this, and he thought it should be re-drawn in the form of a riband or scroll, and he thought the maple leaves were purely a matter of taste and that the scroll itself should be better drawn to show more continuity and the description of the badge was that of a device or badge, and not a crest. Further, there is no registered or official version of the R.C.M. Police badge at the College of Arms.

2. Later, Sir George Bollow wrote advising that he could see no particular reason that twelve maple leaves should be on this badge and suggested six, and he sent a sketch of the badge as he proposed it saying that if we did not like the bison's head we could send a full faced photograph of one. This correspondence was replied to and a picture of a buffalo head was taken from the head in the Commissioner's office, copy of which I am forwarding you, which I would ask be returned. Also, Sir George was advised that it was considered that the twelve maple leaves, on the badge, were required and that they should be green in color or variegated and many hued as in the autumn - the twelve leaves representing the ten Provinces and two Territories.

3. We now have a letter from Sir George Bellow forwarding a revised design for our consideration. I am forwarding you a photostat copy of this design and to be frank I do not like the head of the buffalo. It seems too much like a cow - a jersey cow at that with a whisker on it, the ears and eyes give the effect of being too docile. Further, from some photographs we have here it would appear that the hair on the head of the buffalo is very curly.

4. Now, what I would like to have done, if you can arrange it Belcher, is to have your photographer take photographs of a live buffalo in the Park showing the head in all angles, particularly a photograph of the front view of the buffalo's head, but at the same time I would like shots taken of the side view also, and in forwarding these photographs on you might let me have your opinion of the photostat copy of the sketch forwarded by the Honourable Sir George, and any other comments you wish to make.

5. With kindest regards, and I trust you are not working too hard, but I suppose you have your own trouble, like all of us.

Dear Sir George:

1. I thank you very much for your letter of the 23rd of July, together with the black and white drawing of the R. C. M. Police badge, which badge I now return to you, and would like to make the following comments.

2. The design of the badge is quite acceptable, with the exception of the buffalo head which I do not altogether like as it give the impression of being much too docile for a buffalo.

3. In an endeavour to assist in correcting this impression I enclose two pictures taken of a buffalo head, No.1 showing full face from which you will note the ears do not show, the eyes have rather an angry glare and the hair on the head is quite curly, No.2 shows the profile of the head, and it is hoped these pictures will give you a better idea of the type of head required.

4. I fear the photograph which accompanied my predecessor's letter of May 23rd, did not assist you very much as that particular photograph was taken of a buffalo head in his office; the hair on which, I believe, had been combed out.

5. I hesitate to ask you to have another sketch made correcting the points raised in paragraph 3, but I am most anxious to secure a badge as accurate as is possible, and when this has been accomplished I will let you know definitely our requirements with respect to a coloured design.

6. With regard to the colour of the maple leaves, I agree with you that they should be green.

Who was it that coined the phrase "They Always Get Their Man"? Ever since the days of the North West Mounted Police, nearly every member of the force has been looking for him, but he hasn't been found. He's the man we want, though. This thoughtless cliché was probably intended as a compliment, but it has grown into an unshakable slogan. Radio commentators, public speakers and authors repeat the time-tattered catch-phrase with sickening persistence. Press agents jump at it, fiction writers revel in it, movies perpetuate it. I have examined the newly designed badge of the Force, a copy of which is annexed - figure 1.

2. I called Mr. J.G. Dickson to help me draw up a few comments for your information. It appears to us that the badge is very satisfactory. It departs in only a few details from the existing one, which is a good thing, in that all existing buttons, badges, crests, etc., will not require replacement except by a gradual change brought about over a number of years. I presume that once the new badge is properly registered all new dies and stamps for cutting and printing badges will be made to conform to it, but that such changes will not come about until the old dies are worn out. The change in the badge is so slight that it would hardly be distinguishable from that appearing on the buttons and badges today.

3. The new badge embodies all the essential ingredients of the badge of the Force, while a few non-essentials have been discarded. The essentials are:

- (a) The Imperial Crown proper, which signifies that the Force carries the Prefix Royal granted to it by His Majesty King Edward VII in 1904. At the same time, it signifies that the reigning Sovereign is at the head of the Force as its Honorary Commissioner.
- (b) *Badges* The scroll bearing words "Canada" signifies the country to which the Force belongs. This word appears on some of the older crests of the Force, but has been dropped a good deal of late years. In our opinion, it is a very good idea to put it into the official badge. While it is true the word "Canadian" appears lower down, yet we feel sure that the name "Canada" should appear where it is now placed.
- (c) The North American bison head, or buffalo head as it is commonly called, associates

11

the Force with the prairies of Western Canada where the first tasks of the Force were performed at a time when large herds of this native animal still roamed the prairies.

(d) The scroll surrounding the bison head, bearing the motto of the Force, "Maintiens le Droit", with the meaning of "uphold The Right", written in the French language because that language is so widely spoken and has its origin in the earliest of settlers, The Civic blue recognized as a police colour throughout the English speaking world. Years ago in England, the blue was adopted to replace the red of the military. Whenever there was a serious breach of the peace in those days, the military were called and opened fire upon the mobs. This eventually created an impossible state of affairs because the soldiers refused to fire, maintaining that in many cases they were shooting down their own brothers. The need was then seen for the formation of a Civil Police Force, which amounted to the general public selecting certain of their members to do the task which every civilian should by rights perform. In order to distinguish these new police from the military, the blue uniforms were used, and have continued ever since.

(e) The wreath of maple leaves, the National Emblem of Canada, of which there are twelve in the wreath, one for each of the ten provinces and the two territories of which the country is composed.

(f) The scroll bearing the name of the Force, Royal Canadian Mounted Police.

4. My understanding of badges, crests, and Coats-of-Arms, is that a written description must accompany the design. Any badge which conforms to both the official description and the official design cannot be wrong. Mr. Dickson has drawn up the description in heraldic language, which I think is very suitable. It is as follows:

5. " A bison's head, ^{facings front} affrontee, ppr; surrounded by a scroll ^{blue} azure, edged ^{gold} or; bearing the motto: MAINTIENS LE DROIT, also ^{gold} or; all within a wreath of twelve Canadian Maple leaves ^{vert} vert. On a like scroll below, the legend: ROYAL CANADIAN MOUNTED POLICE, ^{gold} or; The whole surmounted by an Imperial crown ppr; with the name CANADA ^{gold} or; on a scroll ^{blue} azure, edged ^{gold} or; below the crown. "

6. Assuming then, that we have the description of the badge, I would go as far as to say that this description is actually more essential than the drawing of the badge, although to make it complete, a

drawing is necessary. From the description, the actual colours can be obtained, and as far as I can see, in having the description, there is no actual need to register a coloured design. However, I believe this can be done and would, of course, complete the matter entirely. I believe, however, that any badge made according to the description would be correct. For example, if the artist depicts twelve maple leaves and they are green, it does not matter what shade of green they are or what type of maple leaves they are, so long as they are maple leaves and they are green, and there are twelve of them. The same with the scrolls; so long as they are blue and have gold letters and gold edges, they are correct. The same again with the bison head; so long as it truly represents the front face of a bison in natural colours, it must be considered to be correct. The Crown also is fixed by description because there is only one way in heraldry to depict an Imperial Crown proper.

7. Figure 2 is a copy of Figure 1, but done in colour for reference purposes only. On this coloured badge, Mr. Dickson and I have changed Figure 1 in two places.

(a) We have reduced the words, "Maintiens le Droit" in size so that the letters now do not touch the edge of the scroll, as they do in Figure 1. We suggest that this be incorporated into the master design, but at the same time, we realize that it may not be necessary to do so because as I have said these slight changes are permissible by any artist reproducing the badge if he thinks fit to do so. So long as he has the correct letters, I do not think it matters what size the letters are, or what type of letter he uses for that matter. We only suggest this change in the master crest because we think it would match the wording on the scroll bearing "Royal Canadian Mounted Police."


(b) The second change we have made is to put a gold edge on the scroll bearing the word: "Canada". We added this, and suggest it be added to the master crest, to make that small scroll conform to the others. In this way, all scrolls will have gold edges.

8. The lump showing behind the bison head is questioned by some. It represents the top of the neck, of course. We think it might possibly be removed to make a better design.

9. Mr. Dickson's description definitely refers to a bison's head. This is correct, although strange to say, ninety-nine people out of a hundred would refer to the animal as a buffalo. It is definitely a bison, of which species there are actually only two on the face of the earth. There is the European bison and the American bison, the former



being known to naturalists as bison bonas^{us}~~us~~, and the latter bison Americannis. They are both allied to the ox in the family of bovidia, so I read from the encyclopedia. On the other hand, a buffalo is strictly an old world animal. Europe has buffaloes, but they are not true natives. They are the descendants of stock imported from Asia centuries ago. Then, there are the wild Cape buffaloes, and the Indian buffaloes, which have been tamed for domestic use, and in India are the commonest of domestic animals today. But the bison is distinctive from all these, and particularly the bison Americannis, which is found nowhere else in the world except on the American continent.

We have had some further discussions on the proposed new Badge. Inspector Wonnacott and Mr. Dickson have urged me to draw to your attention the fact that they consider that the letter "L" in Royal and the letter "P" in Police on the bottom scroll certainly should not be hidden as they are.

2. Mr. Dickson points out that he has studied a great number of different Badges and he has never, on any occasion, found one with partially hidden letters on it.

3. Another reason why these letters should not be partially hidden is that this Crest will have to be considerably reduced for most of the purposes for which it will be used and it is then that there is liable to be some bad misunderstanding because it will not be possible on such a small scale to imagine what the letters really are.

4. I attach a sketch to demonstrate the two letters in question. Personally I think that this point should be drawn to the attention of the Draftsman who should be asked to arrange the scroll so that all the letters on it are ^{all} clearly visible. This, for them, would be a very small operation and it might save us a lot of misunderstanding in future years.

1. Your letter of December 17th, 1951, setting out the information requested, is acknowledged with thanks.

2. To complete the colour design of the R.C.M. Police badge and have same enrolled in the archives of the College of Arms, I enclose a draft in your favour on the Bank of Montreal, London, England, in the amount of £32.7.0.

3. As requested by you, I am forwarding a photograph of a black and white drawing, also a photograph of the same drawing in colour which I had prepared here, as a guide only, insofar as the proposed colours are concerned, but wish to stress that this is not a finished article. As you will note, the Royal Blue and yellow predominate in this colour design as these are the R.C.M. Police colours.

4. Regarding the Royal Crown, I would, of course, want this to be in proper colours; the maple leaves, green; the buffalo head, in its natural colours of dark brown; the encircling ribbon with motto, the small scroll and word "Canada", and the large scroll and inscription, it is felt, should be depicted in Royal Blue and yellow. However, your views may be contrary to my suggestion, and if so, please do not hesitate in bringing to my attention any changes you feel should be made. In fact, I would request that you kindly let me have your opinion of the coloured sample before completing same, which I will look forward to receiving with pleasure.

Re: R.C.M. Police Badge

1. In perusing the correspondence on the above subject as a partial basis of an article I have been requested to write for the R.C.M.P. Quarterly, it is respectfully suggested that three aspects of the matter be drawn to your attention: (1) The heraldic description of the Badge, (2) The selection of a colour as a background for the Bison, and (3) The manner of lettering the words "Royal Canadian Mounted Police" on the scroll below the design.

2. With regard to (1) above, (description of the design,) it is recommended that the College of Arms give it's official blazon (description of colours, subject matter etc.) of the Badge underneath their coloured painting of it, as a matter of record, and in order to avoid any mistakes in the future, by artists and others. This procedure is followed in the issuing of Grants of Arms by the English College of Arms and the Scottish Court of the Lord Lyon, and I believe we should make such a request, in case it be overlooked.

3. Regarding (2) above, (the colour of the background surrounding the Bison,) it is respectfully pointed out that in his letter dated Dec. 17th, 1951, to the Commissioner, Garter Principal King of Arms mentions that "there remains for consideration, the background" etc. Unfortunately, there is no mention of this matter in the letter dated Jan. 22, 1952 from the Commissioner to Garter. It is evident from Garter's letter that there should be a background surrounding the animal, otherwise it would be left blank, and therefore incomplete and incorrect. It is suggested that consideration be given to the background being azure, or blue, to match the ribbon and scrolls. This would appear to be logical, as blue could also represent the sky, which is part of the surroundings of the roving Bison. It is considered that the use of any other colour would appear to be too garish, and would also tend to make the design very spotty.

We have further communication is made - this matter will be dealt with

4. With reference to (3) above, (the lettering on the large scroll), it is noted that no comments regarding any action taken appear on the Memorandum dated Dec. 12th, 1951 from Assistant Commissioner Bullard, to the Deputy Commissioner. It is most respectfully requested that this matter be considered in view of the recommendations made in that Memorandum. It is therefore strongly urged that in further communication with the Garter Principal King of Arms on the subject of the background for the Bison, that a request be made that the left and right hand parts of the large scroll be slightly expanded to avoid any partial obstruction of the lettering in the words "Royal" and "Police". This would indeed be a simple matter for the artist to correct when he is making the final coloured drawing for us. Then we shall have a Badge as nearly perfect as anyone could desire, and following the precepts and examples of other badges throughout the world.



Dear Sir George:

1. Knowing the extra duties you have recently been called upon to perform due to the regrettable death of His Late Majesty, it is a great wonder to me how you found the time to reply to my letter so quickly, and I do appreciate your doing so.
2. In regard to the point you raise as to using gold instead of yellow for the painting, I am sure the use of gold would enhance the colouring in the badge; but I feel that to use gold colouring might give the impression that our colours are royal blue and gold, instead of royal blue and yellow. In view of this it is felt that we should retain yellow rather than change.
3. I agree that the green of the maple leaves in the painting forwarded you is rather harsh and concur with your proposal, as it is felt this colouring could be altered to advantage.
4. It is assumed that when the badge is enrolled in the Archives of the College of Arms that a complete description of the badge and colours will have been prepared as this would be necessary to prevent any future controversy that might arise over the design and colours.
5. In your letter of December 17th, 1951, you made mention of the background of the badge which in my reply dated January 22nd, 1952, I purposely did not mention, as I felt you would know more about this than I do. However, as you have not mentioned it in your recent letter, I bring the matter to your attention and would suggest an overall background of a suitable blue, the shade to be left to you for decision.
6. There is one other point I would like to bring to your attention which had been the subject of some discussion here, and that is the partial obstruction of the letters "L" in ROYAL and the "P" in POLICE. No



I think the suggestion as contained in your memorandum of May 6, under the above heading, is most excellent. However, I should advise that it has been discovered that our Crest had never been registered. In making application to the Garter Principal King of Arms, College of Arms, London, for registration it was found that certain changes in design were necessary. For example, one comment of the Garter was:

"Garter: Strictly speaking it is not considered right or proper to use the Garter form in such things and this I think ought to be re-drawn in the form of a riband or scroll."

In addition, the badge is to be redesigned to show twelve maple leaves, one for each of the Provinces and two for the Territories.

2. With the alterations mentioned the matter of registration is now under way and we anticipate obtaining official notification of acceptance within the immediate future.

3. Under the circumstances as above outlined I think you will agree that it would not be good policy to



MEMORANDUM ON THE DESIGN OF THE CROWN

Prior to the reign of King Edward VII there was no rule or custom regulating the design of representations of the Crown when used with the Royal Cypher or separately for various official purposes. His late Majesty King Edward VII caused the arrangements to be regularised so that customarily the design known as the Tudor Crown would be shown with or without the Royal Cypher. This design has varied to some extent in detail, but since that time has been generally used with or without the Cypher in Insignia of Orders and in Decorations and Medals, in Coins, Postage stamps, various Badges of the Services, Rank Badges, Buttons, Government publications, Postal vans, Government equipment, Stores, etc.

This Crown does not, however, represent any existing Crown, and The Queen prefers the representation of the Crown in designs to resemble the St. Edward's Crown with which Her Majesty will be crowned in the Coronation Service. This representation has already been adopted in the Royal Cypher. Her Majesty's wishes in regard to the representation of the Crown are as follows:

- (1) The St. Edward's Crown should take the place of the Tudor Crown in all future designs embodying a representation of the Crown.
- (ii) Existing designs on Decorations, Medals, Coins, Stamps, Stationery, etc. should not be changed unless or until it is necessary to do so. Whenever, however, a design embodying the Crown has for any reason to be changed, the St. Edward's Crown should be substituted for the Tudor Crown.
- (iii) No unnecessary expense should be incurred in making these changes, and where alteration in an existing design would involve such expense it should be deferred.
- (iv) There is no objection to the use of two different designs for the Crown in the transition period before all Crowns on Royal Emblems are changed to the design of the St. Edward's Crown.

Canada Gets New Crown; New Coat Of Arms Next?

By DOUGLAS HOW

Canadian Press Staff Writer
OTTAWA (CP)—A new crown is to come into use in Canada.

It is expected to emerge gradually in many Canadian military badges, buttons and insignia, on stamps, on coins, on the governor-general's standard or personal flag and elsewhere. It might even lead to the first alteration in the Canadian coat of arms in 32 years.

The reason is Queen Elizabeth's decision to change the heraldic representation of St. Edward's crown, the Coronation crown, which has adorned such things in Commonwealth countries for 52 years.

The change is relatively simple but its effects will range far and its significance is symbolic of the fluid political pattern of the countries that owe allegiance to the throne.

OMITS IMPERIAL TOUCH

The representation of the crown that is going out had imperial significance. It stemmed from a decision of Queen Victoria to alter the heraldic representation to make it more in keeping with her status as an empress. Elizabeth, a queen but not an empress, is going back to a design that omits the imperial touch.

The difference briefly is this:

The four pearl-studded arches of gold—symbols of independent sovereignty—form a semi-circle in the design being abandoned. In the new representation, they go back to the downward curve—forming a kind of figure eight cut in two lengthwise—at the point of intersection. They dip at the centre as they do in the real St. Edward's crown.

The Queen also is changing the type of lettering in her royal cypher—E II R—to straight Roman style from the Italic script used since Edward VII. This also will mean changes in Canada.

Actually the crown that for years has graced Canadian badges, coins and the like has not accurately pictured St. Edward's crown. It was an heraldic representation, a licensed exaggeration and was known widely as the Tudor crown. The new design will be much closer to the real thing and will be called by the real name, St. Edward's Crown.

CORONATION CROWN

St. Edward's crown is the one which for brief seconds will touch the head of Elizabeth in Westminster Abbey June 2 and never be worn by her again. It weighs five pounds. The crown she will wear on state occasions in the future is the imperial state crown, which weighs about two pounds.

The Canadian armed forces plan to make the change gradually in their insignia. Broadly, the orders are expected to be that there is to be no sweeping immediate switch, that the change will take place as new badges, colors or other emblems come in or as old badges wear out and the dies or patterns would normally have to be replaced.

maple leaves which signify Canada are in a subordinate position hardly in keeping with Canada's present status.

But there is no sign yet that cabinet or its top officials are considering any change.

Thus two reserve force infantry regiments getting new colors—the Royal Newfoundland Regiment and the New Brunswick Scottish—are both to have the new-type representation of the crown in them. The Queen herself approved the colors but signified that they should bear St. Edward's crown.

Two army corps, the engineer and service corps, use both the crown and cypher in their badges and will get both changed. The crown that signifies the rank of army majors will be changed, too, and the same sort of alterations will make themselves felt in the navy and air force.

ON STAMPS, COINS

New stamps and coins bearing the likeness of the crowned Elizabeth are expected to bear St. Edward's crown, too, and the governor-general's standard is also expected to abandon the Tudor representation for its successor.

What the cabinet will decide to do about the coat of arms, if anything, remains to be seen but it also is topped by the Tudor crown. The original, royally proclaimed in 1921, now hangs in the office of C. S. Stein, undersecretary of state, an ornate magnificence about four feet high. Reproductions are used widely throughout the country.

Some heraldry experts feel that if a change is to be made in the coat of arms—or, more rightly, the armorial bearings—the opportunity should be seized to make a general overhaul. They feel the present design is hardly compatible with the autonomy and eminence Canada has achieved since 1921.







RCMP Finally Gets Its Badge After 470 Years


Ottawa, Oct. 2.—(P)—The RCMP has ironed out some heraldic difficulties and now has a new and proper badge.

The badge gradually will be placed in use throughout the force, on buttons as collar badges, on stationery, on automobiles and other property.

The October issue of the RCMP Quarterly says the badge has been granted by the Garter Principal King of Arms, College of Arms, London. It has been registered in the records of the college, founded March 2, 1483.

Previous badges of the force, all variations of one design, were "not of sound heraldic design." For instance, the buckled garter surrounding the buffalo, formerly part of the badge, belongs solely to the most noble Order of the Garter.

The badge is about six inches high and four inches wide. It is on a blue background, with a bison's head facing front surrounded by a blue band with gold border inscribed with the RCMP motto "Maintiens le droit"—"Up-hold the right." The band is surrounded by 12 maple leaves.

1. At the last meeting of the Editorial Committee of the RCMP Quarterly the point was raised that on instructions from the Supply Branch the Quarterly was to make available to the Canada Decalcomania Company Limited the six color plates used to reproduce the Force's new badge in the October 1953 issue of the magazine. It was understood that the Decalcomania Company would utilize the plates in making the colored transfers for future use on police cars, etc. It was the opinion of the Decalcomania representative that use of these plates would result in a substantial saving in time and money to the Force.

2. The Committee desire me to point out, however, that these plates are the property of the Quarterly and were paid for by the magazine and not from public funds. The plates are valued at approximately \$500. As there is always the possibility that these cuts may be scratched or spoiled while on loan to the Decalcomania Company, I have been asked to request your assurance that they will be returned undamaged to the Quarterly, thus guaranteeing our financial interest in them.

3. It was also suggested at the Committee meeting that the Supply Branch be asked to purchase a quantity of the colored reproductions of the badge from the Quarterly for

1. The attention of the Officer in Charge, Identification Branch first became focused on the badge of the RCMP when Cpl. J.R. Abbott commenced sculpture of the badge in clay. Various inaccuracies showing up in the old badge resulted in the College of Arms, London, being asked to prepare a proper design for official adoption by the Force.

2. In the meantime pending arrival of their drawing it had been decided by my predecessor (Inspector Wonnacott) in discussion with the Editor of the Quarterly to reproduce the badge in the magazine to afford personnel of the Force an opportunity of seeing the new official badge in color. When the painting of the new badge was received at Headquarters it was turned over to Inspector Wonnacott by the Deputy Commissioner for use by the Quarterly. Color work in printing is expensive, but as the idea to include the badge in the magazine as a frontispiece originated with the Quarterly management it was assumed that the costs would necessarily be borne from funds of the magazine. It was felt at the time, however, that in view of the possibility of the original painting becoming faded by exposure to light a certain service was being rendered the Force by preserving through the six color plates the original shades included in the painting from the College of Arms. Incidentally, in this regard several thousand reproductions were run off separately on coated stock suitable for framing, a large percentage of which have been disposed of

through canteens throughout the Force.

4. In any event, the reproductions of the badge by the Quarterly represented a total overall outlay of \$931 as shown on the attached invoice. Of this, the six plates alone cost \$468. This price to the Quarterly was extremely reasonable and made possible simply because of the trade discount allowed the magazine through its long connection with Runge Press. The plates were made by Bomac Electrotype Limited and the original painting was taken to Montreal for the engravers to make their color separation negatives of it there.

5. Some time ago the former Supply Officer issued instructions that the plates of the badge and proofs of it be made available to the Decalcomania Company, as outlined in my previous memorandum. As it is apparent now that these cuts are of definite future value to the Force, whereas their value to the Quarterly ceased with their use, I would recommend for your consideration that they be purchased from the magazine by the Force. I would suggest in acquiring these cuts the Force might consider reimbursing the Quarterly to the extent of their cost--as outlined in paragraph four--\$468, and add the provision that the magazine be allowed the use of the cuts at any time in the future should the need arise.



The undersigned desires to report that the Royal Canadian Mounted Police Rules and Regulations were authorized by Order-in-Council P.C. 174/1981 dated March 24, 1945, as amended.

Regulation 270 describes the badge of the Force. For some years, however, it has been known that the details of the badge did not strictly comply with heraldic form, and in 1950 steps were first taken to have it properly redesigned by the College of Arms, London, England. More recently, in compliance with Her Majesty's wishes, the Tudor crown was replaced by a representation of the St. Edward's crown.

This work has now been completed and the new design enrolled in the archives of the College of Arms. A colour reproduction of the painting is attached.

As certain details of the present design do not conform with the description as found in Paragraph 270, the undersigned therefore recommends that Paragraph 270 of the Royal Canadian Mounted Police Rules and Regulations be amended to read as follows:-

"The badge of the Force shall be a bison's head facing frontwise, in natural colours, on a blue background, surrounded by a blue band, with a gold border, inscribed with the motto "Maintiens Le Droit", in gold, surrounded by twelve green maple leaves. Under the device, a gold-edged blue scroll bearing the legend: Royal Canadian Mounted Police, in gold. Above the device, the St. Edward's Crown in the proper colours and metals. Under the crown, on a blue scroll, the name Canada."





DRAFT FOR GENERAL ORDERS, PART ONE

By authority of Order in Council, P.C. 1954-27/256 dated February 25, 1954, Rules and Regulations, 1945, are amended by cancelling Regulation 270 and substituting the following therefor.

270. The badge of the Force shall be a bison's head facing frontwise, in natural colours, on a blue background, surrounded by a blue band, with a gold border, inscribed with the motto "Maintiens Le Droit", in gold, surrounded by twelve green maple leaves. Under the device, a gold-edged blue scroll bearing the legend: Royal Canadian Mounted Police, in gold. Above the device, the St. Edward's Crown in the proper colours and metals. Under the crown, on a blue scroll, the name Canada.

Gentlemen;-

I have your letter of December 30 last addressed to Supt. Perlson in response to his letter of the 22nd.

As we understand it here you are proceeding at the present time to make up a sample of the shoulder cords but in somewhat smaller diameter than the 5/16" shown on the blueprint.

It is presumed that you have in mind 1/4" cord and I would like to be informed definitely on this point and also whether you are, in actual fact, proceeding to make up a sample in this size.

With regard to the print of the crest forwarded to you I am afraid that we did not receive any heraldic description from the College of Arms. We were supplied, however, with a sealed painting in authentic colours as registered with the College of Arms.

I have checked our reproduction against the colours shown in the standard and I feel that the print as forwarded to you is as close to the original as it would be humanly possible to achieve in a reproduction. So that there will be no mistake, I am forwarding, under separate cover, another print which I have initialed as the one I checked against the standard.

Alter Badge Of RCMP

"To correct errors in design," the official badge of the Royal Canadian Mounted Police has been altered as from Feb. 25 last, Justice Minister Stuart Garson informed Rodney A. Adamson (PC, York West) in the Commons on Monday afternoon.

The change was made on the recommendation of RCMP Commissioner L. H. Nicholson, approved by the cabinet by PC 1954 27/256, after the alterations were checked and approved by Sir George Bellew, KCVO, garter principal King at Arms.

As to the changes made, the representation of the St. Edward's Crown was replaced by the Tudor Crown; the bison was redrawn to provide a more life-like looking head; the scroll surrounding "Maintiens le Droit" was replaced by the buckled garter; the leaves were redesigned and brought closer together.

RCMP Badge Design Errors Corrected After 81 Years

Ottawa, March 1 (Staff). — It now turns out that for a large part of the 81 years it had been maintaining the right in Canada, the RCMP was also maintaining something not quite right in its badge.

Justice Minister Garson, in a written reply today to a question by Rodney Adamson (PC, York West), said, yes, the RCMP badge had been altered. For what reason? To correct errors in the design.

The RCMP, which was founded in May, 1873, had been using the now-altered badge since its earliest days. However, it was never official. About two years ago the badge was sent to the College of Heralds in the United Kingdom for examination and proper drawing if found necessary.

The original badge incorporated a buckled garter surrounding the motto, *Maintiens le Droit*. The authorities on heraldry reported there were a limited number of places where the garter properly could be used, and the RCMP

badge wasn't one of them. The buckled garter became a scroll or riband.

The bison's head, which is the central figure on the badge, was redrawn to look more like a bison's head. The maple leaves surrounding the badge were re-designed and brought closer together.

Also changed was the Crown at the top of the badge. This was done as a consequence of "Queen Elizabeth's having picked the St. Edward's Crown, over the Tudor Crown which formerly was used, for official use.
