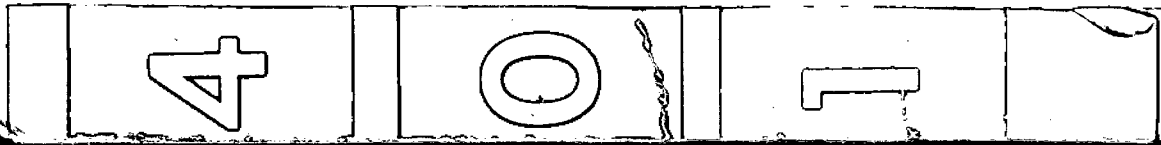

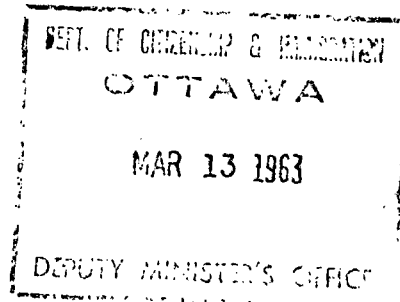

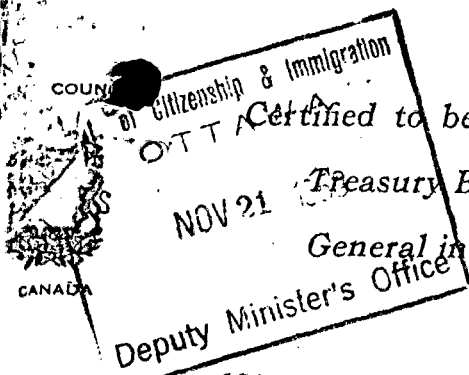

and recommendation from the Honourable the Minister of

Citizenship and Immigration representing:

"That Section 113 of the Indian Act in part provides as follows:

That for a number of years it has been the practice of the Indian Affairs Branch to render financial assistance to Indians, to help them receive educational and professional training of various types at non-Indian schools;

That payments have been necessary for tuition fees and school supplies for most Indians above the elementary, and in some cases at the elementary, school level;

That partial or total transportation costs and board and room have often been necessary when the student had to leave his home to receive training, or if his home was some distance from the educational institution attended;

That it has recently been found essential, on occasion, when the student is an orphan or his family is poor, to provide a monthly personal allowance to cover such miscellaneous expenses as carfare, laundry and other incidentals;

That the cost of this programme for the present fiscal year is estimated at \$850,000 and may be expected to increase by approximately 20 per cent annually if the present trend continues;

The undersigned, therefore, recommends that authority be granted:

- (1) to pay from the Education Vote, No. 74, of the Department of Citizenship and Immigration, on behalf of Indians in training:
  - (a) the cost of tuition, books and supplies;
  - (b) the cost of transportation for the student from his place of residence to the school and return;
  - (c) the cost of partial or total board and room (according to the financial circumstances of the parents or student) while attending an institution of learning;
  - (d) the cost of providing the student with a monthly personal allowance to cover carfare, laundry and other incidental expenditures in connection with his educational training;



- (2) to enter into agreements, exclusive of agreements requiring payment of lump sums for capital expenditure, with the authorities mentioned in Section 113(b) of the Indian Act, for the educational training of Indians."

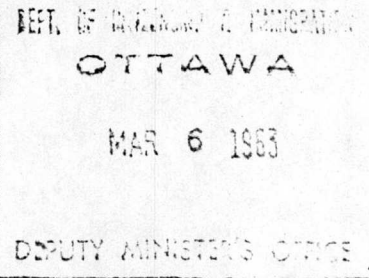

Dear Colonel Jones:

At its meeting of February 22, 1963, the Board considered your Minister's proposal to widen the limits of the general authority covering joint school agreements involving capital contributions.

The Board approved the proposal in substance and also the consolidation of the two existing authorities covering joint school agreements (i.e. P.C. 1961-3/366, and P.C. 1958-8/1578, as amended) and we are issuing a Minute to Council to this effect; the form of the Minute to Council is, of course, altered somewhat from what was originally proposed, but these changes have been agreed to by your officials.

The Board asked that, for the record, certain points be set down in a letter. In approving the proposal, the Board took account of the many advantages of integrated education for Indian children and of the need to provide your Department with reasonable flexibility in negotiations with the various organizations specified in Section 113(1) of the Indian Act. In this connection, it was understood that, while the limit being set on per capita tuition fees under the new general authority is to equal the maximum per capita operating cost incurred under existing agreements, your Department will, for each new agreement, establish the amount of the tuition fee taking into account approximately the number of Indian

children in comparison to the number of non-Indian children and the cost of operating and maintaining the particular school. Provision in the tuition fees to cover depreciation of the school facilities should not exceed, unless the most exceptional circumstances apply, an amount which is consistent with the true life of the facilities. Obviously, where a capital contribution has already been made, no share of the depreciation charge should be paid by your Department.

The Board noted that your Department often enters into agreements requiring capital contributions in years for which the size of the appropriation is not known and asked that, to prevent commitments exceeding the level of appropriation acceptable from a budgetary point of view, the total of commitments for joint school and Indian school capital programs, for each of these years, not exceed an amount equal to 75% of the education capital appropriation (Vote 85) in the then current year.

Although this has not been covered in the Order in Council, the Board approved the continuation of payments, in respect of Indians in training, for the following items:


- (a) tuition, books and supplies;
- (b) transportation for the student from his place of residence to the school and return;
- (c) as determined by the Department in light of the financial circumstances of the Indian and his family, either of
  - (i) partial or total board and room, or
  - (ii) a meal allowance approximately equal to the prevailing cost of board in the locality in which the student is obtaining his education, but not to exceed \$12.50 per week, and partial or total room.

- (d) a personal allowance to cover car-fare, laundry and other reasonable incidental expenses;
- (e) required clothing, as determined by the Department in light of the financial circumstances of the Indian and his family and the type of institution being attended.

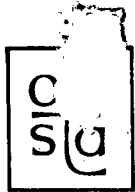





The matter of tuition agreements you raise in your letter of November 7, 1979 is subject to ongoing change and, if considered in depth, one could almost say each situation must be dealt with in an individual manner because a few variables do have to be considered.

At the present time Band Councils are not considered legal entities by the Ministry of Education in the Ministry's legislation. They have for some time had legislation prepared for the Minister to place before the House to make Band Councils legal entities for purposes of The Education Act as it applies to the Ministry of Education, Ontario. This has not yet been presented to the House. The matter of the legal entity of a Band Council unless legislated in this way is still in question.

There have been some doubts as to the legality of a three party agreement. The federal government legal services has expressed concerns about them, however, headquarters at the request of several regions including Ontario is requesting something in writing. The Ministry of Education did in some areas of the province indicate they were not legal, however, they have since agreed to them. We now have fifteen three party agreements in Ontario with different boards.

The matter is not, however, as simple as the Federal and Provincial governments accepting them. We have encountered some difficulty, as you point out, with individual boards who are reluctant to negotiate agreements. This applies to two party agreements between the board and the department as well as three party negotiations. This is made possible by the independent nature of each individual board which permits it to have its own legal counsel and to interpret the situation in a different way than the Ministry. This is more apt to be the problem because the Ministry supports tuition agreements.

An often used reason given by a board in their reluctance to have an agreement is the fact that the Ministry of Education legislation establishes set rules for board fee setting. This, they point out is their legal guide in charging the department for students in their schools.

I would point out that our department will not approve a tuition agreement unless there is evidence the Bands support it by either submitting a B.C.R. or by signing the agreement as having read, understood and agreed with the document. Fifteen as I have noted include the Band directly as the third party to the agreement.

I hope this helps explain your concern.

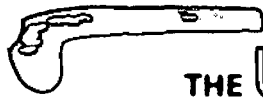

Indian Bands who are represented by the Union of Ontario Indians Association are presently negotiating with the Board of Education on tuition agreements. In the past these negotiations have been carried out between the Board of Education and the Department of Indian Affairs. Some reserves have never had a tuition agreement. Some Band Councils have now assumed control of their education and other services and programs under the policy, Indian Control of Indian education, adopted by the Government of Canada. There is a refusal on the Boards of Education part to allow the Bands to be participants in the negotiation of Tuition Agreements with Provincial School Boards. The reason given is that present Ontario legislation inhibits the Band Council to be signatories to tuition agreements. I understand that three party agreements are not permissible either.

I would like some legal interpretation from your Department on this matter. Is there legislation which inhibits the tuition agreements being signed by the three parties involved - Board of Education, Department of Indian Affairs and Northern Development and the Board? If so, could you cite the references?

Your help in this matter is much appreciated.



A G R E E M E N T

Whereas the Department of Indian Affairs and Northern Development operates schools in Ontario for Indian pupils and whereas, under The Education Act, 1974, section 11(2), the Minister of Education is authorized to make an agreement for the admission of pupils other than Indians to such schools, it is now agreed as follows,

1. Where adequate space is available, and the Indian Community supports the admission, the Department of Indian Affairs and Northern Development may agree to accept for enrolment in its schools such pupils as the Minister of Education may present.
2. Wherever possible, the Minister of Education will notify the Department of Indian Affairs and Northern Development of pupils who wish to be enrolled in Indian schools at least five months prior to school opening so that space availability may be confirmed or alternative arrangements made.
3. The pupils shall be taught in the same manner as the Indian pupils and no special programs or services shall be provided unless specifically authorized under an addendum to this agreement.
4. The number of pupils enrolled on October 15th each year shall be the number to be paid for during the period September 1 to December 30th each year and the number of pupils enrolled on March 15th shall be the number to be paid for during the period January 1 to June 30th each year.

A statement of enrolment and an account shall be issued to Ontario annually at the end of each school year.

The amount to be charged shall be the actual cost per pupil where such is known and verified by an audited statement or otherwise a cost per pupil calculated as closely as possible to the manner in which Ontario calculates such costs or the average cost per pupil for all schools operated by the Department of Indian Affairs and Northern Development in Ontario.

6. This agreement shall continue in force until terminated. It may be terminated on June 30th in any year by either party giving notice in writing to the other at least three months in advance of June 30th.

It may be renegotiated at any time but where no renegotiation has been concluded by March 30th in any year, and no notice of termination has been given, it shall remain in force without change, except by mutual consent, until June 30th of the following year.

Accept non-Indian children into federal schools and provide education services for them in those cases in which accommodation is available and when the relevant Indian Community has by Band Council Resolution indicated its concurrence with such action. A copy of the Band Council Resolution shall be attached to, read with and considered part of this Agreement.

II. Provide for those non-Indian children, the same education services using the same curricula and teaching methods as are provided and used for Indian children attending these schools.

III. Provide to the PROVINCE within 30 days after the conclusion of each school year, a list of the names of all non-Indian children who were enrolled in federal schools in Ontario as of October 15th and March 15th during the school year just concluded.

IV. Provide for the parents of non-Indian children to visit those federal schools attended by their children at such times as shall be agreed upon by the parents and the Principals of those federal schools attended by their children.

V. Provide to the parents of non-Indian children attending federal schools with progress reports, attendance records and other school documents in the same manner and frequency as such are provided to the parents of Indian children attending the same schools.

## SECTION II

The PROVINCE shall:

I. On or before April 1 of any year, provide the MINISTER with a list of the names of those non-Indian children for whom admission to Indian schools in September of the same year is planned so that space availability may be confirmed or alternative arrangements made.

II. Pay to the MINISTER an annual tuition fee for each non-Indian child enrolled in federal schools as of October 15 and March 15, during any school year.

III. The tuition fee for each non-Indian child shall be an amount of money equal to the average of the annual fees paid to provincial School Boards in the Province of Ontario for Indian children attending provincial schools under their jurisdiction.



IV. The fee shall be paid for the months of September to December inclusive on the basis of the non-Indian enrolment of any year in Federal schools as of October 15th of that school year and for the months of January to June inclusive of any school year on the basis of the enrolment of non-Indian children enrolled in federal schools as of March 15th of that school year.

V. The tuition fee shall be paid by the PROVINCE to the MINISTER annually within thirty days of the provision to the PROVINCE by the MINISTER of the list of Indian children in attendance in federal schools as indicated in SECTION I, sub-section III of this AGREEMENT.

SECTION III

It is mutually agreed by the parties hereto that:

(a) This AGREEMENT is effective September 1, 1978 (September 1, 1979);

(b) This AGREEMENT may be terminated by either party effective June 30, of any school year by either party giving notice to the other 90 days prior to June 30 of that school year; and

(c) Amendment to or re-negotiation of this AGREEMENT shall only be arranged by mutual consent of the parties hereto and executed by authorized officers of the MINISTER and the PROVINCE.

The PROVINCE shall:

I.. On or before April 1 of any year, provide the MINISTER with a list of the names of those non-Indian children for whom admission to Indian schools in September of the same year is planned so that space availability may be confirmed or alternative arrangements made.

II. Pay to the MINISTER an annual tuition fee for each non-Indian child enrolled in federal schools as of October 15 and March 15, during any school year.

III. The tuition fee for each non-Indian child shall be an amount of money equal to the average of the annual fees paid to provincial School Boards in the Province of Ontario for Indian children attending provincial schools under their jurisdiction.

IV. The fee shall be paid for the months of September to December inclusive on the basis of the non-Indian enrolment of any year in Federal schools as of October 15th of that school year and for the months of January to June inclusive of any school year on the basis of the enrolment of non-Indian children enrolled in federal schools as of March 15th of that school year.

V. The tuition fee shall be paid by the PROVINCE to the MINISTER annually within thirty days of the provision to the PROVINCE by the MINISTER of the list of Indian children in attendance in federal schools as indicated in SECTION I, sub-section III of this AGREEMENT.

### SECTION III

It is mutually agreed by the parties hereto that:

(a) This AGREEMENT is effective September 1, 1978 (September 1, 1979);

(b) This AGREEMENT may be terminated by either party effective June 30, of any school year by either party giving notice to the other 90 days prior to June 30 of that school year; and

(c) Amendment to or re-negotiation of this AGREEMENT shall only be arranged by mutual consent of the parties hereto and executed by authorized officers of the MINISTER and the PROVINCE.

A G R E E M E N T

Whereas the Department of Indian Affairs and Northern Development operates schools in Ontario for Indian pupils and whereas, under The Education Act, 1974, section 11(2), the Minister of Education is authorized to make an agreement for the admission of pupils other than Indians to such schools, it is now agreed as follows,

1. Where adequate space is available, and the Indian Community supports the admission, the Department of Indian Affairs and Northern Development may agree to accept for enrolment in its schools such pupils as the Minister of Education may present.
2. Wherever possible, the Minister of Education will notify the Department of Indian Affairs and Northern Development of pupils who wish to be enrolled in Indian schools at least five months prior to school opening so that space availability may be confirmed or alternative arrangements made.
3. The pupils shall be taught in the same manner as the Indian pupils and no special programs or services shall be provided unless specifically authorized under an addendum to this agreement.
4. The number of pupils enrolled on October 15th each year shall be the number to be paid for during the period September 1 to December 30th each year and the number of pupils enrolled on March 15th shall be the number to be paid for during the period January 1 to June 30th each year.

5. Payment shall be made by Ontario on behalf of the students who have been accepted for enrolment and in accordance with the enrolment recorded under section 4.

A statement of enrolment and an account shall be issued to Ontario annually at the end of each school year.

The amount to be charged shall be the actual cost per pupil where such is known and verified by an audited statement or otherwise a cost per pupil calculated as closely as possible to the manner in which Ontario calculates such costs or the average cost per pupil for all schools operated by the Department of Indian Affairs and Northern Development in Ontario.

6. This agreement shall continue in force until terminated. It may be terminated on June 30th in any year by either party giving notice in writing to the other at least three months in advance of June 30th.

It may be renegotiated at any time but where no renegotiation has been concluded by March 30th in any year, and no notice of termination has been given, it shall remain in force without change, except by mutual consent, until June 30th of the following year.

The updated budget requirement within the joint school program has increased due to receiving two new submissions from the District.

(1) Bear Island Public School - Temiskaming Board of Education

Due to increased enrollment additional space is required for status Indian students in this school. As this situation is similar to that of the Lady of Fatima joint school agreement, it is suggested that it receive high priority for this fiscal year.

(2) St. Francis School - Fort Frances - Rainy River Separate School Board.

As indicated in your memorandum dated June 28, 1979, this project is in its final stage. However, due to expanding enrollment, the School Board has decided that while the school is still under construction to proceed to meet this requirement by adding additional space. Therefore, this is an amendment to the agreement identified by project no. 31789.

Enclosed you will find these two agreements for your immediate consideration. At the present time one District within the Ontario Region has indicated a requirement for joint school capital funding for the fiscal year 1980/81. 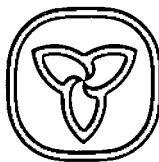

In the revision of any such Agreements, it is probable that there will be requests to include a clause which stresses that Canada has a responsibility for the education of Indian children, and that the Department must be prepared to take whatever steps are necessary to carry out that responsibility.

While there is no basic disagreement with the inclusion of such a clause, you should bear in mind that such a responsibility can only be assumed by the Federal Government within the conditions outlined in the Indian Act. A phrase to this effect should be an integral part of any such clause.

This will enable us to maintain the position outlined in law on this question, regardless of present assertions about "educational rights" or provincial pressures in respect of off-reserve Indians.

Should the law be changed as a result of revisions to the Indian Act, there would be no future need to reword tuition agreements since the suggested phrasing would take this into account.
